#### U.S. will face 'historic remorse' if it quits nuclear deal, Rouhani warns **POLITICS TEHRAN** – Iranian

President Hassan Rouhani said on Sunday that the U.S. will suffer "historic remorse" if Donald Trump's administration quits the 2015 nuclear deal, known as the Joint Comprehensive Plan of Action.

The warning by Rouhani came just a week before Trump decides to either stay in the multilateral accord or leave it.

Iran has threatened to resume its nuclear activities with a speed higher prior to the conclusion of the nuclear agreement if the nuclear agreement is ditched.

### Israeli warplane launches airstrike on northern Gaza

An Israeli fighter jet has targeted a position of the Palestinian Hamas resistance movement in the northern part of the besieged Gaza Strip as Tel Aviv presses ahead with its acts of aggression against the impoverished Palestinian coastal sliver. An unnamed Israeli military spokes-

woman said "the aircraft struck a post belonging to Hamas adjacent to the border fence in the northern Gaza Strip last night." She alleged that the strike was in re-

sponse to kite-borne fire bombings by aza-based resistance fighters. The Ezzedine al-Qassam Brigades,

the military wing of Hamas, said in a statement that a border observation post was hit in the attack, and that nobody was injured.

Local sources said the Israeli F-16 fighter jet bombed a site in Beit Lahia city, causing damage to the site and fear among residents, especially children.  $\rightarrow$  3

#### Yemeni missile destroys Saudi regime positions in Asir

The Yemeni army and allied fighters have hit military positions in Saudi Arabia's Asir region with a ballistic missile and destroyed them, Yemen's al-Masirah television said on Sunday.

A Zalzal 2 missile was fired at the Ain al-Thwareen base in retaliation for the House of Saud regime airstrikes, which hit its target and left an unknown number of casualties, it added.

Yemeni snipers also killed two Saudi regime troops at the Haskul military base in Jizan, while army artillery units pummeled the regime's military positions in the region, the report said.

#### Iranian students to get prepared for world debating championships

**TEHRAN** — In a collaborative effort between the cultural affairs department of University of Tehran and the university's academic center for education, culture and research, called Jahad Daneshgahi, the first round of national English-speaking debating championships will be held to prepare students to take part in international competitions.

The first English-speaking universities debating championship is a huge and essential step to lay the groundwork for the Iranian university students to partake in world debating championships, Majid Sarsangi, director of the cultural affairs department of University of Tehran said on Sunday.

The competitions will also open up opportunities for students to extensively and intensively study, encourage teamwork, and more significantly train students to resolve disputes by negotiating rather than quarrelling," Sarsangi noted.

Issa Alizadeh, Jahad Daneshgahi's director for cultural affairs, for his part, said that the national

onship has been held for six years. "Two years ago we decided to plan the English-speaking debating competitions in order to facilitate students' participation in international championships."

"We are doing the spadework to also host one of the world debating championships in the near future," Alizadeh said, however, he didn't provide any further details on the countries they are planning to invite or the championships they want to host.

Mahdi Kazemi, head of the student organization of Jahad Daneshgahi, also explained that the debating championships held in Iran are similar to international competitions to some extent, but they are modified to suit Iran's cultural and religious context.

The first edition of English-speaking universities debating championship will be held on Tuesday and Wednesday here in Tehran with 8 teams from University of Tehran, universities of Shahid Beheshti, Imam Sadeq, Payam Noor of Ardebil, Shahid Madani, and Mohaghegh Ardebili.

World Universities Debating Championship

onship (WUDC) is the largest English-speaking debate competition worldwide.

The WUDC has been held annually since 1981. Every year the WUDC takes place in a different country and is hosted by a different university and by different debate societies. The tournament gathers students from prestigious universities around the globe, featuring over 400 teams from around 90 countries.

The tournament lasts a week filled with the best level of debate rounds in the world. The debates employ the British Parliamentary (BP) format in which four teams compete against each other on two opposite positions on a given motion, which is announced fifteen minutes before every debate. The competition is run in nine rounds under a Swiss-system where teams of a similar level face off against each other, until the best forty-eight break to the direct elimination rounds. The best Englishas-a-Second-Language (ESL) and English-asa-Foreign-Language (EFL) teams enter their

#### Saudi regime detains 'thousands' for months without trial: HRW

Human Rights Watch (HRW) has blasted the House of Saud regime for detaining thousands of people for excessively long periods without trial, saying the regime's justice system is deteriorating.

The New York-based rights organization said on Sunday that the detentions raised doubts about the Saudi regime Crown Prince Mohammed bin Salman (MBS)'s modernization plan dubbed Vision 2030.

"If Saudi authorities can hold a detainee for months on end with no charges, it's clear that the Saudi criminal justice system remains broken and unjust, and it only seems to be getting worse," said Sarah Leah Whitson, Middle East director at the HRW.

"It seems that MBS's 'Vision2030' plan better describes the length of detentions without charge than an aspirational time horizon for reforms.

The rights group analyzed data from a public online Saudi regime Interior Ministry database, saying 3,380 people had been held for more than six months without a conviction or their "case file under judicial review," including 2,949 for over a year and 770 for above three years.

One Saudi citizen has been held without a conviction since September 2003 and another "under investigation" since December 2006, the HRW added. →3

Zarif was responding to a lawmaker who urged retaliatory measures against the Republic of Azerbaijan which has cancelled visa-free entrance to Iranian nationals, ISNA reported.

The foreign minister said Iran enjoys good economic revenues from Azeri tourists who visit shrine cities, including Mashhad and Oom, inside Iran.

He added that the two religious cities were not the only cities which enjoyed the economic benefits, and that other Iranian provinces were benefiting from it too.



#### **MPs discuss Telegram**, house arrest with Judiciary

**POLITICS TEHRAN** – Members of the pro-reform Hope parliamentary faction have met with Judiciary deputy chief Gholam-Hossein Mohseni-Eje'i to discuss the ban on Telegram app and other issues, ISNA reported.

Bahram Parsaei, the parliamentary faction's spokesman, said on Sunday that during the meeting, which was led by Mohammad-Reza Aref, Mohseni-Eje'i said the Supreme National Cyberspace Council was responsible for the ban on Telegran, which the lawmakers found "unconvincing".

Parsaei said the issue of the house arrest against opposition leaders who claimed vote rigging in the 2009 presidential election was also raised during the meeting, about which Eje'i said the Supreme National Security Council had to decide.

"The U.S. can give it a try. If it wants to pull out of the JCPOA or play a political game to prevent Iran from enjoying its rightful benefits, the Islamic Republic of Iran will definitely make it remorseful,' the veteran politician remarked.

The nuclear parties including the European Union, Germany, Britain, Russia,

and China have reiterated their support for the international nuclear agreement which was signed in July 2015 and took effect in January 2016.

British Foreign Secretary Boris Johnson was slated to travel to the United States late on Sunday in a bid to dissuade Trump from quitting the nuclear deal.

He was to meet senior officials during his two-day trip, including Vice President Mike Pence and Trump's new National Security Adviser John Bolton, both of whom have been critical of Iran and the agreement, according to Express.

Meanwhile, Trump spoke with British Prime Minister Theresa May on Saturday on the issue, the White House said in a statement.

Maj. Gen. Amos Gilad, the former research chief at Israeli Military Intelligence, has told Haaretz that a U.S. withdrawal from the nuclear agreement would mainly help Iran.

## Trump hired Israeli spies in 'dirty ops' to undermine JCPOA: Observer

Aides to U.S. President Donald Trump have reportedly hired an Israeli private intelligence agency to devise a "dirty ops" campaign against key Obama administration officials who helped negotiate the Iran nuclear deal in a scheme to discredit the agreement, the UK-based The Observer newspaper revealed in a report on Saturday.

Trump administration officials contacted private investigators in May of last year, directing them to "get dirt" on former deputy national security adviser Ben Rhodes and Colin Kahl, the deputy assistant to former President Barack Obama, as part of an elaborate scheme to undermine the deal. The extraordinary development comes days before Trump's

May 12 deadline to either scrap or continue to abide by the international pact regarding Iran's civilian nuclear program. 'These are extraordinary and appalling allegations but

which also illustrate a high level of desperation by Trump and [Israeli Prime Minister] Benjamin Netanyahu, not so much to discredit the deal but to undermine those around it," said former British Foreign Secretary Jack Straw.

Officials linked to Trump's team contacted Israeli intelligence elements days after the U.S. president visited Tel Aviv a year ago. Trump then made a pledge to Netanyahu that Iran would never have nuclear weapons - despite the fact that Tehran has always maintained that it is principally and categorically opposed to development and use of nuclear arms. The British newspaper further cited a source familiar with details of the "dirty tricks campaign" as saying that "the idea was that people acting for Trump would discredit those who were pivotal in selling the deal, making it easier to pull out of it.<sup>3</sup>

The Israeli investigators in the "dirty ops" mission were to look at Rhodes' and Kahl's personal relationships with Iran-friendly lobbyists, and to determine whether they had benefited personally or politically from the nuclear deal.

Rhodes slammed the scheme by the Trump administration as "chillingly authoritarian" in a statement to the British newspaper.

"I was not aware, though sadly am not surprised. I would say that digging up dirt on someone for carrying out their professional responsibilities in their positions as White House officials is a chillingly authoritarian thing to do," he said.

A spokesman for the White House's National Security Council offered "no comment" when contacted about the revelation.

Trump has repeatedly signaled his intention to scrap the nuclear deal, denouncing it as "the worst deal ever." In a January speech, he accused his predecessor of having "curried favor" with the Iranian government so as to "push through the disastrously flawed Iran nuclear deal."

The development comes days after Netanyahu again accused Iran of continuing to hide and expand its nuclear weapons know-how after the 2015 deal, in what was widely regarded as a scripted, publicity presentation to further pressure the Trump administration to reject the nuclear deal, also known as the Joint Comprehensive Plan of Action (JCPOA).

During the televised show, Netanyahu claimed that the Israeli regime possessed a wide array of "new and conclusive proof" of purported Iranian violations.

Last month, French President Emmanuel Macron visited the White House for an official state visit, during which he tried to persuade Trump to remain in the agreement. Following the visit, Macron told reporters that he still expects Trump to exit the deal.

"My view — I don't know what your president will decide - is that he will get rid of this deal on his own, for domestic reasons," said the French president.

The European Union, France, the United Kingdom, and Germany have expressed support for the deal in the wake of the Israeli claims.

Iran has on numerous occasions asserted that its nuclear program is merely peaceful.

This is while Israel is widely believed to possess hundreds of nuclear warheads and refuses to either allow inspections of its nuclear facilities or join the nuclear Non-Proliferation Treaty.

U.S. court ruling against Iran is 'mockery' of 9/11 victims: Iran

TICS TEHRAN — Foreign Ministry spokesman Bahram Qassemi has strongly denounced a U.S. court ruling requiring Tehran to pay compensations to victims of the 9/11 attacks, saying the ruling was "politically-motivated".

"Such politically-motivated judgments which are based on unfounded accusations have already been raised in the past," Qassemi was quoted by Fars as saying.

"Not only is it a mockery of the international law system, but it is also a mockery at the expense of the American people, particularly the victims and the bereaved families of the September 11 attacks," he added.



**Russia calls** nuclear deal 'irrevocable' document

**POLITICS TEHRAN** – The Russian Foreign Ministry has said the nuclear agreement is not a simple deal, calling it an "irrevocable" document which has been confirmed by the UN Security Council.

U.S. authorities' pledge to unilaterally withdraw from the nuclear accord is a threat to international law and security and causes instability, the Foreign Ministry spokeswoman Maria Zakharova told IRNA on Sunday.

Zakharov also said the Syrian crisis started by militants who are supported by foreigners. She also praised Iran's role in Syria as "important" and "effective".

Maj. Gen. Amos Gilad, the former research chief at Military Intelligence, has said a U.S. withdrawal from the 2015 nuclear agreement with the big powers would mainly help Iran.

Gilad, also the former director of the political-security division at the defense ministry, told Haaretz that he believed that an American commitment to the deal remained the least bad option.

On last Monday's presentation by Prime Minister Benjamin Netanyahu on Iran's nuclear program, Gilad said the material obtained by the Mossad did not prove that the Iranians were violating the nuclear agreement. He added, "Even after Netanya-

hu's impressive news conference, I don't see other countries, other than the United States, taking a stance in favor of abandoning the agreement. Russia is a strategic partner of Iran in Syria. China trades with Iran and the Europeans aren't budging from their position" supporting the agreement.



"An American announcement that it's withdrawing from the agreement would let Iran drive a wedge between the world powers and gradually loosen international oversight over its nuclear program. If the Americans abandon the agreement, they have to prepare for alternatives, and I don't see this being done."

**POLITICS** d e s k Vice President Nouri al-Maliki has said that a U.S. withdrawal from the 2015 nuclear deal would pose threat against the international peace and security.

In an interview with IRNA published on Sunday, al-Maliki said implementation of the deal, known as the Joint Comprehensive Plan of Action or JCPOA, is beneficial to the entire world.

The JCPOA is a victory for the entire humanity, the region and all the peace-seeking people in the world," noted al-Maliki, who was Iraq's prime minister from 2006 to 2014.

He also said that it is better for the U.S. to remain in the nuclear deal.

Quitting an agreement which has been approved by the UN Security Council will be a violation of international law, the senior Iraqi politician remarked.

Iran, the five permanent members of the UN Security Council - the U.S., UK, France, Russia, and China - Germany and the European Union struck the nuclear deal in July 2015. The deal took effect in January 2016.

The UN Security Council turned the JCPOA into international law by endorsing a resolution in July 2015.

Ali Akbar Salehi, Iran's nuclear chief who is a nuclear physicist, has said his agency will resume enriching uranium to the purity level of 20 percent in a matter of few days if the agreement is ditched.

Rouhani also said necessary decisions have been made in case certain sanctions that had been removed under the nuclear accord are snapped back.

"The economic sector has also received the necessary orders.

Under the nuclear accord Iran is obliged to scale back its nuclear activities in exchange for termination of nuclear-related sanctions

Since the nuclear deal went into effect in January 2016, the International Atomic Energy Agency has issued 10 reports each time confirming that Iran has been honoring its commitments.

"We have been committed to our obligations [under the JCPOA] in spite of the U.S. impediments.

"Since 15 months ago, Trump has started to say that the deal is the worst deal ever which is harmful to the U.S. but beneficial to Iran... but we negotiated with logic and reached an agreement which was approved by the UN (Security Council)," Rouhani explained.

We will build as many weapons as the country needs'

Rouhani also said that Iran will build as many weapons and missiles as the country needs.

The West, led by the Trump administration, has been creating a commotion over Iran's missile program which Tehran has been insisting is purely deterrent.

"It is not related to anybody that what decision the Iranian nation has taken for their defense," Rouhani asserted.

To convince Trump to stay in the nuclear deal, the three European countries party to the nuclear deal (France, Britain, and Germany) have backed negotiations with Iran over its missile program.

However Rouhani said, "We will not hold negotiations on our defense capabilities.

Elsewhere in his remarks, Rouhani said Iran is not after war in the region and seeks "peace, stability and security".

He added, "We do not seek war and tension, however, we defend determinedly against any plot."

# Turkey to retaliate if U.S. halts weapons sales

Turkey will retaliate if the United States enacts a proposed law that would halt weapons sales to the country, Foreign Minister Mevlut Cavusoglu said on Sunday.

Lawmakers in the United States House of Representatives released details on Friday of a \$717 billion annual defense policy bill, including a measure to temporarily halt weapons sales to Turkey. In an interview with broadcaster CNN Turk, Cavusoglu said the measures in the bill were wrong, illogical and not fitting between the NATO (North Atlantic Treaty Organization) allies.

"If the United States imposes sanctions on us or takes such a step, Turkey will absolutely retaliate," Cavusoglu said. "What needs to be done is the U.S. needs to let go of this."

The proposed U.S. National Defense Authorization Act, which is several steps from becoming law, would ask the Defense Department to provide Congress with a report on the relationship between the United States and Turkey, and would block the sale of major defense equipment until the report was complete. Turkey plans to buy more than



Turkey signed an agreement with Russia in December to buy S-400 surface-to-air missile batteries as part of Ankara's plans to boost its defense capabilities amid threats from

Kurdish and militants at home and conflicts across its borders in Syria and Iraq.

The move to buy S-400s, which are incompatible with the NATO systems, has unnerved NATO member countries, which are already wary of Moscow's military presence in the Middle East, prompting NATO officials to

## Blast at mosque in eastern Afghanistan kills 13

An explosion at a mosque in the eastern Afghan prov-ince of Khost on Sunday killed at least 13 people and wounded 31 and the casualty total may rise, a local police official said.

Basir Bina, spokesman for the provincial police, said people were gathered after afternoon prayers in the mosque, which was also being used as a voter registration center for parliamentary elections due in October.

## Israeli warplane launches airstrike on northern Gaza

1 → Meanwhile, Israeli soldiers shot and killed two Palestinians who tried to cross into Israel from the Gaza Strip on Sunday, the military said. "Troops fired towards three suspects who attempted to infiltrate into Israel from the southern Gaza Strip and to damage security infrastructure in the area of the security fence, the military said in a statement. "Two suspects were killed.

Palestinian health officials said the two men had been killed by Israeli gunfire near the town of Khan Younis.

The spokesman for the Gaza Ministry of Health, Ashraf al-Qidra, said in a statement on April 14 that Israeli tanks had targeted a group of civilians in al-Awdah refugee camp east of Rafah city, located 30 kilometers south of Gaza City, leaving four Palestinian men dead and several others injured. He identified three of those killed as Ayed Saleh al-Hamaydeh, Amjad Hosni al-Qatros and Hisham Mohammed Abdelal. On April 11, Israeli battle tanks targeted

several positions of the Palestinian Hamas resistance movement in the Gaza Strip.

The Israeli military alleged in a statement that the shelling came after Palestinians allegedly detonated a bomb near an Israeli construction vehicle adjacent to the border fence between the Gaza Strip and the occupied Palestinian territories, which caused neither injury nor damage. The Israeli military frequently bombs the Gaza Strip, with civilians being the main target of such attacks. Israel has also launched several wars on the Palestinian coastal sliver, the last of which began in early July 2014. The military aggression, which ended on August 26,

2014, killed nearly 2,200 Palestinians. Over 11,100 others were also wounded in the war. The Gaza Strip has been under an Israeli siege since June 2007. The blockade has caused a decline in the standards of living as well as unprecedented levels of unemployment and unrelenting poverty.

The Israeli regime denies about 1.8 million people in Gaza their basic rights, such as freedom of movement, jobs with proper wages as well as adequate healthcare and education. (Source: agencies)

## Yemeni missile destroys Saudi regime positions in Asir

 $1 \rightarrow$  On Thursday, the New York Times reported that about a dozen commandos with the United States Army Special Forces, known as the Green Berets, had been deployed to Saudi Arabia's southern border regions with the aim of countering Yemeni missiles.

The deployment came following reports that Patriot interceptors supplied by the U.S. to Saudi Arabia were increasingly failing against missiles fired by Ansarullah (Houthi) movement fighters. The secretive U.S. mission, according to the report, is aimed at helping the Saudi regime forces locate Yemeni missile launch sites and destroy the missile supplies of the Ansarullah movement. The House of Saud regime has been bombing Yemen since 2015 and punishing it with a crippling blockade on Yemeni ports, airports and borders crossings, which has restricted food, aid and vital supplies from entering the impoverished country.

#### Anger in France, Britain over Trump's gun law speech

The United States President Donald Trump caused anger in France and Britain by suggesting looser gun laws could have helped prevent deadly attacks in Paris in 2015 and linking knife crime in London to a handgun ban.

In a speech to the National Rifle Association (NRA) on Friday, Trump mimicked the shooting of victims in the Paris rampage and said if civilians had been armed "it would have been a whole different story.'

The French government issued its strongest criticism of Trump since he took office and one minister urged the leader to apologies, at a time when President Emmanuel Macron has been reinforcing bilateral ties following a state visit.

"France expresses its firm disapproval of President Trump's comments about the Paris attacks on Nov. 13, 2015 and demands that the memory of the victims be respected," the foreign office said in a statement.

"France is proud to be a country where acquiring and carrying firearms is strictly regulated.'

French Finance Minister Bruno Le Maire said he hoped Trump "would come back on his words and express regret".

"His comments are shocking and not worthy of the president of the world's greatest superpower," Le Maire told BFM television on Sunday

Other French politicians, including the mayor of Paris, took issue with Trump's comments, after he acted out the scene of the massacre by Islamist assailants at Paris' Bataclan concert hall, where 90 of the 130 victims of the attacks died.

'They took their time and gunned them down one by one. Boom! Come over here. Boom! Come over here. Boom!" Trump said, using his hands in a gun gesture.

Francois Hollande, who was French president at the time, said on Twitter Trump's remarks were "shameful" and "obscene". 'Knives, knives, knives'

Trauma surgeons in London, meanwhile, said Trump had missed the point when, in the same speech, he linked knife crime there to an absence of guns.

Comments by Trump have caused upset before in Britain. Relations with Prime Minister Theresa May cooled last year after she criticized him for retweeting anti-Islam videos by a British far-right group.

Trump, who is due to visit Britain on July 13, told NRA members that a "once very prestigious" London hospital, which he did not name, had become overwhelmed with knife attack victims.

"They don't have guns. They have knives and instead there's blood all over the floors of this hospital," he said. "They say it's as bad as a military war zone hospital. Knives, knives, knives, knives," he said, making stabbing gestures.

London suffered a spike in knife crime early this year, and saw more murders during February and March than New York.

Last month, trauma surgeon Martin Griffiths told the BBC some of his colleagues had likened the Royal London Hospital in east London where he works to the former British military base Camp Bastion in Afghanistan.

But on Saturday he indicated Trump had drawn the wrong conclusion from his remarks.

Griffiths posted his comment next to an animation of a stick figure with the phrase "The Point" flying over its head and also linked to a statement on the hospital's website by fellow trauma surgeon Karim Brohi.

There is more we can all do to combat this violence, but to suggest guns are part of the solution is ridiculous. Gunshot wounds are at least twice as lethal as knife injuries and more difficult to repair," Brohi said in the statement on Saturday.

Britain's government effectively banned handgun ownership in England, Scotland and Wales after a school shooting in 1996.

### Saudi regime detains 'thousands' for months without trial: HRW

 $1 \rightarrow$  "We've reverted to a Saudi version of Kafka when authorities detain citizens for over a decade without charge because they are 'under investigation'," Whitson said.

"This effectively means that Saudi authorities can detain and jail anyone they want by claiming they are investigating them, however endless the investigation," she added.

Whitson also urged the Saudi regime's attorney general to promptly charge or release

all the defendants held arbitrarily. She further challenged the crown prince's

pledge to bring major social and economic changes to Saudi Arabia amid a recent dramatic increase in incarceration without trial.

"Mohammad bin Salman's promises to modernize and strengthen the rule of law mean very little when the authorities can lock away thousands of people for years and throw away the key," she said. Under the Saudi regime law, a person may be detained without charge for a maximum of five days, renewable up to six months by a public prosecution order. After six months, the detainee should "be directly transferred to the competent court, or be released."

Bin Salman was appointed the first in line to the Saudi regime throne by his father, King Salman bin Abdulaziz Al Saud, last June, Since then, he has engaged in a string of radical economic and social projects in a bid to portray himself

as "reformist." But those projects have been widely seen more about consolidating his personal power and less about bringing about real change to the Saudi regime.

Hundreds of influential Saudi businessmen and members of the royal family were rounded up in November 2017 in an alleged "anti-corruption campaign" spearheaded by bin Salman.

## Hezbollah, allies poised for win in Lebanese polls

#### Lebanese vote in first general election in nine years

Lebanon went to the polls on Sunday to elect MPs (Member of Parliament) for the first time in nine years, with voter turnout over 20 percent by early afternoon.

Sunday's vote sees 583 candidates compete for the 128 seats in parliament through 77 rival lists, spread across 15 districts. Under the terms of a new electoral law that introduced proportional representation, voters will be casting two votes; one for a list of candidates and one for a single preferred candidate.

Lebanon's parliamentary elections were delayed three times since 2009 due to the crisis in neighboring Syria as well as disagreement over the country's new electoral law.

In an interview with BBC Arabic TV on Saturday, President Michel Aoun underlined the importance of national unity and expressed hope that the new government would be formed soon. "I hope that a new government will be formed quickly and according to the constitution. But if national unity is not preserved, the majority will take over, and the rest will become the opposition," he said.

Hariri's Future alliance vs. Hezbollah and others

The current Lebanese parliament contains more than 20 different political parties. Its biggest party is the Future Movement (Tayyar Al-Mustaqbal), led by Prime Minister Saad Hariri. The next parties are President Michel Aoun's Free Patriotic Movement (Tayyar al-Watan/ al-Horr/Aounist party/at-Tayyar awne), Parliament Speaker Nabih Berri's Amal Movement (Hope Movement/Harakat Amal) and the Hezbollah resistance movement.

An anti-Hezbollah alliance led by Hariri and supported by the House of Saud regime won a majority in the Lebanese arliament in 2009, but it has since disintegrated.

Hariri stunned Lebanon and the world in November 2017 by announcing his resignation in a live television broadcast from Saudi Arabia. He accused the regional Iran and Hezbollah of sowing strife among Arab states, an allegation rejected by both sides.

Senior sources close to Hariri and top Lebanese officials

said Riyadh had coerced the Lebanese premier into stepping down and put him under house arrest.

Hariri, however, managed to get out of the kingdom amid international pressure on Riyadh and rescinded his resignation after returning home.

A recent document pointed to Saudi Arabia's "plot" to assert enormous influence on Lebanon's elections.

Analysts expect more than half the seats of the new Lebanese parliament to be won by Hezbollah and its allies. The resistance movement has played a critical role in the Syrian military's counter-terrorism operations over the past few years.

Under a power-sharing agreement that ended the 1975-1990 civil war in Lebanon, prime minister must be a Sunni Muslim, president a Maronite Christian and parliament speaker a Shia Muslim.

The current cabinet was announced in December 2016 after Aoun's election as president that ended a 29-monthlong political stalemate in the Middle Eastern country.

#### Gold can get to 5 year highs if it can clear one technical hurdle: Bank of America

Gold just ended its third straight week in the red, as investors rediscovered their love for a different safe-haven asset: the U.S. dollar.

The dollar index ended Friday at \$92.61 on Friday, its highest level of the year. The index has climbed by more than 1 percent in the past week. Meanwhile, gold prices are down 0.8 percent for the week, ending Friday at \$1,314.80 an ounce.

However, the yellow metal will find favor again, according to Bank of America Merrill Lynch technical strategist Paul Ciana, and a breakout could push it to recapture highs not seen in half a decade.

"Gold prices have been forming a six-year long base," Ciana told CNBC's "Futures Now" this week. "In the technical world we like to say, the bigger the base, the higher in



space. That's what gold is doing."

Gold prices need to break through the resistance level at \$1,350 to \$1,375, which would then confirm the six-year technical base and set up a larger rally, he said. Prices moved as high as \$1,369 in mid-April, but have failed to crack \$1,370 so far this year.

"As soon as this \$1,350 to \$1,375 area goes, which I do think it will later this year mostly when the dollar rally kind of tempers itself and neutralizes, that puts gold on the path to \$1,450 so plenty of room there," said Ciana.

Gold prices have not traded at \$1,450 an ounce since May 2013. The precious metal has been in a years-long downward trend, holding below \$1,400 since September 2013.

A rally in gold is part of the "bigger picture" of what's happening inside the commodity markets, Ciana continued. He sees a secular commodity bull market in formation.

"If we look at the CRB index, our monthly chart, which is essentially the rising tide of commodity markets, they just broke out ending April," Ciana explained. "They've closed just above \$200, confirming an ascending triangle base." (Source: CNBC)

#### Total risks losing gas field stake to CNPC if it quits Iran

Total SA, the only Western energy major investing in Iran, will lose its stake in the South Pars natural gas field to its Chinese partner if the Paris-based company withdraws from the country, the head of National Iranian Oil Co. said.

Total has spent \$90 million to help develop the offshore field and won't be compensated before production begins, Ali Kardor, managing director of state-run NIOC, said Sunday at a news conference in Tehran. Kardor didn't specify whether Total would receive any compensation if it pulled out of the project in Iran's section of the world's biggest gas deposit.

Total committed in July to develop phase 11 of the giant South Pars field, pledging \$1 billion in investment.

Total has a 50.1 percent stake in the 20-year South Pars project, with China National Petroleum Corp. holding 30 percent and Iran's Petropars, 19.9 percent. If Total withdraws, Iran will transfer the company's full stake to CNPC, based on the contract, Kardor said.

Iran has the world's largest gas reserves, estimated by BP Plc at 1,183 trillion cubic feet (33 trillion cubic meters), and is the third-biggest oil producer in the Organization of Petroleum Exporting Countries. #### **Bank of England to keep rates** steady after market U-turn

The Bank of England looks set to keep interest rates on ice this week, capping a sharp swing in the outlook for the British central bank, which might now struggle to convince investors that it will raise borrowing costs at all this year.

Unexpectedly weak economic data and cautious remarks from Governor Mark Carney have dashed what looked like near-certain expectations of a rate increase until a few weeks ago.

Since he joined the BoE in 2013, Carney has signaled several times that rates were likely to rise, only for economic data to go the wrong way.

With the prospects for Britain's economy unclear and the terms of Britain's departure from the European Union far from settled, Carney is likely to want to hedge his bets on Thursday.

The biggest challenge will be to keep the prospect of a further rate rise this

year credible in the eyes of investors, who feel wrong-footed by a slowdown in the economy that may well prove temporary and by the BoE's shifting guidance.

Sterling fell to its lowest since January against the U.S. dollar on Friday as markets priced diverging prospects for growth and interest rates on the two sides of the Atlantic.

"Resetting communication after sitting out a rate hike will be an uphill task for the Monetary Policy Committee," Barclays economists Fabrice Montagne and Sreekala Kochugovindan said in a note to clients.

"It will have to make a convincing case that softness in Q1... is transitory," they said. "Markets will likely be reluctant to adhere to the MPC's rhetoric given the abrupt change in course witnessed shortly ahead of the May meeting."

#### IMF says Egypt must deepen reforms to catch window of global growth

Egypt will have to deepen its IMF-backed reforms and better encourage private sector growth if it wants to cash in on a wave of global expansion that may soon come to an end, a fund official in Cairo said on Saturday.

Halfway into a three-year \$12 billion IMF loan program it signed in late-2016 tied to tough austerity measures, Egypt is hoping painful reforms like tax hikes and subsidy cuts will now lure back foreign investors and kick-start an economy that crashed after its 2011 Arab Spring uprising.

Speaking to government officials as part of an IMF visit to review Egypt's reform program, First Deputy Managing Director David Lipton praised the country's progress but said "broadening and deepening the reform agenda" is crucial to take advantage of ripe global conditions.

"But now the time has come to take advantage of the hard-won macroeconomic

stability and push on to create jobs and raise living standards through sustainable growth," Lipton said in a prepared statement provided to Reuters.

He described strong global growth, projected at 3.9 percent for 2018 and 2019, and low interest rates likely to rise as "a good window of opportunity for Egypt to undertake reforms...that may not be open for too long.<sup>\*</sup>

Cairo's tough reforms have included currency float that halved the value of its pound, deep cuts to fuel and electricity subsidies and a new value-added tax.

Those measures helped push inflation in the import-dependent country to as high as 33 percent last year, but price rises have since cooled, with headline inflation easing to 13.3 percent in March, its lowest rate since May 2016, clearing the way for further subsidy cuts and lower interest rates.

# Checkmate of Persian Gulf Sultanate in Iran's energy Peninsula Gas Production Capacity from South Pars Gas Field Stands at 800m bpd

Gas production capacity extracted from South Pars Gas Field (SPGF) stands at 800 million barrels per day (bpd).

South Pars or Northern Dome, which one of them is considered deservedly as the good name for Iran-Qatar joint gas field in the depth of the Persian Gulf?

South Pars Gas Field is located on a land area as large as 9,700 square kilometers, 3,700 square kilometers of which belongs to the Islamic Republic of Iran while the rest belongs to neighboring Qatar. With these interpretations, it is obvious that large portion of the field belongs to Qatar, the issue of which is a trump card at the hand of Qatar in terms of geographical and geopolitical dimensions.

Persian Gulf sultanates and sheikhs took advantage of salient advantages of this gas field and created a wide gap with its gas rival i.e. Iran in terms of extraction of more gas volume. From the beginning, Qatari side took advantage of high capabilities and potentials of international contractors and managed to get the lion's share of gas from the field.

Islamic Republic of Iran lagged behind and could not increase its gas volume extracted from the gas field as compared to Qatari side.

Under such circumstances, Iran's lucrative energy peninsula failed to compete with Qatar in this regard since Qatari side hired and employed competent international contractors to develop the region in its favor.

Such illogical and unwise behavior cost dearly for Iranian gas industry. As total gas extracted from South Pars Gas

As total gas extracted from South Pars Gas Field exceeded 2,000 billion cubic meters/day, Islamic Republic of Iran managed to extract only 1,000 billion cubic meters/day over the past years.

Total natural gas extraction volume from South Pars Gas Field since 2002 up to the end of 2015 stood at 879 billion cubic meter gas/day. Considering the production of over 130 billion



cubic meter of gas since the beginning of 2016, the total aggregated Iran's gas volume hit more than 1,000 billion cubic meter per day.

With commissioning 11 new phases over the past four years (from 2013 to 2016), Iran managed to produce more than 285 million cubic meter gas per day and with the production of 155 billion cubic meter gas in 2016, Iran managed to register a new record in this respect.

Lackluster performance of Iranian managers and directors coupled with international sanctions imposed against Iran in the past years caused Iran's share of South Pars Gas Field to reduce considerably. After a long hiatus, the 11th government dubbed "hope and prudence" rolled up its sleeves vehemently in order to regain the lost prestige of Iran in this gas field. After a short period, the Oil Ministry under its wise management could create fundamental changes in the macro development plans and consequently, the country managed to increase its gas output in South Pars Gas Field.

In the meantime, Iranian Oil Minister Bijan Namdar Zanganeh was duty bound to compensate \$25 billion worth of investment waste in 35 months. Accordingly, he prioritized the projects and required investment was made on phases one after another.

After prioritizing the projects, effective steps were taken to prevent gas and condensates from entering into the Persian Gulf sultanates.

For this purpose, Phase 12 of South Pars Gas Field was inaugurated, followed by the inauguration of phases 17, 18, 19, 20 and 21, so that all phases were put into operation in the last Iranian calendar year in 1396 (ended March 21, 2018).

As a result of operation of the first offshore platform in Phase 14, two gas sweetening in the phases from 13 to 22 and 24 and also a new production line, preliminaries were provided for surpassing Qatar in this field in 2018, so that a new record was registered in the production of sweet gas of Iran in south Pars Gas Field.

In the meantime, it is expected that gas extraction capacity of the country from this gas field will hit 800 million cubic meter per day with the continuation of remained phases including Phases 13, 14 and also Phases 22 and 24.

Share of Iranian Contractors from South Pars Gas Field Projects at \$30b

The country owes the development of most projects and phases in south Pars Gas Field to the round the clock activities and performance of domestic manufacturers and contractors.

Start of 2nd Phase of Prioritizing in Neighboring Gas Fields

It is obvious that gas is not merely considered as a commercial tool, rather, gas is used as important achievement in determination of type of diplomacy and foreign and domestic policies, like a powerful leverage.

For this purpose, Pars Oil and Gas Company has focused on providing suitable ground for the construction operation of phases in this field.

Accordingly, under the 6th Development Plan, it was stipulated that South Pars Gas Field should produce 770 million cubic meter gas per day in the production and operation sector, 850,000 barrels of gas condensate, 4,500 tons of sulfur, and annual production of 10 million tons of Liquefied Petroleum Gas (LPG) as well as eight million tons of ethane. With due observance to this statistics, if objective of increased production is materialized, it can compensate the shortfalls as observed in the previous years.

Regardless of the cases mentioned in above, if Pars Oil and Gas Company could materialize its promises given, we should wait hearing the good news of northern Pars gas field, Farza, Belal, Golshan and Ferdowsi gas fields.

Currently, all the aforementioned gas fields have concluded IPC (Iran Petroleum Contract) with the foreign companies.

He seized this opportunity to express his special thanks to the oil minister, industrious engineers and laborers of the company who managed to cope with the in 1396 (ended March 20, 2018) at about 98 percent, the issue of which indicates success of operation made by the company in the same period."

Sustainability of production and assurance of continuation of production process will be followed up strictly in the current Iranian calendar year, he said, adding, "moreover, the company will take giant stride in line with reducing environmental pollution."

Continuation of supporting domestic production in the short, mid and long term will be prioritized in the current year, he opined.

Turning to the environmental programs defined by the company in the current year, he said, "reducing gas burning will be followed up strictly by the company within the framework of gas sales projects to the private sector."

Of the other measures that will be taken in this regard, he pointed to the replacement of new parts and equipment with the old ones, he said, adding, "shortage of water resources was one of the pressing and major problems facing the country in the recent years."

To cope with water shortage problem facing the country, the company has devised necessary measures, one of which is the launch of first industrial wastewater unit in order to reuse the water, he opined.

National Iranian South Oilfields Company (NISOC) accounts for 80 percent share of oil production in the country in a way that



the company set up a new structure entitled "Engineering of Manufacturing Goods" Department.

In the same direction, domestic manufacturing of relevant parts and equipment started at the company, he said, adding, "in this period, about 10,000 parts and equipment have been manufactured in the country by the local expert engineers while construction and manufacturing of about 4,000 other parts and equipment is underway.

In response to a question on domestic manufacturing of these types of products

With due observance to the said issue, National Iranian South Oilfields Company (NISOC) has been tasked with manufacturing some of these products, he said, adding, "in the wake of setting up a strategic Working Group under the management of Deputy Research and Technology Affairs of the Ministry of Oil and membership of the Chief Executive of the National Iranian South Oilfields Company and selection of the company as a certain company, this company is responsible for presenting requirements, submitting technical documents and evaluation of manufacturers in the level of the Ministry of Oil in the groups of commodity of drilling drills (ROCK BIT & PDC), wellhead equipment (W/H & X-MASS), Sucker-Rod Pumping (SRP), dry turbine and masts. The feasibility study and technical specifications as well as manufacturing process of these important parts and equipment have been followed up strictly by the managers and experts of this company meticulously and enjoy relative good progress.

He referred to the construction of first gas-powered turbine manufactured jointly by the National Iranian South Oilfields Company (NISOC) and a knowledge-based company named "Middle East Machine Turbine Mfg. Company" and said, "fortunately, this turbine was installed at Marun Oil & Gas Company successfully." year in 1396 (ended March 20, 2018).

The first Iranian Rock Drill, used for drilling rocks, was manufactured by the company in cooperation with Academic Center for Education, Research and Cultural Activities, he said, adding, "manufacturing the drill was a giant step in the field of cutting dependency to importing such drill from overseas."

Imposition of sanctions by the US and Western countries prompted and forced Iranian parts manufacturers to roll up their sleeves vehemently in order to manufacture products inside the country, no need to import these products from overseas.

"We have the honor of cooperation with potential Iranian companies in manufacturing desalination packages in the country successfully."

Most parts and equipment such as various types of rotor and hot and cold blades of various types of gas turbines, safety valves (wellhead), various types of pipes and wellhead facilities are of the parts and equipment manufactured by the company in cooperation with other companies.

In response to a question on the most important problem facing domestic manufacturers in the field of manufacturing the monopolized parts and equipment of oil industry, he said, "the very parts manufacturers should respond to this question but in my opinion, the most important challenge in this respect is to make huge investment for the mass production. Unlike case manufacturing, mass production requires consumption market and guaranteeing the purchase of product."

What strategy can you define in this respect? Correction of rules and regulations governing the tenders, so that equal behavior should not be considered equally with the manufacturer or supplier of goods. The other strategy that should be taken into serious consideration here is to take the marketing especially in the international relationships both by manufacturers and government.

The first phase of desalination unit with the production capacity of 110,000 barrels of oil was commissioned in Feb. 2018. With the commissioning of this unit, necessary capacity is provided for the continuity of oil production with high quality from Ahvaz Asmari oilfield.

is needed than the existing capacity for processing oil. Therefore, for maintaining and retaining the production ceiling, a desalination unit was constructed with the production capacity of 55,000 barrels of oil in the vicinity of Bibihakimeh No. 1 Desalination Unit. Due to the reduced thickness of oil column of tank, produced wells are moving towards the salinity, so that produced flow rate will be stabilized with the construction of desalination facilities. Moreover, drilling new oil wells will not be required. Commissioning optimization project for processing oil in

environmental aspects, is the other salient specification of this project with the aim of preserving the oilfield and retaining production capacity, promoting quality of produced oil observing requirements of international standards.

Launching Haftkal and Naftsefid Desalination Unit with the daily production capacity of 45,000 barrels of oil (bpd) in the vicinity of Haftkal new desalination unit is of the other important project of the company which was launched in the past Iranian calendar year in 1396 (ended March 20, 2018).

This unit has been put into operation with the aim of processing saline oil as well as stabilization of flow rate produced. Installation of thermal furnaces and also installation of electrical desalination was launched with the aim of optimizing and increasing production capacity of desalination units from 1 to 4 of Ahvaz.

Renovating and rehabilitating and modernizing booster turbo pump number 7 of Ahvaz and rebuilding Ahation and manufacturing dented drills for drilling was manufactured in the country for the first time in cooperation with the Academic Center for Education, Research and Cultural Activities, the product of which is considered as highly consumed and strategic product in the oil industry. Localization of multistage processing pumps (BB3) for the first time in the country was launched by the National Iranian South Oilfields Company (NISOC). All stages ranging from the compilation of technical knowhow, casting and manufacturing these types of pumps are done inside the country in a way that the prototype of this pump was tested successfully, observing requirements of API 610 standard. Multistage centrifugal pumps have mostly been used in the oil industry, so that these types of pumps were manufactured in the country with the aim of preventing capital flight, generating new employment opportunities and supporting domestic industries.

Given the above issue, 42 million feet/ cubic meter as well as 42million feet/cubic meter gad were delegated to two domestic investment companies. # Footprint of Iranian Companies in Successful Development of Oilfields



The contract for the development of North Yaran Oilfield can be termed as one of the unique and unprecedented contracts in the country. To highlight the equality of this contract, knowing this issue seems enough that this contract is the first Buyback contract inked with an Iranian company, so that such a contract has not been concluded after that.

As the main Iranian contractor, Persia Oil and Gas Development Company, affiliated to TADBIR Energy Group, has been tasked with the development of this oilfield i.e. North Yaran Oilfield.

On the other hand, geographical situation of this oilfield had led to know this oilfield as Iran Oil Venice.

For his part, Arash Bagherzadeh the project commissioner of development of North Yaran Oilfield at Oil Engineering and Development Company (MATN) has emphasized to it and said, "positioning of the oilfield among Hoor al-Azim waters has made this project with difficulty environmentally and technically."

This oilfield i.e. North Yaran Oilfield has been defined among Iran Onshore Fields but in some cases, construction operation should be conducted in waters with 4- to 5-meter depth."

Significance and importance of this project will be doubled if we know that the concluded contract had been determined less than the ceiling. According to Seyyed Abbas Hosseini, supervisor of this project at Persia Oil and Gas Development Company said, "as a matter of fact, ceiling of contract of this project had been approved at \$665 million by the National Iranian Oil Company (NIOC)."

But with the talks that MATN Company conducted with Persian Oil and Gas Development Company, the contract was concluded with the amount of \$585 million, the issue of which brings about saving of \$80 million for the country."

But this currency saving is not terminated to this point. According to Bagherzadeh, in very close cooperation between employer of the project

and Persia Oil and Gas Development Company, other \$65 million in addition to \$80 million was saved and finally, the contract was completed with \$525 million and this issue should be taken into serious consideration.

On the other hand, Ali Amiri project manager of Persia Oil and Gas Industry Development Company said, "unlike foreign contractor, Iranian contractors did not embark on receiving \bounce' award for the activities of the company.

According to him, although necessary license had been received for interim drying of some part of Hoor al-Azim in the initial contract, this company prevented from doing such activity due to the environmental issues and employer's request in the 11<sup>th</sup> government dubbed 'hope and prudence'.

Also, production of two wells was taken into consideration for the early production program, so that their produced oil was dispatched to Azadegan Oilfield as a result of special pipeline but at the time of implementation of pipeline, three other wells were added to this pipeline with the agreement of contractor. All the above- mentioned factors along with 72% share of Iranian manufacturers led to the brilliance of competent Iranian engineers and experts as well as differentiation of this project from other oil projects in Iran.

# Foreign policy failure: America has not learned from its wars

It's time for the Washington foreign-policy establishment to consider the seemingly unthinkable: perpetual foreign-military operations and occupations do not enhance American national security and economic prosperity

Overwhelming evidence - currently on painful display in Syria, Afghanistan and Yemen — reveals the stark reality that these operations drain the American nation of critical resources, produces a slow-bleed of U.S. troops, and deteriorates our ability to respond to potentially existential battles in the future. Changes must be urgently made if we are to reverse this negative condition.

After the catalyzing and emotionally power-

ful attacks that struck America on 9/11, a succession of U.S. presidents and senior officials have settled into the belief that the only way to handle difficult international problems is to use lethal military force.

This tendency has become so deeply ingrained that even the consideration of using nonlethal means to address tough problems is almost reflexively dismissed as appeasement.

Instead, the troops have remained and numerous officials in the White House and Pentagon have been searching for other jobs the troops can accomplish. Rather than strategy driving troop deployments, Washington fiercely resists bringing any troops home, almost irrespective of the lack of need; once a mission has begun, the mission itself becomes the objective. The operation in Yemen is a case in point.

#### America's vital interests

Yet despite this obvious failure and absence of any American vital national interests at play, the Pentagon has lobbied hard to ensure the mission continues without restriction and select members of Congress have blocked efforts to end America's involvement. A bipartisan ground of senators tried to force a vote to end support of the mission last month, but the measure was defeated 55-44. Today, the war continues without purpose or resolution.

Yet America's military involvement there has no set of metrics it seeks to accomplish and thus no criteria the accomplishment of which could ever signal an end to the mission.

The unsuccessful mission in Afghanistan costs American taxpayers about \$45 billion a year. Last year, fifteen Americans were killed in Afghanistan and many more wounded. In 2019, the United States is expected to spend \$16 billion on the mission in Svria: to date, four Americans have been killed in Syria. Those two missions alone will cost taxpayers more than \$60 billion and some unknown number of American lives.

It is time to take a hard, critical, and

unemotional look at U.S. foreign policy in the post-9/11 era and admit that the routine and near-permanent use of lethal military power abroad has not made us safer, continues to squander billions that could be better used in other ways, and needlessly sacrifices the lives of our service members

For the sake of our national security and economic prosperity, we must stop the re-flexive use of lethal military power abroad in an attempt to solve problems and rediscover that sometimes other instruments of national power are better suited to achieve positive outcomes for the nation.

# Stoke relegated as West Brom Houdini act continues

LONDON (Reuters) — Stoke City's 10year stay in the Premier League ended on Saturday following a 2-1 home defeat by Crystal Palace in a dramatic penultimate round of matches.

Yet never-say-die West Bromwich Albion kept their hopes alive of pulling off one of the great escapes with a lastgasp 1-0 win over top-four aristocrats Tottenham Hotspur.

West Brom took their wholly unlikely unbeaten run under caretaker manager Darren Moore to five matches with a stoppage-time winner from Jake Livermore.

Then the Baggies enjoyed yet another incredible reprieve when a Southampton victory at Everton in the late game, which would have confirmed their relegation, was prevented by a 96th minute equalizer for the home side in a 1-1 draw.

Though Southampton were left fuming that the goal had been scored after the allotted four minutes of added time, the point still moved the Saints out of the drop zone on goal difference ahead of Swansea City, who lost 1-0 at Bournemouth.

It leaves the battle for survival in the final week even more fascinating, with Swansea hosting Southampton in a critical match on Tuesday.

West Brom jumped on to 31 points, leapfrogging doomed Stoke on 30, with both sides having one game left in the final week while Southampton and Swansea are both on 33 with two games left.

At the other end of the table, Tottenham's defeat left them fourth on 71 points and gave Chelsea new hope that they might steal the fourth Champions league spot if they can move onto 69 points by beating Liverpool at Stamford Bridge on Sunday.

Burnley fans were left celebrating too as Everton's draw ensured the seventh-placed Clarets will be playing in the Europa League next season, the first time they have been in European competition



since the 1966-67 Inter-Cities Fairs Cup. The day began with Stoke's faint hopes

were briefly revived in the early kickoff as Xherdan Shaqiri's deflected free kick just before halftime put them ahead against Palace.

Yet Roy Hodgson's resurgent side, dominant after the break as Stoke were gripped by nervy caution, equalized after a sharp counter-attack through James McArthur before a Ryan Shawcross mistake let in Patrick van Aanholt for the 86th-minute winner.

Despite overseeing a 13-match winless streak, Stoke's worst run in a top-tier season for 34 years, manager Paul Lambert saluted the effort of his players.

"This club has to bounce right back up," he said. "The club is too big not to. It will regroup and it's got the right infra-structure in place to do it."

Albion's revival is beggaring belief, even if their chances of the most miraculous survival are still minimal.

Their relegation after weeks of defying

the prophets of doom seemed assured as the game against Spurs went into added time but Livermore forced the ball over the line from close range in a manic finish.

Less than three hours later, it seemed their heroics could be all in vain as Nathan Redmond's header for Southampton at Goodison put the Saints, who later had Maya Yoshida sent off, in sight of the three points that would condemn Albion.

Yet though referee Jon Moss had added on only four minutes, there were just over 95 minutes on the clock when Tom Davies' strike deflected in off Wesley Hoedt.

"I am the one up here but it is we as a football club — the supporters, staff and officials — and through hard work and commitment that the results are coming," said Albion's folk hero Moore.

Both Bournemouth, who beat Swansea with a Ryan Fraser goal, and Crystal Palace ensured their safety for another season and West Ham United look set to join them after a deserved 2-0 victory at Leicester City.

# Iran's Sareh Javanmardi achieves double

**SPORTS TEHRAN** — Sareh Javanmardi from Iran claimed a gold medal at the 2018 World Shooting Para Sport Championships.

The crowd began clapping in unison as the remaining two shooters fired their final shots. Amid the intense atmosphere, Sareh Javanmardi was telling herself that she would win – and she did.

Javanmardi defended her title in the P2 (women's 10m air pistol SH1), as day three of the 2018 World Shooting Para Sport Championships finished on Sunday in Cheongju, South Korea. It was one of two individual medal events held on this day.

"In the last shot series, it was so stressful," Javanmardi told Paralympic.org. "But I was sure that I would be the gold medallist. And I think in these situations it is the god that helps the people and me.<sup>3</sup>

Through the finals, Javanmardi was chasing Ukraine's silver medal finisher Iryna Liakhu. Olivera Nakovska-Bikova, from the former Yugoslav Republic of Macedonia, won bronze.

It did not help that Javanmardi received a one-point deduction for a penalty. That left her fighting from behind, and only until the penultimate shot series was she able to hit a near-perfect 10.8 to take the lead.

"This was the first time in 10 years that I am a shooter [to get a penalty] and at first yes, it was a serious fall for me, but I tried to manage everything," Javanmardi said. "This was the first time, and the last time that I ever do such a thing again.

Javanmardi repeated her success from the last World Championships in 2014 held in Suhl, Germany. There, she secured a slot for the Rio 2016 Paralympic Games – where she won the P2 Paralympic title. Sunday's victory brought back old feelings.

"Of course this is not the first time that I have had such a great and very pleasant feeling," she said. "This medal is for a Paralympic slot [for Tokyo 2020]."

#### Ali Karimi on the verge of leaving Sepidrood Rasht



**S P O R T S TEHRAN** – Ali Karimi is on the brink of parting company with Iranian football club Sepidrood Rasht.

The ex-Bayern Munich and Persepolis midfielder was appointed as coach of the Iranian top-flight football team in January and saved the struggling team from relegation.

Debutants Sepidrood finished in 13th place last season six points above the Iranian Professional League relegation zone. Iranian media reports suggest that Se-

pidrood club owners and Karimi have not

reached an agreement to continue their cooperation.

According to IRNA, Karimi has two years remaining on his contract but he has accepted to bring an end to his career in the Rasht-based football club.

On 25 September 2014, Karimi was named as the assistant coach by Carlos Queiroz in the Iranian national team, however, he stepped down from his role shortly before the 2015 AFC Asian Cup.

He was later appointed as Naft Tehran coach in June 2017 but resigned in September.

Abu Dhabi: Al Jazira will play their first AFC Champions League knockout stage match since 2014 when they host 2017 semi-finalists Persepolis in the first leg of the Round of 16 at Mohammed bin Zayed Stadium on Monday.

The Emirati side ended a 15-game winless run in the continental competition in February and went on to finish runners-up in Group A with strikers Ali Mabkhout and Romarinho netting eight of their nine goals between them.

Al Jazira's domestic form has been poor of late as they ended their UAE Pro League season with a 4-1 defeat to Al Wahda. Since beating Al Gharafa in the group stage in early April, the Abu Dhabi side have lost four of the past



#### five matches.

Persepolis wrapped up their second successive Iranian Pro League title some time ago and have been in fine form on the continent too, beating Al Sadd three weeks ago to finish top of Group C having won four of their six games.

Indeed, the Tehran side have not conceded on the continent since a Matchday Two defeat to Al Sadd and boast the meanest defence in the competition. Captain and key defender Jalal Hosseini, though, is suspended for the Mondav's clash.

Ferguson won a total of 49 trophies during his illustrious managerial career, which also included spells at St Mirren and Aberdeen. The Scotsman led United to an impressive 38 trophies during his nearly 27-year reign at the club.

Real Madrid forward and five-times Ballon d'Or winner Cristiano Ronaldo kickstarted his career at United under Ferguson from 2003 to 2009.

"My thoughts and prayers are with you, my dear friend. Be strong, Boss!" the Portugal captain said on social media as he shared a picture of him and Ferguson during their time together at Old Trafford.

Beckham was part of the famous "Fergie's Fledglings" group, along with Ryan Giggs, Paul Scholes, Nicky Butt and brothers Gary and Phil Neville, that led United to numerous trophies from the mid-1990s, including the

historic 1999 treble.

"Keep fighting Boss. Sending prayers and love to (Ferguson's wife) Cathy and the whole family," Beckham said on Instagram with a picture of him signing his United youth

contract as Ferguson stood by his side.

Many current and former United players, including Michael Carrick, Rio Ferdinand, Diego Forlan and David de Gea also offered messages of support as did United's Premier

League rivals Manchester City, Arsenal, Chelsea, Tottenham Hotspur and Liverpool.

"The thoughts of everyone at LFC are with Sir Alex Ferguson and his family... a great rival but also a great friend who supported this club during its most difficult time, it is hoped that Sir Alex will make a full recovery,' Liverpool said in a statement.

Ferguson and his family also received well wishes from clubs all around the world.

Italian sides AC Milan and Inter Milan, Spanish champions Barcelona and Scottish champions Celtic were among a host of clubs to support the Scotsman.

Soccer greats, managers, fans, politicians and news outlets sent messages of support as did athletes and governing bodies from other sports, including the National Basketball Association (NBA).

"Sir Alex I'm praying you get through this, you've won everything in life any player or manager dreams of, I as a friend am stunned..., England great Paul Gascoigne said.

## Marquez wins in Spain and takes MotoGP lead

JEREZ, Spain (Reuters) - Marc Marquez won his home Spanish Grand Prix and took the overall MotoGP lead on Sunday after the reigning champion's main rivals collided spectacularly.

The Honda rider was in a race of his own for the last eight laps after the Ducati pairing of Andrea Dovizioso, the previous championship leader, and Jorge Lorenzo collided with Honda's Dani Pedrosa while fighting for second place.

Pedrosa, who had wrist surgery less than a month ago, was thrown high over his bike after trying to go past the two Ducatis on the inside.

Lorenzo came across into the corner as Dovizioso went

wide, colliding with Pedrosa and sending the two Ducatis into the gravel. All three riders walked away from the crash.

French Tech3 Yamaha rider Johann Zarco was gifted the runner-up slot, 5.241 seconds behind, and is now Marquez's

"I found it very exciting," Lloyd Webber said Thursday. "I loved the score. I hope that does well." The six-time Tony winner said he's seen all the shows on Broadway: "It's an intriguing season."

Lloyd Webber himself is part of the latest Tonys mix. He and actress Chita Rivera each will receive 2018 awards for Lifetime Achievement.

Lloyd Webber was at the Hollywood Pantages theater this week to promote the Los Angeles premiere of his Broadway and London hit "School of Rock - The Musical", based on the 2003 movie that starred Jack Black as a down-and-out musician who stumbles into a gig as a prep-school teacher.

Lloyd Webber said he originally only planned to produce the project, but found the show's pop-rock sensibility so appealing that he ended up as the show's composer.

As for his next show, Lloyd Webber seemed eager to discuss it – but just can't. He said its fate is currently in the hands of higher powers - in this case, rights holders.

It's the same story with one of his passion projects: a film version of his musical adaptation of the 1950 film-noir classic "Sunset Boulevard." Paramount first announced it was in the works, way back in 2005.

"The situation with 'Boulevard' is that I don't control it," Lloyd Webber said. "Glenn Close desperately wants to make it, as I do. But we haven't had a green-light from the studio."

Lloyd Webber, who turned 70 in March, has written a recently published autobiography that ends with "Phantom" and covers the first part of his life.

to adherents as the "Big Book", sold at auction Saturday for \$2.4 million to billionaire and Indianapolis Colts owner Jim Irsay.

The auction house Profiles in History announced the sale of the manuscript with handwritten notes from the group's founding fathers

Irsay told The Associated Press he plans to build a special display for the manuscript and display it for several months a year at Alcoholics Anonymous' headquarters in New York. He says he attempted to buy the manuscript when it was up for auction several years ago, and he is thrilled at the opportunity to share it publicly.

Irsay said he considers himself a steward for the manuscript, which he said he may also send out on tour so it can be seen by more people.

"I've held it. I've looked through it. It is absolutely mind-blowing," he said. "It was just a miracle to see this thing live.'

Irsay, who was clearly excited about obtaining the manuscript during a telephone interview, said he considered remaining anonymous about purchasing the manuscript, but wanted to go public to try to relieve the stigma of alcoholism and addiction.

"The only way we stay sober is to give it away," Irsay said.

"I think it'll help a lot of people," he said. "That's the reason I'm doing it."

He said he attended his first Alcoholics Anonymous meeting 25 years ago, and marvels at the reach of the organization and what its founders built.

It is the third time the 161-page typed document has been sold. It sold in 2007 for \$850,000 and for \$1.6 million in 2004. Saturday's auction was delayed by a dispute with Alcoholics Anonymous World Services, Inc.

The manuscript includes notes and

scribbles from one of AA's founders, William Wilson, more commonly known as "Bill W."

Wilson's widow Lois owned the papers after his death in 1971, and she passed them on to her friend Barry Leach. Alcoholics Anonymous said Leach signed and notarized a letter in 1979 saying the manuscript would belong to the organization after his death. He died in 1985, but the manuscript did not make its way to Alcoholics Anonymous, which did not know about the notarized letter at the time.

Its ownership history in the ensuing years is not entirely clear until 2004, when Sotheby's auctioned it for \$1.6 million. Then it sold to Roberts in 2007.

A website devoted to the auction describes the manuscript as a "Bible to millions" that has sold 30 million copies since 1939, been translated into 43 languages and has been ranked by the Library of Congress as a top non-fiction book that shaped America.

"We are thrilled this most historic manuscript has sold and hope it will be exhibited for the world to see the manuscript that has saved the lives of millions of people, Profiles in History founder Joe Maddalena said.
