# WB sees the impact of U.S. sanctions on Iran 'wane' in 2020-21

**TEHRAN** — The World Bank (WB) in its latest world economic outlook report "Global Economic Prospects", predicts a 0.9 percent growth of gross domestic product (GDP) for Iran in 2020, indicating that the impact of the U.S. sanctions will ease in the mentioned year.

The bank predicts a -4.5 percent growth for the country' GDP in 2019 but expects it to experience one percent of GDP growth in 2021. "In Iran, the impact of U.S. sanc-

# U.S. grants Iraq new Iran sanctions waiver: source

(AFP) — The United States has granted Iraq another 90-day waiver to continue with vital energy imports from neighboring Iran despite re-imposed sanctions, a government source said Saturday.

The extension came after "long discussions" with Washington ahead of a looming deadline on a previous extension granted in December, the official, close to the negotiations, told AFP on condition of anonymity.

The talks came amid spiking tensions between Iraq's two closest allies -- the U.S. and Iran -- following a twin attack on tankers in the Persian Gulf that U.S. President Donald Trump has blamed on Tehran.  $\rightarrow 2$

TEHRAN — Referring to hasty US accusations against Iran after the suspicious attacks on oil tankers in Oman Sea, Qatar University research assistant says international community is reluctant to accept US hypothesis aiming to boost its military presence in the Middle East.

#### Ship insurance costs soar after Middle East tanker attacks

**TEHRAN** — Insurance costs for ships sailing through the Middle East have increased by at least 10% after attacks on two tankers in the Gulf of Oman on Thursday, with the potential for costs to rise further as regional tensions escalate, ship insurers said.

The attacks have already stoked concerns about reduced flows of crude oil on one of the world's key shipping routes, pushing up oil prices by as much as 4.5%. Reuters reported.

Some tanker companies have already sus-

pended new bookings to the Persian Gulf.

Freight rates for supertankers transporting oil from the Persian Gulf to Asia were already close to a two-month high on Thursday at nearly \$13,000 a day, up nearly \$2,000 from Wednesday.

Every ship needs various forms of insurance, including annual war-risk cover as well as an additional 'breach' premium when entering high-risk areas. These separate premiums are calculated according to the value of the ship, or hull, for a seven-day period.

Ship insurers say the biggest vessels sailing through the Persian Gulf area face additional costs of up to \$200,000 for a single seven-day voyage, roughly twice as expensive as earlier this week.

The facts on the ground have changed. If any of those tankers sink, you will see a rise across the board in the annual war premiums," one underwriter said.

"This is not the first incident, and what we are seeing (with rates going up) reflects the worsening situation in the area."  $\rightarrow$  13

#### **Tehran lashes out at UAE for** attack on Zarif

**POLITICAL TEHRAN** – Tehran has responded to the UAE e s k for making remarks against Foreign Minister Mohammad Javad Zarif.

UAE Minister of State for Foreign Affairs Anwar Gargash claimed in a tweet on Friday that Zarif's reference to the so-called B-Team "becomes more farcical and his credibility diminishing," Press TV reported.

Responding to Gargash's tweet, Iran's Foreign Ministry spokesman Abbas Mousavi said countries that lack "credibility and independence" and serve as "milk cows" for the U.S. are in no position to raise doubts about the Iranian officials' credibility.

Zarif had tweeted that U.S. allegations against Iran over the Thursday attacks on two oil tankers in the Sea of Oman were part of "sabotage diplomacy" adopted by the "B-Team" to cover up "economic terrorism" against Tehran.

Zarif has coined the phrase "B-Team" to refer to U.S. national security adviser John Bolton and three other hawkish officials in the region, including Abu Dhabi Crown Prince Mohammed bin Zayed Al Nahyan who are trying to drag Donald Trump into an armed conflict with Iran.

The UAE and Saudi Arabia are the major arms importers from the United States

A report in May said Trump was approving the sale of billions of dollars' worth of weapons to Saudi Arabia, citing Iranian threats to its arch rival to reap the sweet fruit of his weeks-long fierce anti-Iran propaganda where he has claimed increasing threat from Iran to the interests of America and allies in the Middle East.

Before his presidency, Trump had described Saudi Arabia as "a milk cow" which would be slaughtered when its milk ran out.

In September 2018, Trump said he had told Saudi King Salman bin Abdulaziz Al Saud that Riyadh had "trillions of dollars" and could pay its military bills.

"I love Saudi Arabia. They are great, King Salman, I spoke with him this morning. I said, king, you have got trillions of dollars. Without us, who knows what's going to happen. .... With us they are totally safe," Trump said then.

In October 2018, the U.S. president warned King Salman that he would not last in power "for two weeks" without the U.S. military support.

In August, Trump emphasized that he would like to keep Saudi Arabia as a close partner because of the Riyadh regime's extravagant purchases from American companies.

"They [Saudis] have nothing but cash, right?" he told a rally in Wisconsin. "They buy a lot from us, \$450 billion they bought."

#### **UK Labor leader says no** 'credible evidence' of Iran role in tanker attacks

**POLITICAL TEHRAN** – The UK Labor Party leader has called on the government to abstain from escalating tensions with Iran without "credible evidence" that Tehran was responsible for attacks on two oil tankers in the Gulf of Oman.

Jeremy Corbyn said Britain risked increasing the threat of war after the Foreign Office said it was "almost certain" in its assessment that "a branch of the Iranian military ... attacked the two tankers on 13 June", the Guardian reported on Saturday.

The foreign minister, Mohammad Javad Zarif, had said earlier that the U.S. "immediately jumped to make allegations against Iran without a shred of factual or circumstantial evidence".

Corbyn tweeted: "Britain should act to ease tensions in the (Persian) Gulf, not fuel a military escalation that began with U.S. withdrawal from the Iran nuclear agreement.

"Without credible evidence about the tanker attacks, the government's rhetoric will only increase the threat of war.' On Friday, Donald Trump told Fox News that Iran "did do it".

The price of oil rose sharply on Thursday amid fears of disruption to one of the world's most important tanker routes.

The suspected attacks came after four commercial ships were "subjected to sabotage operations" in the Persian Gulf in May.

# **Cooperation with neighbors is** Iran's fixed principle: Rouhani

**TEHRAN** – President Hassan Rouhani said on Saturday that cooperation with neighboring countries is a fixed principle of Iran's foreign policy.

Rouhani made the remarks during a meeting with Qatari Emir Sheikh Tamim bin Hamad Al Thani on the sidelines of the CICA summit in Dushanbe, Tajikistan, which brought Asian leaders together.

"Bilateral and multilateral consultation and more cooperation are the only ways to reduce differences and solve problems in the region and Iran is always ready to contribute to this," Rouhani stated. Rouhani said, "The stability and security of regional

countries are intertwined and we want spirit of moderation, brotherhood and wisdom in relations among the countries. He also said called for unity among Muslim states.

The president also described Iran-Qatar relations as "friendly" and "brotherly" and said the ties benefit the whole region.

For his part, Sheikh Tamim said Doha is ready to expand relations with Tehran in various areas.

He said problems in the region can be solved through dialogue, collective cooperation and political ways.

The amity between Tehran and Doha has been increasing since Iran opened its arms to Qatar when Saudi Arabia, the United Arab Emirates and Bahrain closed their land, sea and air to the country in June 2017.

'Iran interested in expanding ties with Turkey' Rouhani also met separately with Turkish President Recep Tayyip Erdogan during which he said Iran is interested in expanding ties with Turkey.

Rouhani noted that the value of annual trade ties between the two countries should increase to 30 billion dollars. Erdogan also said his country attaches great importance

The Iranian and Tajik people share close cultural and historical affinities. They speak a common language, Persian. Rahmon also said developing ties with Iran is the "will of the Tajik government".

"I am sure that, in view of the two governments' will, bilateral ties will be strengthened in line with meeting interests of Tehran and Dushanbe and reinforcing regional security and stability," Rahmon stated.

# Iran cannot stick to nuclear deal unilaterally: Rouhani President says Iran has acted as a 'powerful barrier' against Takfiri terrorism

Hassan Rouhani said on Saturday that Iran cannot unilaterally remain committed to the 2015 nuclear deal, known officially as the Joint Comprehensive Plan of Action.

"It is obvious that Iran cannot unilaterally remain committed to the JCPOA, and it is necessary that the other countries contribute to the survival of this important agreement, he said during a speech at the Conference on Interaction and Confidence-Building Measures in Asia (CICA) in Dushanbe, Tajikistan. Rouhani also said that Iran has acted as

a powerful barrier against Takfiri terrorism. Following is the text of his speech published by the presidential website:

Undoubtedly, holding the CICA Summit in Dushanbe provides a perfect opportunity for consultation and discussion, given the current situation in the region and the wide range of topics, opportunities, challenges and threats.

Now, Asia, which enjoys the legacy of great civilizations and huge achievements in the field of reasoning and interaction, is facing a huge challenge. From the easternmost parts of Asia to its westernmost regions, there has been cultural interaction and commerce for hundreds of years through the Silk Road on the earth and the sea, in a way that even today, this valuable experience can be the basis of better and more

**POLITICAL TEHRAN** – President innocent people who have been grappling with war and its resulting disasters, fighting unilateralism by which a country tries to dominate others with material power and the use of force, explicit opposition to the production of any weapons of mass destruction from nuclear to chemical, and ultimately, constructive interaction with all countries that believe in these values.

It is on this basis that the Islamic Republic of Iran, as a key player in the region, has repeatedly expressed its willingness to draft and approve bilateral and multilateral political and security mechanisms to ensure peace and security, and has welcomed any interaction and exchange of opinions with CICA member states on ways to approach the challenges and cope with existing threats.

The interference of some foreign powers in the internal affairs of the countries of the Middle East region, forceful unilateral policies, terrorism and extremism, their blatant breach of promises and lawlessness in matters related to international peace and security, including the important nuclear deal with Iran, known as the Joint Comprehensive Plan of Action (JCPOA), have made our region one of the world's most instable regions.

Regarding the JCPOA, I would like to remind you that the full compliance of Iran to its obligations has repeatedly been approved by the IAEA and, despite the withdrawal of the United States, the resumption of its unilateral, illegal sanctions and the negligible support of the other parties to the agreement, we still believe that the fulfilment of the agreed-upon commitments by all relevant parties will play an important role in increasing regional and global stability. It is obvious that Iran cannot unilaterally remain committed to the JCPOA, and it is necessary that the other countries contribute to the survival of this important agreement. Now that our utmost goodwill and strategic tolerance on the one hand, and the United States' lawlessness on the other hand have

been proved to everyone, the Islamic Republic of Iran, while announcing its readiness for any interaction, has decided to reduce its obligations under Paragraphs 26 and 36 of the JCPOA to restore balance. In case of the absence of proper response, we will inevitably have to take more measures.

We are all aware of the role of the current U.S. government's policies in destabilizing the countries of the region. The current situation in Palestine, Iraq, Syria, Afghanistan, and Yemen are clear examples of the consequences of this policy in recent years. These policies have violate the right of self-determination as one of the fundamental rights of all nations in many countries of the region.

Palestine's longstanding problem remains the most important factor of insecurity and the spread of violence in the region and the world. The international community's indifference to the Israeli regime's illegitimate actions, the illegal move to move the U.S. Embassy to the Holy Quds, and supporting the annexation of the Golan Heights to the Zionist Regime have led to the continuation of expansionist policies and has caused reaching a comprehensive and fair solution to this crisis to become more far-fetched than the past. The international community must fulfil its duty to uphold the rights of the Palestinian people, including the formation of an independent Palestinian state with the Holy Quds as its capital. The just settlement of the Palestinian issue and the rights of the Palestinians is a key to the return of stability and sustainable security and economic development of the Southwest Asian region. The Islamic Republic of Iran has acted as a powerful barrier against Takfiri terrorism in Syria and Iraq, and has prevented the spread of terrorism to other parts of the world, and has played a worthwhile role in bringing peace and stability to the region and the world. Furthermore, since the beginning of the foreign invasion on Yemen,

we have been calling for the cessation of the operation of foreign forces by promoting a comprehensive Yemeni-Yemeni dialogue, and we believe that any further delay in the implementation of this initiative will lead to further life and financial losses.

Due to the sensitivity of the current situation and the necessity of confronting unilateralism, it is worthwhile for us to adopt wise policies for strengthening the process of multilateralism and developing new fields in political-security, economic and commercial cooperation, independent of the unilateralist approaches of some countries, and expanding our partnerships and engaging in inter-regional cooperation with other geographic areas to deepen our relations and combat unilateralism.

As a country at the junction of North-South and East-West corridors with strong industrial and technological infrastructure, educated work force and huge opportunities in the fields of energy, mining, tourism and transit, we welcome the presence and activities of businesspersons and companies of this conference's member states in Iran. In addition, Iran's traders, industrial companies and exporters of engineering and technical services are ready to participate in the development projects of the member states. The pursuit of the policy of active regionalism, including the creation of common markets for trade, energy and

In this context, we consider cooperation with the countries of the region and the use of the mechanism of multilateral dialogue in the form of CICA summits extremely useful, necessary and effective.

# Everyone is concerned about fate of nuclear deal, Putin says

Russian President Vladimir Putin said on Saturday that everyone is concerned about the fate the 2015 nuclear deal, officially called the Joint Comprehensive Plan of Action.

Addressing the Conference on Interaction and Confidence-Building Measures in Asia (CICA) in Dushanbe, Tajikistan, Putin said, "The United States' withdrawal from the agreement has significantly impeded its implementation, and has had a negative effect on the overall situation in nuclear non-proliferation.'

We believe that the only reasonable solution is for all signatories to continue honoring their commitments under the Plan, and this is what Russia is set to do," he said.

On May 8, Iran announced a partial withdrawal from some aspects of the pact, saying that the country would no longer adhere to some of the limits on its nuclear activities.



It also threatened to step up uranium enrichment if an agreement is not made within 60 days to shield it from

the sanctions' effects.

Under the JCPOA, Iran agreed to put caps on its nuclear work in exchange for termination of economic and financial sanctions. However, Trump unilaterally pulled Washington out of the nuclear deal in May 2018 and ordered reimposition of sanctions against Iran. The first round of sanctions went into force on August 6 and the second round, which targets Iran's oil exports and banks, were snapped back on November 4.

Also, on April 22 the U.S. announced that Washington has decided not to extend waivers allowing major importers to continue buying oil from Iran. The waivers ended on May 2.

Putin and Chinese President Xi Jinping issued a statement on June 7 denouncing the unilateral sanctions imposed by the U.S. against Iran.

# Raeisi calls on people, elites to help Judiciary improve

**POLITICAL TEHRAN** — Judiciary d e s k Chief Ebrahim Raeisi has called on the people and the elite to give feedback on judicial processes in order to help improve the performance of the body under his leadership

In a letter on Saturday, Raeisi underscored the role of public opinion in improving the efficiency of the country's bureaucracy due to their access to different means of communication including the internet, the Tasnim news agency reported.

He said such public feedback could help the Judiciary become a "popular, revolutionary and anti-corruption" body.

The top judge said he will be making more calls for public comments on ways to initiate,

amend, or complete certain legal processes approaches, regulations and bylaws.

Raeisi also warned the country's decision-makers not to make a miscalculation by ruining the opportunity for direct contact with the people through the internet, echoing remarks by Leader of the Islamic Revolution Ayatollah Ali Khamenei that the invaluable opportunity provided by the cyber space should be seized.

In a decree in March, Ayatollah Khamenei appointed Raeisi as the new head of the Judiciary. He was national attorney general and served as the chief custodian of Astan Quds Razavi, the organization managing the affairs of the Holy Shrine of Imam Reza (AS), the eighth Shiite Imam.



# Israel responsible for oil tanker attacks: ex-diplomat


On Thursday morning, two commercial oil tankers were hit in the Gulf of Oman, prompting the evacuation and rescue of dozens of crew members.

The United States has blamed Iran for the attacks. In an interview with Iran Online, Asefi said Israel benefits the most from such accusations against Iran, hence "logically

"I was surprised when the Foreign Ministry said the attack was suspicious, because there's nothing suspicious about it and it's clear," he stated.

Soon after the attacks, U.S. Secretary of State Mike Pompeo appeared in the State Department Briefing Room to significantly raise the stakes.


"It is the assessment of the United States government that the Islamic Republic of Iran is responsible for the attacks that occurred in the Gulf of Oman today," Pompeo said.

He cited intelligence, weapons used, the required expertise and sophistication of the assault and previous attacks to conclude it was the latest assault by Iran on "freedom-loving nations."

Asefi rejected Pompeo's rash decision to accuse Iran, arguing that it is not rational to think Iran would benefit

Ghani made the remarks in a meeting with President Hassan Rouhani on the sidelines of the SCO Summit in Bishkek on Friday. He highlighted Iran's status and role in the region, saying Kabul is after promoting collaboration with Iran in all fields,

IRNA reported. "We favor Iran's bigger role in the Afghanistan peace talks

and the issue of drugs is among the issues which should be pursued within the framework of bilateral and international talks," Ghani said.

Tehran and Kabul should join hands to fight terrorism, drugs, and extremism, the Afghani president asserted.

President Ghani also said, "We will never allow Afghan territory to be used against Iran."

# U.S. allies balk at blaming Iran for tanker attack

A day after two oil tankers were attacked in the Gulf of Oman, some U.S. allies were reluctant to join the Trump administration in blaming Iran for the incident as conflicting accounts emerged, the Foreign Policy said on Friday.

U.S. President Donald Trump's administration was quick to blame Iran for the Thursday attacks, which targeted a Norwegian-owned and a Japanese-owned vessel carrying petroleum products in the strategic chokepoint through which much of the world's oil travels. The U.S. Defense Department released black-and-white video footage purportedly demonstrating that Iran is behind the attack, but some of the United States' allies have held back from explicitly blaming Iran—including Japan and Norway. For its part, the Iranian government denied the U.S. accusations that it was involved.

U.S. Central Command took the unusual step of releasing footage of the incident, which it says shows Iranian special forces removing an unexploded mine from the side of one of the oil tankers damaged in the incident, a few hours after the attack. The Japanese owner of one of the tankers contradicted the account put forth by the U.S. military, saying the vessel was struck by a flying projectile and not a mine or torpedo, adding further confusion.

After the UK government conducted its own assessment, British Foreign Secretary Jeremy Hunt on Friday backed up Centcom's account, saying in a statement that the Islamic Revolutionary Guard Corps (IRGC) was "almost certainly" behind the attacks from the 2015 nuclear accord with Iran, haven't gone as far and appear to be treading carefully around a potentially explosive diplomatic standoff between Washington and Tehran. German Foreign Minister Heiko Maas said the video evidence isn't sufficient by itself. "The video is not enough. We can understand what is being shown, sure, but to make a final assessment, this is not enough for me," he told reporters

on a visit to Oslo, Norway. Some U.S. allies may not "want to be seen as bandwagoning with a U.S. administration that may be seen as a loose cannon on this," said Michael Eisenstadt, an expert on the region at the Washington Institute for Near East Policy, a think tank. "They're going to want to wait until their intelligence agencies get from the American intelligence community our assessments and forensics," he said. "They'll want to have their own intelligence people look at the ships before they arrive at their own judgment."

The conflicting reports of the attacks are stirring further unrest in a region already beset by tensions as the Trump administration ratchets up pressure on Iran through severe sanctions and diplomatic maneuvering. Trump in April designated Iran's elite branch of its armed forces, the IRGC, as a terrorist organization, and Iranian President Hassan Rouhani hit back by declaring all U.S. troops in the Middle East terrorists. The latest attacks also come after the White House hit Tehran with additional sanctions as part of a so-called maximum pressure campaign to squeeze the country and sent a fresh deployment of U.S. forces to the region to deter what the administration called "credible" threats from Iran and its proxies against U.S. troops. Iranian Foreign Minister Mohammad

Javad Zarif condemned U.S. accusations that Iran was behind the incident, saying they were made without "a shred of factual or circumstantial evidence."

Zarif even went so far as to insinuate the incident was a setup, tweeting, "Suspicious doesn't begin to describe what likely transpired." The attacks occurred while Japanese Prime Minister Shinzo Abe was meeting with Iran's Supreme Leader Ali Khamenei for talks, in part to try to open a dialogue between Tehran and Trump.

On Friday, Zarif rebuffed Pompeo's allegations that Iran was to blame, saying they were part of the "sabotage diplomacy" pushed by the "B-Team".

The B-Team is a reference to hawkish U.S. national security adviser John Bolton, Israeli Prime Minister Benjamin Netanyahu, Saudi Crown Prince Mohammed bin Salman and Abu Dhabi Crown Prince Mohammed bin Zayed Al Nahyan.

Iranian Foreign Ministry spokesman Abbas Mousavi also asked, "While Japan's prime minister is meeting with the number one figure of the Islamic Republic of Iran to reduce tensions, which clandestine hands seek to undermine these efforts in the region and who benefit from it?"

Jeremy Corbyn, Britain's Labor Party leader, has warned against blaming Iran for the tanker attack without "credible evidence", the Independent reported.

Writing on his social media account, Corbyn said, "Britain should act to ease tensions in the (Persian) Gulf, not fuel a military escalation that began with U.S. withdrawal from

Also, Russia on Thursday warned against rushing to attribute blame for suspected attack on oil tankers, saying the incident should not be used to stoke tensions with Tehran, Russia's state-run RIA news agency reported.

"I would take the opportunity to warn against hasty conclusions, against attempts to lay the blame at the door of those we don't like," the agency quoted Russian Deputy Foreign Minister Sergei Ryabkov as saying.

"Lately we have been seeing a strengthening campaign of political, psychological and military pressure on Iran. We wouldn't want the events that have just happened, which are tragic and shook the world oil market, to be used speculatively to further aggravate the situation in an anti-Iranian sense," Ryabkov was quoted as saying.

#### INSTEX remains on paper, Larijani says

**POLITICAL TEHRAN** — Majlis Speaker Ali Larijani on Saturday criticized the role of France in salvaging the 2015 nuclear accord, saying the European banking mechanism has remained "on the paper" and has not been made operational.

"Despite various talks, the French president's promise to the Iranian president for preserving Barjam (nuclear deal) has not been met and it should be actually said that the INSTEX mechanism has remained on the paper," Larijani told Marielle de Sarnez, the head of France's parliamentary foreign affairs committee.

European countries established INSTEX in January to help shield trade with Iran from U.S. sanctions imposed after President Donald Trump withdrew from the multinational nuclear deal in May 2018.

On March 20, Iran's central bank governor Abdolnaser Hemmati announced that a mechanism similar to INSTEX has been registered in Iran, officially called the Special Trade and Finance Institute (STFI).

#### **Guardian Council says ready** to hold electronic elections

**POLITICAL TEHRAN** — The Guardian Council is prepared to hold electronic elections, its spokesman Abbasali Kadkhodaei said on Saturday.

"To the extent that the Interior Ministry is ready and the facilities and security of election are provided, we are ready to hold electronic elections," Kadkhodaei told the Mehr news

# UN chief urges independent inquiry into oil tanker attacks

**POLITICAL** description de terres, the secretary-general of the United Nations, has urged an independent probe into Thursday's attacks on two oil tankers in the Sea of Oman.

The UN chief in a Friday statement underlined the need for an investigation to establish the facts about the attacks and noted that only the Security Council could order a UN inquiry.

He added, "It's very important to know the truth and it's very important that responsibilities are clarified. Obviously that can only be done if there is an independent entity that verifies those facts."

The Japanese-owned Kokuka Courageous and Norwegian-owned Front Altair oil tankers were struck by explosions near the strategic Strait of Hormuz waterway in the early hours of Thursday.

They were hit while sailing in the Sea of Oman after leaving ports in Saudi Arabia and the United Arab Emirates.

Japan's government said both vessels were carrying "Japanese-related" cargo. The attacks came as Japanese Prime Minister Shinzo Abe was meeting with Leader of the Islamic Revolution Ayatollah Seyyed Ali Khamenei in Tehran.

The cause of the attack is not yet known, but the Japanese shipping company has said two "flying objects" attacked its tanker in the Oman Sea, contradicting the U.S. account that mines had hit the vessels.

A few hours after Thursday's attacks, U.S. Secretary of State Mike Pompeo offhandedly blamed Iran for the attacks without providing evidence. U.S. President Donald Trump also claimed that the incident had Iran "written all over it"

The accusation was further echoed by British Foreign Secretary Jeremy Hunt, who blamed Iran and Iran's Islamic



Revolution Guards Corps (IRGC) for the attacks.

On Thursday, the U.S. Central Command (CENTCOM) released a grainy footage purportedly showing "an IRGC Gashti Class patrol boat ... removing [an] unexploded limpet mine" from the side of the Japanese ship following the blasts.

Iran was the first country to respond to a distress call and rush to the assistance of the oil tankers, transferring all their 44 crew members to its southern shores.

"The American government has turned into a serious threat to the stability of the region and the world over the past two years through misusing its economic, financial and military capacities," Iran's President Hassan Rouhani said on Friday.

Foreign Minister Mohammad Javad Zarif also tweeted

that the U.S. had "immediately jumped to make allegations against Iran without a shred of factual or circumstantial evidence."

He said the U.S. allegations against Iran over the tanker attacks were part of "sabotage diplomacy" adopted by the so-called B-Team.

The B-Team refers to U.S. national security adviser John Bolton, Abu Dhabi Crown Prince Mohammed bin Zayed Al Nahyan, Israeli Prime Minister Benjamin Netanyahu and Saudi Crown Prince Mohammed bin Salman.

Iran also warned the U.S. to stop playing a blame game through "suspicious" attacks on oil tankers in the Middle East, describing the American behavior as "worrying".

On Thursday, Iran's deputy ambassador to the UN, Es'haq Al-e Habib, brushed aside the U.S. claims that Tehran was responsible for the attacks in the Sea of Oman.

"Strongly we are rejecting any accusation of Iran," he said. "Definitely, those that accuse Iran have the main role in creating those incidents and it could be the United States itself."

In an indirect reference to Israel and Saudi Arabia, the Iranian diplomat noted that the two regimes "are looking for more tensions" in the Persian Gulf region and that Washington is a staunch backer of them.

The incident in the Sea of Oman "happened at the same, exactly at the same time that the prime minister of Japan was in Iran and meeting our leaders, and it shows that these are orders that are behind this incident, and the previous one," he added.

Oil prices jumped as much as 4 percent following Thursday's incident.

The blasts came a month after mysterious attacks on four oil tankers -- an Emirati, a Norwegian and two Saudi vessels -- off the coast of Fujairah in the UAE on May 12.

**POLITICAL TEHRAN** — The Iranian embassy in Afghanistan has rejected as "untrue" and "inauthentic" an accusation leveled by U.S. Secretary of State Mike Pompeo against Iran over an explosion in Kabul.

In a statement issued on Friday, the embassy said the Islamic Republic denounces terrorist attacks anywhere in the world, IRNA reported.

Addressing a press conference on Thursday, Pompeo blamed Iran for the car bomb attack near the main gate of Marshal Fahim Military University in Kabul on May 31.

"On May 31st, a car bomb in Afghanistan wounded four U.S. service members, killed four Afghan civilians, and wounded bystanders," Pompeo stated, accusing Iran of being behind the attack.

The Iranian embassy reiterated that Iran has announced its readiness for cooperation with regional governments, especially the Afghan government, to fight such measures.

The U.S. is leveling such baseless accusations while Iran has been working for peace, stability and security in the neighboring state and proved that it will never intend to bring its disputes with certain countries into the Afghan soil.

Afghan national security advisor Hamdullah Mohib recently declared in an interview with one of the country's TV networks that Iran is keen on establishing peace and calm in Afghanistan.

#### **Global economy on leading** edge of recession

Global trade flows are flat or falling in all major regions as the world economy flirts with recession for the first time since 2008/09-which will cut growth in oil consumption, especially for mid-distillates such as diesel

According to gulfbusiness.com, freight volumes handled through major ports such as Long Beach and Singapore as well as air cargo handled through hubs such as Hong Kong, Memphis, London and Frankfurt are either flat or down compared with 2018.

Hong Kong International Airport, the largest air freight hub in the world, has seen volumes fall more than 5 percent in the three months from March to May compared with a year earlier.

London's Heathrow reports cargo down 4.5 percent between March and May compared with a year earlier, the worst performance since 2013.

Germany's Frankfurt has seen volumes fall almost 3 percent, while at Tennessee's Memphis International volumes were down almost 1 per cent, in both cases year-on-year between February and April.

Air freight is used only for the most valuable and time-sensitive merchandise but is generally a good leading indicator for the rest of the cargo sector and the broader economy. Seaborne container volumes through California's Long Beach, the

largest terminal for trans-Pacific trade, fell by 10 percent in March-May compared with a year earlier, the worst performance since 2015/16.

Container volumes through Singapore were up 1 percent between March and May compared with a year earlier, but growth has slowed from 16 percent in the first quarter of 2018.

Forward-looking freight indicators suggest the slowdown is likely to continue for the rest of the year and could turn into an outright recession

Global manufacturers report new export orders have been falling for nine months and are now declining at the fastest rate since 2015/16, according to the JPMorgan global purchasing managers' index.

South Korea's KOSPI-100 equity index, a good proxy for global trade growth given its heavy exposure to exports, was down almost 15 percent at the end of May compared with a year earlier.

The World Trade Organization's trade outlook indicator has fallen to its lowest since 2010, signaling a continued deceleration in trade volume growth.

In March, the OECD's composite leading indicator of economic activity in the advanced economies and major emerging markets fell to its lowest level since the recession of 2008/09.

The U.S. economy in recession

Since 1970, whenever the OECD indicator has fallen this low, the U.S. economy has always entered a recession, and taken the other advanced industrial economies with it.

# Annual crude steel output to hit 30m tons by March 2020

Zarandi further pointed to development of non-oil exports as one of the major seven plans of the ministry under the sanctions time and said, "Given the difficulty in international transactions, we put development of non-oil exports specially to the neighboring countries a top agenda of our work in the current year.

The official also mentioned promotion of domestic production, development of mining sector, benefiting from knowledgebased companies, market management, and improvement of business environment as some other priorities of the ministry in the current year.

In mid-April, Iranian industry, mining



and trade minister said the country plans to double its exports to the neighboring countries by the Iranian calendar year of 1400 (which starts in March 2021).

Mentioning the fact that only two percent of the total imports of Iran's neighbors comes from the Islamic country, Rahmani noted that his ministry is going to focus on developing domestic production and defining new projects to manufacture all the industrial equipment needed inside the country

The official further pointed to some of the potent areas which could be worked on in order to increase exports including home appliances, apparel industry, petrochemicals, and marine industries, basic metals such as steel, aluminum and copper as well as agriculture.

#### WB sees the impact of U.S. sanctions on Iran 'wane' in 2020-21

 $1 \rightarrow$  Growth is projected to gradually rise to 2.8 percent by 2021, predicated on continued benign global financing conditions, as well as a modest recoverv in emerging market and developing economies (EMDEs) previously affected by financial market pressure.

As for the Middle East region, growth is projected to fall to 1.3 percent in 2019 and to pick up to about 3 percent in 2020-21.

"The projected pickup over the next two years is largely driven by an assumed rebound in activity in Iran as the impact of recent U.S. sanctions wanes,' the report said.

In its previous report, WB predicted a 1.1 percent GDP growth for Iran in

2020 and 2021.

The bank saw a -3.6 percent growth for the country' GDP in 2019 but expected it to experience 1.1 percent of GDP growth in the following two years.

Global economic growth was also projected to slow to 2.9 percent in 2019 from a downwardly revised 3 percent in 2018 amid rising downside risks.

#### U.S., Japan exchange candid views on trade

Japan and the United States have deepened their understanding of each other's positions on trade, Japan's economy minister said after meeting his U.S. counterpart, adding that the two countries will likely meet again a head of a Group of 20 (G-20) summit later this month.

After Thursday's meeting in Washington, Mr. Toshimitsu Motegi said he exchanged views on trade "candidly" with U.S. Trade Representative Robert Lighthizer, but refrained from commenting on details.

"Japan and the U.S. have been sorting out points of discussion over trade issues and those points are clarifying but we need to continue ministerial talks," Mr. Motegi said. Motegi said Japan and the U.S. have already agreed to aim for an early trade deal after Japan's Upper House election, likely to be held next month.

Trade issues are seen as among key topics of debate during U.S. President Donald Trump's expected meeting with Japanese Prime Minister Shinzo Abe on the sidelines of the G-20 summit in Osaka, western Japan, on June 28-29.

President (Donald Trump) would have preferred to have seen something done last vear. Let me be clear ... we're way behind schedule from this standpoint.

Trump has pressured Tokyo to speed up talks for a two-way trade deal that would open up the Japanese market for US goods, particularly in areas of agriculture, and fix what he sees as a huge bilateral trade imbalance.

In an interview with The Japan Times, U.S. Ambassador to Japan William Hagerty said Trump was "frustrated" by the fact that the U.S. and Japan have yet to seal a trade deal.

Japan's ruling party officials have signalled their hopes of holding off on signing a deal that could require concessions on agriculture at least until the summer Upper House election, for fear of losing farmers' votes.

Responding to a journalist's question. Motegi said Japan has been requesting that Washington cut its tariffs on industrial products.

E N E R G Y TEHRAN – National Irae s k nian Oil Company (NIOC) will offer two million barrels of heavy crude oil at Iran Energy Exchange (IRENEX) on Tuesday, Shana reported.

The base price for this round of offering, which is the third round, is \$59.59 per barrel. Iran's biggest gas storage center launched

**ENERGY TEHRAN** – Iran's biggest gas storage k center was inaugurated in an official ceremony in Khorasan Razavi Province in northeastern Iran on Friday, Shana reported.

The opening ceremony was attended by directors of the National Iranian Oil Company (NIOC) and Central Oilfields Company, as well as the Khorasan Razavi officials.

Located at the Khangiran gas field, the storage center is aimed at storing 10 million cubic meters of natural gas during the hot season.

The nearly \$23-million project included the construc-

tion of a gas storage facility, electricity boards, control and emergency shutdown systems, production and reproduction pipelines, and connecting injection pipelines to the center.

Discovered in 1967, the Khangiran gas field is the only source of hydrocarbons in the east and northeast of the country, and about 95 percent of its production gas is sour gas. It began production in 1980 and produces natural gas

and condensates. The total proven reserves of the Khangiran gas field are around 17 trillion cubic feet and production is slated to be around 600 million cubic feet per day.



# France launches 480 megawatt Saint-Nazaire offshore wind farm

The French government has this week reaffirmed its commitment to wind energy, announcing winners of its third onshore wind energy auction in which it awarded 516 megawatts (MW) of capacity, only days before it finally launched the long-awaited development of the 480 MW Saint-Nazaire offshore wind farm.

According to cleantechnica.com, on Wednesday, France's Ministry for the Ecological and Inclusive Transition announced winners from its third onshore wind tender, awarding a total of 516 MW to 21 projects across the country. The average weighted price from the tender was €63 a megawatt-hour (MWh), down from €65.4/MWh and €68.7/MWh recorded in the previous two auctions.

The "development of onshore wind energy is a pillar of France's energy and climate strategy and a key lever for decarbonizing energy production and achieving the goal of zero net greenhouse gas emissions by 2050," said François de Rugy, Minister of State, Minister



for Ecological Transition and Solidarity. "I am delighted to once again support the development of the sector through the selection of 21 new projects that will make it possible to install 150 new wind turbines on the territory.'

Included in the winning tender recipients was Canadian renewables developer Boralex, who revealed on Wednesday that it had been awarded three projects totaling 68.2 MW-the 25.2 MW Bois des Fontaines wind project, the 20 MW Helfaut wind project, and the 23 MW Caumont Chériennes.

#### Wind energy a viable solution

"Wind energy as an economically and technically viable solution in the French energy transition is unquestionable and this third tender period is further proof of this," said Nicolas Wolff, Vice-President and General Manager of Boralex Europe. "We believe that France is - and will remain - a major market for thedevelopment of our renewable energy projects, which are structuring and promising for the country's economy.

"With the launch of the Saint-Nazaire park project today, France is finally entering the age of offshore wind turbines," declared François de Rugy. "By 2022, 80 wind turbines installed off Saint-Nazaire will provide 20% of the electricity of Loire-Atlantique. It's a first in France.

"But we do not stop there, we accelerate," de Rugy continued. "Today, we are also initiating the Dunkerque park project, at a rate comparable to the best European results,

which demonstrates the competitiveness of the French sector. Tomorrow, we will launch and award larger projects: 1 GW per year, compared to 750 MW originally planned in the Multi-Year Energy Program, by working with all the territories.'

France already has several projects intended to contribute towards its new gigawatt-target, and three tenders for commercial floating wind farms on the horizon. Specifically, a tender for a 250 MW floating offshore wind farm will soon be launched, to be developed south of Brittany in 2021, and two further 250 MW tenders will be launched in the Mediterranean in the Occitanie and PACA regions.

Development of the 480 MW Saint-Naziare offshore wind farm will be conducted by a consortium composed of EDF Renouvelables, Innogy, and Enbridge. The news comes only days after the final legal restrictions were dismissed in court, allowing development to continue.

#### **Argentina LNG exports** positioned to meet peak demand in Asia

Rising natural gas production in Argentina, coupled with competitive global LNG transportation costs, is expected to position the country as an emerging source of gas supply to Asia during peak demand periods, according to new research from Wood Mackenzie.

As said by hellenicshippingnews.com, global LNG demand is showing increasing seasonality, and peak potential LNG production in Argentina during the summer months coincides with strong winter demand from utilities in Asia. This seasonal dynamic could attract Asian buyers and present a strong economic case for Argentinian LNG.

In addition, Argentinian LNG liquefaction plants have lower

shipping costs to reach Asian markets than U.S. Gulf Coast facilities, avoiding potential Panama Canal congestions and presenting an overall cheaper alternative to U.S. exports. Supported by the Vaca

Muerta, Argentina's production in the Neuquén basin will ramp up over the next few years, with major scale LNG production expected to begin in 2024. Based on the new research, Wood Mackenzie anticipates that LNG production volumes could potentially reach 6 million tons per annum (mmtpa)



in that year, which could then grow to 10 mmtpa by 2030.

Associated gas from Vaca Muerta will also represent 15% of Argentina gas production by 2024, and other projects in the condensate and dry gas window with break-even below \$3 per million British thermal units (mmbtu) will enter into full development in the upcoming years.

#### Lack of natural gas storage

A lack of underground natural gas storage facilities close to demand centers in Argentina means that gas flow to potential LNG export terminals will also be seasonal.

Despite other price challenges posed by the seasonal utilization of LNG plants, Wood Mackenzie estimates a break-even for Argentina LNG of \$8/mmbtu at delivery ex. ship for Japan.

Mauro Chavez Rodriguez, principal analyst, Latin America Gas & LNG, said: "Vaca Muerta's gas production has dramatically changed the outlook for Argentinian gas. It is already bringing cheap gas for local industry and also supporting the construction of new major gas pipelines.

"Nevertheless, not even the domestic demand and exports to neighboring countries such as Chile and Brazil are enough for Vaca Muerta's gas potential. LNG exports could be a solution that enables Vaca Muerta's production to continue the growth story.

"Argentina's LNG could be interesting to players who want to diversify supply outside North America. The seasonality of its output could be also seen as a virtue for Asian utilities that are looking to contract just for their peaking demand months in the northern hemisphere.

Some Asian players are already active in the Argentinian shale. Petronas is participating with YPF in the joint venture of La Amarga Chica, while CNOOC participates indirectly through its subsidiary, Pan American Energy, in the Aguada Pichana Oeste. Meanwhile, Qatar Petroleum recently has shown interest in Argentina, buying a stake of ExxonMobil's business unit in that country, and also partnering for exploration offshore.

'We see further opportunities for Asian players looking for foreign investment, not only in upstream but also for major midstream infrastructure, such as gas processing plants, pipelines, have petrochemicals, and LNG export plants.

## Gazprom Neft calls for end of OPEC+ oil cuts

OPEC and its partners should start increasing oil production to keep the market well supplied and prices reasonable, Gazprom Neft's chairman Alexander Dyukov said, as quoted by eliminated.

These remarks are in tune with some made earlier this month by Russia's President Vladimir Putin, who told media that Russia is comfortable with lower oil prices than Saudi Arabia. They are also in tune with a comment by Rosneft's Igor Sechin, who said the cuts affected Russian companies' market share in favor of U.S. producers.

## Oil tanker attacks raise fear of surge in global energy prices

#### By Jillian Ambrose

The attack on two oil tankers in the Gulf of Oman has escalated tensions between the U.S. and Iran and raised fears of a surge in global energy prices.

Concerns over a spike in prices center on Tehran's potential to close the strait of Hormuz, the narrow shipping lane between Iran and Oman and the world's most strategically important oil route.

Some ship owners have already taken matters into their own hands after Thursday's oil tanker attack, the second in as many months, by barring their oil-laden vessels from moving through the strait.

The owners are seeking safety assurances, and are understood to be in talks to secure a naval escort for their cargoes through the waterway, through which almost a third of the world's oil shipping passes.

One senior London-based ship broker said a number of tankers in the area are unwilling to move without these assurances.

"They are very concerned. Think of the volume of traffic which goes through the strait every day. A naval escort for each laden tanker would take time. Most charters are taking a step back to assess what measures could be taken," he said.

Trump plays down Iran's strait closure Donald Trump played down fears Iran might close off the strait. The U.S. president told Fox News on Friday that if it did happen "it's not going to be closed for long".

Paolo d'Amico, the chair of the tanker trade group Intertank, said the industry is extremely worried. "We need to remember that some 30% of the world's crude oil passes through the strait. If the waters are becoming unsafe, the supply to the entire western world could be at risk," he said.

Around 18 million barrels of oil are forecast to travel through the straits every day in 2020. This is more than half the 29.8 million barrels produced by members of the OPEC oil cartel.

It is also a major avenue for Qatar's liquefied natural gas (LNG) exports, or roughly 30% of the global LNG trade. UK gas supplies would not be affected by a short-term closure of the strait.

One London-based gas trader confirmed that no UK-bound tanks were en route through the straits at the time of the attack. Europe also has plenty of gas reserves after a mild winter, which should mean most of Qatar's shipments will head east to buyers in Asia.

A long-term closure or restriction of traffic, however, would undoubtedly lead to higher gas prices and an economic boom for exporters in the U.S. and Russia, he said.

The oil price climbed by a relatively modest 4% to \$62.64 a barrel after the attacks in the Gulf of Oman, which is the gateway to the Strait of Hormuz for inbound vessels, but experts say a prolonged hiatus could trigger record oil prices and reignite the risk of a global recession.

"We're talking hundreds of dollars," said Chris

Midgley, the head of analytics at the oil market specialists S&P Global Platts.

#### Global commodity prices

"This would have a dramatic effect on the whole economy, right down to consumer spending. Every major recession we have seen has been preceded by a ramping up of global commodity prices ... this would raise a huge recessionary risk." he said.

Midgley said he expected diplomatic efforts to see off the risk of a complete closure, but that the world was nonetheless closer than it has ever been to an energy chokehold.

"In the days when the U.S. had a huge dependence on energy from the Middle East it had a huge military presence in the area to ensure that the straits would remain open. What is different today is that the U.S. has its energy independence. This is a significant change," he said.

The U.S. shale revolution means the former energy importer will become a net exporter of oil for the first time this year.

A global escalation in oil and gas prices could provide an economic boom for the country, but Trump is likely to weigh the benefit against the impact on consumer energy bills.

The "U.S. still has a strong incentive to defuse the situation, and China – which relies heavily on energy imports - will also be motivated to step in," Midgley said. A "shutdown of the straits would be the ultimate 'nuclear' option for Iran."

#### Kushner as a colonial administrator: let's talk about the 'Israeli Model'

**ANTIWAR** — In a TV interview on June 2, on the news docuseries "Axios" on the HBO channel, Jared Kushner opened up regarding many issues, in which his "Deal of the Century" was a prime focus.

The major revelation made by Kushner, President Donald Trump's adviser and son-in-law, was least surprising. Kushner believes that Palestinians are not capable of governing themselves.

Not surprising, because Kushner thinks he is capable of arranging the future of the Palestinian people without the inclusion of the Palestinian leadership. He has been pushing his so-called "Deal of the Century" relentlessly, while including in his various meets and conferences countries such as Poland, Brazil and Croatia, but not Palestine.

Indeed, this is what transpired at the Warsaw conference on "peace and security" in the Middle East. The same charade, also led by Kushner, is expected to be rebooted in Bahrain on June 25.

Much has been said about the subtle racism in Kushner's words, reeking with the stench of old colonial discourses where the natives were seen as lesser, incapable of rational thinking beings who needed the civilized "whites" of the western hemisphere to help them cope with their backwardness and inherent incompetence.

Kushner, whose credentials are merely based on his familial connections to Trump and family friendship with Israeli Prime Minister, Benjamin Netanyahu, is now poised to be the colonial administrator of old, making and enforcing the law while the hapless natives have no other option but to either accommodate or receive their due punishment.

This is not an exaggeration. In fact, according to leaked information concerning Kushner's "Deal of the Century," and published in the Israeli daily newspaper, "Israel Hayom", if Palestinian groups refuse to accept the US-Israeli diktats, "the US will cancel all financial support to the Palestinians and ensure that no country transfers funds to them."

In the HBO interview, Kushner offered the Palestinians a lifeline. They could be considered capable of governing themselves should they manage to achieve the following: "a fair judicial system ... freedom of the press, freedom of expression, tolerance for all religions."

The fact that Palestine is an occupied country, subject in every possible way to Israel's military law, and that Israel has never been held accountable for its 52-year occupation seems to be of no relevance whatsoever, as far as Kushner is concerned.

On the contrary, the subtext in all of what Kushner has said in the interview is that Israel is the antithesis to the unquestionable Palestinian failure. Unlike Palestine, Israel needs to do little to demonstrate its ability to be a worthy peace partner.

While the term "US bias towards Israel" is as old as the state of Israel itself, what is hardly discussed is the specific of that bias, the decidedly condescending, patronizing and, often, racist view that US political classes have of Palestinians – and all Arabs and Muslims, for that matter; and the utter infatuation with Israel, which is often cited as a model for democracy, judicial transparency and successful "anti-terror" tactics.

According to Kushner a "fair judicial system" is a conditio sine qua non to determine a country's ability to govern itself. But is Israeli judicial system "fair" and "democratic"?

Israel does not have a single judicial system, but two. This duality has, in fact, defined Israeli courts from the very inception of Israel in 1948. This de facto apartheid system openly differentiates between Jews and Arabs, a fact that is true in both civil and criminal law.

"Criminal law is applied separately and unequally in the West Bank, based on nationality alone (Israeli versus Palestinian), inventively weaving its way around the contours of international law in order to preserve and develop its "(illegal Jewish) settlement enterprise"," Israeli scholar, Emily Omer-Man, explained in her essay "Separate and Unequal".

In practice, Palestinians and Israelis who commit the exact same crime will be judged according to two different systems, with two different procedures: "The settler will be processed according to the Israeli Penal Code (while) the Palestinian will be processed according to military order. This unfairness is constituent of a massively unjust judicial apparatus that has defined the Israeli legal system from the onset. Take the measure of administrative detention as an example. Palestinians can be held without trial and without any stated legal justification. Tens of thousands of Palestinians have been subjected to this undemocratic "law" and hundreds of them are currently held in Israeli jails. It is ironic that Kushner raised the issue of freedom of the press, in particular, as Israel is being derided for its dismal record in that regard. Israel has reportedly committed 811 violations against Palestinian journalists since the start of the "March of Return" in Gaza in March 2018. Controversial poll in the United States Yesterday saw an important poll in the United States. ABC News on Friday published the results of an internal poll conducted by President Donald Trump's reelection campaign in March, a survey that Trump himself denied even existed. Data from President Donald Trump's first internal reelection campaign poll conducted in March, obtained exclusively by ABC News, showed him losing a matchup by wide margins to former Vice President Joe Biden in key battleground states. Trump has repeatedly denied that such data exists.

The polling data, revealed for the first time by ABC News, showed a double-digit lead for Biden in Pennsylvania 55-39 and Wisconsin 51-41 and had Biden leading by seven points in Florida. In Texas, a Republican stronghold, the numbers showed the president only leading by two points.ABC News did not obtain the poll's early matchups against other candidates. The New York Times was first to report the existence of the internal polls. When presented by ABC News with these numbers, the Trump campaign confirmed the data saying in a statement that the numbers were old and that they have seen huge swings in Trump's favor.

"These leaked numbers are ancient, in campaign terms, from months-old polling that began in March before two major events had occurred: the release of the summary of the Mueller report exonerating the President, and the beginning of the Democrat candidates defining themselves with their far-left policy message," Trump campaign manager Brad Parscale told ABC News in a statement. "Since then, we have seen huge swings in the President's favor across the 17 states we have polled, based on the policies now espoused by the Democrats. For example, the plan to provide free health care to illegal immigrants results in an 18-point swing toward President Trump." Attorney General Bill Barr's summary of special counsel Robert Mueller investigation into Russian meddling in the 2016 election was released on March 24. While the Trump campaign's full poll, which canvassed 17 states,

was already in the field, it was well underway for four additional days after the release of Barr's letter to the public. The poll was conducted from March 15 through March 28.

The Trump campaign did not provide the results of the full 17 state poll, matchups against other candidates nor any updated polling figures.Mueller's report did not find a conspiracy between Trump's campaign and the Russian government. The special counsel did not reach a conclusion about whether the president obstructed justice, and specifically did not exonerate him on that front.

Earlier in the week, the Trump campaign referenced "new data" that they claimed showed the president has a "lead in every state" they polled, according to a statement provided to ABC News by Trump campaign communications director Tim Murtaugh. The campaign is claiming the new poll "tested the issues the Democrat field is running on" and produced a more favorable result for the president in head to head match-ups against 2020 Democrats when tied to issues like providing free healthcare to illegal immigrants.

Early polls are often subject to change, but it's notable that the new poll the campaign is now touting tested "issues" tied to 2020 opponents — meaning the Democratic candidates were politically defined by the campaign. "The President is correct that we have no current polls against defined Democrats – at all – that show him losing in any of the states we have tested. For example, the President leads in Florida by 8 points. He holds leads in all other states we have polled," Parscale's statement said. "Again, these months-old numbers are meaningless because they are pre-Mueller and pre-Democrat messaging, and should not be given any weight when discussing the current state of the race."

In the recent days the president has continued to lash out against reports that his campaign's internal polling showed him trailing in key battleground states, slamming the numbers as "phony polling information." Trump has called his internal poll numbers "unbelievable" and that he was "the strongest I've ever been."

Speaking with ABC News Chief Anchor George Stephanopoulos on Tuesday during an exclusive interview, the president said his internal polling showed that he is "winning everywhere."When Stephanopoulos mentioned reports of polls commissioned by the Trump campaign that showed Biden ahead of him in key states, the president said "those polls don't exist." you want to know the truth, you just run a campaign and whatever it is, it is, but I just had a meeting with somebody that's a pollster and I'm winning everywhere, so I don't know

what you're talking about." A day later, the president took to Twitter and again claimed internal polling showing him behind in battleground states didn't exist. "The Fake (Corrupt) News Media said they had a leak into polling done by my campaign which, by the way, and despite the phony and never-ending Witch Hunt, are the best numbers WE have ever had. They reported Fake numbers that they made up & don't even exist," the president tweeted.

What is certain is that Trump will not have an easy path to win the upcoming presidential election. Public opposition to the policies of Donald Trump, the controversial president of the United States, is still on the rise. Polls conducted in the United States indicate that many of the American citizens who voted for Donald Trump in the 2016 presidential elections, are now regretting their choice.

Biden, Warren, Sanders Lead 2020 Field Monmouth University Polling Institute reported that Former Vice President Joe Biden is the front-runner among likely Democratic caucusgoers in Nevada while Massachusetts Sen. Elizabeth Warren takes second place, just ahead of Vermont Sen. Bernie Sanders. The first Monmouth University Poll of Silver State Democrats in the 2020 cycle finds that Warren has a particularly positive rating in Nevada compared to her standing elsewhere. Health care tops the list of concerns for Democratic voters, but the poll finds that immigration is more of a factor for choosing a nominee in Nevada than it is in other early states.

In a field of 24 candidates, Biden holds a clear lead with 36% support among registered Democrats and unaffiliated voters who are likely to attend the February 2020 Nevada caucuses. He is followed by Warren at 19%, Sanders at 13%, South Bend Mayor Pete Buttigieg at 7%, and California Sen. Kamala Harris at 6%. Other candidates registering at least 1% in the poll are former Texas Rep. Beto O'Rourke (2%), New Jersey Sen. Cory Booker (2%), entrepreneur Andrew Yang at 8%, and Harris at 5% among this group. Among very liberal voters, though, the contest is between Warren (27%) and Sanders (26%), with Biden garnering just 19% along with Harris at 7% and Buttigieg at 7%. Very liberal voters make up about one-quarter of likely caucusgoers.

About 1-in-5 voters (21%) say 2020 will be the first Democratic caucus they participate in. Among these first time caucusgoers, nearly half (48%) prefer Biden, with 16% supporting Sanders, 6% for Buttigieg, and 4% each for Warren and Harris. Among those who have attended a Nevada caucus in the past, 33% support Biden, 23% are for Warren, 12% for Sanders, and 7% each for Harris and Buttigieg.

Harris and Buttigieg. The race appears to be only somewhat tighter among Latino voters for Biden (27%), Sanders (19%), and Warren (11%), followed by O'Rourke at 6% and Yang at 5%. A sizable 20% of Latino voters do not have a candidate preference at this time. It is important to note, though, that this subsample has a larger margin of error that ranges from 7 to 10 percentage points for the top three candidates. Among white non-Hispanic voters, Biden leads Warren 37% to 23%, with Sanders at 13%, Buttigieg at 10%, and Harris at 5%. Among all other voters, the majority of whom are African-American, Biden has a clear lead of 42% with Harris (14%), Warren (12%), and Sanders (6%) trailing.

"Nevada is the first state on the Democrats' 2020 calendar with an ethnically diverse electorate. Latino voters seem to be particularly up for grabs right now," said Patrick Murray, director of the independent Monmouth University Polling Institute.

The top issues that Nevada Democrats are thinking about in choosing a presidential nominee are health care (41%), followed by environmental concerns (17% climate change and 7% environment in general), immigration (19%), jobs (17%), reproductive rights (15%), and beating Trump (14%). Other issues that are important to voters include education (8%), civil rights (8%), income inequality (8%), foreign policy (7%), social security (5%), competence and experience (5%), taxes (5%), honesty and integrity (5%), gun control (4%), and a number of other issues named by 3% or less. Immigration and the combination of jobs and income inequality are more important issues for Nevada Democrats than they are in other early states polled by Monmouth. Specifically, immigration is named as a top issue by 19% in Nevada, compared to 9% in New Hampshire last month and 14% in Iowa two months ago. Jobs and income inequality are named by 25% in Nevada, compared to 15% in New Hampshire last month and 15% in Iowa two months ago. Health care has been the top issue mentioned in all three states - 41% Nevada, 41% New Hampshire, and 51% Iowa – while climate change and the environment have also been important for Democrats in all three states - 24% Nevada, 24% New Hampshire, 29% Iowa. In Nevada, health care is the top concern for all demographic groups except Latino voters, for whom immigration (37%) and health care (37%) are equally mentioned as a top issue

What they urgently need, instead, is international solidarity to help them win the fight against Israeli occupation, racism and apartheid. The Monmouth University Poll asked caucusgoers to rate 24 announced candidates in the race. Biden holds the most positive rating at 78% favorable to 13% unfavorable. However, the ratings for Warren (70% to 11%) and Harris (67% to 9%) are nearly as strong. Other relatively well-known candidates include Sanders (65% to 20%), Booker (61% to 9%), O'Rourke (54% to 16%), Buttigieg (56% to 8%), New York Senator Kirsten Gillibrand (38% to 16%), and Klobuchar (43% to 10%). New York City Mayor Bill de Blasio is well-known but has a net negative rating of 25% favorable to 33% unfavorable.

# U.S. short-sighted in politicizing business issues

**GLOBAL TIMES** — A dispute over patent fees between Huawei and US carrier Verizon has suddenly taken center stage following US President Donald Trump's restrictions on the Chinese telecom giant. As the US-China trade war escalates, Washington should avoid intervening in and politicizing commercial disputes.

Huawei has told Verizon that the carrier should pay licensing fees for more than 200 of its patents, the Wall Street Journal (WSJ) reported on Wednesday, citing people familiar with the matter. No further details were released but the case has aroused widespread concern among people who are following the trade war.

A Verizon spokesperson was quoted by the WSJ as saying that the issue is a potential legal matter. The patent fee dispute should be resolved based on international laws and practice, without intervention from either Washington or Beijing. We believe it's what both American and Chinese companies want to see, because the politicization of an economic issue can do nothing but complicate the situation.

It is not clear yet whether the patent licensing issue will involve more US companies such as wireless carriers Sprint



#### Corp, AT&T Inc and T-Mobile.

Ås of March, Chinese companies accounted for 34 percent of worldwide applications for major patents related to 5G technology, the Nikkei Asian Review reported, citing statistics from Germany-based IPlytics.

If the US government bans Chinese-brand equipment

from the country's 5G networks, how should US companies use patented technology in their products?

The question should be answered based on the rule of law rather than the rule of geopolitics.

The case may create a demonstration effect for latecomers. If Washington unilaterally intervenes in a commercial dispute, or ignores international laws and relies on domestic regulations, China should be prepared to take countermeasures to protect the legitimate interests of Chinese enterprises. If the issue is mishandled by Washington, we may see an escalation of the trade war.

We don't want this scenario to become reality, especially ahead of the G20 summit in Osaka, Japan, later this month in which trade issues are likely to be highlighted. The licensing fee dispute is only a demand for patent fees and shouldn't be used as part of the geopolitical battle between China and the US.

Despite a substantial rise in trade tensions, we still hope US companies and Huawei can achieve common development because the Chinese giant's alliance with the US telecom industrial chain is indivisible. The short-sighted US actions to exclude Huawei from its 5G construction will hurt both itself and others.

# The immigration-bigotry-war nexus

ANTIWAR — Americans increasingly view Muslims as a threat to their security, especially Republicans. According to a Pew Charitable Forum survey in 2017, 65 percent of Republicans believe there is a "natural conflict between Islam and democracy." Amusingly, 56 percent of Americans polled by CivicScience in 2019 said American students should not be required to learn Arabic numerals (i.e.: 1,2,3,4,5,6,7,8,9,0) as part of their educational curriculum. A 2018 Chapman University poll noted that – although prejudice against Muslims had fallen somewhat between 2016 and 2018 – more than 60 percent of Republicans believed "Muslims are more likely to engage in terrorist activity than non-Muslims" and nearly 40 percent said America should end immigration from all Muslim countries.None of those attitudes are an accident. Nor are they the result of the rare blowback from America's interventions abroad.

The attitude of a fundamental struggle between the Muslim world and the West is being engineered, and it is not a result of a natural conflict among the Muslim people with democracy. Muslims have seen their popularly elected governments repeatedly overturned in U.S.-based coups d'etat, from Syria (1949) to Iran (1953) to Egypt (2013). Instead, the "Muslim terror threat" is being manufactured with millions of dollars in donations to virulently anti-Muslim hate-groups from establishment sources with deep ties to the Military-Industrial-Surveillance Complex (MISC).

Only through the propagation of negative stereotypes about Muslims (and, to a lesser extent, Hispanics) can wars in the Middle East and coups in Latin America remain politically sustainable. If Americans see immigrant Muslims from Middle Eastern countries as fellow human beings who act logically (if, at times, desperately) as a result of U.S. government military malfeasance abroad, their fears will likely fade and aggressive US wars become politically untenable.

#### **Insidious U.S. entraps HK** with new Act

**GLOBALTIMES** — The US Senate introduced the bipartisan Hong Kong Human Rights and Democracy Act on Thursday, while the House of Representatives' bill is expected to be approved on Friday. The act requires the US government to reaffirm Hong Kong's autonomy, human rights and democracy every year, and re-evaluate whether Hong Kong warrants a special status as a separate customs territory by Washington.

In other words, the current China-US tariff war has no direct impact on Hong Kong unless the region is stripped of separate customs territory treatment.

The US Congress' insidious act is to turn Hong Kong into a new tool to add pressure on the Chinese mainland. Meanwhile, the US is trying to incite complaints among Hong Kong residents against the mainland and create a fake impression that Beijing is threatening Hong Kong's special status. Washington is inflaming Hong Kong's situation.

Some Western politicians have never really thought of Hong Kong's welfare since its return to the motherland. As a child of China, Hong Kong was like being forced to be adopted, or abducted, by others. When the child was returned to its birth parents, what should people do if they really care about the child?

First, give the child good conditions. The UK may have had such an intention during its negotiations with China over the return of Hong Kong, although what it really cared about was maintaining its interests in Hong Kong. To some extent, the "one country, two systems" policy considered Hong Kong's experience of being adopted, and the Basic Law endowed Hong Kong with much better democratic conditions than the so-called democracy during British rule. Hong Kong's British governors were sent by the UK, but today Hong Kong's chief executive is elected according to the law.

Second, if Western countries regard themselves as Hong Kong's then adoptive parents, they should tell the child to get along well with its birth parents and adapt to the new environment, if they really love the child.

But the UK had been trying to sabotage Hong Kong's relations with its motherland. The last British governor of Hong Kong Christopher Patten created a series of incidents to incite Hong Kong's confrontation with the mainland when he left the region. After Hong Kong's return, the US continued to interfere in Hong Kong's affairs. This shows their dark mindset: If Hong Kong does not belong to the West, turn it into China's problem.

The US Congress has created a systematic threat to cancel Hong Kong's separate customs territory status, and this is like using a baby to threaten the parent: Promise me my conditions or I'll drop the baby. The US is ruining Hong Kong and is trying to make the mainland look cold-hearted.

Hong Kong's interests are tied to the mainland. We expect Hong Kong's promising future and feel hurt to see the disturbance. But US politicians will do anything to worsen Hong Kong's condition.

The global situation is changing profoundly. The US now regards China as its major strategic rival, so how can it be in the mood to care about Hong Kong's welfare? It only wants to use the region to restrain China. If people of Hong Kong are not vigilant against this, they will fall into the US trap as pawns.

It's time for Hong Kong and the mainland to unite in op-position to US strategic plots and manipulation. We should together maintain Hong Kong's prosperity, which concerns the interests of Hongkongers as well as the whole country. As a result, organizations funded by these donors can continue to promote fake news that hypes the alleged Muslim threat to America, such as:

Gatestone Institute (Muslim refugee rape crisis in Sweden) Daniel Pipes' Middle East Forum (No-go zones in European refugee areas)

The Clarion Project (Muslim extremist camps in the US) **Donors Trust: The Fear-Funding Front** 

Donors Trust is the granddaddy funnel for all anti-immigrant and pro-war funding sources. The organization boasts of doling out \$1.1 billion since its 1999 founding, and it acts as a sort of anonymizer for big political donors for a host of right-wing/Republican issues, from climate change skeptics to Koch Brothers foundations to anti-immigrant causes.

Donors Trust operates as a shell foundation for the super-rich, through which they can designate funds for their pet causes. One of the key causes anonymized by Donors Trust is fear of immigrants. Among the recipients of Donors Trust funds are Daniel Pipes' Middle East Forum, Numbers USA, the Center for Immigration Studies, the Federation for Immigration Reform, Frank Gaffney's Center for Security Policy, The Clarion Project, the Middle East Media Research Institute, the Committee for Accuracy in Middle East Reporting in America (CAMERA), Robert Spencer's Jihad Watch, Concerned Women for America, David Horowitz Freedom Center, and others.

The investigative website Sludge has conducted some important research on this topic, and found that Donors Trust and three other "donor-advised funds" (also including Fidelity Charitable Gift Fund, Schwab Charitable Fund, and Vanguard Charitable) donated more than \$7 million over three years to anti-immigration or anti-Muslim organizations designated hate groups by the Southern Poverty Law Center. Sludge also noted in a follow-up report that Goldman Sachs Philanthropic Fund had given \$50,000 to the virulently anti-Muslim Clarion Project in 2015-17, along with donations from Vanguard Charitable (\$875,000) and Schwab Charitable Fund (nearly \$250,000).

While the National Christian Foundation focuses mainly on other issues, it has also funded anti-Muslim and anti-immigrant organizations, according to research by Sludge: "Anti-Muslim groups ACT for America (\$98,000), American Freedom Law

Gatestone hoaxes, such as the phony Muslim rape wave in Sweden (The government's rape statistics hit the stratosphere after a 2005 Swedish government law that designated some consensual sex acts as "rape"), have been reliably copied from Gatestone origins to Breitbart, Alex Jones' InfoWars, the John Birch Society's The New American magazine, and others. The Gatestone Institute has also continued to promote the idea of "no-go zones" in European communities where Muslim immigrants had settled, even though the originator of the phrase, anti-Muslim academic Daniel Pipes, was forced to recant his earlier claims about this myth. Undaunted, Gatestone authors have continued to manufacture lies about the mythical zones of Sharia in Europe. And Gatestone has also hyped an alleged "crime wave" in Germany – which has admitted a large number of Muslim refugees – although the country has experienced the lowest crime rates since reunification in 1992. Despite record-low crime rates, Gatestone authors continue to beat the drums of an immigrant crime wave in Germany.

The transmission of Islamophobic lies from Gatestone to Breitbart is a natural distribution, as it was part of a vertical corporate merger of sorts in the war-hate industrial alliance. Hedge fund billionaire Robert Mercer sold his interest in Breitbart to his daughter Rebeckah beginning in 2018, who sits on the board of the Gatestone Institute. This makes for a more reliable and direct channel for anti-Muslim, pro-war propaganda making its way onto the Breitbart platform.

The founding force behind the Gatestone Institute is Sears & Roebuck heiress Nena Rosenwald. Rosenwald's family foundation is The Abstraction Fund, and she is a former board member of AIPAC, the most powerful Israeli lobby in the United States. Gatestone gets its money from Rosenwald and her foundations, Long Island real estate developer Lawrence Kadish, the Mercer family foundations (complete donations in 2014), and Daniel Pipes' Middle East Forum.

But the Gatestone Institute has strong ties to Deep State military and intelligence agencies, with its past Chairman John Bolton now serving as Trump's National Security Advisor. Longtime Defense Department employee Harold Rhode also sits on the board; he was a key part of Bill Kristol's "Project

# Apollo-era tech built foundation, but private industry now leads space innovation

Space travel technology may seem to have stalled since the Apollo and space shuttle eras, but private industry is now fueling rapid innovation.

Reusable rockets, commercialized by SpaceX and under development by others in the last few years, have dramatically lowered the cost of reaching space, along with other advances. Lessons learned from 135 shuttle missions and almost 20 years at the International Space Station have boosted knowledge about working and living in space.

The surge of innovation leading to the Apollo 11 moon landing 50 years ago was unprecedented, historic and fueled by the Cold War. As the nation looks back on five decades of space exploration since then, many have wondered why we aren't on the moon or even Mars.

"The innovation is coming along now because private industry is coming along now," retired shuttle astronaut and businessman Sid Gutierrez said. "Now you have people like Elon Musk and Jeff Bezos who got in there and shook things up. After they shook it up, that opened the door for more people to come in."

Few people alive have Gutierrez's grasp of the evolution in rocket technology. Not only has he flown to space on top of a rocket, but he's also CEO of a new company called Rocket Crafters. And his father was part of the U.S. Army's special operation to recruit German rocket scientists after the Nazi defeat in World War II.

The Germans were the first to reach space with their V-2 rocket, designed to bomb Allied cities. Operation Paperclip is what brought the leader of Apollo rocketry, Wernher von Braun, from Germany to the United States.

"War is historically what drove innovation," Gutierrez said. "In the Cold War, we didn't really care that much about cost or even safety after launch if it was carrying a weapon. And money was essentially unlimited for the Apollo program."

Apollo's Saturn V rocket system was entirely disposable. Stages of the rocket either burned up in the atmosphere, crashed into the ocean, crashed into the moon or entered orbit around the sun or Earth.

The space shuttle was all about being reusable, but the shuttle never got to the frequency of launches that was originally envisioned,



and the main fuel tank was never reusable -- it simply dropped into the atmosphere and burned up into small pieces over the ocean.

Shuttle boosters were reusable, but only after they fell into the ocean, which added a lot of other risks of damage.

In 2015, Blue Origin and SpaceX perfected landings of rocket boosters that actually fly back to Earth and land, making them less expensive and quicker to refurbish and turn around for another launch. SpaceX says its Falcon 9 Block 5 can be refueled with little need for any refurbishment.

In a 2017 presentation, Musk said throwing away rockets after one use is crazy.

"It is really crazy that we build these sophisticated rockets and then crash them every time we fly," he said. "This is mad. I cannot emphasize how profound this is and how important reusability is."

Today, a launch on a SpaceX Falcon Heavy, essentially three Falcon 9's strapped together, is advertised for \$90 million. That compares to \$350 million for a launch on its main competitor, a Delta IV Heavy by United Launch Alliance.

ULA says its long-standing success record for launches makes the extra cost worth it. But it also is developing a new rocket, the Vulcan, that will include reusable engines. NASA, meanwhile, is developing the Space Launch System with an SLS rocket, solid rocket boosters and the Orion spacecraft.

"The good thing about the new space companies and the venture capital involved is you are now putting a lot of new money into it," said Mitchell L. R. Walker, professor of aerospace engineering at the Georgia Institute of Technology.

SpaceX has proven regular, commercial usage of concepts with which others had tinkered, including the landing of a firststage booster and use of supercooled liquid oxygen, Walker said. Recovering a second stage is proving more difficult, although Musk tweeted out ideas in 2018 for an inflatable heat shield.

"It's great, but they're still on the path to proving total reusability over the long haul, and with a reliability needed to carry people," Walker said. "It has the potential to save taxpayers a lot."

The liquid fuel used in rockets hasn't changed much since the Apollo era. The basic liquids involved are liquid oxygen, liquid hydrogen and rocket-grade kerosene.

To make oxygen usable in a rocket, it has to be condensed and cooled below -297 degrees Fahrenheit. SpaceX took that one step further by cooling it more into "deep cryogenic" liquid oxygen. That makes it more dense, so it would take up less room in the rocket, leaving it lighter or with more room for other things, Walker said.

Methane now is being included in development of next-generation rocket engines -- the BE-4 from Blue Origin and the Raptor from SpaceX -- in a bid for more efficiency. Methane also is considered to be something that could be produced on Mars -- the working target for a new generation of space exploration.

Seetha Raghavan, associate professor of aerospace at the University of Central Florida, noted that the shuttle had several reusability problems -- like heat shield tiles that needed to be replaced repeatedly.

"We've definitely come a long way," she said. "Rocket technology is more efficient and manufacturing is more cost-effective. Reusing a booster by having it fly back to the launch pad, without having to recover it, is very big."

Other advances have been made in learning about the surface of the moon and asteroids, allowing the moon to be a stopover on the way to Mars, Raghavan said.

"The combustion process is not that much different, but there's more going on than you can see," she said. "We know more about how these materials behave in extreme environments now, and we have a lot of experience and technology to help us test them."

The drawback to chemical, liquid rockets is painfully obvious looking at the history of rocketry: explosions.

Hybrid fuel systems are being attempted by Gutierrez's Rocket Crafters and by Richard Branson's Virgin Galactic. They use a solid fuel with a liquid oxidizer.

Rocket Crafters' solid portion is basically Lego-type plastic mixed with powdered aluminum, which only burns under precise conditions. The company says it is far more stable and less dangerous than a liquid-only rocket system.


"SpaceX is doing a lot of nice innovation," Gutierrez said. "But given that they are still using liquid bi-propellant, there may be only so far they can go with that."

Mitchell also said he thinks more than chemical rockets will be needed if Mars really is a target.

"We need to get an electrical propulsion system with higher power to start pushing stuff off to Mars," he said.

#### Research reveals liquid gold on the nanoscale



The research published in Nature Communications set out to answer a simple question - how do nanoparticles melt? Although this question has been a focus of researchers for the past century, it still is an open problem - initial theoretical models describing melting date from around 100 years, and even the most relevant models being some 50 years old.

Professor Richard Palmer, who led the team based at the University's College of Engineering said of the research: "Although melting behavior was known to change on the nanoscale, the way in which nanoparticles melt was an open question. Given that the theoretical models are now rather old, there was a clear case for us to carry out our new imaging experiments to see if we could test and improve these theoretical models."

The research team used gold in their experiments as it acts as a model system for noble and other metals. The team arrived at their results by imaging gold nanoparticles, with diameters ranging from 2 to 5 nanometers, via aberration corrected scanning transmission electron microscope. Their observations were later supported by large-scale quantum mechanical simulations.

Professor Palmer said: "We were able to prove the dependence of the melting point of the nanoparticles on their size and for the first time see directly the formation of a liquid shell around a solid core in the nanoparticles over a wide region of elevated temperatures, in fact for hundreds of degrees.

"This helps us to describe accurately how nanoparticles melt and to predict their behavior at elevated temperatures. This is a science breakthrough in a field we can all relate to - melting - and will also help those producing nanotech devices for a range of practical and everyday uses, including medicine, catalysis and electronics."

# India plans to launch own space station



India will look to create its own space station following the completion of the country's first manned mission into space in 2022, its space agency chief said on Thursday.

The space station, where astronauts can stay for 15 to 20 days, would be placed in an orbit of about 400 kilometers (km) above the Earth, K. Sivan, chairman of the Indian Space Research Organization (ISRO) told a news conference.

The space station would weigh 20 tonnes, Sivan said.

The ISRO would take about five to seven years to launch the proposed space station after its first manned mission is completed in 2022, Sivan said. That mission, announced last year, will carry either two or three crew members to space for five to seven days in a craft placed in a low earth orbit.

On Wednesday, India also announced its second lunar mission which, if successful, would make it the fourth country to perform a "soft" landing on the moon and put a rover on it.

# Scientists ask the public to help search for a rare breed of black hole

If you have a computer and a few spare moments, you can help search the cosmos for an elusive breed of black hole that astronomers once thought didn't exist.

Black holes come in two main types: stellar mass black holes, which generally have about 10-24 times the mass of our sun, and the much heavier variant known as supermassive black holes, which can be billions of times more massive. But astronomers have also found a handful of socalled intermediate mass black holes that fall between the two extremes.

Now a group from the North Carolina Museum of Natural Sciences is calling on the public to help detect more of these rare in-betweeners, which could yield insights into how the more common supermassive black holes form.

Volunteers simply need a computer with internet access and a mouse. After a brief tutorial on the project website, they are shown photos of spiral galaxies from around the universe and asked to trace the arms, a process that generally takes about a minute or less. The scientists will then combine the tracings from 15 different volunteers to get a composite trace for each image. Ultimately, the goal is to find galaxies that are wound looser than normal, a shape that suggests an intermediate mass black hole may lurk at the center.

If the crowd sourced effort is fruitful, the researchers plan to use additional telescope observations and a different type of relationship -- between black hole mass and the scattering of stars near the galactic center -- to confirm the initial hints of an intermediate mass black hole.

Humans are better than computers at discerning patterns in difficult-to-interpret images of spiral galaxies, such as those with low contrast, broken lines, or other imperfections, said Patrick Treuthardt, an astronomer at the North Carolina Museum of Natural Sciences. He spoke about the project at a press conference this week at a meeting of the American Astronomical Society in St. Louis.

# Out of their eggs, into the sky: how baby pterosaurs may have taken flight

Modern nature teaches us that flying isn't child's play. Newborn birds spend their early days in the nest, and bat pups don't take off for weeks on end, often requiring prodding from their mothers.

But what about baby pterosaurs?

Some researchers think the young of these flying reptiles that lived in the time of the dinosaurs also stayed on the ground for a while, tended by adults. Others argue the opposite: Young pterosaurs could immediately fend for themselves, hatching and heading straight for the skies.

A paper published Wednesday in Proceedings of the Royal Society B supports this stirring vision, marshaling evidence from all known pterosaur embryos to argue that the prehistoric creatures were flight-ready from birth.

The researchers took advantage of a fossil cache unearthed in northwest China in 2017. Sometime between about 145 and 100 million years ago, a flood rushed through the area and buried an entire colony of pterosaurs, said David Unwin, a paleobiologist at the University of Leicester in England and the study's lead author. The site has "adults and juveniles, and it's got lots and lots of eggs."

Over 300 have been found there so far, 16 with embryos preserved inside. But attempts to figure out the stage of development each embryo had reached have been "kind of ad hoc — just look-at-it-and-guess," Dr. Unwin said. He and Charles Deeming, a zoologist at the University of Lincoln in England, set out to standardize the process.

The pair used fossils from that site, along with eggs and embryos from Argentina and



elsewhere in China. They first looked at limb lengths, along with egg size and shape. The researchers found that in general, smaller, narrower eggs represent early-stage embryos, while larger and rounder ones indicate a later stage.

Next, they examined patterns of bone ossification, or hardening, looking at embryos along with young pterosaurs, called flaplings. Overall, they compared data from specimens of nine pterosaur species, from Hamipterus tianshanensis — the type in the flooded colony, which had a crested snout and a wingspan of up to 11-1/2 feet — to the swallow-sized and stubby-tailed Anurognathus ammoni.

Because bones harden in a particular order, they can serve as "developmental markers," Dr. Unwin said. They then matched these patterns to those observed in quails and alligators, both considered modern analogues of pterosaurs. This helped to sort the pterosaur embryos, from newly laid to about to hatch.

Along the way, they noticed something about one bone, the manus digit IV. Equivalent to our ring finger, this is a pterosaur's "wing finger," the long, flexible appendage that is attached to its wing membrane and allowed the animal to fly. In most vertebrates, that bone is one of the last to harden. Pterosaurs, though, "ossify it very early," he said.

To Dr. Unwin, this — along with similarly early ossification of other important flight-related bones — is further evidence that pterosaurs could get airborne right out of the egg. A pterosaur from the species Ningchengopterus Liuae, with a wingspan of around 6 inches, was probably only a few days old when it drowned in a lake in what is now Inner Mongolia. Dark stains around the arm and body are fossilized remains of its wing membranes.

"It's extremely unlikely that they would equip themselves with a flight apparatus if they were not going to use it," he said. He says it follows that these babies didn't require much oversight: "What do you need mummy and daddy for if you can do everything yourself?"

The study supports the idea that pterosaurs "required minimal parental oversight, if any, as hatchlings," said Luis Chiappe, a paleontologist at the Natural History Museums of Los Angeles County who was not involved in the research.

Other experts were convinced by the paper's assessment of embryo development, but not its behavioral conclusions.

In order to prove those, the study would need to compare the pterosaurs with megapodes, chicken-like birds from Australia that can fly from birth, said Edina Prondvai, a postdoctoral researcher at Ghent University in Belgium and the MTA-MTM-ELTE Research Group for Paleontology in Budapest. Kevin Padian, a biologist at the University of California, Berkeley, called the idea that hatchlings could support their own body mass in the air "quite a stretch," based on studies of birds.

Dr. Unwin replied that he would have liked to compare pterosaurs with megapodes, but could not find enough data, and that "pterosaurs are not birds."

### NASA tries to get Martian "mole" working again



Scientists and engineers at NASA's Jet Propulsion Laboratory (JPL), Pasadena, have a new strategy to get a troubled Mars instrument working again. The Heat Flow and Physical Properties Package was provided by the German Aerospace Centre (DLR) for the InSight Mars lander. The instrument's heat probe, known as the mole, should dig itself down as far as five meters into the Martian ground but came to a standstill on 28 February, having burrowed just 30cm (12 inches) below the surface.

It was first thought the mole may have hit a rock but several months of testing a replica on Earth have suggested a different reason. The mole uses a hammering action to push it deeper. Tests suggest the Martian soil is not providing enough friction for the probe to push against, so the probe is bouncing in place.

NASA now plans to lift the mole's support structure to see what is going on underneath. There is a risk, however, as they must be careful not to pull the mole out of the ground.

If successful, they could then press down on the area with the spacecraft's robotic arm to increase friction around the mole. The delicate procedure is scheduled to begin near the end of this month. (Source: The Guardian)

#### Man discovers snake in his bag after flying from Florida to Hawaii

A 20-year-old man flying from Fort Lauderdale to Hawaii got the shock of his life when he found he accidentally brought a teeny, tiny, slithery stowaway with him on his journey, MSN reported on Friday.

The Associated Press reported the man was unaware a southern black racer snake had found its way into his backpack somewhere along his route. He didn't discover the creature until he arrived all the way at his rental property in the community of Pukalani.

The non-venomous snake, officials told the AP, measured in at about a foot long and a quarter inch in diameter. Luckily, this one seemed to be fairly tiny — as NBC reported, the species can grow up to 6 feet in length.

After the snake slithered out of the man's bag the property owner reportedly informed the visitor that snakes are illegal in the state. The owner then alerted the police, who were able to capture the snake with a little help from the Department of Land and Natural Resources. The team is expected to transfer the snake to Oahu.

Although the man appeared to have no know how the snake got in his bag, he could have gotten into serious trouble.

Transporting illegal pets is a felony in Hawaii, according to the AP, with fines up to \$200,000 and 3 years in prison. Oddly enough, this isn't the first (or second or third) time a

snake has accidentally hitched a ride on a plane.

In 2017, a passenger found a five-foot-long snake hiding under a duffle bag after its owner left it behind. In February of this year, a woman found a python hiding in her shoe that had escaped Australia with her. And, in 2018, scientists reported that brown tree snakes were purposefully boarding planes from Guam to Hawaii all on their own. Because really, who doesn't love a vacation in Hawaii?

# Rosewater festivals attract travelers to northern Iranian villages

**HERITAGE** d e s k **TEHRAN** — Every year, by early June, rosewater festivals take center stage in Gildeh and several neighboring villages, attracting hundreds of travelers to Shaft county of the northern Gilan province.

Shaft embraces some six hectares of very sweet smelling kind of roses, best known as Mohammadi roses in the country.

The county, however, is little-known when it comes to such festivals that are more established in the oasis city of Kashan or its surrounding villages in central Iran.

Visitors may revel in lush flower gardens or witness how locals make rosewater step by step from harvesting to steaming damask rose petals. They usually buy bottles of fresh rosewater and other household products.

Golab or rosewater is a fragrant distillate of the roses which is used nationwide in diverse traditional dishes to flavor them or consumed as a religious perfume as well. Distillation ceremonies are locally called "Golab-giri".

are locally called "Golab-giri". Almost every 30 Kg of rose petals plus 80 liters of water are poured into each pot that is connected to metal pipes for the steam moving through to obtain the hydrosol. The waste of distillation is used for feeding livestock or composting.

Many believe traditionally distilled rosewater is of higher quality from that of produced in factories probably due to shorter time interval between the

been a holy place of Shintoism since the earliest times. Itsukushima is situated in the Seto inland sea of Japan.

The first shrine buildings here were probably erected in the 6th century. The present shrine dates from the 13th century but is an accurate reflection of the 12th century construction style and was founded by the most powerful leader of the time, Taira no Kiyomori.



A UNESCO World Heritage site, the property covers 431.2 hectares on the Island of Itsukushima, and the buffer zone (2,634.3 ha) includes the rest of the island and part of the sea in front of Itukushima-jinia.

The buildings of Itsukushima-jinja are in the general tradition of Japanese Shinto architecture, in which a mountain or natural object becomes the focus of religious belief to be worshipped from a shrine, generally constructed at the foot of the mountain.

The harmoniously arranged shrine buildings in the property are located on the sea and the scenery, with a trinity composed of the man-made architecture in the center, the sea in the foreground, and the mountains in the background, and have become recognized as a Japanese standard of beauty.

## Ancient Afghan citadel collapses, cultural heritage sites at risk

**GHAZNI, Afghanistan (Reuters)** — An ancient tower dating back 2,000 years in the historic Afghan city of Ghazni collapsed last week, local officials said, raising concerns about the vulnerability of the country's cultural heritage and the government's ability to protect them.

The old citadel known as Ghaznain Fort originally had 36 towers, but 14 of the towers had collapsed in recent years due to decades of war, heavy rain and neglect.

The fort is one of dozens of unique historic sites in Afghanistan - ranging from the pre-Islamic Buddhist center in the Bamyan valley to the 12th century minaret of Jam in a remote area of Ghor province - in urgent need of protection.

Officials in Ghazni, which nearly fell to the Taliban last year in some of the heaviest fighting seen in the war, said the tower collapsed on Tuesday following heavy rain. A short video posted on social media shows it crumbling but local residents say negligence also contributed to its collapse.

"The government paid no attention to the sites and didn't build canals to divert flood water," said Ghulam Sakhi, who lives near the citadel.



"We have warned the government about the dire condition of the citadel but no one visited," Sakhi said.

Mahbubullah Rahmani, acting director of culture and information in Ghazni, said heavy rain and recent fighting had contributed to the tower's collapse but said the government was working on a plan to protect the site from complete destruction.

He said a German archaeologist had worked at the site as recently as 2013.

Ghazni, a strategically vital center on the main highway between Kabul and southern Afghanistan and two hour drive from the capital, is home to a range of cultural and archeological artifacts, some of which date back to pre-Islamic period.

The province and its cultural heritage was officially declared as Asian Capital of Islamic Culture in 2013 by the Islamic Educational, Scientific and Cultural Organization, a Morocco-based body created in 1981, supported by UNESCO.

The collapse of the tower in Ghazni follows concern over the condition of the 900-year-old Minaret of Jam, in Ghor, which has been on the UNESCO List of World Heritage Properties in Danger since 2002.

The Taliban during their austere regime from 1996-2001, before they were toppled by the U.S. and coalition force in late 2001, blew up two giant Buddha statues in central Bamiyan province, calling them idols.

# Ancient Egyptian fortress built by Ramses II reveals its secrets

An ancient Egyptian fortress built by the Pharaoh Ramses II is revealing its secrets to archaeologists.

Researchers discovered the remains of two new buildings at the fortress site in Beheira Governorate northwest of Cairo, Egypt Today reports.

The circular-shaped buildings were used as stores, according to a Facebook post by Egypt's Ministry of Antiquities. Animal bones were found within the silos.

Ramses II, also known as Ramses the Great, ruled Egypt from 1279 BC. to 1213 BC. He is credited with expanding Egypt's

reach as far as modern Syria to the east and Sudan to the south.

Egypt continues to reveal fresh details of its rich history. Archaeologists recently uncovered an ancient cemetery near the famous Giza pyramids just outside Cairo. In a separate project, experts uncovered

the 2,500-year-old remains of a powerful high priest in dramatic fashion.

The secrets of a mysterious "Tomb of the Warriors" were also recently revealed in a PBS documentary, and solving an ancient puzzle, archaeologists discovered the wreck of an extremely rare vessel that traveled the Nile around 2,500 years ago.

In another project, archaeologists recently found a large ram-headed sphinx that is linked to King Tutankhamun's grandfather. In other projects, a teenage girl's skeleton was discovered in a mysterious grave near the Meidum pyramid, south of Cairo.

In April, experts announced the discovery of dozens of mummies in ancient desert burial chambers. Archaeologists also recently explained the strange brown spots on some of the paintings in King Tutankhamun's tomb.

In January, archaeologists announced the discovery of ancient tombs in the Nile Delta north of Cairo. In a separate project, two ancient tombs dating back to the Roman period were uncovered in Egypt's Western Desert.

In another project, archaeologists discovered a stunning sphinx statue at an ancient temple in southern Egypt.

Last summer, experts unlocked the secrets of a mysterious ancient 'cursed' black granite sarcophagus. The massive coffin, which was excavated in the city of Alexandria, was found to contain three skeletons and gold sheets with the remains.

selves in far more complex ways from our unique lived experiences. Someone who almost drowned as a child might suffer panic attacks from being confronted with summertime ads for pools in their area, while someone who almost died from a food allergy might be traumatized by endless images of that food item in their news feed from well-meaning friends that don't know about their allergy or experience.

Today's social filters are designed around the idea of banning universally toxic topics like hate speech. Ironically, for platforms that intimately personalize their content streams, the major platforms have yet to roll out personalized toxicity filters that would learn from the sensitivities of their users and allow fine-grained customization.

Perhaps that is the role our digital assistants of the future could play.

Imagine a digital assistant that could curate all of the social posts arriving in our news feeds in real-time, scanning each against a personalized model that removes posts that would be traumatic to us, regardless if to others they might be acceptable or even welcome.

Our assistant could learn through our behaviors and feedback over time what kind of content is harmful to us individually, becoming ever better at protecting us and even adapting to new traumas in our lives. The death of a beloved pet would cause our assistant to proactively immediately filter out the pet ads and happy pet posts we once embraced, until the pain of our loss has subsided.

Such a personalized toxicity filter would not entirely strip away the reality of the world to present a caricature of a "happy" utopia. Rather, it would merely filter the toxicity that affects us directly, allowing us to experience the world's negativity without becoming traumatized and without confronting hateful attacks directed at us personally or our demographics.

Putting this all together, perhaps someday the social networks will build customized toxicity filters that learn our unique vulnerabilities and create a more welcoming and inclusive environment. At best, however, each platform would have its own filters with differing abilities and knowledge about us, creating an uneven filtering landscape that is reset each time we join a new network.

In the meantime, perhaps the coming era of more advanced digital assistants might offer a world of universal filtering, protecting us from the internet's worst.



#### Iranian cyclists to ride around the world planting trees, promoting peace

"We start our trip in Iran by touring 7 provinces of Alborz, Qazvin, Gilan, Ardabil, East and West Azarbaijan, and plant trees in those provinces," he added.

"After these provinces, we will travel to Georgia, Armenia, Turkey, Greece, Italy, Austria, Germany, France, Belgium, the Netherlands, Denmark, Norway and South America, to cultivate 1,400 trees

The journey will take 6 months, he concluded.

#### **Bermuda land snail: An** animal 'back from the dead'

Thousands of critically endangered snails have been released into the wild after being rescued from the edge of extinction, with a little help from a British zoo.

The greater Bermuda land snail was thought to have disappeared for many years until an empty shell turned up in the territory's capital city, Hamilton.

Live snails were then found among litter in a nearby alleyway. Some were flown to Chester Zoo for a unique breeding programme

More than 4,000 snails raised at the zoo have now been taken back to the island and released.

Many more captive snails will soon be returned to their homeland to help give the species a new lease of life.

Mark Outerbridge, a wildlife ecologist for the Bermuda government, said the snail was a "Lazarus species", which was considered extinct not so long ago.

Then, in 2014, a man walked into his office in the capital, Hamilton, holding a fresh snail shell.

"It turned out that, yes, this was in fact the greater Bermuda land snail, a species that we thought had gone extinct 40 years earlier," he said.

"He came back the next day with a fresh one, a live one in his hand, and that's how I was thrust into this conservation project.' A small but thriving population of land snails was discovered behind a restaurant. The gastropods were living among litter - specifically inside thrown-away plastic bags - in a "dank wet alley", surrounded by four-storey buildings. (Source: BBC)

# Human-animal interactions: Hospitable locals play host to storks for ages in Iran

→ Mousa Madhajji, an environmental expert told ISNA that the greatest population of storks and storks' nests in the country is in southwestern Khuzestan province, as this year 57 active nests have been identified in the province, which belong to white storks.

Temperate species like the white stork, black stork and yellow-billed stork live in Iran who undertake long annual migrations in winter, he said, adding, stork population started to decline in the country and some areas which were once home to flocks of storks are not witnessing even a pair of them such as Ahvaz city.

Although, there have been times when the population had fallen to fewer than some pairs in the entire country, even in places identified with the white stork for centuries, conservation measures successfully increased the population of birds thanks to the locals' efforts, he stated.

The nests are typically used for years, so nest change is often related to a change in the pairing and failure to raise young the previous year, and younger birds are more likely to change nesting sites, he noted. Dezfool city currently holds the highest number of active nests in the province,



Years ago, storks have managed to find a way of living with humans, preferring human settlements and rooftops for nesting to more natural habitats like treetops, and surprisingly, humans also have rarely attacked or persecuted them.

which are mainly set up on the power towers, he stated.

He went on to say that due to the birds tendency to nest on high settlements specially electricity towers or lamp posts, electricity distribution companies can turn to bird-friendly associations and build them safer man-made nests on the power towers.

This can flourish the stork's population in the province of Khuzestan and to expand in other areas favorable to these species, he highlighted.

With the start of summer, locals started to build tens of nests for storks in the western city of Marivan, Kordestan province, which attracted many of the storks to stay during the warm season.

Bird population increase over time mostly demonstrate a direct relationship between the flourishing of bird species with human flourishing; storks are also likely to expand whenever the buildings and human-inhabitation expands, however, there have been cases that human population raise have resulted in bird species population decline, yet historical ecology may be a reminder to realize that how much blessing "birds" can bring us and how human must reconcile with nature.

# Iran to implement food safety program

**SOCIETY** desk**EHRAN** — A food safety document will be approved and implemented in the future in the country, Vahid Mofid, an official with the Food and Drug Administration has stated.

The document is under review and must be approved by the health commission of the Majlis (Iranian Parliament), which is hoped to soon go into effect, he said, IRNA reported on Friday.

The document is consisting of standards through which food safety is best ensured; the whole food production process from cultivation to markets will be under control, it also identifies and controls hazards in the production, manufacturing and handling of food rather than relying on end product standards alone, he explained.

The standards enable the country to oblige food businesses to meet the document principles, they will be subject to periodic observations by a suitably qualified food safety auditor, he added.



He went on to note that the amount of toxins consumed, the types of fertilizers used and the ways food is distributed,

the quality of water and the irrigation methods are defined in the food safety document, as these factors affect the quality of the food products.

Food policy is cross sectoral, so the document emphasizes on a focused integrated policy, according to which related devices are obliged to well cooperate for the best food quality, he concluded.

Food safety is important as it helps to protect consumer from the risk of food borne illnesses. It also helps to prevent consumers from risks of health -related conditions such as allergy and even death.

It also protects food processing establishments from product recalls which results in financial losses due to unsafe products. Other issues due to unsafe products which can impact a business include: rejected products, possible lawsuits and business closure by the public health authorities due to reports of unsafe product sold to the general public.

# 11m ha of plains require aquifer, watershed management

**ENVIRONMENT TEHRAN** — Some 11 million hectares of the country's plains need watershed and aquifer management plans, so they must be prepared in this regard, director of watershed management at Forests, Rangelands, and Watershed Management Organization has said.

Watershed management aims at the sustainable distribution of its resources and the process of creating and implementing plans, programs, and projects to sustain and enhance watershed functions that affect the plant, animal, and human communities within the watershed boundary

and the overall planning and utilization of watersheds. Landowners, land use agencies, storm water management experts, environmental specialists, water use surveyors and communities all play an integral part in watershed management.

The vision of the aquifer management is to identify and map aquifers at the micro level, to quantify the available groundwater resources, and to propose plans appropriate to the scale of demand and aquifer characteristics, and institutional arrangements for participatory management.

Over the past 10 years, the country experienced 11 millimeters of rainfall decline while evaporation rate increased by 54 millimeters, ISNA quoted Khoshroo Shahbazi as saying on Thursday.



He went on to add that this led to a reduction in groundwater level; one of the scientific solutions to offset this deficit is the implementation of watershed and aquifer plans, which must be conducted on over 11 million hectares of the plains across the country. Last year, a total budget of \$200 million from the National Development Fund ear-

marked for conducting watershed and aquifer management plans, through which some 6000 areas have undergone implementation nationwide, he explained.

He further highlighted that this year, a budget amounting to €150 million from the Fund will also be allocated in this regard.

Shahram Montaseri, director for Fars province's forests, rangelands, and watershed management organization, for his part said that Fars was among the provinces undergone the highest number of aquifer management plans amounting to 35 projects worth 280 billion rials (around \$6.6 million).

In the case of allocation of funds up to 8 trillion rials (about \$190 million), we are capable of implementing watershed and aquifer management projects, he concluded.

# Climate change: Arctic permafrost now melting at levels not expected until 2090

Permafrost hs begun thawing in the Canadian Arctic more But the study found thawing levels were above 150 to than 70 years early because of climate change, according 240 per cent above historic levels.

Researchers also recorded thawing at depths not expected until air temperatures rose to levels that the UN Intergovernmental Panel on Climate Change (IPCC) predicted it would reach in 2090. Along with Mould Bay, researchers observed thermokarsts - a type of land surface that occurs when the ice melts in permafrost, characterised by uneven ground with low rounded hills and small ponds - at three siites along the 430 mile section of the high Arctic in Canada they were monitoring. Six pairs of Chinese crested terns have been seen rearing chicks on a tiny islet which is visited by fisherman hunting for eggs. It had been thought that this bird was extinct. BBC Science reporter Toby Murcott reported.

The last confirmed sighting of the Chinese crested tern was in 1937 - but after more than sixty years **classified** as extinct the **species** has returned from the dead. The birds were **spotted** by a tourist, who sent photographs to the Wild Bird Federation, Taiwan, part of the global Birdlife International. The excited ornithologists carefully examined the photos and confirmed that the tern is alive and well. The exact location of the islet where the birds have been found nesting is being kept a closely guarded secret to prevent them being disturbed. Egg poaching probably contributed to their decline in the first place

But it will be a challenge to protect the few remaining birds, as so little is known about these elusive creatures. One idea that's worked in other areas of **conservation** is to encourage people living nearby to benefit from protecting the species; fishermen could take birdwatchers to see these rare seabirds rather than collecting their eggs. With the rate of extinction **estimated** at around one hundred species per day, conservationists are taking at least a **glimmer** of hope from this one species still hanging on to life - just.

It had been thought that the permafrost - ground that remains frozen for at least two years - would remain until at least 2090.

Researchers called this a "truly remarkable amount". Mould Bay on Prince Patrick Island was the worst-affected site, according to the study, published on the journal Geophysical Research Letters.

There, permafrost thawing levels were 240 per cent higher than historic levels and the ground sank 90cm over the course of the study which ran for over 12 years, between 2003 and 2016.

# Top Bahraini court upholds jail terms against dozen anti-regime activists

TEHRAN — Bahrain's supreme court of appeals has upheld jail terms, ranging from life imprisonment to three years in prison, against a dozen anti-regime activists.

On Friday, the Court of Cassation upheld life terms for four convicts and sentenced seven others to between three and 10 years in jail. The last defendant was handed a sixyear sentence

The defendants were found guilty of "planting an explosive device underground in a sand yard in the northern village of Karrana, luring police forces to the area and then detonating the bomb."

Meanwhile, a Bahraini inmate has launched a hunger strike in protest at harsh prison conditions and mistreatment at the hands of prison authorities.

Female human rights campaigner Ebtesam al-Sa'eq wrote on her Twitter page that 29-year-old Hussein al-Tawil has been on hunger strike since Monday, and his family is fearing for his life as the detainee suffers from diabetes and serious blood sugar fluctuations

"Taweel is dying a thousand times a day due to symptoms of the disease. His eyesight



is affected by unstable blood sugar levels, and irregular treatment doses," Sa'eq said. Bahraini officials have reportedly leve-

U.S. warns Israel against deepening business ties with China

**FEHRAN** — The United States has warned Israel, a staunch ally in the Middle East, against deepening business ties with China, citing "security implications.

In its latest military budget bill, the Senate warned Israel not to allow China to run the port of Haifa, a long-time docking point for the U.S. Sixth Fleet and a place where joint American-Israeli drills have been held.

The Shanghai International Port Group, which has signed a deal with Haifa, is slated to operate its port for 25 years, beginning in 2021.

"The United States has an interest in the future forward presence of United States naval vessels at the port of Haifa in Israel but has serious security concerns with respect to the leasing arrangements of the port of Haifa," according to a draft text of the 2020 National Defense Authorization Act.

Washington also urged "Israel to consider the security implications of foreign investment in Israel," which has awarded several key infrastructure contracts to Chinese companies.

The bill was passed on Thursday by the Senate Armed Services Committee and it is likely to pass a full Senate vote.

Last year, U.S. officials warned the Israelis that "the United States could not be friends with a country for which China was building ports."

Dealings with China have had repercussions for Israel in the past too. During the administration of former President George W. Bush, the strategic dialogue with Israel was suspended for three years until Tel Aviv agreed to allow Washington to review any Israeli military sales to China

According to Press TV, Mark Dubowitz, the director of the Foundation for the Defense of Democracies, a pro-Israel think tank, reacted to the new deal on Twitter, saying, "This is serious and Israel's strongest supporters are losing their patience.

This comes amid an ongoing trade war between the US and China, the world's two major economic powers.

#### No decision to move Israel embassy, top Romanian official says

**TEHRAN** — State Secretary in the Roma-nian Foreign Ministry Maria Magdalena Grigore says her country is committed to its historic position and that of the European Union on the Israeli-Palestinian conflict and the so-called two-state solution, dismissing reports that Bucharest is planning to move its embassy in Israel from Tel Aviv to occupied Jerusalem al-Quds.

Speaking in a meeting with Jordanian Foreign Minister Ayman Safadi in Amman on Thursday, Grigore stressed the absence of any decision to shift the Romanian embassy to Jerusalem al-Quds.

She then praised Jordan's role in enhancing security and stability in the Middle East, emphasizing the importance of the Aqaba meetings.

The Aqaba meetings are reportedly a series of international meetings launched by Jordanian King Abdullah II in 2015 to bolster security and military cooperation, coordination and exchange of expertise among regional and international partners to counter terrorism

Safadi, for his part, said settlement to

the Palestinian issue lies on the two-state solution, and the establishment of an independent Palestinian state based on the 1967 borders with Jerusalem al-Quds as its capital.

Back on March 24, Romanian President Klaus Iohannis said the statement by his country's Prime Minister Viorica Dancila was false, and that the Romanian embassy would not move to Jerusalem al-Quds.

Iohannis wrote on his official Twitter page that the decision "was not even sent" to him, stressing that the "final decision about moving the embassy" is with him and that the prime minister is "ignorant of foreign affairs." Dancila had vowed in Washington that her country would move its embassy in Israel from Tel Aviv to Jerusalem al-Quds, breaking with both the European position and apparently with her own country's president.

According to Press TV, the Romanian prime minister made the announcement before the annual conference of the American Israel Public Affairs Committee (AIPAC) - an influential pro-Israel lobby.

#### Yemen army says missiles can hit Tel Aviv

→1 Yemen's Arabic-language al-Masirah news website said Saudi warplanes pounded the Bani Hushaish district in Sana'a late Friday. Saudi media confirmed the air raids.

Saudi state TV claimed that the airstrikes targeted military positions, including air-defense systems, in the Yemeni capital. The Saudi warplanes also conducted air raids on the city of

Harad in the province of Hajjah on Friday, al-Masirah said. There were no immediate reports on possible casualties as a result of the air raids.

Saudi Arabia launched a devastating campaign against Yemen in March 2015, with the goal of bringing the government of former Yemeni president Abd Rabbuh Mansur Hadi back to power and crushing the Houthi movement.

The U.S.-based Armed Conflict Location and Event Data Project (ACLED), a nonprofit conflict-research organization, estimates that the Saudi war has claimed the lives of over 60,000 Yemenis since January 2016.

The war has also taken a heavy toll on the country's infrastructure, destroying hospitals, schools, and factories. The UN says over 24 million Yemenis are in dire need of humanitarian aid, including 10 million suffering from extreme levels of hunger. Yemen's army and allied popular committees have carried out

various attacks on Saudi positions in retaliation for the kingdom's fatal aggression against their country.


Jonathan Moss, head of transport and shipping with law firm DWF, said the extent of geopolitical turmoil had not been seen since the U.S. war in Iraq in 2003, when underwriters increased premiums on fears of claims arising from collisions, groundings and attacks on ships and oil facilities.

"This coming year will see a drive by insurers to raise premiums in the face of a cocktail of instability in the region," Moss said. Rate increases for hull, machinery and war risks are likely to

be between 10% and 20%, he added. "Once again the international shipping industry finds itself caught in the middle of a geopolitical conflict over which it has no control," tanker association INTERTANKO said.

#### **Bowing to pressure, Hong** Kong leader suspends extradition bill

TEHRAN - Hong Kong leader Carrie Lam on Saturday indefinitely delayed a proposed law that would have allowed extraditions to mainland China, in a dramatic retreat after anger over the bill triggered the city's biggest and most violent street protests in decades.



The military said in a statement that the attack on Balad Air Base, located 64 kilometers (40 miles) north of Baghdad, took place early on Saturday and caused small fires in bushes on the base, The Associated Press reported.

#### Trump says 'it doesn't matter' if Xi attends G20

**TEHRAN** — U.S. President Donald Trump said on Friday "it doesn't matter" if Chinese leader Xi Jinping attends the Group of 20 summit later this month in the Japanese city of Osaka, predicting a trade deal with Beijing would occur at some point anyway.

"We're going to see. Eventually they're going to make a deal," Trump said in an interview with Fox News Channel.

Trump repeatedly said he would meet with Xi at the summit, although China has not confirmed the meeting. The two men last met at last year's G20 summit in Argentina, and agreed to a pause to their trade war.

Trump also said China manipulates its currency in order to avoid the squeeze of U.S. tariffs on Chinese goods.

"They're paying hundreds of billions in dollars. I have 25% on \$250 billion ... They're manipulating their currency in order to pay for it." he said.

The United States and China have been embroiled in trade tensions since last year marked by tit-for-tat tariffs on each other's imports as Washington seeks for Beijing to make changes to its business policies.

The two countries were engaged in talks in order to reach a detente, but those ended in May without a deal. Washington has accused Beijing of reneging on several promises, which China has denied.

China has ramped up its rhetoric since last month, promising to "fight to the end" in the trade war and neither give in to pressure nor compromise on its principles.

In a commentary on Saturday, an

influential and widely-read state media social media account said certain people were "creating talk of a so-called 'leaders meeting'" in the run-up to the G20 summit, **Reuters** reported.

If the United States can return to the consensus reached at the leaders' meeting in Argentina and earnestly seek to resolve China's core concerns, then it's quite possible the Osaka summit could mark a turning point, said Taoran Notes in a WeChat account run by the Economic Daily.

#### U.S., NATO war game in Baltic mirrored by Russian maneuvers

TEHRAN — The United States and its NATO allies have kicked off naval exercises near Russia's western border to counter what they describe as "Russian threat".

Thousands of U.S. and European forces and some 50 ships on the Baltic coast near Russia participated in the exercise dubbed BALTOPS, which is part of the largest U.S.-led war games in the past five years.

The annual maritime-focused exercise, which involves 18 allied and partner nations, was kicked off on Wednesday and will last until June 21.

This is the first time in four decades that the drill is being led by the U.S. Navy's 2nd Fleet, which operates in the North Atlantic and became known during the Cold War for several maneuvers.

Back in 2011, the administration of Former president Barack Obama disbanded the fleet over what it described as a diminished Russian threat.

The fleet, however, was revived in 2018 "in response to Russia's growing naval activity in the Atlantic," according to the U.S.-led NATO military alliance.



This is also the first deployment of the new U.S. fleet in Europe.

Vice admiral and commander of the fleet, Andrew Lewis, said the fleet was "reestablished in response to a changing security environment globally." He noted that "It was not specifically aimed at a country.

"Russia is a Baltic nation and we respect that," he said.

"But we, NATO, have a responsibility to maintain that international free use of the seas ... we're looking for deterrence and peaceful coexistence," he added

#### Russia conducts its own war game

Meanwhile, Russia is not only watching the U.S.-led maneuver along its borders, but mirroring the drills along its own side of the border.

On Wednesday, the Russian navy trained for the sinking of an "enemy" submarine in the Baltic Sea.

A missile strike on "enemy" ships was also simulated in the Kaliningrad region.

This has raised concern over a potential accident between the NATO and Russia in the region.

according to Press TV, Russia's Deputy Foreign Minister Sergei Ryabkov warned that the lack of trust between the U.S. and Russia as well as a lack of military-to-military contacts, have created a dangerous situation for both of them.

Russia has warned the U.S.-led NATO alliance over its decision to beef up military presence in the strategic Baltic region, saying such a move would further increase tensions.

The extradition bill, which would have covered Hong Kong's seven million residents as well as foreign and Chinese nationals there, was seen by many as a threat to the rule of law in the former British colony.

Around a million people marched through Hong Kong last Sunday to oppose the bill, according to organizers of the protest, the largest in the city since crowds came out against the bloody suppression of pro-democracy demonstrations centered around Beijing's Tiananmen Square on June 4, 1989.

Demonstrations continued through the week and were met with tear gas, bean bag rounds and rubber bullets from police, plunging the Asian finance hub into turmoil and piling heavy pressure on Lam, Reuters reported.

#### Putin gives Xi ice cream on his 66th birthday

TEHRAN — Chinese President Xi Jinping celebrated his 66th birthday on Saturday with Russian President Vladimir Putin, who Xi considers a close friend and who gave Xi ice cream as a present, Chinese state media reported.

The discussion of senior leaders' private lives is extremely rare in China, and the exact birth dates of most of them are not revealed publicly, as they are considered a state secret.

State television showed pictures of Xi and Putin holding up champagne glasses to toast Xi's birthday at the hotel he is staying at in Dushanbe, the capital of Tajikistan, where they are both attending a regional summit.

While Putin gave Xi Russian ice cream - the flavor was not mentioned - Xi gave Putin back some Chinese tea, the report said.

Xi thanked Putin and said that in China Putin was extremely popular, it added.

Pictures on Chinese state television's website showed the two men inspecting a white cake decorated with red and blue confectionary flowers with the words written on it, in somewhat shaky red-colored Chinese characters, "good fortune double six"

It was not immediately clear if Xi ate any of the cake, Reuters reported.



#### **Brazil win but fans unhappy** at lacklustre display

Brazil got the win they wanted in their Copa America opener on Friday but the postmortem of the 3-0 victory over Bolivia was as much about the lack of atmosphere as the lacklustre display.

The 46,342 fans, who turned out to see the match at Sao Paulo's Morumbi stadium were not impressed and the team were booed at halftime with the scores tied at 0-0.

The entire game at the stadium, which was 70% full, was notable for the lack of atmosphere.

Coach Tite admitted the players heard the boos and said it was not realistic to expect supporters to cheer a team that was not playing well.

We felt it!" Tite told reporters. "Young lads feel it. The coach feels it.

"Having been at big clubs, when you sometimes don't produce, then don't expect the fans to understand. They will boo. When you pass the ball along the back, from full back to central defender to goalkeeper, the first thing you here is BOOOOOO!"

"We need to understand. If we get forward and create chances then they will applaud."

Crowds in Brazil's two big cities of Sao Paulo and Rio de Janeiro are known to be notoriously fickle and captain Daniel Alves hoped the home fans would get more behind their team when they take on Venezuela in his home state of Bahia on Tuesday.

"This is normal in Sao Paulo, there are lot of fans of clubs so it's always complicated playing here, but we showed personality," Alves said.

"There was even a moment when Tite shouted and you could hear it out on the pitch.

"It's different in Bahia. People miss the Brazil team, and the energy that we bring. For sure, things will be more animated than here.'

# **Froome fractured neck in crash & faces** six weeks in hospital

Britain's Chris Froome suffered a fracture to his neck in Wednesday's serious crash, scans have shown.

The four-time Tour de France champion faces six weeks in hospital and is not expected to compete again this year.

Froome, 34, lost consciousness after the crash and also sustained a fractured right femur, a broken hip, a fractured elbow and fractured ribs.

He is likely to spend "at least six months" away from cycling, says the surgeon who operated on him. Froome had a six-hour operation, which has been described as a "success" although chief surgeon Remi Philippot said it was "difficult to be sure" on an exact length of time for his recovery.

He added: "Maybe we will need to do other things. Maybe the rehabilitation will not be as we want." Doctors have said they are are "very happy"

with Froome's progress.

The crash happened during a practice ride before stage four of the Criterium du Dauphine in Roanne, France.

In footage captured by ITV4 minutes before the incident, a team-mate tells Froome "you don't have to take risks, Chris" as he takes both hands off the handlebars to put on a jacket.



But moments later, Froome took his hand off his handlebars again to blow his nose and was travelling at 54km/h when a gust of wind caught his front wheel, causing him to hit a wall. "First things first, the surgery was a success," said Team Ineos doctor Richard Usher. "The operation, which lasted for six hours, went very well.



# Caster Semenya declines Rabat 800m race: organizers

Two-time Olympic champion Caster Semenya will not run her specialist 800m distance at Rabat on Sunday despite having received an invitation to do so, in the latest twist of her bitter court battle over gender rules.

She received an invitation but is unable to organize her schedule to come to Rabat," organizer Alain Blondel told AFP.

Semenya was cleared to take part in the Diamond League meeting after Switzerland's top court rejected an IAAF request to re-impose rules obliging her to lower her testosterone before competing in certain events.

Organizers of the Morocco event had initially refused to allow the South African to take part but on Friday they "confirmed her invitation".

After checking the situation of Caster Semenya in the light of the decisions of the Swiss Federal Court, and the Court of Arbitration for Sport, the head of the international athletics meeting in Rabat, Alain Blondel, is happy to confirm the invitation," a statement on the event's official site said.

The Swiss federal court issued their order on Wednesday, explaining "this means that Caster remains permitted to compete without restriction in the female category at this time".

The IAAF had earlier this month opposed a ruling by the court temporarily suspending the federation's rules following an appeal by Semenya who won the women's 800 meters at the 2012 and 2016 Olympics.

The athlete was contesting a decision by the Court of



Arbitration for Sport which previously found the rules were "discriminatory" but "necessary" to ensure fairness in women's athletics

The rules require women with higher than normal male hormone levels, a condition known as hyperandrogenism, to artificially lower the amount of testosterone in their bodies if they are to compete in races over distances of 400m to the mile.

#### 'I keep winning'

"No woman should be subjected to these rules," Semenya said in a statement Thursday, adding she had "thought hard about not running the 800m in solidarity unless all women

can run free. But I will run now to show the IAAF that they cannot drug us".

The athlete, who underwent a gender test shortly before she won gold at the 2009 Berlin world championships, also dismissed the IAAF's claim that it is committed to the full participation of women in sport.

"I am a woman, but the IAAF has again tried to stop me from running the way I was born," she said in the statement, pointing out the hormonal drugs she had been required to take to compete had made her feel "constantly sick and unable to focus for many years".

"No other woman should be forced to go through this," said Semenya, whose Berlin test allegedly showed she had both male and female characteristics.

Semenya took to the track at the Montreuil meeting in eastern Paris on Thursday in the rarely-run 2,000m.

The 28-year-old duly won that race, taking to social media afterwards to say: "They keep talking, I keep winning. Isn't that beautiful ...?

That tweet, accompanied by emojis of crossed fingers and a talking head, garnered more than 65,000 "likes".

Semenya, who won the 800m in the season-opening Doha Diamond League, is now slated to run the 3,000m at the Diamond League Prefontaine Classic, exceptionally being held held in Stanford, California this year, on June 30. (Source: AFP)

# The reasons behind a poor first season for Alireza Jahanbakhsh at Albion

Alireza Jahanbakhsh has begun with a bang under one new boss

Now Albion will be hoping a change at the top prompts a more productive season for record signing Alireza Jahanbakhsh.



It should not be overlooked that Jahanbakhsh's first Premier League starts coincided with Albion's most profitable period of the season, the hat-trick of 1-0 wins in October against West Ham, Newcastle and Wolves.

He opened the scoring for Iran last week in the 5-0 thrashing of Syria, which launched the reign of former Belgian coach Marc Wilmots.

Graham Potter, the new head coach at the Amex, needs to get more out of Jahanbakhsh to justify owner-chairman Tony Bloom's faith in investing £17 million in the winger last summer.

That's quite different to the Dutch league and so on where the number of games is less, the competition isn't as intense week to week, moving to a new country, adjusting in some cases to a new language, being away from close family and friends.

"All of those things combined mean sometimes the adjustment can take longer than people would imagine."

Under Hughton the wingers were required to work backwards as well as forwards. Jahanbakhsh was not used to that at Alkmaar but nevertheless adapted well.

injury in the next match at Everton, just as his season was gaining momentum.

By the time he recovered, Jahanbakhsh was off on his travels again, playing for Iran at the Asian Cup in the United Arab Emirates at the turn of the year.

Their progression to the semi-finals kept him out of contention until February. By then it was as if his season was starting all over again.

"Football-wise he wants to use the wingers and get them to create chances. It's all about looking forward and scoring goals, but he also wants to talk to the players and get the feeling of the way they like to perform.

"I am really looking forward to linking up with him and to see how he wants us to play."

One of the striking features of their campaign has been how many of the younger squad members have stepped to the fore, with Sasaki's fellow defender Hayato Araki - who scored the winner against Daegu FC on Matchday Four – among those to have taken his chance with both hands.

Sasaki, meanwhile, is one of the more experienced players within the ranks and it was the 29-year-old's goal against Guangzhou on

Matchday Five that sealed Sanfrecce's place in the knockout rounds for the first time since 2014.

"We overcame the problems we had in the first game and since then we have been able to get stronger and stronger," added Sasaki.

"Araki has already played many times in the J.League and, not only does he contribute defensively, he can also score goals.

"Overall we have been really good so far, but we have to keep focusing on every game in front of us. Having the second leg at home [against Kashima] can be an advantage, so we hope we can use it to our benefit.

countries," the Danish Ambassador vowed. Explaining about this year's European

film week, he continued to say that "since last year, The European Film festival has increased number of cities and number of participating countries by 25 percent. This shows the importance that the EUNIC cluster attach to developing cultural ties with Iran and its people.

"We strongly believe that cultural exchange is the key element to deepen our mutual understanding and create opportunities for bridge building," he noted.

"This year's Danish Contribution: 'A Fortunate Man', directed by Oscar and Golden Globe-winning director Bille August. The movie is based on a novel written by Nobel Prize Winning author Henrik Pontoppidan (won the prize in 1917). It is a social drama taking place in the late 19th century. The story is about the bright young man, who chooses to leave his devout Christian family in the western part of Denmark to go study engineering in the Capital of Copenhagen. The story raises the difficult questions, every person is bound to consider: how to deal with your roots while making your own choices in life - and whether you can, after all, ever completely turn your back on your roots. At the same time, the story is deeply socially



conscious, and lets the spectators reflect upon the significance of social structures and how each person in one way or another must relate to these during their life.

"Social drama and a social consciousness play an important role in Danish cinema, which 'A Fortunate Man' is a great example of. The last two year's contributions to the European Film Festival (The Day Will Come and The Hour of the Lvnx) also both exemplify the Danish tradition of social drama and how films can ask the difficult questions and offer new perspectives. These films can change how we relate to ourselves and the societies we live in," he added.

He in the end explained about the European Union National Institutes for Culture (EUNIC), who is in charge of running the event in Iran in cooperation with the Art & Experience Cinema Institute.

Since its founding in 2006, the national clusters of the European Union National Institutes of Culture (EUNIC) have been building trust and understanding between the peoples of Europe and the rest of the

world through culture. Denmark has been a steadfast participant in the European Film Festival here in Iran," he said.
