

## 1st section of Tehran-Shomal freeway inaugurated

**TEHRAN** – The first section of the long-awaited Tehran-Shomal freeway, which shortens the route between the Iranian capital and Mazandaran province in north, was officially inaugurated on Tuesday by President Hassan Rouhani.

The inauguration ceremony was also attended by senior officials including Transport and Urban Development Minister Mohammad Eslami. Speaking in the inauguration ceremony, Rouhani described the project as a manifestation of Iranian engineers' capabilities, adding that "Sanctions didn't influence our determination to construct the freeway."

## Rainfall increases Lake Urmia level

**TEHRAN** – Recent rainfall has increased the level of Lake Urmia to 1,271 meters, a step closer to its ecological level of 1,274 meters.

Shared between West Azarbaijan and East Azarbaijan provinces in northwestern Iran, Lake Urmia was once the largest salt-water lake in the Middle East.

However, decades of long-standing drought spells and elevated hot summer

temperatures that speed up evaporation as well as increased water demands in the agriculture sector shrank the lake drastically. In 1999 the volume of water which was at 30 billion cubic meters drastically decreased to half a billion cubic meters in 2013. Moreover, the lake's surface area of 5,000 square kilometers in 1997 shrunk to one-tenth of that to 500 square kilometers in 2013.  $\rightarrow$  9

#### The FATF blacklist and its reverse impact on stock market

I t may seem a little too soon, but I believe the world is on the threshold of facing a new kingdom, an economic one. Here is the story of The Kingdom.

Right in the middle of parliamentary elections of Iran on February 21, 2020, people of Iran were shocked by a piece of news that came just out of the blue: Iran's name goes on the FATF blacklist. For most Iranians, it seemed bad and scary, mostly because they don't know what it means. The FATF (Financial Action Task Force) is an intergovernmental organization founded in 1989 on the initiative of "G7" to develop so-called "policies" to combat money laundering and later, terrorism financing. BEING in the FATF's blacklist is not something new for Iran, but KNOWING that we are in that list, is a brand new information for most Iranians. Iran was added to The List in 2009 alongside countries like South Korea and Cuba. So yes, we were there before, but in 2015 after the Joint Comprehensive Plan of Action (JCPOA) was signed by parties, this inclusion was suspended. The FATF, as merely a supervisory structure and not an executive one, has posed different conditions on Iran to exclude the country from The List. One of them is the so-called Action Plan which includes 42 clauses. This Plan was SECRET-LY granted by Ali Tavebnia, the minister of economic affairs and finance in Hassan Rouhani's first government. In fact, out of 42 clauses, 38 are already effective and in process. The entire controversy is over the remaining 4 and once the rest of these clauses are taken in, members of the FATF should decide whether or not Iran will be excluded from the list. Guess who is seating there to decide? Israel, next to the U.S. and Saudi Arabia... But here is the question: if being in a blacklist, in any blacklist, is bad, then why Iranian Stock Exchange index skyrocketed just one day after the blacklist monster was unleashed? Howcome the reactions were not so promising in other markets like gold or currency? The math is simple: The Blacklist lets the genie out of the bottle!  $\rightarrow$  7

#### Saudis see Trump as unpredictable and fear who might be the next American president: Askari

**TEHRAN** — Professor Hossein Askari, an expert on Saudi Arabia who also teaches international business at the George Washington University, believes that "The Saudis see Trump as unpredictable and fear who might be the next American President."

"Open up a small channel with Iran in case it is needed given the unpredictability of U.S. foreign policy," Hossein Askari, who served as special advisor to Saudi finance minister, tells the Tehran Times.

Following is the text of the interview:

The Lebanese newspaper Al-Banna disclosed that Saudi Arabia had expressed willingness to negotiate with Iran after the Aramco oil facility incident, but it was ultimately the Americans who prevented Riyadh from fulfilling its demand. How effective do you think America is in affecting such decisions in Riyadh?

A: Historically, Saudi Arabia would never think about negotiating with Iran before two conditions were met. The King was convinced that Iran was not bent on overthrowing the Al-Sauds, a paranoia that has poisoned rapprochement between the two countries. And second, America's concurrence about a dialogue with Iran as the Kingdom is totally dependent on the United States for its self-defense. After the Iran Nuclear deal in 2015 (JCPOA), the Al-Sauds had second thoughts about relying on American support. Could they continue to depend on the United States? But when Trump became president and after his trip to Saudi Arabia, the Al-Sauds became emboldened. They felt they could do anything in the region because Trump had their back. But after the Aramco incident, when Trump did not retaliate against Iran for its alleged role, the Al-Sauds became weak in their needs. They had second thoughts. They were willing to hedge their bets. I don't know, but I think the U.S. did not want any dialogue that would weaken its hands in dealing with Iran in the future.

In your opinion, what groups within Saudi Arabia are in favor of dialogue with Iran, and what groups oppose this? In general, the question is whether internal disputes within Saudi Arabia itself determine whether or not to negotiate with Iran.  $\rightarrow$  7

Many predicted the bill to create serious problems for the country's economy in the upcoming year.

Now that the bill has also been rejected by the members of parliament, it is time to take a more detailed look into the budget bill to see what the reasons for such a unanimous rejection could be.

#### Oil revenues

The first and most important objection to the budget bill was regarding the unrealistic estimations of the country's oil revenues considered in preparing the draft.

Iran's next budget bill has been set based on the prediction of selling one million barrels of oil at \$50 per barrel, however, many believe that due to the U.S. sanctions on the country's oil industry, the Iranian government will not be able to realize this prediction.

The submitted bill has envisaged a total of 2.61 quadrillion rials (about \$62.14 billion) of incomes, while revenues from exporting oil, gas, and gas condensate are estimated at 454.9 trillion rials (about \$10.83 billion).

These numbers have been opposed by many of the MPs for being unrealistic since the country is currently facing some problems for its oil exports and also the demand for oil is significantly falling in the global markets.

"Unfortunately, the next year's budget includes unrealistic numbers for oil sales, but we have to be realistic and base the budget on realistic figures," an MP said.

#### Tax incomes

The government has envisioned various strategies for compensating a probable deficit in the next year's budget due to the fall in oil revenues.  $\rightarrow 4$ 

**TEHRAN** — A countdown for the formation of a new Iraqi cabinet has begun. Iraqi parliamentarians were due to hold a meeting to discuss the cabinet formation and vote of confidence on Monday, but it did not happen.

In this regard, Iraqi parliament sources said that an extraordinary session to examine the cabinet of Iraqi Prime Minister-designate Mohammed Tawfiq Allawi is postponed to Wednesday. The first deputy speaker of the parliament, Hassan Karim al-Kaabi, announced that the extraordinary session of the Iraqi parliament will be held on Wednesday instead of Monday to discuss Allawi's efforts to form a new government.

Head of the Parliamentary Bloc Hisham Al-Suhail called on the Prime Minister-designate to and not to rush until reaching an agreement that satisfies all parties.

However, the latest news and reports on the process of proposing cabinet to the parliament indicate that most cabinet members entered the final phase and the prime minister-designate is ready to submit the lineup to the parliamentarians.

Accordingly, it is expected that the process of presenting the new Iraqi cabinet to parliament will be finished on Wednesday, and political disputes over the nomination of some as ministers will end.

Meanwhile, foreign political pressure on Baghdad to prolong the presentation of new cabinet cannot be ignored. The U.S. has exerted political of new government.

About two weeks ago, the U.S. has agreed to extend a waiver for Iraq to import Iranian energy supplies for 45 days, while Washington has repeatedly extended the exemption for periods of 90 or 120 days.

By this action, the U.S. is in fact applying political pressure on Allawi to disrupt the formation of new government and make him to distance from the Islamic Republic of Iran.

Another factor that has obstructed the formation of new cabinet is political disputes. In this connection, Iraqi activist Alaa al-Khatib, a person close to the prime minister-designate, said that The Kurdish Democratic Party (KDP),  $\rightarrow$  7

The statement said that after 25 days of non-stop sailing and hoisting Iran's flag in international waters, the fleet berthed at Jakarta port

In the meantime, Captain Ehsan Nasiri, the fleet commander, said that the fleet will stay in Jakarta port city for three day.



He added, "Holding meetings with the senior Indonesian navy commanders and managing sports competitions with the hosting country's navy staff are among programs of the fleet during its stay in Jakarta.'

The fleet, including Khark helicopter-carrier and Bayandor destroyer, left the Iranian port city of Bandar Abbas in early February

In recent years, Iran's naval forces have increased their presence in international waters to secure naval routes and protect merchant vessels and oil tankers against pirates.

In line with international efforts to combat piracy, the Iranian Navy has also been conducting anti-piracy patrols in the Gulf of Aden to safeguard the vessels involved in maritime trade, especially ships and oil tankers owned or leased by Iran.

#### **Rouhani: Coronavirus** outbreak will be reined in soon

## Urgent action needed to lift medical bans on coronavirus-hit Iran, physician tells WHO

**POLITICAL** d e s k **TEHRAN** — A top Iranian physician and media activist has urged the World Health Organization to take urgent action to help lift medical sanctions against Iran as the country is struggling to contain a rapid outbreak of the novel coronavirus.

Humanity demands action today; otherwise, the vulnerable will pay the price," Dr. Abolfazl Fateh said in a letter to WHO director Tedros Adhanom Ghebreyesus.

Following is the text of the letter:

As you are aware COVID-19 has placed the world in a dangerous epidemic and all the forecasts indicate the very fast spread of the virus. As the World Health Organisation declared a global health emergency on 31st January, it seems that we are only just dealing with the tip of the iceberg. News from Iran indicates that so far, tens, probably even hundreds of people have been infected with COVID-19.

Iran has an advanced healthcare capacity and system however, as you are aware, the country is under unprecedented and extreme sanctions put in place by the United States of America. Due to the harsh conditions and the spread of the population of 80 million in such a large territory, along with its borders; it is evident that they are short of the required resources and equipment for diagnosis, prevention and treatment, especially laboratory kits, masks N-95, protective gowns for medical staff, ambulances, specialised medicines, antiseptics and appropriate medical supplies; in addition there is also a need for the latest information on successful trials in combating this virus.

Health, hygiene and access to medical care are the fundamental rights of all the human beings regardless of race, religion, and nationality.

As an Iranian physician and senior media activist residing outside of Iran, I sincerely seek your urgent attention for the sanctions on providing healthcare support, drugs,



medical laboratory kits and preventive equipment to be lifted immediately.

Iranians living outside the country are willing to send humanitarian support in such a difficult situation for the impacted population, however due to the sanctions, it is not possible to do so.

It must be brought to the attention of other global organisations not to overrule the healthcare rights through political considerations.

I firmly believe this is the request of a vast majority of Iranians living abroad.

Clearly, any delay in removing the sanctions on healthcare support will result in countless innocent and vulnerable people losing their lives.

It is our humane duty to do the right thing immediately and not to carry over the tragic consequences.

Humanity demands action today; otherwise, the vulnerable will pay the price.

I sincerely hope that you take the action needed to combat the sanctions on healthcare that Iran faces, and do not let health care become politicized and the political pressure take innocent lives.

#### Govt. must continue efforts to reduce consequences of FATF blacklisting: analyst

**POLITICAL TEHRAN** — Mehdi Motaharnia, a political analyst, has said that the government must continue efforts to reduce consequences of being blacklisted by the Financial Action Task Force (FATF).

"We have to study the current situation, restrictions and destructive consequences in order to be able to reduce the consequences," he told ISNA in an interview published on Tuesday.

He noted that 80 percent of international trade are done under regulations of the FATF and being blacklisted will cause restrictions on economic and banking transactions. President Hassan Rouhani said on Sunday that Iran

has been a forerunner in fighting money laundering and did not deserve to be blacklisted by the FATF.

The great Iranian people and the Islamic Republic of Iran did not and do not deserve to be placed on an international body's countermeasures list while it [the country] is forerunner in fighting terrorism and money laundering," he said during a cabinet meeting. He added, "We made efforts to prevent being introduced

by the United States and the Zionist regime as violator of these measures while we are forerunner in fighting terrorism and money laundering."

Being blacklisted by the FATF is against the Iranian people's interests, the president remarked. "As it was expected, it made the United States happy

and will justify intensification of cruel and inhumane sanctions. Now, those who gave pretext to the United States must be accountable for their unprofessional position," Rouhani asserted.

The FATF on Friday placed Iran on its blacklist after Iran refused to comply with all requirements of the body. According to Reuters, the FATF appeared to leave

the door ajar for Iran saying "countries should also be able to apply countermeasures independently of any call by the FATF to do so."

"Those who impeded procedure of joining the FATF must be accountable for pressure and the future situation and be responsible for being blacklisted," he said.

Kourosh Ahmadi, an expert on international affairs, has said that the way to get removed from the FATF blacklist is open to Iran.

"Removal from the FATF blacklist is open for Iran. It We can just continue the job from where it was stopped. One case is joining the CFT and the Palermo bill," he told IRNA in an interview published on Sunday.

He noted, "The FATF has mentioned six points to remove Iran from blacklist and one of them is joining the CFT and the Palermo bill. Other points includes technical and legal issues with which Iran has no problem."

Foreign Ministry spokesman Abbas Mousavi said on Friday that the blacklisting of Iran is "politically motivated".

"Unfortunately, what happened is politically motivated which exists in the international mechanisms by the United States, Saudi Arabia and the Zionist regime of

He noted that Iran can never be labeled with money laundering and financing of terrorism.

The U.S., the Zionist regime and Saudi Arabia had made great efforts to pressure the international body to blacklist Iran.

However, Abdolnasser Hemmati, Iran's central bank governor, has argued the move will not affect the Iranian foreign trade and stability in foreign exchange market.

'The performance of the central bank over the last year has given this assurance to the people that such events will not create problems for Iran's foreign trade and stability in foreign exchange market," Hemmati wrote on his Instagram page immediately after Iran was put on the blacklist.

Hemmati said such "political and unprofessional" behaviors toward Iran has been continuing against Iran since the summer of 2016.

He said the representatives of the U.S. and its allies at the FATF had been focused on undermining expert reports about the great steps taken by Iran in line with the FATF requirements.

The FATF said in October 2019 that it has given Iran a final deadline of February 2020 to tighten its laws against money laundering in compliance with the global watchdog's financial standards.

"If before February 2020, Iran does not enact the Palermo and Terrorist Financing Conventions in line with the FATF Standards, then the FATF will fully lift the suspension of counter-measures and call on its members and urge all jurisdictions to apply effective counter-measures, in line with recommendation 19," the FATF said in a statement.

In November 2019, Gholamreza Mesbahi-Moghadam, a cleric member of the Expediency Council trained in economy, said, "In a situation in which the country is under the most severe sanctions, joining such conventions is (synonymous with) self-inflicted sanctions. In the situation in which the United States seeks to limit the

#### Hit-and-run shooting kills a person, injures another one in southwestern Iran

Mohsen Beiranvand said, "Following an announcement by the police emergency center (110) over a shooting near Nasr mall in an industrial area in Mahshahr, the policemen arrived at the scene."

"One person was murdered at the scene and another one sustained serious injury who was immediately transferred to the nearest medical center," he added.

Beiranvand went on to say that a team of policemen are investigating the incident.

Eyewitnesses also reported that the assailants, in a Pride passenger car, opened fire at two young people before noon, February 25, leaving one of the young men killed and another injured.

The shooting, reportedly, was due to personal conflicts.

#### Iran: Countries imposing medical bans not qualified to be HRC members

(**Press TV**) — The head of the Iranian Judiciary's High Council for Human Rights says countries imposing sanctions on supply of medicine to Iran are "murderers of human beings" and lack qualification to be members of the UN Human Rights Council (HRC).

Ali Bageri-Kani made the remarks while addressing the 43rd session of the Human Rights Council in Geneva, Switzerland, on Monday, where he described the unilateral sanctions imposed by the United States on Iran as the "most recent grave and systematic violation of human rights."

Emphasizing that "the Iranian nation is the major victim of such a violation,' Bageri-Kani said, "The United States has created an international sanction regime which amounts to a systematic violation of human rights at an international level.'

This new policy in practice has prevented the access to medicine and basic needs by those who are in need," the Iranian rights official said, adding, "Those who impose sanctions on medicine are not only violators of human rights but also murderers of human beings. And those who impose sanctions on life-saving medicine are not eligible to be a member of the Human Rights Council."

Refuting U.S. claims that its anti-Iran sanctions do not cover supply of medicine, the official said, "Although the US claims that basic needs such as pharmaceutical and commodities are not sanctioned, access to the most basic human needs are



blocked due to the sanctions imposed on international financial transactions and banking.

Baqeri-Kani slammed U.S. allies and some other countries for following the US sanctions policy against Iran and said, "To preserve their political and economic benefits, many states that may not approve such sanctions, not only have failed to oppose such inhuman treatment, but also supported these policies by succumbing to them."

"These acts are not only the collective punishment of a nation, but also a modern method of violation of human rights, which should be put high on the agenda of the Human Rights Council," he added. The U.S. returned its sanctions against Iran in 2018 after leaving a historic nuclear accord -- officially known as the Joint Comprehensive Plan of Action (JCPOA) signed between Iran and major world powers. The measures defied the agreement's multilateral nature and the fact that it had been ratified by the United lations Security Council.

Washington then began forcing other parties to toe its sanctions line. The three European signatories to the deal -- Britain, France, and Germany -- have stopped their transactions with the Islamic Republic,

bowing under the pressure.

Switzerland late in January launched the so-called Swiss Humanitarian Trade Arrangement (SHTA), claiming it was aimed at facilitating the medicine trade, reportedly using the Central Bank of Iran's credits. Swiss officials have, however, refused to clarify how such transactions would continue if the CBI ran out of credit with Swiss banks.

Iranian Foreign Ministry Spokesman Abbas Mousavi on February 3 dismissed as insufficient the Swiss-U.S. "humanitarian" channel, arguing that the United States is originally banned by the International Court of Justice from subjecting Iran's much-needed medical supplies to sanctions.

"We do not recognize any such so-called humanitarian channel. We do not recognize sanctions [for that matter]. Medicine and foodstuffs were never subject to sanctions in the first place so they can now create a channel [for their transfer] with much publicity," he added.

An NGO reported in November 2019 that Iranian children suffering from a rare skin condition known as EB are losing their lives as US economic sanctions hamper the flow of vital medical products.

Hamid Reza Hashemi-Golayegani, the head of the NGO that helps such patients, said that at least 15 Iranian children with epidermolysis bullosa (EB) have died since the US launched its new sanctions on Iran in August.

## Zarif: Coronavirus, like terrorism, knows no bounds

POLITICAL TEHRAN — Foreign d e s k Minister Mohammad Javad Zarif has said like other viruses, including terrorism, coronavirus knows no borders, calling for more regional cooperation to combat it.

"Like other viruses - incl terrorism -#COVID19 knows no borders and doesn>t distinguish between ethnicities or faiths,' Zarif said on Tuesday in a tweet.

'To combat it, neither should we," he said, adding, "In line with #HOPE, Iran calls for more regional cooperation incl long overdue Joint Center for Disease Control & Prevention." Iran is one of the countries inflicted with

the novel coronavirus, scientifically known as COVID-19.

Health Minister Saeed Namaki has said effective measures have been taken and comprehensive plans are underway to get rid of the novel coronavirus in the country.

Iran has put in place a set of contingency plans, including the temporary shutdown of schools, universities and cultural centers, to curb the coronavirus outbreak that by Tuesday afternoon had claimed at least fifteen lives in the country.

"With regard to the past experience, I say that we will defeat the coronavirus before



long," the minister said on Sunday.

"As a veteran soldier in the Iranian health front, I have taken the responsibility of removing measles, tetanus, and polio which astonished the World Health Organization as the country is grappling with sanctions with no international support. So, I [definitely] say that we will defeat the coronavirus."

Meanwhile, the head of the Iranian Judiciary>s High Council for Human Rights has said countries imposing sanctions on supply of medicine to Iran are "murderers of human beings" and lack qualification to be members of the UN Human Rights Council (HRC).


dressing the 43rd session of the Human Rights Council in Geneva, Switzerland, on Monday, where he described the unilateral sanctions imposed by the United States on Iran as the "most recent grave and systematic violation of human rights.'

Emphasizing that "the Iranian nation is the major victim of such a violation," Bageri said, "The United States has created an international sanction regime which amounts to a systematic violation of human rights at an international level."

"This new policy in practice has prevented access to medicine and basic needs by those who are in need," the rights official said, adding, "Those who impose sanctions on medicine are not only violators of human rights but also murderers of human beings. And those who impose sanctions on life-saving medicine are not eligible to be a member of the Human Rights Čouncil."

Refuting U.S. claims that its anti-Iran sanctions do not cover supply of medicine, the official said, "Although the U.S. claims that basic needs such as pharmaceutical and commodities are not sanctioned, access to the most basic human needs are blocked due to the sanctions imposed on international financial transactions and banking."

#### Coronavirus outbreak will be controlled next weeks: civil defense chief



**TEHRAN** — The chief of Iran>s Civil Dek fense Organization said on Tuesday the Iranians' national resolve is to overcome the coronavirus outbreak, noting the situation will be brought under control over the next weeks

"Controlling the epidemic situation resulting from coronavirus should be paid attention from two different aspects of field reality and public opinion," Brigadier General Gholamreza Jalali said.

"Fortunately, a form of national will and coordination has been created at the highest level of the country's management system which has resulted in partial controlling of coronavirus outbreak nation-wide," Jalali explained.

"The mentioned control is meant that we will witness a decline in the number of the virus-affected people," the general explained.

The general also said it is unfair to question the performance of the Health Ministry and call its officials "liar".

"Calling the country's health sector as liar and inefficient and spreading panic among people are the techniques used by the enemies' media outlets," he further said. On Monday, Ali Rabiei, the government spokesman,

condemned any move to politicize the outbreak of coronavirus, scientifically called COVID-19, urging political groups, parties and media outlets to refrain from making baseless

accusations against the Health Ministry officials.

Rabiei pointed out that outbreak of coronavirus is a health issue and "we must trust the physicians".

He added, "I have called on the entire political parties, groups and media outlets to refrain from politicizing coroavirus outbreak."

He said people should help the health sector more than ever and observe Health Ministry's instructions in their daily life and social activities.

Touching upon the government's firm will to control and root out coronavirus in the country, Rabiei said, "The session of anti-coronavirus headquarters, presided by President Hassan Rouhani, will be held on Tuesday.

Coronavirus, officially known as COVID-19, appeared first in the Chinese city of Wuhan in December and has since spread globally. The World Health Organization has declared it a global health emergency. According to Kianoush Jahanpour, the head of the Health

#### Ways and means to improve situation around nuclear deal to be discussed: Russian diplomat

#### Moscow sees JCPOA Joint Commission as opportunity for de-escalation

**POLITICAL TEHRAN** — Russian Foreign Minister e s k Sergey Lavrov says Wednesday's Joint Commission meeting of the JCPOA would be an opportunity to stop the escalation of tensions surrounding the Iran nuclear agreement.

"Tomorrow, Vienna should host the meeting of the Joint Commission of the JCPOA participants. This is a chance, although not a 100 percent one, but still a chance to stop the process of escalation until it is too late," Lavrov said on Tuesday at the Disarmament Conference in Geneva, according to Sputnik.

Russian Deputy Foreign Minister Sergey Ryabkov will represent the country at the meeting.

Earlier on Monday, Iranian Foreign Ministry spokesman Abbas Mousavi said that the Wednesday meeting of the commission will be a 'regular and periodic session' led by deputy foreign ministers and political directors.

The spokesperson also emphasized that the upcoming session will have no connection with the JCPOA's dispute

resolution mechanism.

The JCPOA was struck between Iran and the five permanent UN Security Council members - the United States, Russia, China, France, and the UK – as well as Germany and the European Union.

The accord came under increasing strain ever since U.S. President Donald Trump announced the U.S. withdrawal from it in May 2018 and unleashed the "toughest ever" sanctions against Iran despite worldwide objections.

On May 8, exactly one year after the U.S. abandoned the deal, Tehran announced that its "strategic patience" is over and began to partially reduce its commitments to the agreement at bi-monthly steps.

The move was intended to push European countries to salvage the JCPOA from U.S. pressures. Iran argued that the three European members of the deal, namely France, Britain, and Germany, have done nothing of value to protect Iran's benefits from the deal.

Finally, Iran announced in January that it is taking the



last and final step to suspend all of its commitments to the JCPOA. The decision was based on Europe's failure to keep up its part of the deal, but Tehran clarified that it will return to the deal as soon as Europe fulfills its obligations.

#### China signals more easing to shore up economy

China's top leaders signaled they are planning to increase stimulus this year through fiscal and monetary policy, as the coronavirus outbreak hammers the world's second-biggest economy.

At a meeting chaired by Chinese President Xi Jinping last Friday, officials pledged to be more "proactive" in using fiscal policy and exercise "more flexibility" in monetary easing.

The wording indicates a greater easing bias compared with the stance that was endorsed at a top-level economic meeting last December, where the Communist Party leadership laid out stimulus plans for this year.

In a separate statement from the central bank over the weekend, eputy governor Liu Guogiang said the People's Bank of China (PBOC) will free up part of the reserves of some commercial lenders to unleash long-term funding to the economy, and consider adjusting the benchmark deposit rate at an appropriate time. The coronavirus outbreak has forced officials to keep millions of people at home and away from work, impacting businesses both big and small - which have suspended or limited operations. The epidemic is weighing on an economy that was already growing at its slowest in three decades, with ratings company S&P Global warning that a prolonged public health crisis could cause the bad loans ratio in China's banking system to more than triple. The "rate cut, if rolled out, may not be a big one," Mr. Ting Lu, chief China economist at Nomura International in Hong Kong, wrote in a note. The "current benchmark deposit rates are quite low anyway. Cutting the reserve requirement ratio, using lending facilities like pledged supplementary lending to fund loan extensions, tax cuts, rent cuts and interest payments should be much more effective in the current situation.3

## **Industry minister holds** talks with manufacturers of heath products amid coronavirus outbreak

## Why Majlis rejected the budget bill?

 $1 \rightarrow$  One of the major measures provisioned for such compensation is said to be increasing the tax revenues.

Tax incomes are predicted to be 1.95 quadrillion rials (about \$46.42 billion) in the next year's budget bill, rising 27 percent from 1.72 quadrillion rials (about \$40.95 billion) envisaged in the present year's budget.

Considering the current economic situation, the question is how much of this revenue can be realized; is the taxpaying population going to expand or tax evasions are going to be eliminated or is the Iranian National Tax Administration (INTA) seeking to put more pressure on existing taxpayers?

Some MPs believe that the envisioned tax income is not in line with the provisions of the country's Sixth Five-Year National Development Plan (2016-2021).

"Every year's revenues must be set based upon an estimation of the one-sixth of the total revenue envisaged in the country's national development plan, and this year's budget bill is far from such an estimation," an MP said.

Another issue that was raised by MPs about the tax section of the bill was regarding the current situation of the country's factories and producers as major taxpayers

"Our producers are facing many problems for importing their required raw materials and machinery and their production has reduced significantly, so how they are going to pay more tax?" said another MP.

Selling government assets

The government has suggested selling its excess assets as



another source for offsetting the next year's budget deficit, however, parliament members are not convinced that such a program could be fully realized.

In the next year's budget bill, it has been estimated that the government would gain 490 trillion rials (about \$11.6 billion) from the sales of its assets.

However, although last year the government had set a much lower target for the sales of its assets, unfortunately, it couldn't be realized.

In addition to the transferring assets, using forex reserves, selling Islamic bonds, and withdrawing 450 trillion rials (about S10.714 billion) from National Development Fund, were also among the strategies suggested for compensating budget deficits.

"This figure is more than double the previous year's total development performance, we are putting the country's future on sale," an MP stressed.

#### People's livelihood

In the next year's budget bill, the basic salary for workers has been set to be 24 million rials (about \$570), 15-percent more than last year's basic salary.

Many MPs believe that the 15 percent rise which has been envisioned for all workers equally is not fair for all classes of the society

Considering the inflation rate this amount of increase is not going to be even nearly enough, an MP said.

The government is also going to combine the cash subsidies which was paid to people in the form of two packages, one 450,000 rials (nearly 11 dollars) and one 2,000,000 rials (nearly 48 dollars) for each person, and provide each person with only one 700,000 rials (about 16 dollars) to reduce the government's expenditures.

The combination of cash and livelihood subsidies would nearly halve the figure, which will make people unhappy next year," said an MP.

#### TEDPIX, IFX on rising trend

ECONOMY TEHRAN – TEDPIX, d e s k the main index of Tehran Stock Exchange (TSE), rose 14,778 points to 518,513 on Tuesday, after it notches the ever-high record of one million points on Monday, IRNA reported.

As reported, over 8.16 billion securities worth 52.914 trillion rials (about \$1.25 billion) were traded at TSE on Tuesday. The first market's index climbed 9,754

points and the second market's index went up 34,466 points.

Indices of Persian Gulf Petrochemical Industries, Mobarakeh Steel Company and Golgohar Mining and Industrial Company mostly contributed to the TEDPIX growth during the Tuesday trades.

Tehran Stock Exchange has been ranked as the second best performer among the members of the World Federation of Exchanges (WFE) in terms of the main index growth during the 12-month period of De-



According to the TSE's office of public relations, TEDPIX registered a growth of 133 percent in the mentioned time span to become the second-best performer after Jamaica Stock Exchange.

On Tuesday, IFX, the main index of Iran's over-the-counter (OTC) known as Iran Fara Bourse (IFB), also rose 139 points to 6.691. as 2.62 billion securities valued at 26.346 trillion rials (about \$627.2 million) were traded at this market.

#### Housing price climbs 3.8% in Tehran City

ECONOMY TEHRAN – Housing price rose 3.8 percent in Tehran City during the past Iranian calendar month of Bahman (ended on February 19), compared to its previous month, ISNA reported on Tuesday.

The housing price has also climbed 43 percent in the capital city in Bahman of this year from the same month in the previous year.

As reported, the number of real estate deals increased 25 percent in the past month from its preceding month and 42 percent from the same month of the past year.

Two month ago, Deputy Transport and Urban Development Minister for Housing and Construction Affairs Mahmoud Mahmoudzadeh had said that the government was planning on launching a national real estate and housing system, aimed at controlling the country's housing and real estate market by the end of the current Iranian calendar year (March 19, 2020).

"In order to control and regulate the real estate market, the Ministry of Transport and Urban Development is following four major programs which include taxing vacant houses, completing Mehr housing units, constructing and supplying new housing units through the National Housing Plan and finally setting up a professional real estate and housing system," the official explained.

According to Mahmoudzadeh, one of the main goals of establishing this system is to identify vacant and unused houses in order to receive tax from the owners.

"The system will be able to bring back 2.6 million vacant housing units into the real estate market, and consequently affect the rent prices significantly," he said.

On the sidelines of the committee meeting, the two sides' businessmen and entrepreneurs discussed and followed up on expansion of economic relations.

#### The ECB is in for a Covid-19 shocker

Last week, new data showed that the eurozone economy had seen an encouraging rebound in February, as activity in the services sector expanded strongly, while manufacturing slowed less than expected. However, the disruptions from the Covid-19 epidemic look set to hit the region's businesses hard, especially as the number of cases outside of China grows.

The European Central Bank (ECB) and euro region finance ministers have seemed oddly sanguine in recent weeks, but that's likely to change soon.

The rosy figures sparked optimism that the euro area may be emerging from a soft patch at the end of 2019. The region's economy expanded by a mere 0.1 percent in the last three months of last year, as France and Italy both contracted. The new Purchasing Managers' Index (PMIO readings for Germany's manufacturing industry - which touched 47.8 in February from 45.3 last month - were particularly encouraging. This sector had shrunk substantially at the end of last year, raising fears that Germany could soon head for a recession.

The trouble is that these indicators are unusually noisy. PMI indices incorporate a number of gauges, which are both backward- and forward-looking. Unfortunately, some figures that predict future activity - such as new foreign orders - were particularly weak. A possible interpretation is that the damage from the spread of the virus outbreak is not yet fully visible in the data.

Moreover, the outbreak appears to be spreading fast. The number of infected individuals in China has risen to above 79,000, with more than 2,500 fatalities. Europe, which had been spared largely, has seen a steep increase in the number of cases: In Italy, it climbed in just a few days to more than



130. The country's government had to take some dramatic measures, including the cancellation of Venice's Carnival celebration and suspending schools and other public spaces in a number of northern regions.

Propping up the global economy

Until now, policymakers had displayed little sense of hurry. At the weekend, finance chiefs and central bankers from the world's largest 20 economies failed to put in place a concerted set of measures to prop up the global economy, as they only agreed to a "menu of policy options" if conditions worsen amid the virus outbreak. Last Tuesday, eurozone finance ministers had approved a joint policy recommendation that alluded to some form of fiscal expansion if the slump deepens. However, it is unclear when the boost would

actually occur or how forceful it would be. Germany's politicians appear particularly reluctant to open their purse. The German economy is now one of the worst performers in the currency area, and yet its leaders continue to rack up fiscal surpluses.

The ECB has also been surprisingly upbeat recently. At the last press conference, its president Christine Lagarde displayed excessive optimism that inflation was edging closer to the central bank's target of close to but below 2 percent. On Friday, Philip Lane, the ECB's chief economist, said he still expected the impact from the virus to be "V-shaped", meaning there would be an economic contraction followed by a rapid expansion. The implication is that the central bank could just look through such weakness, since it would be largely temporary

So far, the fears for the global and European economies were largely the product of what was happening in China, a large export market for European businesses and is deeply rooted in their supply chains. However, there will now be serious consequences for domestic demand and supply too.

The outbreak in Italy has occurred between Lombardy, Emilia-Romagna and Veneto - the country's industrial heartland. As people choose to stay at home and travel less, this is bound to impact local services.

# Iran's gas output to hit record high by mid-March: Zanganeh

**E N E R G Y TEHRAN** – Iranian Oil d e <sup>s k</sup> Minister Bijan Namdar Zanganeh said on Monday that the country's daily gas production is going to reach one billion cubic meters (mcm) by the end of the current Iranian calendar year (March 19) when all the South Pars phases go operational

"Today, Platform A of Phase 13 of South Pars Gas Field was installed which is the latest phase in South Pars development project and the last platform of this phase will be installed by the yearend," he said after a meeting with the chancellors of oil industry universities.

After the installation of the phase 13 platforms, all the 27 platforms of the giant gas field's phases will be installed completely and the country gas output will reach a new high, the minister said.

South Pars gas field, which Iran shares with Qatar in the Persian Gulf, covers an area of 9,700 square kilometers, 3,700 square



kilometers of which, called South Pars, are in Iran's territorial waters. The remaining 6,000 square kilometers, called North Dome,

Oil prices rise on bargain-hunting; virus fears cap gains

Oil climbed on Tuesday as investors sought bargains after crude benchmarks slumped almost 4% in the previous session, although concerns about the coronavirus spreading out of China and curbing major economies and fuel demand capped gains.

Brent crude rose 49 cents, or 0.9% to \$56.79 a barrel by 0751 GMT, after slipping 3.8% on Monday.

U.S. crude futures gained 42 cents, or 0.8%, to \$51.85, recovering from a 3.7% drop in the previous session.

'Because we've seen a very significant fall in case of West Texas, from above \$60 to touch below \$50 (over the past six weeks), I think oil has largely reflected a lot of risk, unlike other markets," Michael McCarthy, chief market strategist at CMC

Markets, told Reuters over the phone. Crude markets are also close to an important technical support level between \$49.50 and \$50 a barrel for WTI and between \$54.50 and \$55 for Brent, McCarthy said.

"For this week, key factors are coronavirus, inventory data and the technical picture," he said.

Demand concerns savaged prices for oil and a whole swathe of commodities on Monday, while both U.S. and European equities suffered their steepest losses since mid-2016.

Asian share markets were trying to stabilize on Tuesday after a wave of early selling petered out and Wall Street futures

managed a solid bounce.

In the United States, crude oil inventories were seen building for a fifth straight week, while refined products likely fell, a preliminary Reuters poll on the expectations for the week ended on Feb. 21 showed on Monday

Countries around the world are stepping up efforts to prevent a pandemic of the flulike SARS-CoV-2 virus originating from China late last year that has now infected more than 80,000 people, 10 times more than the SARS coronavirus of 2002/2003.

"Fears that the rapidly-spreading coronavirus outside of China could lead to a bigger-than-anticipated impact on global economy and oil demand will likely keep weighing on market sentiment," Satoru Yoshida, a commodity analyst with Rakuten Securities said.

Saudi Aramco expects the coronavirus impact on oil demand to be short-lived, however, and for consumption to rise in the second half of the year, Chief Executive Amin Nasser told Reuters on Monday.

On Tuesday, Saudi Arabia's Minister of Energy Prince Abdulaziz bin Salman said that OPEC+ should not be complacent about the coronavirus.

Indonesia's oil and gas output set for drop: analysts

Indonesia's oil and gas output is expected to contract for a fourth consecutive year in 2020, as aging fields and delays to new projects keep production levels below government targets, analysts said.

The output decline comes as Jakarta proposes a new law and aims to set up a special state vehicle aimed at reducing red tape and attracting foreign investment into the industry.

Details on the new initiatives remain scant but analysts said it could take years to boost energy exploration and production in Southeast Asia's largest economy.

Indonesia's crude oil output has been declining for years, from a peak of more than 1.5 million barrels per day (bpd) in the mid-1990s to below 800,000 bpd now as key fields run dry.

Oil output in 2019 was 3.7% below target while gas output dropped 15.2% below target due to field curtailments, pipe leaks and dozens of unplanned field shutdowns, according to SKK Migas.

"We are forecasting a 6% decline in liquids, and a 2% drop in gas output for 2020," said Andrew Harwood, Wood Mackenzie's research director for upstream oil and gas in Asia Pacific.

"Any increase from new projects will be offset by declines at Chevron's Rokan PSC, Pertamina's Mahakam block, and Pertamina's wider operations across Java and Sumatra." Pertamina will take over the Rokan block

from Chevron next year, but Indonesia's oil



Pertamina drills further on the block." Rystad Energy analyst Prateek Pandey said.

"Given this lackluster outlook, it is imperative for Indonesia's oil and gas production that Pertamina reduces sanctioning hurdles that have long delayed many of its projects, and implements advanced enhanced oil recovery technology on its mature fields,<sup>3</sup> he said.

The only promising project commencing operations this year is Eni's Merakes gas development, which analysts say may reach 60,000 barrels of oil equivalent production per day once at full capacity - deemed at least a year away.

Even if the new is passed, any revival in output may take years to materialize due to lingering investor worries about Indonesian resource nationalism

"I don't know what's going to happen in five years from now, or three years from now when the campaign for the next presidential elections kicks off again," Harwood said. (Source: oedigital.com)

#### Cutting collective oil output

OPEC and its non-OPEC allies, led by Russia, will meet in Vienna on March 5-6 but there is uncertainty over whether the entire group will agree to cut their collective oil output further with rumors that Russia is still undecided. As it stands, the alliance has reduced its total oil output by 1.7 million barrels a day in a bid to stabilize oil prices.

The technical committee of OPEC+ met earlier in February to debate a possible oil output cut but the meeting ended with no solid recommendation.

The Saudi minister referred to a statement made last week by his Russian counterpart, Energy Minister Alexander Novak, in which Novak said Russia had not yet made a decision on any further cut and that it continued to discuss the matter with its **OPEC** partners

Prince Abdulaziz said the statement showed that Novak remains "positively engaged." "I'm confident of our partnership as OPEC+, I'm confident that everyone in the OPEC+ is a responsible and responsive producer."

Oil prices steadied on Tuesday after crude benchmarks slumped almost 4% in the previous session on concerns over the impact of the coronavirus on already dented global demand and a build in U.S. crude oil inventories.

Brent crude for April delivery was trading at \$56.79 per barrel Tuesday, while West Texas intermediate (WTI) was trading at \$51.87.

#### Energy storage to accelerate global energy transition, research agency says

The global energy storage market is set to grow from approximately 4 GW of annual deployments in 2019 to more than 15 GW in 2024, according to a new analysis from research agency Wood Mackenzie.

Costs have fallen, direct incentives and clean energy targets are proliferating and competitive markets and vertically-integrated electricity providers are beginning to recognize the potential of energy storage.

In the next decade, the already consolidating web of manufacturers, developers, investors and integrators will compete for their slice of this burgeoning industry, carving out mature supply chains and propelling cost reductions. As they do, continued policy and regulatory efforts will be key to driving upside in the market,

According to the analysis, the end of the decade will benefit from stabilizing supply chains and mature and experienced players, however, there will be even more potential for disruption from new technologies and policies.

Daniel Finn-Foley, Wood Mackenzie Head of Energy Storage. sees six key themes that will be the biggest trends to watch in the global energy storage market in 2020.

Finn-Foley said, the "energy storage industry is in the enviable position of juggling growth game changers from multiple directions. Plunging costs drove speculation in the first scaled markets but as price declines enter a steadier rate, further recognition of storage's value - rather than cost - will be the key factor in determining growth."

As with all renewable energy technologies, energy storage has an important role to play in the energy transition.



Oil major Total and automaker Opel announced a collaboration on electric vehicle (EV) cell manufacturing earlier this year, potentially investing as much as \$5.5 billion in up to 47 GWh of manufacturing capacity. "Total, already investing in stationary storage applications, and Opel clearly see batteries as a key element of the future," said Finn-Foley

Companies like Microsoft, Google and Facebook have blazed a trail for scores of companies seeking to shrink or eliminate their carbon footprints. "When Google announced a partnership with NV Energy for significant solar-plus-storage investment to power data centers, they were not just breaking new ground in a key market but were pioneering a new way corporations value renewable energy.

Procuring renewables in real-time shows "Rather than simply offset consumed electricity, Google seeks to time-match consumption with availability and that requires storage. If this catches on among other climateforward corporations, the upside could be huge. Daimler's commitment to procure renewables in real-time shows that this trend may become global," added Finn-Foley.

In 2019, the European Commission launched a EUR 10 billion innovation fund targeting low-carbon technologies, including energy storage. On top of this, the U.S. Department of Energy's Energy Storage Grand Challenge represents the S. federal government's largest-scale action to date.

With millions behind this technology globally, innovation efforts have the potential to encourage alternatives to lithiumion and potentially shift the market, according to Wood Mackenzie. While solar and wind can displace carbon-emitting forms of energy supply, storing energy will be critical when renewable generation is not prolific.

Energy storage can play a role in balancing supply with demand on the electric grid and opportunities for BTM residential and non-residential energy storage are growing.

As the decade progresses and further incentives accelerate the energy storage market, the dynamic of the industry pushing stakeholders to recognize the technology for its potential will quickly flip, the analysis revealed.

"Stakeholders are already pulling, rather than being pushed, and turning to storage rather than being forced to consider it. The timing and speed of this push/pull shift and the speed with which the industry can react will define its potential," said Finn-Foley

Repsol posted a loss of €3.82b for the full year compared to a profit of €2.34b for 2018.

There has been an increase in demand from our shareholders for a clear identification of the risks associated with climate change and its impact on the future demand on our productions. This has made us reviews our assumptions on the price of oil and gas," Imaz said.




 $1 \rightarrow$  A: I think the issue is within the Al-Saud tribe. They don't listen to other voices in Saudi Arabia. The Saudi public wants peace, less military expenditures and less foreign adventures in places such as Yemen or Syria. The Al-Sauds have to be convinced that Iran has no designs on their rule and will not work with anyone or any group in Saudi Arabia to change the ruling structure in Saudi Arabia. Until then, something that is impossible to predict as relations and events can change, it will rely on the United States the best it can and even secretly secure Israeli support.

Saudi Arabia has aligned with Ŵashington in pursuit of U.S. maximum pressure campaign toward Iran. But after the Aramco attack and the lack of serious U.S. support for Saudi Arabia, Riyadh found that its problems with Iran had to be resolved bilaterally. Do you agree with this assessment?

A: Yes, bilaterally but with full U.S. backing to reach a global security arrangement for the entire Middle East region.

In your opinion, which foreign countries oppose the normalization of Iran-Saudi relations and benefit more from the current situation?

A: The countries that benefit are clear. First, the United States. Because of the conflict, it sells arms to Saudi Arabia and has preferred access to Saudi Arabia for selling



everything else, goods and services, that the country imports. U.S. financial institutions are major beneficiaries of managing Saudi assets. But also don't forget the benefits to lobbyists and consultants of turmoil in the

Persian Gulf. The second country that ben efits is Israel. I believe it has found a secret channel to Saudi Arabia, affording Israel a useful wedge to use against Iran and extract indirect Arab support in its suppression of Palestinian rights. Russia and China are afforded a role to exploit opportunities for influence in the region.

Some media reported that the Americans had informed the Riyadh authorities that the Iranian system was in dire straits after the demonstrations in Iraq, Lebanon and Iran began and there was no need to negotiate. If this is true, why is Saudi Arabia fully defining its foreign policy towards Iran, despite the lack of American support for the Aramco attack?

A: U.S. hawks, such as Bolton and the Israeli lobby, are all the time touting the imminent collapse of the government in Iran if just a little more pressure is brought to bear. Always, a little bit more. I don't see any collapse of Iranian cooperation in Iraq or Lebanon. The one thing that has gotten worse for Iran is its economy. And even this seems to have stabilized. Still for the longer run, the migration of talent from Iran to Europe, North America and Australia spells further trouble ahead. But even if I am wrong and the Iranian system is in dire straits, the Saudis see Trump as unpredictable and fear who might be the next American President. A Bernie sanders would scare the Al-Sauds to no end. They want to slowly hedge their bets. Open up a small channel with Iran in case it is needed given the unpredictability of U.S. foreign policy.

#### Nine years after Bahrain's uprising, its Human Rights crisis has only worsened

It's been nine years since Bahrain's February 2011 uprising. Tens of thousands of demonstrators marched in cities and towns across the country to protest the ruling Al Khalifa family's tight grip on power, discrimination against the country's majority Shia population, and arrests of political critics.

The 2011 uprising itself came 10 years after the 2001 referendum in which citizens voted overwhelmingly for the National Action Charter. The charter promised key democratic reforms, including a popularly elected national assembly.

Despite the "honeymoon" after the National Action Charter's adoption, Bahrain gradually reverted to its repressive past, and by 2010 authorities were detaining prominent opposition activists and closing opposition organizations, and reports of torture of detainees surfaced frequently.

A similar pattern played out following the last uprising.

In the years since, Bahrain's human rights crisis has only worsened. The authorities have demonstrated a zero-tolerance policy for any free and independent political thought, and they have imprisoned, exiled, or intimidated into silence anyone who criticizes the government

From the very beginning, Bahraini authorities carried out a systematic campaign of retribution, using lethal force to disperse protests, arresting thousands, and firing hundreds of public sector employees suspected of supporting the protesters' democratic demands. The Bahrain Independent Commission of Inquiry, in its November 2011 report, confirmed the "existence of an operational plan" to terrorize protesters and concluded that a lack of accountability had led to a "culture of impunity."

A case in point is that of Nabeel Rajab, one of Bahrain's most prominent human rights defenders and a member of Human Rights Watch's Middle East advisory committee, in prison since July 2016 due to his peaceful criticism of Bahrain's dismal human rights record. Although Rajab should not be in prison at all, the courts have also repeatedly rejected his appeals to serve a non-custodial sentence instead of his five-year prison term.

His case is not unique. He is one of dozens of human rights defenders, political activists, opposition leaders, and journalists unjustly imprisoned since the government quelled the 2011 protests.

In October, we found that Bahraini authorities were denying high-profile political prisoners urgently needed medical care, in some cases putting their lives in danger. In one example, the health of Abduljalil al-Singace, a leading opposition figure serving a life sentence for his role in the 2011 protests, has deteriorated significantly.

Al-Singace had polio as a child and needs crutches to walk. His daughter told us that he has severe chest pain, numbness in his fingers, and shaking in his left hand. Prison authorities have refused to take al-Singace to his medical appointments because he refuses to wear a prison uniform or shackles, which he considers humiliating. International human rights experts have said that using restraints on elderly or infirm prisoners who do not pose an escape risk can constitute inhuman or degrading treatment.

We have also documented routine torture in Bahrain's prisons, especially during interrogations. Detainees describe electric shocks, suspension in painful positions, forced standing, extreme cold, and sexual abuse.

Bahraini prosecutors and judges use confessions obtained under torture to convict detainees, and even sentence some to death. In July, the authorities executed two men whose trial was marred by allegations of torture and serious due process violations. On January 8, the appeals court reinstated the death penalty against two others, even after a Bahraini oversight body presented evidence "raising suspicions" that the two men had been tortured.

While the authorities actively prosecute people solely for exercising their right to free speech, there have been precious few prosecutions of security personnel implicated in

widespread abuses against detainees. The few prosecutions have almost exclusively involved low-ranking officers, and have without exception - resulted in acquittals or disproportionately light sentences.

Bahrain's allies, including the United States and United Kingdom, seem reluctant to face the reality of what's happening in the country. During 2019, the U.S. State Department approved three major weapons sales to Bahrain worth 3.4 billion dollars, despite the government's dismal record on human rights and relentless persecution of dissidents. The United States has also failed to publicly raise human rights concerns with Bahraini authorities.

Based on freedom of information requests, the United Kingdom has provided 6.5 million pounds of technical assistance to Bahrain since 2012, including support aimed at security and justice sector reform. Yet the oversight bodies the UK has supported have repeatedly failed to hold prison guards and officers to account, amid evidence of inhumane and degrading conditions of Bahrain's prisons.

Bahrain's allies need to investigate — and publicly report – how effective their arms sales and assistance to Bahrain have been. They should consider whether they should suspend their support for the security sector until Bahrain releases Nabeel Rajab and others unjustly jailed for criticizing the authorities. (Source: fpif)

#### One billion-year-old green seaweed fossils unearthed in China

Scientists have found evidence that green seaweeds were proliferating in Earth's oceans several hundred million years before modern plants began colonizing dry land.

The 1-billion-year-old micro-fossils, tiny imprints left behind by the algae species Proterocladus antiquus, comprise the oldest evidence of green seaweeds yet discovered.

The algae imprints were discovered in rock slabs recovered near the city of Dalian in the Liaoning Province of northern China. After dying in the shallow seas where they lived, the green seaweed became baked into layers of ancient marine sediment -- the shapes of their multiple branches and upright growths preserved in rock for millions of years.

Researchers described the record discovery this week in the journal Nature Ecology and Evolution.



'These new fossils suggest that green seaweeds were important players in the ocean long before their land-plant descendants moved and took control of dry land," Virginia Tech geoscientist Shuhai Xiao said in a news release.

Life on Earth depends on plants and algae for food and oxygen, but prior to 450 million years ago, plant life had not yet adapted to dry land. The latest findings suggest green algae anchored Earth's food chains for the 550 million years leading up to the arrival of the first land plants.

"Our study shows that green seaweeds evolved no later than 1 billion years ago, pushing back the record of green seaweeds by about 200 million years," Xiao said. "What kind of seaweeds supplied food to the marine ecosystem?'

Most geobiologists estimate Proterocladus antiquus and its relatives adapted to land over the course of a few hundred million years. Trees, grasses, food crops and bushes all evolved from these early green seaweed species, members of the Chlorophyta phylum.

'Molecular clock and biomarker data indicate that chlorophytes diverged in the Mesoproterozoic or early Neoproterozoic, followed by their subsequent phylogenetic diversification, multicellular evolution and ecological expansion in the late Neoproterozoic and Palaeozoic," researchers wrote in their paper.

Not everyone is in agreement. Some researchers claim green plants first evolved in rivers and lakes and only later made their way into the ocean.

The thousands of seaweed species found on Earth are divided into three classes: brown, red and green. Scientists have found fossil evidence of red seaweed, Rhodophyta, dated as far back as 1.047 billion years old.

Now, scientists can confirm that green seaweed was living in Earth's oceans around 1 billion years ago, too. And they looked a lot like green seaweeds found in the ocean, today

"There are some modern green seaweeds that look very similar to the fossils that we found," Xiao said. "A group of modern green seaweeds, known as siphonocladaleans, are particularly similar in shape and size to the fossils we found.'

# Iran targets Russia, India as future tourism markets

HERITAGE TEHRAN — Iranian Tour Operators Association Director Ebrahim Pourfaraj has said that the country is considering Russia and India as its main tourism markets for the future.

"We have now become active in attracting Russian tourists and also considering India as [a main] tourism market for the country,' ILNA quoted Pourfaraj as saying on Monday.

The senior tour operator also referred to fears of coronavirus spread in the country, saying "Currently, some potential travelers to Iran are facing challenges [such as tour or flight cancelations].'

Talking on China as one of the most desired travel markets for Iran, he explained," "China was [selected to becoming] one of Iran's largest tourism target markets, and in that regard, heavy investments have been carried out in the arenas of advertising and introducing travel attractions to the those who are active in the field of tourism."

We also held Even B2B meetings, however, coronavirus outbreak forced borders and air travels to come to a halt, he added.

'We are planning to hold B2B meetings with Russian and Indian travel agencies in the near future.'

Pourfaraj last vear said a majority of potential Russian travelers are unaware of vast tourist attractions that exist in every corner of Iran, "The fact is that Iran's political and economic relations with Russia are considered as good, but this has nothing to do with attracting tourists because it is directly connected with the Russian people. It is the Russian people who must choose Iran as their destination."

Last November, Maya Lomidze, president of the Association of Tour Operators of Russia (ATOR), said "Iran, as an open-air museum of cultural heritage, is steadily attracting the attention of more Russians.' "Russian tourists' interest in traveling

to Iran has increased," Lomidze said. Iranian tourism minister Ali-Asghar

Mounesan earlier this month announced the country will follow up on the issue of visa-free travel for mutual tourist groups with Russia at the upcoming [27th edition] Moscow International Travel & Tourism Exhibition (MITT), which will be held from March 17 to 19.

'The Russian fair is very important [for us] so that we should have a strong and influential presence in this exhibition ... One of the major issues is to pursue and finalize visa cancellation for Iranian and Russian group tours," Mounesan said.

In December, Mounesan announced that Tehran was considering to allow Russian tourists to visa-free entry into the country to boost tourism after it granted the same privilege for some other nationals including Chinese and Omani passport holders.

Iranian President Hassan Rouhani and his Russian counterpart Vladimir Putin inked a preliminary visa-free agreement in 2017 for certain tourist groups during their meeting in Moscow.

Based on the agreement tour groups of 5 to 50 people heading to [easternmost parts of] Russia from Iran or vice versa are granted a visa-free stay of up to 15 days.

Iran welcomed some 7.8 million foreign nationals last year, achieving 52.5 percent increase year on year.

The country expects to reap a bonanza from its numerous tourist spots, including 22 ones that have been placed on the UNESCO World Heritage list. Under the 2025 Tourism Vision Plan, the country aims to increase the number of tourist arrivals from 4.8 million in 2014 to 20 million in 2025.

Azeri, UAE airlines continue flights to Iran despite coronavirus



TOURISM TEHRAN – Azerbaijan's low-cost airline Buta Airways and its Dubai-based counterpart Flydubai have announced they will continue flights to and from Iran despite the outbreak of the novel coronavirus in the region.

Buta Airways will operate flights to Tehran despite the coronavirus threat, Azer News quoted Press Service of Azerbaijan Airlines (AZAL) as saying on Tuesday.

"Low-cost airline Buta Airways is operating daily flights on the Baku-Tehran-Baku route and plans to continue flights under the current schedule," AZAL President Jahangir Asgarov said.

Heydar Aliyev International Airport and other airports of Azerbaijan will not impose any restrictions on flights operated

by Iran Air, he said. "Azerbaijan's Ministry of Health has strengthened the sanitary-quarantine control on arrivals from Iran. Additional

measures will be taken in this direction". Meanwhile, a spokesperson for flydubai told Arabian Business: "Flydubai flights to Iran are currently operating according to schedule. We are following the directives issued by the relevant authorities with regards to screening and onward travel around the region. We continue to monitor



the situation."

Turkey, Pakistan, Afghanistan and Armenia closed land borders with Iran on Sunday. Iraqi and Kuwaiti authorities have both banned travel to and from the country, amid growing regional concerns about the spread of the virus.



#### 'Kids should sit with their parents': Petition urges airlines to seat families together for free

Travelers buying airline tickets today are increasingly faced with a costly decision: pay up for seat assignments or risk not sitting together on the plane.

Blame the proliferation of pricey airline seat selection fees, which have spread from no-frills airlines like Spirit and Frontier to major carriers including Delta, United and American, and the advent of basic economy tickets.

The latter don't come with a free advance seat as-

signment, and airlines routinely try to scare travelers into buying a pricier regular economy ticket (which may or my not come with a free seat assignment) or into paying a fee for seat assignments.

Anna Laitin, director of financial policy for Consumer Reports' advocacy arm, said it's a calculation travelers with younger children should not have to make.

adults traveling with children 13 and younger to sit together without paying a fee. The initial goal was 25,000 signatures, which was quickly surpassed. On Monday, the number of signatures was approaching 45,000.

The plea: "I expect you to put safety over profits, and seat children with their families without charging them extra for it.'


# "We Defeat Coronavirus" national campaign launched

**SOCIETY** d e s k **TEHRAN** — A nation-al campaign called "We Defeat Coronavirus" is going viral among Iranian social media users.

Kianoush Jahanpour, head of the Ministry of Health's public relations and information center, expressed hope to soon be able to announce the containment and control of the virus and eventually elimination of the disease.

The campaign defines students as health ambassadors who promote public motivation to combat coronavirus, ISNA reported. So far, 95 people in the country have been

infected with the virus, of whom 15 died. Iranian Health Minister Saeed Namaki has said effective measures have been taken and comprehensive plans are underway to get rid of the novel coronavirus, known as COVID-19, in the country.



The country has put in place a set of contingency plans, including the temporary shutdown of schools, universities and cultural centers, in an effort to curb a coronavirus outbreak that has already claimed eight lives in the country.

"With regard to the past experience, I say that we will defeat the coronavirus before long," the minister stressed.

"As a veteran soldier in the Iranian health front, I have taken the responsibility of removing measles, tetanus, and polio which astonished the World Health Organization as the country is grappling with sanctions with no international support. So, I [definitely] say that we will defeat the coronavirus.'

He went on to say that the nation has been mobilized against the virus and "we will announce its defeat soon.

#### Facts being ignored on coronavirus status in Iran's neighbors

**SOCIETY TEHRAN** — After the detection of coronavirus in Iran, some neighboring countries reacted as if their territories are free of covid-19, however, available evidence suggests otherwise.

The news of some cases of coronavirus infection in Iran was enough for a number of neighboring countries to consider the necessity of closing their borders with Iran. These countries always seek to benefit from critical situations, and this time, they are striving to conceal the real truth about their own territory.

Meanwhile, the emergence of #close\_Iran\_borders has also raised questions, but are the neighboring countries of Iran immune from covid-19?

#### Turkey

If we consider the relations of various countries with China as the criterion for the transmission of the virus, then based on the reports of Daily Sabah, more than 403,000 Chinese tourists have traveled to Turkey in 2019 and according to statistics another 30,000 Chinese tourists had planned to visit Turkey, however, due to the outbreak of coronavirus in China, only half of these trips were canceled.

None of the Turkish media outlets have indicated whether or not the other half of the Chinese tourists who were supposed to travel to Turkey have actually arrived in the country, nevertheless, the beginning of coronavirus outbreak in China was December 2019.

Although the coronavirus outbreak in China began in December 2019, a search in Turkish media indicates that airline agencies such as Turkish Airline did not cancel their flights to China till the end of January, which is more than a month after the outbreak.

Meanwhile, the Yeni Safak Daily reported on January 2020 that Turkish Airlines were utilizing special gloves and masks to prevent coronavirus infections.

These findings show that despite more than a month

since the outbreak of the Coronavirus in China, Turkish airliners continued transporting passengers from the country and did not say a word about the necessity of closing borders to Chinese tourists nor the prevention of flights originating from China.

At the same time, reports of providing Turkish hospitals with advanced equipment that can detect covid-19 in 60 minutes were released in Turkish media.

Now we must ask Turkish authorities whether or not their country is thoroughly clean after the arrival of a huge number of Chinese tourists?

Those who have traveled to Turkey admit the substantial presence of Chinese tourists in the country and believe that Turkey is unlikely to prevent the arrival of Chinese nationals due to maintaining tourism markets and its benefits, nor will they inform Turkish people properly regarding the possibility of coronavirus infection.

It should be noted that currently, Chinese nationals can book tickets to Istanbul at https://www.trip.com/flights/ shanghai-to-istanbul/airfares-sha-ist/, while Iranian flights to Turkey Have been canceled.

Protecting people's lives or political revenge? The closure of the Turkish border with Iran and the

cancellation of flights from Iran to Turkey are carried out amid new hostilities in the region. Turkey recently has occupied some parts of Syria apparently for the fight against terrorism and this led to some sort of tension with Iran and Russia.

Turkish officials now appear to be exaggerating about the spread of coronavirus in Iran, seeking revenge on Tehran over Syria since they canceled the trip of a Turkish delegation to Tehran seemingly due to covid-19 infection, as Tehran hosted top European authorities on Feb. 23.

A Turkish cultural delegation which was supposed to sign a memorandum of understanding with regard to Tehran

Book Fair reportedly canceled their flight to Iran. The situation in other neighboring countries of Iran Other neighboring countries of Iran have not been

immune to coronavirus, as a number of infections have been reported in UAE, Bahrain, Afghanistan, and Kuwait. For example, by February 9, at least 9 cases of infection

were reported in UAE, however, unofficial reports indicate other facts

Sources in UAE have reported the deaths of 18 cases of the new coronavirus infection dubbed covid-19. So far, about 50 cases have been diagnosed in UAE. Official sources in UAE have so far refused to publish these figures.

The reaction of Pakistani officials to coronavirus is interesting. While most countries have moved their own nationals out of China, Pakistan asked them to stay in that country.

#### The new phase of Iran phobia

It seems that the outbreak of coronavirus in Iran has created a new opportunity for the countries and media outlets opposing Iran to launch a massive offensive against the Islamic Republic. These countries reported the news of covid-19 in a way as if Iran was the primary source of infection. not china.

Exaggerating the problems of one country with the aim of hiding the same issues elsewhere is a situation we observe these days in some neighboring countries. Sooner or later the coronavirus outbreak will end in Iran, and then these countries must take responsibility for their behavior. It must be seen if the rulers of neighboring countries will ignore Iranian tourists during the Nowruz holidays or simply forget the dangers of coronavirus.

One should bear in mind the huge propaganda against coronavirus and the situation it created between Iran and neighboring countries. Moreover, it gives rise to the theory of the US exaggerating the issue to undermine the Chinese economy.

The world's accountants must put the climate crisis at the forefront of their work to spur global companies to adopt green policies and help prepare them for the risks, according to the Institute of Chartered Accountants in England and Wales (ICAEW) and other industry groups.

They have called on a global alliance of accountants, representing more than 2.5 million professionals worldwide, to put their skills to use by helping companies prepare for a climate emergency

panies to set more sustainable business strategies.

Michael Izza, the chief executive of the ICAEW, said it is crucial that chartered accountants use their "unique position" at the core of almost every business, government and non-governmental organisation to make the case for sustainability.

"Chartered accountants bring practical skills like measurement and management to the table, and can work with business to build green policies into their working practices. We need to make this a decade of transition for business; failure to make this move will make the inevitable adjustments required much more difficult," he said.

Accountants should demonstrate the risks to business posed by the climate crisis, such as the impact of flooding or the effect of drought on the price of crops needed in the supply chain, the industry groups said.

The call for climate action comes after the accounting watchdog, the Financial Reporting Council, launched a review into whether companies and their auditors are adequately reflecting the financial risks of the climate crisis in their annual financial accounts.

financial risks of the climate crisis and provide clear information to investors.

Bruce Cartwright, the chief executive of Icas, the global professional body, said there are "dramatic implications for failing to tackle climate change – environmental, social and economic"

He said: "It is our future that is at risk and the urgency at which we are required to act must remain front of mind. Icas is working with fellow accountancy bodies to act now to limit the negative effects of climate change. Our individual actions, collectively, have the ability to make a difference.

#### **Rainfall increases Lake Urmia level**

 $1 \rightarrow$  The lake is expected to reach its ecological level within 10 years by completing the restoration plans which started four years ago.

Farhad Sarkhosh, head of the Lake Urmia Restoration Program's office in West Azarbaijan province, said that the Lake's level is now 58 cm higher than it was last year.



According to the latest monitoring, the lake's water volume is estimated at more than 3.6 billion cubic meters. He added that the lake surface area has reached 2,883

square kilometers, adding that the figure is increased by 538 square kilometers compared to the same period last year.

Although the ecological level of the lake is defined as 1,274 meters, the lake will also have favorable conditions at 1.272 meters and more than 90 percent of sand and dust storm hotspots will be eliminated.

Alireza Shari'at, head of monitoring and supervision department of the Lake Urmia restoration program said in September 2018, that in order to maintain the Lake Urmia ecological balance of 14 billion cubic meters over the next 10 years, an annual amount of 3.3 billion cubic meters of water is required.

The sharp rise in precipitations rates over the past crop year since now has raised hopes for total restoration of the once glorious Lake Urmia.

This is a while, deputy environment chief Masoud Tajrishi told Khabaronline in July 2019 that rainfall is not the only the reason behind Lake Urmia coming back to life. Thus, restoration measures turned out to be effective, unlike the previous years of high rainfall poured over the lake but did not raise the lake level.

The effort put into properly dredging and clearing of weed and vegetation in river beds as a way came efficient in the lake conservation, he added.

#### Iraqi legislators schedule confidence vote for new government

However, the Iraqi parliament, known as the Council of Representatives of Iraq, said in a statement on Monday that the confidence-vote session would be held on Thursday.

Months of political turmoil began in Iraq in early October last year, when public grievances grew, pressing the government to bring in reforms that would root out corruption and alleviate the economic woes.

Demonstrations, however, soon turned violent, amid reports of foreign interference. Hundreds of people, including members of security forces, were killed.

In November, Abdul Mahdi stepped down. The parliament approved his resignation in early December, but he had retained the position ever since as caretaker prime minister.

Allawi, the son of a wealthy Iraqi industrialist who educated at the American University of Beirut, is a cousin of pro-Western Shia politician Ayad Allawi, a figure who has been at the heart of many political disputes in Iraq for the past years.

Mohammad Allawi has a reputation of repeatedly clashing with Nouri Maliki, a key political figure known for his anti-American positions who led two governments in Iraq after the 2003 US invasion of Iraq.

#### **U.S. wants Afghan president** to postpone planned inauguration

The United States wants Afghan President Ashraf Ghani to defer his second-term inauguration over concerns it could inflame an election feud with his political rival and jeopardize U.S.-led peacemaking efforts, two sources familiar with the matter said.

Ghani claimed victory last week in a disputed Sept. 28 election and plans to take the oath of office on Thursday, an Afghan official said. His opponent, Abdullah Abdullah, Afghanistan's chief executive, also proclaimed himself the winner and is planning a parallel inauguration, according to Afghan media reports.

The competing claims, neither of which Washington has recognized, threaten a U.S.-led peace process that got a boost on Saturday with the start of a week-long reduction in violence that is to culminate on Saturday with the signing of a U.S.-Taliban deal on a U.S. troop withdrawal.

The U.S.-Taliban agreement is to be followed by inter-Afghan talks on a political settlement to end decades of war.

But the Ghani-Abdullah feud threatens to further complicate the naming of a delegation to negotiate with the insurgents, a process already mired in delays and disputes.

A source familiar with the matter said that because of those concerns, U.S. Special Representative Zalmay Khalilzad, who has been in Kabul since last week, wants Ghani to delay his planned inauguration to a second five-year term. The U.S. State Department and White House did not imme-

diately respond to requests for comment. The Afghan Embassy in Washington declined comment.

# Hosni Mubarak, Egypt's long-time dictator, dead at 91

INTERNATIONAL TEHRAN — Hosni d e s k Mubarak, the former autocratic president of Egypt, whose hold on power was broken and place in history upended by a public uprising against the poverty, corruption and repressive police tactics that came to define his 30 years in office, died on Tuesday. He was 91.

His death was confirmed by state TV. Mubarak ruled Egypt for 30 years until he was ousted following mass protests

against his rule in 2011. Mubarak spent most of his final years at the Maadi Military Hospital in southern Cairo, under guard in a room overlooking the Nile as he defiantly battled courtroom charges of corruption and conspiracy to murder. He was finally released on March 24, 2017, having been convicted in a single, relatively minor case, and spirited across the city to his mansion in the affluent neighborhood of Heliopolis.

Last October, he made a rare appearance in a video published on YouTube where he shared his memories of Egypt's 1973 war against Israel, when he commanded Egypt's air force. It was the first time he had spoken before a camera since his ouster during the Arab Spring in 2011.

Mubarak had once appeared invincible. He had survived multiple assassination attempts, held power longer than anyone since Muĥammad Ali Pasha, the founder of the



modern Egyptian state, suppressed a wave of terrorism by Islamic fundamentalists and appeared even to defy the gravity of age.

But his edifice of power turned out to be fragile and dated, built on strong-arm rule, cronyism and an alliance with the West. It was ultimately brought down by the shock wave of popular unrest in the Arab world calls for democracy, the rule of law and an end to corruption - that came to be called the Arab Spring.

He was forced to resign on Feb. 11, 2011, after 18 days of protests, when the Egyptian public poured into the streets by the millions, stripping authority from a man who had been likened to a modern-day pharaoh.

At first, it appeared he would be able simply to withdraw from the scene and live quietly in his villa in Sharm el Sheikh, a Red Sea resort. But the crowds would not allow it. They demanded that he and his family be investigated for corruption, and that he be

held accountable for the more than 800 people killed during the days of protest.

The public pressure worked; he was arrested and remanded to a military hospital while he awaited trial. His sons, Alaa and Gamal, once treated as princes of the state, were jailed in the notorious Tora prison.

In June 2012, Mubarak was wheeled back into court, his arms crossed defiantly across his chest as he was convicted and sentenced to life in prison. But an appeals court overturned that verdict and ordered a retrial, and he was ultimately exonerated. He also skirted several corruption accusations.

The 2012 trial occurred against the tense backdrop of a presidential election. The two candidates heading for a runoff were polarizing figures, one a leader with the Muslim Brotherhood, a popular Islamist movement; the other, Mubarak's last prime minister. And the verdict drew thousands of people into the streets to denounce it as a sham, many believing that the judge laid the groundwork for the former president to go free on appeal.

Mubarak never did actually resign publicly; apparently stumbling in a speech on Feb. 10, 2011, he failed to choke out the words. The next day, against a tide of public anger, Omar Suleiman, the longtime chief of intelligence and newly installed vice president, read a statement on television signaling the end of Mubarak's reign.

liceman, a senior officer told AFP. More rioting was reported Tuesday, with a large plume of black smoke rising in the sky.

Broadcaster NDTV said three of its reporters and a cameraman were attacked by a mob on the northeastern fringe of the megacity of 20 million people.

"There is hardly any police presence in the area. Rioters are running around threatening people, vandalizing shops," a resident of the poor, migrant neighborhood of Maujpur told the Press Trust of India.

Delhi Chief Minister Arvind Kejriwal, who visited a hospital where the injured were being treated, called for calm.

National Home Minister Amit Shah, whose ministry controls law and order in the capital region, met with senior Delhi government officials and promised to deploy more police if they were needed, Kejriwal said.

#### **Trump secures \$3 bln** military sale with India

U.S. President Donald Trump said Tuesday India will buy \$3 billion worth of military equipment, including attack helicopters, as the two countries deepen defense and commercial ties in an attempt to balance the weight of China in the region.

India and the United States were also making progress on a big trade deal, Trump said. Negotiators from the two sides have wrangled for months to narrow differences on farm goods, medical devices, digital trade and new tariffs.

India's tariffs were still too high, probably the world's highest, Trump said in his only criticism of the world's biggest democracy during a visit that he said was a spectacular success

"We are being charged large amounts of tariffs, can't do that," he said at a news briefing, again pointing to Indian duties on Harley-Davidson motorcycles

Trump was accorded a massive reception in Indian Prime Minister Narendra Modi's home state of Gujarat on Monday, with more than 100,000 people filing into a cricket stadium for a "Namaste Trump" rally.

On Tuesday, Trump sat down for one-on-one talks with Modi followed by delegation-level meetings to try and move forward on issues that have divided the two countries, mainly a festering trade dispute.

After those meetings, Trump said his visit had been productive, with the conclusion of deals to buy U.S. helicopters for the Indian military. India will buy 24 SeaHawk helicopters from Lockheed Martin equipped with Hellfire missiles worth \$2.6 billion and plans an order for six Apache copters.

India is modernising its military to narrow a gap with China and has increasingly turned towards the United States over its traditional supplier, Russia.

President Donald Trump has called reports that Russia is interfering with the 2020 election "highly exaggerated," and blamed the rumor on House Intelligence Committee Chairman Adam Schiff.

The specter of 'Russian interference' raised its head again last week, when the Washington Post ran an article claiming the Kremlin is interfering in the upcoming presidential election on behalf of Vermont Senator Bernie Sanders, with the ultimate goal of getting Trump re-elected. The story provided no specifics on what form the supposed interference took, but claimed that Sanders and Trump had both been briefed on the threat.

"Intelligence never told me," Trump told reporters on Tuesday at a press conference held during his state visit to India. "What I'm reading," he continued, is that "they went to see Bernie and they told Bernie."

While Sanders responded to the story by denying receiving Russian assistance, and warning Russian President Vladimir Putin to "stay out of U.S. elections," Trump took



#### a different approach.

Calling the story "highly exaggerated," Trump accused House Intelligence Committee Chairman Adam Schiff of leaking it to the media, following a closed-doors briefing on Capitol Hill. Schiff, of course, was one of the principal architects of the impeachment effort against Trump, and one of Washington's loudest proponents of the "Russian collusion" conspiracy theory.

"Schiff leaked it," Trump said on Tuesday. "Bernie is probably winning... and maybe they don't want him. So they put out a thing that Russia's backing him. This is what they do. I've gone through it for a long time. I get it. I get the game better than anybody.

They ought to stop the leaking," Trump continued. "I can imagine that people are going to go after them and find out what's happening," he added, without elaborating further.

"I want no help from any country and I haven't been given help from any country," Trump stated.

The president has previously described Adam Schiff as "the biggest leaker in Washington," and Tuesday's press conference was not the first time he has accused the California Democrat of being behind the Sanders/Russia story. On Sunday, he warned that Schiff should "stop leaking classified information or, even worse, made up information, to the Fake News Media.'

#### Qatar postal blockage ends as regional rivals restore service

A postal blockage against Qatar has ended with Saudi Arabia, Bahrain and Egypt restoring services after mail links were severed in 2017 as part of a campaign to isolate Doha, the UN postal agency said.

The restoration of postal services is a small step towards normalisation as talks to resolve the wider rift have stalled, Qatar said earlier this month, after a flurry of diplomacy late last year raised hopes of a breakthrough.

The three nations, along with the United Arab Emirates, severed all diplomatic, trade and transport ties with Qatar in June 2017. The bloc accused Doha of supporting "terrorism" and seeking closer links with Saudi regional rival Iran - allegations Oatar denies.

Representatives of the four boycott coun-

tries met a Qatari delegation at the Universal Postal Union's (UPU) headquarters in the Swiss capital Bern on January 29 to discuss the re-establishment of postal links.

The UAE had already resumed services to Qatar on February 9, according to the UPU, the UN agency responsible for coordinating global postal services.

"I warmly welcome the resumption of international postal exchanges between these countries via transit through Oman,' UPU director general Bishar Hussein said in a statement.

"All of the countries, including Oman, deserve praise for their commitment and dedication to ensuring that postal items continue to be exchanged and delivered over the Union's single postal territory.

#### Germany tightens carnival security after car driven into crowd injures 60

Germany increased security at some carnival processions on Tuesday after a local man plowed his car into a parade in the western German town of Volkmarsen, injuring around 60 people, including at least 18 children.

The incident on Monday shook Germans still struggling to take in last week's racist gun attack on two bars in the town of Hanau which left 11 people dead.

The driver was detained on suspicion of attempted homicide and was being treated for his own injuries. The prosecutors' spokesman said he had not been in a fit state to be questioned overnight, but was not drunk at the time of the incident. Tests for drugs were due in the course of the day.

Prosecutors did not appear to see a political motive because a spokesman said there was no sign the investigation would be handed to national prosecutors.

While some carnival processions in the state of Hesse, home to Volkmarsen, were canceled, others were due to take place in the region on Tuesday. A police spokesman said security would be intensified.

Rose Monday is the height of the carnival season in Catholic areas of Germany, especially in the Rhineland where tens of thousands of people dress up, drink alcohol and line the streets to watch decorated floats that often mock public figures.

Prosecutors said there was no concrete reason to think that the risks of attacks at parades had increased, but they urged organizers to review their security arrangeents and adjust them if necessary. (Source: Reuters)

"I'll have to look at another crying meme (of myself) for years," Jordan quipped, wiping away tears. The 20,000 mourners at Staples Center, all clearly familiar with the "Crying Jordan" meme, burst into laughter.

<sup>\*</sup>I told my wife I wasn't going to do this because I didn't want to see (a new meme) for the next three or four years,' he continued. "That's what Kobe Bryant does to me."

Bryant was often compared to Jordan throughout his NBA career and regularly sought advice from the Chicago Bulls legend.

"He used to call me, text me 11:30, 2:30, 3:00 in the morning," Jordan recalled. "Talking about post-



up moves, footwork, and sometimes the triangle. At first it was an aggravation, but then it turned into a certain passion. This kid had passion like you would never know. And it's an amazing thing about passion. If you love something, if you have a strong passion for trying to work on your moves?' I said, 'What age?' He said, '12.' Please, rest in peace. little brother.<sup>3</sup>

"Personally, I can only look forward with excitement, as well as some nerves, but more importantly, conviction that this will be without a doubt - the best tournament. We are determined to ensure that the first World Cup in the Middle East and Arab world will set a benchmark in the history of hosting major sporting events."

When it comes to tournament preparations, Qatar and FIFA have been scrutinizing the lessons learned from the FIFA Club World Cup, held in December last year, and which will return to the country later in 2020.

According to the local authorities, the tournament brought over 50,000 international fans into the country. The event's official fan zone welcomed 43,000 visitors over the course of the tournament.

"After the Ministry of Culture and Islamic Guidance announced the cancelation of all the art, cultural and cinematic events, the exhibit is half open and the visitors are asked to visit the exhibit with an appointment in response to the situation," she remarked.

"The works are also available on the gallery's Instagram page, however, I think people are not in the mood for purchasing any artworks," she noted. She said that they are forced to close the exhibit

on Friday, adding, "Because it is not clear what will happen next week and because people will get busier with the preparation for Noruz.

#### Weinstein found guilty in victory for #MeToo movement

**NEW YORK (Reuters)** — Former movie producer Harvey Weinstein was convicted of sexual assault and rape in a New York court on Monday and taken off to jail in handcuffs, a victory for the #MeToo movement that inspired women to publicly accuse powerful men of misconduct.

Once one of Hollywood's most influential producers, Weinstein, 67, was found guilty of sexually assaulting former production assistant Mimi Haleyi in 2006 and raping Jessica Mann, a onetime aspiring actress, in 2013.

Officers helped Weinstein unsteadily to his feet before leading him away. His lawyer said Weinstein, who has used a walker throughout the trial, was expected to be taken to a medical facility at New York City's Rikers Island jail complex.

A spokesman for Weinstein said later that the onetime movie mogul was diverted instead to Bellevue Hospital in Manhattan, which has a unit that provides medical care for jail inmates

The spokesman, Juda Engelmayer, told Reuters he did not know why Weinstein went to Bellevue or how long he would be there. But a number of news outlets, including Variety, reported that he had complained of chest pains. Either destination would be a sharp contrast to the posh

Four Seasons hotel where the producer of such acclaimed films as "The English Patient" and "Shakespeare in Love' started his day.

After the verdict Arthur Aidala, Weinstein's lawyer, quoted his client as saying, "I'm innocent. I'm innocent. How can this happen in America?"

His sentencing hearing was set for March 11. The attorney vowed to appeal. Weinstein never testified in his defense. He told reporters during the trial that he had wanted to speak but his lawyers said it was unnecessary because the case against him was weak.

Actress Rose McGowan, who had accused Weinstein of rape, wrote on Twitter: "Today is a powerful day & a huge step forward in our collective healing.'

A statement for the #MeToo movement said: "The jury worked with an incredibly narrow and unjust set of laws governing sexual assault, and though he was not convicted on all counts, Harvey Weinstein will have to answer for his crimes."

Weinstein faces up to 25 years in prison on the sexual assault conviction. He was also convicted of third degree rape which carries a prison sentence of up to four years.

The jury of seven men and five women acquitted Weinstein on the most serious charges, which carried a potential life sentence

Asked by reporters outside court how the jury service experience was for him personally, jury foreman Bernard Cody said, "Devastating," but declined to elaborate.
