Iran to host 2025 SCO counterterrorism exercise

TEHRAN - The Shanghai Cooperation Organization (SCO) will hold its 2025 joint counterterrorism exercise in Iran, with the country's intelligence and security agencies taking the lead, officials announced on Friday.

Olarbek Sharshiev, Director of the Executive Committee of the SCO's Regional Anti-Terrorist Structure (RATS), said during a press briefing that the drill—titled "Sahand-Counterterrorism-2025"—is set to take place near the northwestern city of Tabriz on December 4.

Sharshiev noted that formal invitations and detailed schedules will soon be sent to both member and observer states.

The large-scale exercise aims to enhance coordination and readiness among SCO members in response to cross-border terrorist threats, which often affect multiple nations simultaneously. ▶ Page 3

Iran, China cultural exchanges accelerate, Beijing's ambassador says

TEHRAN – Beijing's ambassador to Tehran has said that cooperation between Iran and China in cultural heritage research has gained greater speed and depth over the past two years, describing the field as a strategic platform for expanding bilateral scientific and civilizational exchanges.

Slim prospects for a breakthrough in Iran-Europe relations

In an interview with Ham Mihan, European affairs expert Morteza Makki assesses the outlook for Iran's engagement with the European troika as not promising. Makki says: Europe currently lacks the strategic capacity to assert an independent role in the Middle East. Even if European governments were inclined to adopt a more flexible posture toward Iran, their deep economic, political, and security dependence on the United States renders such autonomy unattainable. As long as Europe remains aligned with the unilateral policies of Washington and Tel Aviv, it cannot pursue a distinct approach toward Tehran. European demands mirror those of the United States: curbing Iran's nuclear program, limiting its missile capabilities, and removing enriched uranium from the country. These demands continue to serve as political leverages to alter Iran's behavior. Given this harsh stance, the prospect of a meaningful opening in Iran-Europe relations appears re-

Khorasan: Challenging Washington's monopoly on global authority

Khorasan analyzed the recent joint letter by Iran, Russia, and China declaring the expiration of UN Security Council Resolution 2231. The newspaper says: The move marks a pivotal moment in the erosion of U.S. dominance over global governance and a critical test for Iranian diplomacy. For decades, Washington has invested vast political, military, and media resources to position itself as the ultimate arbiter of international order. The joint initiative by three non-Western powers—two of them major global actors—represents an unprecedented challenge to this narrative (the erosion of the U.S. domination). It disrupts the continuity of American power projection and signals to the international community that the era of Washington's unilateral imposition of its will as international law may be drawing to a close. This coordinated action marks the first formal effort by Iran, Russia, and China to contest the authority of the United States within the framework of the Security Council. It may herald a new phase in the reconfiguration of global power dynamics.

Arman-e-Melli: Middle East enters a phase of strategic ambiguity

Arman-e-Melli has described the current state of the Middle East as one of "complete ambiguity." It said: While active warfare has subsided in parts of the region, the shadow of

war looms over Iran, Gaza, Lebanon, and Yemen, and the Middle East is in a suspended and ambiguous state. With the continued deadlock on the Ukraine issue and the deadlock in diplomacy between the U.S. and Iran, it can be expected that the Middle East region will undergo new developments. Despite the recent 12-day war and attacks on the nuclear facilities, Iran's nuclear program remains intact, and its activities appear to be continuing. The nuclear file, like much of the region's strategic posture, remains opaque. With diplomatic channels between Tehran and Washington effectively blocked, the risk of renewed military confrontation against Iran and Lebanon has increased. It is unlikely that Israel will accept the current status quo indefinitely. The imagination that the war with Iran is over or improbable is premature. The possibility of renewed conflict remains real and immediate. From a macro-strategic perspective, the Middle East is in a holding pattern, marked by volatility, unresolved tensions, and the prospect of three more difficult years ahead.

Iran: IAEA's approach is affected by geopolitical competition

The Iran newspaper wrote that the technical body of the International atomic Energy Agency is under the influence of geopolitical rivalries. It said: The global order is undergoing a structural shift from unipolarity to multipolarity, driven by the rise of new powers such as China, Russia, and India, alongside assertive regional actors like Iran and Turkey. This transformation has turned international institutions into arenas of geopolitical and economic competition. Within this evolving landscape, the International Atomic Energy Agency has not remained immune. Its traditional neutrality has been undermined, and its institutional independence and professional credibility have come under strain. As a result, trust in the Agency's impartiality has diminished among several member states, including the Islamic Republic of Iran. Despite the collapse of the Cairo Agreement following the activation of the snapback mechanism, Iran has reiterated its willingness to consider new cooperation frameworks with the Agency. This stance reflects Tehran's continued commitment to diplomacy and engagement within multilateral institutions. In the context of a shifting international order, maintaining technical dialogue with the IAEA is not merely a diplomatic gesture; it is a strategic imperative for managing crises and restoring confidence in global governance.

Araghchi congratulates Kazakhstan on **National and Republic Day**



TEHRAN – Iranian Foreign Minister Abbas Araghchi has sent a message of congratulations to his Kazakh counterpart, Yermek Kosherbayev, on October 25 - Kazakhstan's National and Republic Day.

In his message, Araghchi extended his "sincere congratulations" to the government and people of Kazakhstan, describing them as a "friendly and brotherly nation." He expressed hope that the two countries' close ties and cooperation will continue to expand across all sectors.

Iran and Kazakhstan have long maintained strong relations, particularly in energy, transport, and trade. Iran's strategic location provides Kazakhstan with access to southern

ports and key trade routes, including the International North-South Transport Corridor, while Kazakhstan serves as a gateway to Central

Both countries are also linked through the Eurasian Economic Union (EAEU). The bloc comprises Russia, Belarus, Kazakhstan, Kyrgyzstan, and Armenia, with Iran, Uzbekistan, and Cuba holding observer status. In December 2023, Iran and the EAEU signed a free trade agreement, which came into effect in May 2025 after ratification by all member states. The deal eliminated tariffs on about 87% of traded goods, boosting Iran's exports to EAEU members by 20% in the previous Iranian calendar year (ending March 19), surpassing \$2 billion.

The unbreakable soldier

A brief look into the life of the late Brigadier General Mohammad Hassan Mohaghegh through those closest to him

TEHRAN - During the 12 days of Israeli and United States attacks on Iran in June, numerous events profoundly impacted the Iranian public, eliciting feelings of shock, sorrow, and fear. The targeting of residential areas, the bombing of Iran's national television headquarters, the strike on a prison, and the horrific scenes from Tehran's Tajrish Square, where Israeli missiles sent cars and pedestrians hurtling into the air, were among the incidents that deeply moved the Iranian people.

Iranian For journalists, particularly those in Tehran, all of it was equally horrifying. Each day, we navigated the city that held everything for us, struggling to reconcile its familiar reality with the fact that it was under attack. During those twelve days, I remember deliberately avoiding dwelling too long on any single incident or news item; my focus had to remain on reporting what was unfolding. I told myself that grief, curiosity, and even pride would have their place later, after the war's end. One image, one I resolved to contemplate more deeply afterward, was an old photograph I encountered for the first time during the aggression: a top military commander, missing a leg, with his other, apparently injured, leg resting on a coffee table. The years-old photo belonged to Brigadier General Mohammad Hassan Mohaghegh, the deputy head of the Intelligence Organization of the Islamic Revolution Guard Corps (IRGC). It widely appeared on news websites on June 16, 2025, one day after Israel assassinated the commander.

Mohaghegh was among the lesser-known commanders targeted by Israel during the twelve-day war. This month, I finally managed to connect with some of his family members and friends. The first person I spoke to was Esmaeil Kowsari, an Iranian lawmaker who had been Mohaghegh's comrade during Iraq's invasion of Iran in the 1980s and later became his brother-in-law.

"I don't' think I have ever seen someone work as hard as Hassan did," Kowasri said. "Hassan was physically weaker than most people, but he worked harder than everyone around him."

Mohaghegh's life was shaped by struggle from a very young age. Born in Tehran in 1963, he grew up in the shadow of his father, a prominent cleric in Rafsanjan who was deeply involved in the political upheaval against the Shah. As the eldest son, Hassan naturally followed in his father's footsteps, his teenage years consumed not by schoolyard concerns, but by the dangerous world of political activism. This path led him straight into the crosshairs of the Shah's secret police, SAVAK, who arrested him in the tumultuous months leading up to the 1979 Revolution. The details of his imprisonment are mostly lost to history.

With Saddam Hussein's invasion of Iran, he joined Iranian soldiers at the war fronts in his late teens. A few years into the 8-year war, he became the commander of the Habib Ibn Mazahir Battalion, part of the prestigious 27th Mohammad Rasulullah Division. The unit was known for its intellectual and religious makeup.

"Hassan was badly injured operations in 1986. When I saw his body, he was missing one

Ahwaz," Kowsari explained.

It was only by chance that comrades, checking one last time, detected Mohaghegh's faint pulse. He even experienced one cardiac arrest while in the hospital in Ahwaz, but ended up surviving his injuries miraculously.

After the war, Kowsari introduced Mohaghegh to his sister, a 23-year-old recent graduate working as a teacher. She told me she hadn't been seriously considering marriage when they met. "I had just started working and wanted to focus on building my career. My previous encounters with suitors weren't really significant. I was planning to stay single, at least for a few years," she said.

However, the young woman felt something stir within her when she first saw Mohaghegh. "We were a religious and traditional during one of Iran's important family, so our first meeting was a formal introduction at our home with his family. The young couple instantly developed an affinity for each other. "I don't know how to describe the feeling we experienced. Haj Hassan later told me that he, too, knew I would be his wife the moment he saw

In the years following the war, Mohaghegh divided his time between military service and academia. He earned two PhDs, eventually becoming a top IRGC commander, and had three children with his wife. Throughout those four decades, he continued to grapple with the injuries he had sustained during the Iran-Iraq war. "He had surgery numerous times in the following years," his wife recalled. "But even when he was in deep and excruciating pain, he did not complain. He did his best to recover quickly and attend to his military and fatherly duties. He believed he had duties that he needed to fulfill, no matter how much pain he was in."

When Israel assassinated Mohaghegh, his only daughter struggled the most with his loss. "She was closest to her father. I have two sons as well, but they always say the bond between a father and a daughter is very strong. This was certainly the case in our household."

A few days after Mohaghegh's martyrdom, the daughter told her mother that she believed her father was helping her cope with sorrow. "After some very difficult days, my daughter started to improve. She told me she was feeding milk to her infant when she felt her father's presence in the room. His presence made her feel much better."

From the day a young Mohaghegh was during the Iran-Iraq war to the day he was assassinated by Israel decades later, much had transpired. "He, however, remained unchanged. In his 60s, he was still the same determined young man I had seen at our first meeting. His ultimate goal was to serve his country and God, and he did exactly that," his wife said.

Armed Forces fully prepared, Iranian commander warns adversaries

TEHRAN - A senior commander of the Iranian Army warned Friday that the country is fully prepared to counter any aggression, emphasizing that its armed forces are drawn from the nation's most capable young personnel and are ready to defend against threats on land, at sea, and in the air.

Admiral Habibollah Sayyari, Deputy Coordinator of the Iranian Army, spoke to reporters on the sidelines of the 4th World Armies Archery Championship (WAC 2025), hosted by the Army Air Force at the national Archery Federation venue.

The remarks come amid ongoing efforts by Tehran to showcase its military preparedness and deter potential adversaries. Brigadier General Reza Talaei-Nik, Deputy for Strategic Planning and Parliamentary Affairs and spokesperson for the Ministry of Defense and Armed Forces Logistics, stressed that Iran's armed forces have significantly increased their armament, operational, and logistical capacities since the "12-day war," a brief but intense conflict that tested the country's of enemy preparations to strike Iran, the aggressor failed in the 12-day war. He warned that any future attempts at aggression would meet an even stronger Iranian response. citing enhanced defensive readiness and the increased vulnerability of potential adversaries to Iran's offensive capabilities. "Given the heavy losses and failures suffered in the 12-day war, it is unlikely the enemy would attempt another attack without carefully calculating its own vulnerabilities," he said.

TEHRAN - The ongoing saga between the Islamic Republic of Iran and the Financial Action Task Force (FATF) took another frustrating turn this week, as the global financial watchdog once again decided to keep Iran on its "high-risk" list. This decision came despite continued efforts by Iran to engage with the FATF process, and amidst opposition from some political factions within the country.

The narrative pushed by the FATF is one of Iranian non-compliance. In a statement published on Friday, the Paris-based watchdog claimed it "acknowledges Iran's re-engagement with the FATF... and that it aims to address deficiencies in its AML/CFT regime."

"Iran has failed to address the majority of its action plan since 2016," it further stated, adding that "Iran will remain on the FATF High Risk Jurisdictions Subject to a Call for Action statement until the full Action Plan has been completed."

Mere days before the statement, Iranian President Masoud Pezeshkian officially ratified and communicated the law on Iran's accession to the International Convention for the Suppression

of the Financing of Terrorism (CFT) to relevant executive bod-

Iran upholds sentences for 14 in massive fuel-smuggling case

TEHRAN – The Chief Justice of Hormozgan Province in southern Iran has announced that a provincial appeals court has upheld the verdict issued by the Bandar Abbas Court, finalizing the convictions of 14 members of an organized network involved in smuggling 27 million liters of diesel fuel.

According to the ruling, four ringleaders of the network were each sentenced to five years in prison and fined a combined total of 26 trillion rials (approximately USD 245 million). They have also been barred from all maritime activities, including transport and

fishing, for three years.

The remaining defendants received varying prison terms and financial penalties.

Authorities said the smuggling vessel was confiscated by court order after the operation led to an armed confrontation in which the suspects used incendiary materials against law enforcement officers.

Iran continues to grapple with widespread fuel smuggling, both overland and through maritime routes, a problem fueled by the country's heavily subsidized fuel prices—

among the lowest in the world. The sharp price gap between Iran and neighboring countries has long encouraged large-scale illegal fuel transfers.

In response, Iranian authorities, in coordination with the IRGC Navy, the Army, and law enforcement agencies, have intensified efforts to intercept smugglers by land and sea. Official figures indicate that an estimated 25 to 30 million liters of fuel products, including gasoline and diesel, are smuggled out of Iran every day.

Iran, Pakistan, Turkey to relaunch container train service in December

Pakistan's Ministry of Railways announced that both sides will draft a joint action plan to expand rail transport cooperation. They also agreed to launch the project to upgrade the Quetta-Taftan railway line next year, a key route linking the two countries.

Both nations committed to strengthening commercial and passenger rail operations and to creating a coordinated mechanism to follow up on bilateral agreements.

Sadegh, referring to last month's 22nd Iran-Pakistan Joint Economic Commission held in Tehran, emphasized the need to implement existing accords to deepen cooperation

She added that Iran and Pakistan's corridor capacities provide ideal opportunities for connecting China to Europe through their shared routes.

The regional transport conference in Islamabad, attended by representatives from 11 countries including Iran's road and urban development minister, concluded on Friday.

Last week, Pakistan's government has issued a new executive order aimed at promoting barter trade with Iran after months of consultation and review to address the concerns of both countries' business communities, Pakistan's ambassador to Tehran, Muhammad Mudassir Tipu, announced.

In a post on X on October 19, Tipu said: "I am pleased to announce that Pakistan has issued a new executive order (SRO) to promote barter trade with the Islamic Republic of Iran"

He explained that following an extensive and inclusive review process, many of the issues raised by Iranian and Pakistani traders have been addressed in the new regulation. The envoy expressed hope that the measure would significantly enhance the volume and diversity of trade between the two neighbors.

"I invite industrialists and the business communities of both countries to fully benefit from this order and contribute to the expansion of bilateral trade," he added, urging chambers of commerce and trade bodies in both nations to circulate the regulation among their members to help maximize its bonefits.

Earlier this month, Pakistan's Ministry of Finance approved a proposal by the Ministry of Commerce to revise the bilateral barter trade agreement with Iran. The decision was later endorsed by the federal cabinet chaired by Prime Minister Shehbaz Sharif.

Following the 22nd Iran-Pakistan Joint Economic Committee meeting in Tehran (September 15-16), co-chaired by Iran's Minister of Transport and Urban Development, Farzaneh Sadegh, and Pakistan's Federal Minister for Commerce, Jam Kamal Khan, Minister Sadegh published an article on the ministry's news portal. Below is a translation of her piece.

On the eve of new developments in the regional economic order, the Iran-Pakistan Joint Economic Committee has once again provided a platform for developing sustainable cooperation between these two important and influential neighbors in South Asia.

Iran-Pakistan relations over the past decades have always been influenced by regional developments, global politics, and security imperatives. Although political relations between the two countries have always been maintained at an acceptable level, their economic and trade capacities have not been actualized as they should have been. Now, on the eve of new developments in the regional



economic order, the Iran-Pakistan Joint Economic Commission has once again provided a platform for developing sustainable cooperation between these two important and influential neighbors in South Asia.

The 22nd meeting of the Joint Economic Committee was not only an opportunity to review the past and chart the future of the two countries' economic relations, but also, by holding an unprecedented joint business conference on its sidelines, sent a clear message to regional economic actors, governments, and observers: Iran and Pakistan are ready to turn their potential capacities into the driving engine of economic and trade cooperation.

Along with their long shared border, Iran and Pakistan also enjoy deep cultural and historical commonalities. The adjacency of the two countries in a region that houses the main arteries of energy, transportation, and trade has created a unique position for economic cooperation.

On one hand, Iran, with its vast oil and gas resources, can play a role as a reliable energy supplier for Pakistan. On the other hand, Pakistan, with its young and growing population and extensive needs in the fields of energy, infrastructure, and trade, can be one of Iran's most important export markets.

This natural convergence, although overshadowed by political considerations and sanctions in the past, can become the driving engine of the two countries' economic interactions in the new regional atmosphere.

The Iran-Pakistan Joint Economic Committee has, over the past two decades, always been a platform for negotiation and agreement in various fields. But what distinguished the 22nd meeting of this committee was the serious entry of the private sector into the process of dialogue and cooperation.

Holding a joint business conference with the participation of 50 Iranian companies and over 100 Pakistani companies, totaling 500 participants, indicated the serious determination of economic actors in both countries to move beyond the traditional boundaries of interactions. Such an event is rarely seen on the sidelines of Joint Committee meetings, which doubles its special importance.

At this conference, economic actors had the opportunity to closely familiarize themselves with the capacities, needs, and areas of cooperation of the other side and propose solutions for removing obstacles to direct trade, joint investment, and the development of border infrastructure.

One of the key points of this meeting and the business conference was the emphasis on the centrality of the private sector in Iran-Pakistan economic relations. Chabahar-Zahedan railway project surpasses 84% progress

TEHRAN – The Chabahar-Zahedan railway has passed 84 percent physical progress and is expected to become operational by the end of the current Iranian calendar year (March 20, 2026), according to Abbas Khatibi, deputy head of Iran's Construction and Development of Transportation Infrastructure Company.

Khatibi said the project has set a new national record by laying 50 kilometers of track

in just one month, achieving a daily rail-laying rate of 3,500 meters.

"This unprecedented milestone marks a new chapter in Iran's railway development," he said, emphasizing the government's strong determination to complete the eastern corridor and link the strategic port of Chabahar to the national railway network.

Tehran, Dushanbe to expand capital market cooperation; Iran offers to help launch Tajik commodity exchange

TEHRAN – Iran has expressed readiness to assist Tajikistan in establishing a commodity exchange and developing its securities market, the Securities and Exchange Organization (SEO) said on Saturday.

During a meeting between Iran's SEO Head Hojjatollah Seyedi and Tajik Finance Minister Faiziddin Qahhorzoda, both sides called for deepening bilateral cooperation in capital markets.

Seyedi noted that the two nations' cultural and linguistic affinities provide a strong foundation for closer collaboration.

"With around 60 years of experience in stock exchanges and over two decades in commodity markets, the SEO is ready to share its expertise with Tajikistan in launching commodity exchanges and implementing commodity-backed securities," he said.

He expressed hope that the meeting would mark the beginning of deeper cooperation between the two countries to expand capital market development.

Qahhorzoda said Tajikistan's economic policy prioritizes expanding partnerships with other countries, adding that cooperation with Iran in economic fields has been strong but could grow further.

He highlighted Tajikistan's steady economic growth over the past decade and welcomed Iran's support in establishing various types of stock and commodity exchanges to strengthen Tajikistan's financial infrastructure.

"Bridge of Trust and Development" Conference held with participation of Iran and Tajikistan

The specialized conference "Bridge of Trust and Development" was held on Saturday (October 25) in Dushanbe with the presence of Faiziddin Qahhorzoda, the Minister of Finance of Tajikistan, and Alireza Haghighian, the Ambassador of Iran.

At this meeting, Iranian ambassador, referring to Iran's experience in international financial institutions such as IOSCO, announced Tehran's readiness for cooperation, training, and the exchange of financial knowledge with Tajikistan.

Furthermore, Hojatollah Seydi, the Head of Iran's Securities and Exchange Organization, along with a group of experts from the organization, presented lectures on capital markets, Islamic financial instruments, green finance, and the supervision of emerging markets as part of this conference.

Iran and Tajikistan have agreed to address outstanding banking issues and establish a joint investment task force to enhance cooperation in areas such as energy, infrastructure, and agriculture, marking another step toward deepening their economic and financial relations.

Iran's Minister of Economic Affairs and Finance Seyed Ali Madanizadeh met with Sultan Rahimzoda, head of Tajikistan's State Committee on Investment and State Property Management, on October 15, to discuss practical measures for expanding bilateral collaboration.

During the meeting, Madaniza-



deh—who also chairs Iran's State Banks Assembly—highlighted the need to resolve pending banking and financial coordination issues between the two countries. Both sides agreed to accelerate efforts to finalize banking arrangements that would facilitate trade and investment flows.

The Iranian minister emphasized the investment potential in technical and engineering services, mining, infrastructure, agriculture, and knowledge-based industries, calling the Dushanbe International Investment Forum a vital platform for promoting mutual understanding and private-sector engagement.

He noted that three key economic agreements between the two countries—on investment promotion and protection, avoidance of double taxation, and customs cooperation—are now in force, providing a legal foundation for expanding commercial ties.

Madanizadeh also announced the signing of a memorandum of understanding to form the Iran-Tajikistan Joint Investment Working Group, which has already held three sessions, the most recent on the sidelines of the 17th Economic Cooperation Summit in Shiraz

He further underscored the readiness of Iran's private sector to exchange specialized business delegations and enhance knowledge of the Tajik market, adding that recent progress in visa-free travel has already boosted cultural and medical tourism between the two nations.

The Iranian delegation's trip to Dushanbe in mid-October and participation in the international investment forum underscored a strategic shift toward operational economic diplomacy, building on decades of cultural, linguistic, and historical ties.

A key focus of the talks was developing banking cooperation to remove long-standing financial barriers. Given the central role of banking systems in trade facilitation and capital transfer, resolving these issues could unlock new pathways for joint investment and empower private-sector initiatives

The implementation of the three foundational economic agreements—on investment protection, double taxation, and customs—provides a framework of mutual trust for businesses and investors. The establishment of the joint investment task force signals a move from political understanding to structured, results-oriented cooperation.

Collaboration in technical and engineering services, mining, infrastructure, agriculture, and knowledge-based industries has emerged as a key priority. These sectors, rich in development potential, can contribute to technology transfer, job creation, and sustainable growth in both countries. The Dushanbe forum served as a platform to identify shared capacities and connect Iranian and Tajik entrepreneurs.

The Iranian private sector is expected to play an increasingly vital role in this process. By forming expert delegations and strengthening trade intelligence, Iranian firms can establish joint ventures and seize opportunities in Tajikistan's growing market.

The visa-free travel agreement between Iran and Tajikistan has significantly expanded cultural and medical tourism, while also facilitating smoother business interactions. Analysts note that the deep cultural and civilizational ties between Tehran and Dushanbe have evolved into a powerful engine for economic cooperation, positioning Iran as a reliable partner in Tajikistan's path toward sustainable regional development.

Iran's minister of economic affairs and finance emphasized the expansion of brotherly relations and economic, commercial, and infrastructure cooperation between Iran and Tajikistan and proposed special opportunities for deepening these relations under the current conditions.

Seyed Ali Madanizadeh made the remarks in talks with Emomali Rahmon, the president of Tajikistan, on the sidelines of his participation in Dushanbe International Investment Forum.

During this meeting, the Iranian minister, thanking the provided opportunity for the meeting, announced that he carries a warm and sincere message of greetings from Mr. Masoud Pezeshkian, the president of the Islamic Republic of Iran, to the president of Tajikistan.

He emphasized that Mr. Pezeshkian is eager to meet and host him in Tehran.

Madanizadeh, stressing the importance of brotherly relations and close cooperation between the two countries, stated: Mr. Pezeshkian always places special emphasis on developing these relations in all fields.

He sincerely appreciated the principled and courageous positions of the Tajik government in condemning the attacks by the Zionist regime and the U.S. against the Islamic Republic of Iran, describing this stance as indicative of a deep understanding of the sensitive regional conditions and the necessity of supporting stability and sustainable security.

The Iranian minister also congratulated the president of Tajikistan on the successful holding of international meetings, especially the recent summit of heads of

state in the beautiful city of Dushanbe, and noted that Iran-Tajikistan relations have been noticeably growing in recent years.

Elsewhere in his remarks, Madanizadeh proposed that by defining special financial and banking mechanisms, using national currencies, bartering goods and services, and implementing joint projects, cooperation between the two countries could be expanded away from the effects of sanctions.

He continued: "In this regard, significant capacities for cooperation in various fields have been provided; including in investment and infrastructure projects, Iranian companies are ready to actively participate in implementing construction, power plant, road construction, housing, and urban development plans in Tajikistan."

The minister also said: "In the field of energy and electricity, cooperation in the construction of hydroelectric power plants, Tajikistan-Afghanistan-Iran electricity transmission lines, and the development of renewable energies are among the practical axes of cooperation. In the field of trade and banking, establishing direct payment channels, using national currency, and reciprocal credit lines will play an important role in facilitating economic relations."

He also announced Iran's readiness to establish a joint science and technology park, develop knowledge-based companies, and digitalize the economy with Tajikistan.

Emphasizing the high capabilities of Iranian technical and engineering companies in implementing large projects, Madanizadeh stated: "Strengthening the presence of these companies in Tajikistan, in addition to developing infrastructure, will lead to the transfer of Iran's technical knowledge and engineering technology to this country."

He added that Iran and Tajikistan can play an important role in the regional supply chain in the fields of energy, pharmaceuticals, agriculture, and technical and engineering services, and by synergizing their capacities, enhance their economic standing in the region.

At the end of the meeting, Madanizadeh once again thanked the president and the government of Tajikistan for their warm hospitality and emphasized: "We look forward to hosting Mr. Rahmon in Iran so that we can have constructive and effective talks in Tehran about the strategic roadmaps for long-term and sustainable cooperation between the two countries."

Speaking on Tuesday at the Dushanbe International Investment Forum, Madanizadeh highlighted the strengthening of economic and cultural ties between Iran and Tajikistan, emphasizing green investment opportunities and regional cooperation in energy, technology, transport, and agriculture as the foundation for sustainable development across Central Asia.

He said the conference, focused on green investment, serves as "a bridge for sharing ideas and a gateway to a sustainable and prosperous regional future."

'Power plant fuel reserves ready for winter, no blackouts expected'

TEHRAN – Iran's Energy Minister Abbas Aliabadi said the country's power plants are fully stocked with fuel for the winter, adding that no electricity shortages are expected in the coming months thanks to new generation projects and inter-ministerial coordination.

Speaking to state media, Aliabadi said despite facing five consecutive years of drought and an exceptionally hot summer, "compre-

hensive measures" have been taken to ensure stable electricity supply during the cold season

He noted that the Energy and Oil ministries have closely coordinated to fill power plant fuel reserves. "Compared with last year, we have managed to increase our fuel storage levels significantly," he said.

The minister emphasized, however, that public cooperation through energy saving remains essential.

"If the agreed fuel supply schedule between the Energy Ministry, Oil Ministry, and other agencies is implemented as planned, we will have a smooth winter with no disruptions to power for households or industries until early spring," he added.

"No Kings" slogan unites diverse voices, says American scholar

Philip Rocco notes the movement's strength lies in its broad symbolism that connects workers, immigrants, and defenders of civil rights

TEHRAN - In an exclusive interview with the Tehran Times, Philip Rocco, a professor of political science at Marquette University, examines the rise of the "No Kings" protests across the United States.

He describes the movement as both a revival of America's anti-authoritarian tradition and a response to the growing concentration of power in the executive branch under President Donald Trump's second term.

Rocco argues that the protests expose deep tensions between federal and state governments while signaling a broader crisis of democratic accountability.

By invoking the revolutionary slogan "No Kings," he notes, activists are linking the nation's founding ideals to today's fight against inequality, political polarization, and the erosion of institutional checks and balances.

The following is the text of the interview

How would you contextualize the emergence of the "No Kings" protest in the broader history of U.S. political dissent? Are we witnessing a new form of grassroots activism or an extension of long-standing anti-authoritarian movements?

That's a great question. I'm not a social movements scholar, so it's hard for me to give a definitive answer, but I can say that the form of protest we're seeing now draws on a long tradition of social movement mobilization going back at least a century.

At the same time, activists today are responding to new demands, new threats, and new challenges in mobilizing a populace that's quite socially fragmented. People no longer have the same social institutions that used to connect them routinely, even half a century ago. That has required using new forms of technology and communication to bring people together. By many measures, these are among the largest protests the United States has ever seen.

The choice of "No Kings" as a political formula is consistent with what successful social movements tend to do: they choose a symbol that's robust to different interpretations.

You have groups focused on the administration's attacks on workers, immigrants, and marginalized communities, as well as those concerned about fundamental democratic rights like voting and free speech. There's so much going on that finding a symbol that speaks to all those different groups can be difficult.

Academically speaking, how do you distinguish between strong executive leadership and the personalization of power? Where does the current U.S. con-

The growing power of the executive branch makes it difficult for Congress to assert leadership when the president pushes in another direction. Over the last year, we've seen the executive impound funds Congress has appropriated, with little congressional pushback.

What distinguishes the personalization of power from simple executive expansion is the use of state resources for personal political gain. For example, it would have been unthinkable for a prior president to deny disaster aid to a state simply because it didn't vote for them—but now we've seen signs that this is happening. That's not just strong leadership; that's the use of office to advance personal power.

Looking historically, which period of U.S. political development most resembles the current moment? Are we repeating cycles from past "imperial presidencies," or entering new territory?

It's difficult to draw direct historical parallels because the federal government today wields far greater power than in earlier eras.

We can trace threads back to illiberal moments—like the Alien and Sedition Acts under John Adams, the Civil War, or the Redeemer period after Reconstruction—but the current situation is unique. Even at those times of intense social conflict, power was not as concentrated in the presidency as it is now. This moment feels rather singular.

Catherine Connolly wins Irish presidency in landslide after pro-Palestine campaign



Catherine Connolly swept to victory in Ireland's presidential election, defeating center-right rival Heather Humphreys after early tallies put Connolly at roughly two-thirds of first-preference votes. Humphreys conceded as the gap proved

Turnout was around 40% and spoiled ballots surged to a historic level of roughly 13% — a sharp signal of public frustration over housing, the cost of living, and what many voters saw as a thin field of mainstream options that helped fuel Connolly's surge

A former clinical psychologist and barrister supported by an unusual left-wing coalition, the 68-year-old Connolly campaigned on social justice and Irish neutrality, emerging as the campaign's most visible voice on Gaza.

She has said plainly: "Israel has committed genocide in Gaza. The normalization of genocide is catastrophic for the Palestinian people, and it is catastrophic for humanity. I will stand in sol-

idarity with the Palestinian people as long as I have breath in my body."

About Hamas, she told The Irish Times that it is "not up to" Britain's prime minister to decide the group's role, arguing that Palestinians must choose their leaders. She has also accused the UK and the U.S. of enabling what she describes as genocide in Gaza.

Those blunt positions — together with her criticism of the EU's move toward greater military spending and stark historical comparisons about rearmament — won her fierce support at home and prompted warnings abroad.

Analysts say the largely ceremonial presidency gives Connolly a moral platform to spotlight humanitarian crises, but her rhetoric could also create diplomatic tensions with European capitals and Washington at a time when Ireland's economy remains closely tied to transatlantic

From cocaine to crude: Unmasking the U.S. agenda in Venezuela

From page 1 ▶ CNN reports that President Trump is considering strikes on cocaine facilities and trafficking routes inside Venezuela, even as officials acknowledge the country's minimal role in the drug trade. The United Nations and U.S. Drug Enforcement Administration confirm that coca cultivation is concentrated in Colombia, Peru, and Bolivia—not Venezuela. Nevertheless, Secretary of State Marco Rubio and other officials have aggressively painted President Nicolas Maduro as a "narcoterrorist", using these drug claims to justify possible military intervention.

Drop Site reporting sheds further light on the mechanics behind this campaign. Rubio, long a proponent of regime change, has redirected millions in the so-called "pro-democracy" funding toward military preparation, while U.S. contractors ramp up operations with combat boats, virtual training programs, and intelligence assessments. The leaked documents suggest a coordinated effort to position U.S. forces for action—echoing decades of covert interventions, from CIA operations to USAID-backed programs targeting Venezuelan institutions. Presented as "democracy promotion," these programs have historically served U.S. strategic interests rather than those of the Venezuelan people.

The drug narrative is increasingly pretextual. Access to Venezuela's oil resources appears to be the real priority, with regime change framed as the most efficient path to securing them.

Even military actions ostensibly targeting narcotics raise serious ethical and legal concerns. U.S. strikes on alleged drug boats have already killed dozens, with little evidence linking the vessels to smuggling capable of reaching U.S. shores.

Venezuelans are acutely aware of the U.S. underlying motives. As journalist Kleybergel González told the Tehran Times: "We Venezuelans are very clear that the U.S. government's true intention is to seize our natural resources, including oil and our rare earths in the south of the country. Therefore, many have responded by supporting President Maduro's calls for mobilization. Furthermore, we remain at work with a strong sense of patriotism and civic spirit, but alert to any U.S. military escalation."

For decades, the U.S. has sought to influence Venezuela's internal affairs under the guise of promoting democracy. From CIA covert operations to USAID and National Endowment for

Democracy programs, Washington has consistently invested in shaping political outcomes to align with its economic and geopolitical interests. Venezuelan sovereignty and stability hang in the balance while foreign interests pursue a prize that is not theirs

Canceled China visit marks early setback for Germany's Merz

has postponed his planned trip to China after Beijing confirmed only a meeting with Foreign Minister Wang Yi, with no additional high-level

Germany's Die Welt reported Saturday that the cancellation is viewed as a foreign policy setback for Chancellor Friedrich Merz, who, nearly six months into office, has yet to make his first visit to China.

The chancellor's office had reserved days for possible travel to China and India in the coming week, but President Xi Jinping reportedly did not find time to receive Merz on those dates.

The delay underscores the delicate phase of

Israel wages war on Lebanon from Safed under Washington's direction

BEIRUT — A consistent pattern of conflict connects Lebanon's past and present confrontations with American power, from the mountain outposts of Safed to the corridors of the Pentagon.

On the morning of October 23, 1983, a handful of young Lebanese operatives struck a blow against

Command headquarters in Safed, directly supervising the Israeli army's operations against Lebanon.

Every missile, every drone, and every incursion is executed under American watch. Washington no longer hides behind diplomatic neutrality — it has become a partner in the aggression.

Iran, China cultural exchanges accelerate, Beijing's ambassador says

TEHRAN - Beijing's ambassador to Tehran has said that cooperation between Iran and China in cultural heritage research has gained greater speed and depth over the past two years, describing the field as a strategic platform for expanding bilateral scientific and civilizational exchanges.

Ambassador Cong Peiwu said joint research projects in archaeology and related cultural heritage studies had provided a strong foundation for scientific and cultural cooperation between the two nations, IRIB reported on Saturday.

"These capacities have existed for years, and they are now being pursued in a more organized and profound way," Cong was quoted

Referring to China's recent international initiatives, Cong said cultural and scientific collaboration between Tehran and Beijing had expanded since the launch of a global initiative by Chinese President Xi Jinping. He said the trend showed that "two ancient Asian civilizations are taking effective steps toward mutual cultural and scientific enrich-

The ambassador also cited his visit to the UNESCO World Heritage site of Persepolis in April, where he met a group of Chinese re-



searchers, including members of the Chinese Academy of Sciences.

The presence of Chinese scientists at such a World Heritage site is a manifestation of ongoing practical cooperation in archaeology between the two countries, he explained.

"With significant progress in cultural heritage studies and mutual understanding between civilizations, we expect Iran-China cooperation in this field not only to continue but also to expand in a more structured and comprehensive way," the Chinese envoy said.

"Cultural heritage can serve as a lasting bridge between two ancient nations that have contributed greatly to global civiliza-

Minister calls for stronger private sector role to boost Tehran's tourism potential

TEHRAN - Iran's Minister of Cultural Heritage, Handicrafts and Tourism has underlined Tehran's significant potential for tourism growth while urged greater participation from the private sector to make full use of the city's capacities.

Seyyed Reza Salehi Amiri told IRNA on Saturday that 101 tourism investment projects worth 3.55 trillion rials (about \$3.5 million) are currently under way in Tehran province. He said the projects are expected to create more than 20,000 jobs.

"Achieving sustainable economic development is not possible without the active presence of the private sector," Salehi-Amiri said. He added that the government should shift from direct management to a facilitative and supportive role for entrepreneurs.

According to the minister, real support for private investors includes removing legal barriers, creating a strong competitive environment, and providing conditions for innovation.

Elsewhere in his remarks, Salehi-Amiri said he had visited several tourism sites in Tehran, including Bamland, the [artificial]

lake of Persian Gulf, [the cultural and tourism zone of Abbasabad , and the Alibaba complex, as well

He said the government's policy focuses on empowering the private sector, supporting creativity, and promoting competition within Iran's start-up eco-

Armenian Cultural Week begins in Isfahan's **Vank Cathedral**

TEHRAN—Concurrent with the beginning of the Armenian Cultural Week, the art medal of Khachatur Kesaratsi, the founder of the first printing house in Iran and West Asia, was unveiled at the Vank Church museum in New Jolfa, Isfahan, on Friday.

According to a Mehr news agency, this cultural event was held with the support of the Nerses Shnorhali Library of Vank and in the presence of the religious leader of the Armenians of Isfahan and Southern Iran, Bishop Sipan Kashjian, the head of the Assembly of Representatives of the Armenian Caliphate of Isfahan and Southern Iran, Noel Minasyan, and a group of artists and researchers in the field of Armenian history and culture.

The Khachatur Kesaratsi art medal is the work of artist Masih Ahmadi, which was designed and made as the first medal in a series centered on the famous Armenians of Isfahan.

In this work, he recreated part of the lead letters used in the printing of the first Armenian book in Jolfa in the 17th century and incorporated the Armenian letter symbol, the symbol of God in Armenian script, which was used in the printing of the Psalms of David in 1638 CE, into the design of the medal.

At the beginning of the ceremony, Director of the Archives and Manuscripts Department of the Vank Church Complex, spoke about the life and scientific legacy of Khachatur Kesaratsi and stated that Kesaratsi was not only the founder of the first printing house in Iran and the Middle East, but also turned New Jolfa into one of the scientific and intellectual centers of the East with his efforts and cultural

He added that the establishment of the printing house in Jolfa, Isfahan, is a turning point in the history of the transfer of knowledge and art from Europe to Iran.

Then, the artist who created the work, Masih Ahmadi, explained the process of designing and making the medal: "The idea of ??creating a series of art medals in memory of the prominent Armenians of Isfahan was formed about two years ago, and currently the first medal of this series has been realized, inspired by the life and works of Khachatur Kesaratsi.'

He added that in addition to its artistic aspect, this medal carries a message of preserving the role of Armenians in the cultural history of Iran.

In the final part of the ceremony, the Khachatur Kesaratsi Medal was unveiled by Bishop Sipan Kashjian and Masih Ahmadi, and copies of it were donated to the Armenian Caliphate Council of Isfahan. A short film of the design and manufacturing process of the medal was also shown to the attendees.

Khachatur Kesaratsi was an Armenian archbishop in Safavid Iran. He is credited with the founding of the first printing press in Iran, in 1633, or 1636. The first book was printed; a Saghmosaran (Psalter) in 1638.

Tourism maps installed at 14 Tehran metro stations, citywide map to be unveiled soon

TEHRAN - Tourism maps have been installed at 14 Tehran Metro stations as part of a broader plan to introduce city attractions through the public transport network, the head of Tehran's municipal tourism office said on Saturday.

Amir Qasemi, head of the Tehran Municipality's Tourism Headquarters, on Saturday said the initiative aims to enhance passenger experience and promote urban tourism by highlighting attractions near metro stations.

"The plan to organize and present tourism attractions at metro stations has been implemented to improve the travel experience of citizens and tourists and to develop tourism in the city," Qasemi said.

He added that planning for metro-based city tours began about a year ago, during which routes and key urban areas were identified. "We selected stations with potential for introducing nearby attractions and designed specific tourism maps for them," he

According to Qasemi, 40 metro stations have been targeted in the first phase of the project. Maps have been installed at 14 of them, including Baharestan, Sa'di, Darvazeh Dowlat, Ferdowsi, Darvazeh Shemiran, Khayyam, Imam Khomeini, Hosseinabad, Panzdah-e-Khordad, Mohammadiyeh, Molavi, Qiam, Shohada and Mellat.

The maps show each station's location along with tourist sites, services and facilities within a 500-meter radius to help passengers and



visitors explore nearby destinations.

Elsewhere in his remarks, Qasemi said a comprehensive tourism map of the entire Tehran Metro network has also been completed and will be unveiled soon. "This map will allow citizens to experience Tehran from a new perspective through the metro system," he said.

In the heart of this region, Sezar (Caesar) Cave, with its unique geological structure, has of environmentalists, tourism activists and public representa-

It is not just a natural phenomenon, but it can be a leading example of converting natural resources into economic advantage while protecting and respecting the environment; a model that many regions of the country need.

Abbas Papizadeh, an MP representing Dezful in the Iranian parliament, pointed to the latest efforts in the field of tourism development in Shahyoun. Sezar Cave is very important from a geological perspective due to its karst structure and special rock layers. Local experts believe that this cave can form part of the Northern Zagros cave network and be introduced as a special study point on the national geological map.

Initial studies have shown that in some parts of the cave, water pools, natural reliefs and rare species of bats and insects can be seen, indicating its biological richness. Such features can make Sezar Cave one of the leading geotourism attractions in the south of the country in the

Also, Adel Mola, Khuzestan's Department of Environment deputy chief, said that currently, Dezful County has the largest number of identified caves in the province, and five caves, including one cave in Behbahan and several caves in the Shahyoun district of Dezful, are in the firstclass category. These caves are of great importance due to their unique structure and special biodiversity, he added.

According to the vice-presidency for science, technology, and knowledge-based economy, the need to manage energy resources, optimize consumption, and improve energy efficiency is of particular importance, IRNA reported.

The high energy consumption in Iran and the increasing pressure on national resources have doubled the need to develop the culture of saving, utilize modern technologies, and achieve greater productivity in all economic and industrial sectors.

This year's event aims to showcase the latest achievements, share knowledge and expertise between experts, and serve as a platform to boost cooperation between the public and private sectors.

Holding specialized panels on energy optimization policies, optimizing energy in industry, buildings, and transportation are other sections of the fourth IREEC.

On the sidelines of the conference, domestic and international companies will display their latest technological accomplishments and innovative solutions in optimizing energy and improving efficiency.

Iran to boost renewable power capacity

Attending the 29th meeting of the International Renewable Energy Agency (IRENA), Iran's representative underlined the country's commitment to the expansion of renewable energy sources via taking various measures.

These include growing solar and wind power production capacities and implementing strategies to improve energy efficiency across residential and industrial sectors, IRNA reported.

The 29th IRENA was held on September 11 and 12 in Abu Dhabi, Dubai. Iran participated in the meeting for the first time.

The meeting gathered more than 400 officials from IRENA's Members, comprising 169 countries and the European Union, to provide strategic guidance on the Agency's work

programme and to address pressing issues shaping today's global energy transition.

In August, an energy official said Iran plans to expand its renewable energy capacity to 7,000 megawatts by the next Iranian calendar year (begins late March 2026), up from

Jafar Mohammadzadeh, deputy head of investment at the Renewable Energy and Energy Efficiency Organization (SATBA), told IRIB that the government has accelerated solar and other renewable projects, targeting a sharp increase in output. He noted that the ministry's plan to add 100 MW each week reflects earlier preparations in the sector.

"Our goal is to raise renewable energy's share in the country's electricity mix from the current 1.5 percent to 15 percent by the end of the 14th government's term," he said, adding that Iran's vast solar potential gives the target strong backing.

Mohammadzadeh said peak electricity demand occurs during summer, when solar output is also at its highest, making renewables particularly valuable. He added that small- and large-scale solar projects are being supported through attractive contracts, including long-term guaranteed purchase agreements that allow investors to recover costs in about three years.

He also noted that in the short term, some equipment imports will be required to speed up construction of large-scale plants, with the Ministry of Industry, Mining and Trade providing support.

TEHRAN - Over 1,100 participants from 65 countries, including Pakistan, Oman, Vietnam, Tunisia, India, Turkey, Bangladesh, Iraq, Azerbaijan, Lebanon, Indonesia, the Netherlands, and Romania, will attend the second international technology Olympics, which is planned to be held from October 27 to 30, at Pardis Technology Park,

The first international technology Olympics was held last year, attracting over 6,300 participants from Iran and other countries. This year, the number of elite Iranian students participating in the event has risen to over 11,000, ISNA quoted Hossein Afshin, the vice president for science. technology, and knowledge-based economy, as saying.

The participants will compete in five different fields, including artificial intelligence, cybersecurity, programming, robotics, drones, and Internet of Things (IOT). Each of these competitions consists of several leagues, covering different specialized areas within the field.

The robotics section involves lightweight, heavyweight, and student leagues, and the drone section has various competitions in different fields such as autonomous missions, group flying, and flight intelligence.

The event aims to identify talented individuals, train them, and help them get employed at the national and international levels, Afshin said.

Iran ranks 72 in technology, innovation According to the United Nations Conference on Trade and Development (UNCTAD) Technology and Innovation Report 2025, Iran is ranked among upper middle-income coun-

tries, ranking 72nd among 166 countries.

The country's ranking has improved by one position compared to 2022.

UNCTAD has categorized 17 types of technologies as frontier technologies, including artificial intelligence, Internet of Things, big data, 5G, 3D printing, robotics, drone technology, solar photovoltaic, concentrated solar power, biofuels, biogas and biomass, wind energy, green hydrogen, electric vehicles, nanotechnology, and gene editing.

The Technology and Innovation Report 2025: Inclusive Artificial Intelligence for Development surveys the complex artificial intelligence landscape, aiming to help decision-makers design science, technology, and innovation policies that foster inclusive technological progress.

The Report 2025 calls for AI that puts people first and is shaped through global cooperation in which all countries have a say. The Report identifies three key leverage points infrastructure, data, and skills – offering a broad socioeconomic perspective on AI while analyzing requirements and policies to promote sustainable industrialization and inno-

The sub-indices of readiness for frontier technologies in 2025 show that Iran's best ranking is in the research and development sub-index (35th in the world).

In the finance sub-index, the country's ranking has improved from 62 in 2022 to 56 in 2025. In other sub-indexes like skills and the establishment of information and communication technology, its ranking has lowered from 74 and 78 in 2022 to 82 and 94 in 2025, respectively.

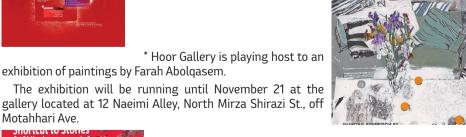

"Oliver!" was the first musical adaptation of a famous Charles Dickens work to become a stage hit. The plot of Dickens's original novel is considerably simplified for the purposes of the musical, with Fagin being represented more as a comic character than as a villain, and large portions of the latter part of the story being completely left out.

"Oliver Twist" is the second novel by English author Charles Dickens. It was originally published as a serial from 1837 to 1839 and as a three-volume book in 1838. The story follows the titular orphan, who, after being raised in a workhouse, escapes to London, where he meets a gang of juvenile pickpockets led by the elderly criminal Fagin, discovers the secrets of his parentage, and reconnects with his remaining family.

"Oliver Twist" unromantical-

ly portrays the sordid lives of criminals and exposes the cruel treatment of the many orphans in England in the mid-19th cen-

In an early example of the social novel. Dickens satirizes child labor, domestic violence, the recruitment of children as criminals, and the presence of street children. The novel may have been inspired by the story of Robert Blincoe, an orphan whose account of working as a child laborer in a cotton mill was widely read in the 1830s.

It is likely that Dickens's own experiences as a youth contributed as well, considering he spent two years of his life in the workhouse at the age of 12 and subsequently missed out on some of his education.

"Oliver Twist" has been the subject of numerous adaptations, including the 1948 film of the same name, starring Alec Guinness as Fagin; a highly successful musical, "Oliver!" (itself adapted into the Oscar-winning 1968 film), and Disney's 1988 animated feature film "Oliver & Company".

Audiobook of Vahid Yaminpour's travelogue to Japan released

TEHRAN- The audio version of the Iranian writer Vahid Yaminpour's travelogue to Japan, "The Kannushi of the Jinja Temple," has been released in Tehran.

Narrated by Yaminpour, the audiobook has been produced by Samava, an Iranian institute that produces audiobooks, Mehr reported on Friday.

Award-winning artists join 450 Jews demanding Israel sanctions

More than 450 prominent Jewish figures worldwide have issued a collective demand for international sanctions against Israel in response to the situation in Gaza. In an open letter to United Nations officials and global leaders, the group called for concrete measures against what they described as Israel's violation of international humanitarian law in Palestinian territories.

The signatories urged world powers to comply with rulings from both the International Court of Justice and International Criminal Court while immediately halting weapons transfers to Israel. They also demanded guaranteed humanitarian access to Gaza and rejection of what they termed unjustified "antisemitism accusations" against those advocating for peace and justice. The letter emphasized that Palestinian solidarity constitutes "the fulfillment of Judaism, not its betrayal," Yeni Şafak reported.

Among the distinguished signatories are

former Israeli Knesset Speaker Avrom Borg, former peace negotiations head Daniel Levy, British writer Michael Rosen. Canadian author Naomi Klein, Oscar-winning director Jonathan Glazer, American actor Wallace Shawn, Emmy-winning actresses Ilana Glazer and Hannah Einbinder, and Pulitzer-winning author Benjamin Moser. The letter's publication precedes an upcoming European Union leaders summit amid discussions about potential sanctions relief for Israel.

Concurrent with this diplomatic initiative, significant shifts in American Jewish perspectives are emerging. A Washington Post survey reveals that 61% of American Jews believe Israel has committed war crimes in Gaza, with 39% characterizing Israeli actions as genocide. A separate Brookings Institution poll indicates 45% of all Americans view Israel's campaign as genocidal, including 77% of Democrats, reflecting growing domestic criticism of Israeli policies.

Since October 7, 2023, at least 68,000 Palestinians have been killed and more than 170.000 injured, according to Gaza's health ministry, while the UN estimates that roughly 90% of the population is internally displaced. Two US Democratic senators, Chris . Van Hollen and Jeff Merkley, concluded after a fact-finding mission to the region in September that Israel was implementing "a systematic plan to destroy and ethnically cleanse Palestinians from Gaza", with the US complicit in these actions.

Their report detailed the near-total destruction of civilian infrastructure, the weaponization of food and systematic obstacles to humanitarian aid delivery.

More than two years of conflict have left over two million Palestinians, half of whom are children, without access to sufficient water, food, or medical care. Famine has become a deadly reality, with catastrophic hunger tightening its grip across the population.
