TEHRAN – As the Rapid Support Forces (RSF) consolidate control over western Sudan with the fall of el-Fasher, the capital of North Darfur, questions are growing about the involvement of foreign actors—particularly Israel and the United States—in shaping the trajectory of the country's civil war.

While Israel has not formally recognized either the RSF or the Sudanese Armed Forces (SAF), mounting evidence suggests it has quietly tilted toward the RSF, prioritizing long-term strategic gains over short-term diplomatic optics. The United States, meanwhile, has publicly condemned RSF atrocities—but has done little to restrain its closest allies from supporting the group.

Frontlines shift

On October 26, the RSF captured el-Fasher, SAF's last stronghold in Darfur. The city's fall marked a grim milestone: the RSF now holds de facto control over more than a quarter of Sudan's territory.

Israel, U.S. fabricating a plot to justify attack on Iraq

Gaza's shadow over NYC: How a mayoral race turned into a moral referendum

TEHRAN – Zohran Kwame Mamdani, the Ugandan-Indian son of a postcolonial scholar who was born in Uganda, has done something the pundit class assumed impossible: his campaign dragged the once-distant politics of Gaza into the center of a New York mayoral election and forced voters to decide whether American power remains accountable.

Mamdani's blunt language — "We are on the brink of a genocide of Palestinians in Gaza" — didn't occur in ivorytower debate; it landed in subway stations, viral clips, and the homework of swing voters.

That moral naming is the reason his rise matters and the reason the backlash was immediate.

When he doubled down with lines like "If I'm the Mayor, the NYPD will arrest Netanyahu" and "It is important that NYC is in compliance with international criminal law," Mamdani signaled that his politics weren't just rhetorical—they were about wielding power in ways that unsettled the establishment.

Iran secures first place among Islamic nations in Leiden ranking

TEHRAN – The 2025 Leiden University ranking system has included 48 Iranian universities among the top 1,594 universities worldwide, up from 46 in 2024, ranking the country first among Islamic nations in terms of the number of universities for the second consecutive year.

A total of 184 universities from Islamic countries are included in this year's ranking. Turkey, with 45 universities, Saudi Arabia, with 20, Pakistan, with 16, and Egypt, with 15, are placed second and fifth, respectively, IRNA reported.

A sanctions-proof port

The Iran newspaper highlighted the strategic importance of Chabahar Port for India. The paper argued that with the U.S. extending its sanctions waiver for Indian activities at Chabahar until April 2026, New Delhi has once again secured its foothold in one of the region's most critical maritime and land connectivity hubs. This decision carries broad geopolitical implications, positioning Chabahar as a pivotal node in the balance of power and transit corridors linking South Asia to Central Asia. For India, Chabahar is not merely a port development project; it is a vital link in its dual strategy to establish both maritime and overland access to Central Asia. According to India affairs expert Omid Babolian, Iran's significance in New Delhi's strategic calculus goes beyond economic cooperation. With its maritime location, civilizational depth, and ability to bridge diverse geopolitical spheres, Iran is an indispensable element in India's connectivity policy. Removing Iran from this equation would create a structural gap in India's strategic outreach. In this context, the renewed sanctions exemption is not just a bilateral gesture between India and the United States; it reflects Tehran's central role in New Delhi's broader strategic vision known as the "Maritime India" doctrine.

Ettelaat: The enemy seeks psychological

Ettelaat analyzed recent claims that Iran received a message from Donald Trump via Oman regarding a resumption of nuclear negotiations. The report noted that speculation surged following news of diplomat Takht-Ravanchi's visit to Oman. However, a wellinformed source emphasized that no such message had been received and dismissed the reports as baseless. Given Oman's history of mediation, such claims were predictable. But the official denial shows that Iran is unwilling to accept narratives that talk about a negotiation offer without mentioning America's unacceptable conditions. Negotiations with unacceptable conditions would be meaningless, and would only serve to accuse Iran of being opposed to negotiations. The American side, through such media tactics, appears intent on reviving the defunct negotiation track and tying public sentiment to the psychological impact of any news related to talks. The outcome of this approach is that any pause in negotiations triggers economic shock, allowing sanctions to retain their leverage over Iran's economy.

Shargh: Hope for surrender, diplomacy amid doubt and distrust

Shargh reflects on the stalemated nuclear talks, suggesting it has reached a juncture best described as the "Station of Hope for Surrender." Each side in this high-stakes game believes its pressure tactics will ultimately force the other to retreat. As the current impasse persists, diplomacy has increasingly become a waiting game. Iran continues to assert its right to nuclear technology and its stance of resistance, while the United States and its allies insist on maintaining pressure until Tehran fully returns to previous restrictions. The lack of inspector access has made it difficult to accurately assess the status of Iran's centrifuges and uranium stockpiles. This oversight vacuum raises the risk of miscalculations. Two decades of negotiations between Iran and the West have shown that no deadlock in international politics is permanent. Just as past pressures eventually led to talks, there remains a possibility of a gradual softening of positions. However, this time, the cost of returning to the negotiating table will be significantly higher for all parties involved. Until then, nuclear diplomacy remains trapped in a cycle of mistrust and speculative hope for surrender.

Kayhan: Post-JCPOA Iran and imperative of power-building

Kayhan argued for a paradigm shift in Iran's foreign policy, asserting that continuing pre-JCPOA strategies would be a big mistake. It said in a world transitioning from a unipolar order to a multipolar structure, actors capable of intelligently managing their power will exercise decisive influence. In this context, Iran must adopt a strategy rooted in "power-building" to secure its role as an independent and impactful regional force. Shifting from an engagementcentric approach to one focused on strategic empowerment could steer Iran toward a policy of active and intelligent resistance. Real diplomacy succeeds only when backed by genuine power. In a global arena where negotiation tables are set to favor the powerful and where military aggression can occur mid-negotiation, Iran must possess tangible instruments of strength to safeguard its interests. Only then can it engage major powers from a position of parity, rather than weakness.

Institute hosts press briefing on 'We and the West' conference set for November 10



TEHRAN - Ahead of Iran's Day of Anti-Imperialism, the press conference for the conference "We and the West: The Thoughts and Views of the Leader of the Islamic Revolution" was held at the Islamic Revolution Research and Cultural Institute.

The event was attended by Mohammad Eshaqi, Deputy for Research and Education at the institute; Mousa Haqqani, the conference's scientific secretary; and Mousa Najafi and Mohammad Javad Larijani, members of the policy council overseeing the event.

Es'haqi highlighted the historical and contemporary influence of Western civilization, saying, "Western countries have

progressed from colonial powers to a system of global hegemony. In contrast, over the past 25 years, the Islamic Revolution has built a broad front of resistance that extends even into the United States, Europe, and their universities and think tanks."

He added that the foundations of Western civilization—both theoretical, including human rights, democracy, secularism, and women's rights, and practical, such as military, economic, and media power-are now facing a legitimacy crisis. "Recent events in Gaza, Lebanon, and other countries show the West's limited commitment to human rights and the freedom of nations," he said.

Another alleged Iranian spy arrested in Israel

Apprehension comes as Iran's June attacks fueled Israeli anger over the regime's handling of security

report that a 23-year-old Israeli citizen, of Tubariya, has been apprehended on charges of spying for Iran in exchange for

"Yosef Ein Eli, 23, allegedly received thousands of shekels to collect intelligence for Iranian operatives on hotels, IDF soldiers and senior officials in latest case of Israelis charged with espionage since Gaza war began," claimed Ynetnews.

"He was arrested in September following a joint investigation by the Shin Bet intelligence agency and the Lahav 433 serious crimes unit of the police," the report added. Iran has not confirmed the report.

Over the past couple of years, the Israeli regime has arrested an increasing number of people on charges of spying for Iran.

Earlier this year, Iranian Intelligence Minister Esmail Khatib noted that a "treasure trove" of intelligence containing millions of diverse and invaluable pages of data pertaining to the Israeli regime had been transferred to Iran.

"These documents contain [information on] the ... regime's previous and current projects, projects to upgrade and reprocess old nuclear weapons, joint ventures with the U.S. and certain European countries, as well as full information on the administrative structure of, and

arms," the Iranian minister said.

He reiterated that Israeli nuclear and military institutions as well as ordinary citizens cooperated with the Iranian Intelligence Ministry, sharing with Iran a large quantity of documents.

"The motive behind this cooperation was two-fold; first material incentives and getting money, and second, hatred of the corrupt and criminal Israeli prime minister," he explained.

Israel's internal security agency (Shin Bet) reported a

those associated with atomic 400% increase in identified espionage cases in 2024 compared to the previous year. This number is expected to have risen further in the first half of 2025, especially after the 12-day war with Iran. Reports indicate that Jewish residents of the occupied territories believed Netanyahu had dragged the regime into a war with Iran without preparing the necessary defenses for downing Iranian missiles. During the exchange of fire, Iran wrought expansive destruction in Israeli cities, including Tel Aviv and Be'er Sheva. General Rahim Safavi, an advisor

to Iran's Leader, recently stated that Israel's defense systems were crippled during the war.

Meanwhile, the launched a massive advertising campaign in July urging Israelis to resist the "lure" of spying for Iran, warning that the consequences far outweigh any financial reward. The unusual drive came a month after the 12day war ended.

The campaign, entitled "Easy Money, Heavy Cost," would run on radio, major internet sites, and social media platforms, and had been devised by the Shin Bet, and the National Public Diplomacy Directorate.

In one of the two 20-second videos, a father is shown eating with his family, while the second shows another man having drinks with friends before a caption on the screen reads: "For 5,000 shekels is it worth ruining your life/family?"

The 5,000 shekels is an apparent reference to how much Israelis have been paid for allegedly cooperating with Iran.

The ad says people who took Iranian cash are now behind bars and warned that anyone helping Tehran faces up to 15 years in prison. "Easy money, heavy cost."

In his video message, Intelligence Minister Khatib said there are numerous people inside the occupied territories that are still in cooperation with Iranian forces.

'Iran's rights are non-negotiable'

Referring to the possibility of renewed talks with Washington, Baqaei said: "The situation is clear. The rights and interests of the Iranian nation must be respected. In no negotiation will we unilaterally give up our legitimate rights."

He stressed that only if "realism and mutual respect" emerge can the grounds for dialogue be established. "At the moment," he added, "we are not at that stage."

Before waging war on Iran, the U.S. president Donald Trump managed to get the country to engage in indirect negotiations on its nuclear program - a contrast to his first term when Tehran had refused such talks after he withdrew from the 2015 Iran nuclear deal and re-imposed sanctions against the nation. Yet, the U.S. President began the war only days before a sixth round of the negotiations was set to take place in

'No message from the U.S. via Oman'

Addressing reports about Iran's Deputy Foreign Minister Takht-Ravanchi's visit to Oman, Baqaei said the issue of "polluted water imports" was raised but clarified that the matter was resolved and a statement would soon confirm that the goods posed no problems.

He rejected claims of any message transfer from the United States during the visit, saying:

"No message from the U.S. was conveyed to us in Oman. Intermediaries may exchange messages, but that does not mean negotiations have begun."

In an interview with Al Jazeera published on Sunday, Iranian Foreign Minister Abbas Araghchi also denied claims of receiving messages from the United States.

'Main threat to the region is the Zionist regime'

Baqaei said the region continues to face "a major problem called occupation," adding that despite the so-called ceasefire, the genocide in

"More than 200 people have been martyred since the ceasefire. The guarantors of the truce now bear an even greater responsibility." he

He also condemned the killing of 270 journalists during the ongoing Israeli assault, describing it as "an unprecedented crime" and proof that what is taking place in Gaza "is not war, but genocide."

Responding to remarks by regional officials, Baqaei underlined that there is "no doubt among regional states" that the main threat comes from the Zionist regime, adding: "We are in a real war with this regime. Genocide in Palestine and the ongoing occupations in Palestine and Syria prove this reality."

He echoed Omani statements emphasizing that regional security must be achieved through understanding and cooperation among the region's countries, not external interference.

deteriorate under the Israeli regime's blockade The United Nations said more than 16,500 Palestinians in need of specialized medical care remain trapped inside Gaza, unable to leave for

More than three million years of human life have been lost in Gaza since the genocide began, according to a new study published in The Lancet. The research analyzed the deaths of more than 60,000 Palestinians between October 2023 and July 2025, estimating that each life lost equated to an average of 51 years.

Most victims were civilians, and more than one million of those life-years belonged to children under 15. The study noted that its figures are conservative, counting only direct deaths from airstrikes and shelling, not those caused by hunger, disease, or the collapse of Gaza's health

'Epstein emails reveal moral corruption of

Commenting on emails attributed to Jeffrey Epstein mentioning military pressure on Iran, Bagaei said they expose "the moral decay of Iran's

"A man guilty of human trafficking symbolizes the corruption of those who lecture others on human rights," he said.

'U.S. actions against Venezuela violate international law'

Baqaei strongly condemned U.S. actions against Venezuela, calling them "a violation of international peace and security" and contrary to the UN Charter.

Iran-US conflict a deep-seated clash of interests

TEHRAN - Leader of the Islamic Revolution Ayatollah Seyyed Ali Khamenei addressed the prospect of Iran-US normalization on Monday, saying the two countries represent two different currents, and that Washington must take several necessary steps before it can establish ties with Iran.

The Leader's remarks came during a meeting with Iranian students, commemorating November 4th, the day Iranian students took over the U.S. embassy in Tehran over fourand-a-half decades ago. The embassy had been used to orchestrate the 1953 coup against the democraticallv-elected government of Mosaddegh, and was also the site where U.S. officials were plotting against the newly-victorious Islamic Revolution

Referring to some statements by the U.S. expressing willingness to cooperate with Iran, Ayatollah Khamenei stated, "Cooperation with Iran is not compatible with the US's cooperation and support for the accursed Zionist regime."

Ayatollah Khamenei described Washington's continued assistance and support for the Zionist regime, despite this regime being publicly exposed and condemned worldwide, as meaningless and unacceptable when requesting cooperation from

The Leader of the Islamic Revolution further emphasized, "The U.S. sometimes says it's willing to cooperate with Iran. If they stop supporting Zionist regime, remove military bases from the area and stop interfering in the region, these matters could potentially be reviewed. This

isn't something foreseeable for now, nor for the near future."

In his remarks, Ayatollah Khamenei elaborated on the historical enmity of the U.S. with the Iranian nation and the dimensions of the US Embassy seizure on November 4, 1979. He stated, "The seizure of the American embassy by the youth can be examined from two perspectives: historical and identity-based."

From a historical perspective, Ayatollah Khamenei described November 4, 1979, and the courageous action of the students in seizing the U.S. embassy, as a day of honor and victory for the Iranian nation. He emphasized, "In the history of Iran, there have been both days of victory and days of weakness and decline, both of which must be preserved in the national memory."

Discussing the identity dimension of this significant event, the Leader stated, "The embassy seizure clarified the true identity of the U.S. government as well as the real essence and nature of the Islamic Revolution."

Referring to the Ouranic root of the word arrogance (istakbar), he explained that it signifies self-superiority. He stated, "At times, a state such as Britain in a certain era. or today the U.S., grants itself the right to interfere in the vital interests of nations, dictate terms to them, establish military bases in countries with weak governments or unaware populations, or plunder the oil and resources of nations. This is the very arrogance we oppose and protest against."

The Leader of the Islamic Revolution also referred to the conspiracies of Britain and its allies to disable

Mossadegh's government, recalling Mossadegh's naive approach and reliance on the US to save Iran from Britain. He added, "The U.S. smiled at Mossadegh, but behind the scenes, in collusion with the British, they orchestrated a coup, overthrowing the national government and returning the fleeing Shah to Iran."

Ayatollah Khamenei described the first encounter of the U.S. with the Islamic Revolution as the hostile resolution passed by the U.S. Senate. He highlighted the public anger that arose after allowing Mohammad Reza Pahlavi to enter the U.S., stating, "The Iranian nation felt that by hosting the Shah there, the US was attempting to repeat the coup of August 19, 1953, and prepare for his return to Iran.

Iranian MPs approve provisions to counter infiltration of foreign spy services

TEHRAN - The National Security and Foreign Policy Committee of Iranian Parliament has approved some provisions of a motion on countering the infiltration

"Members of the committee reviewed a motion to counter the infiltration of foreign intelligence services, governments or institutions into the country, and ratified some of its provisions," said Ebrabim Rezaei, the spokesperson for the committee.

Also present at the meeting were representatives of relevant bodies, namely intelligence authorities

Iran has seriously dealt with spies and espionage activities as part of measures to safeguard national security. In mid-June, 2025, Iran executed a man convicted of collaborating with the Israeli Mossad spy agency and attempting to share classified and sensitive information with the occupying Tel Aviv regime in exchange for money. The execution took place after the Supreme Court upheld the death sentence.

The individual, identified as Esmaeil Fekri, was in close contact with Mossad operatives, and was captured in December 2023 during a complex intelligence operation carried out by Iranian security agencies. Iranian officials have also arrested a number of people on suspicion of spying for Israel's Mossad intelligence agency, following the latest Israeli military aggression against the Islamic Republic.

'Same results for Israel— only worse', Iran FM cites greater readiness than 12-day war

TEHRAN - Iran is fully prepared to defend itself against any aggression, Foreign Minister Abbas Araghchi said in an exclusive interview with Al Jazeera published on Sunday, asserting that the country's military, intelligence, and missile capabilities are stronger and more coordinated than ever.

He warned that any repeat of the 12-day war with Israel would meet "the same results — only worse" for the aggressors.

At the same time, Araghchi emphasized that Tehran is ready to resume nuclear negotiations based on mutual interests, noting that the formula used in the 2015 JCPOA agreement remains viable today.

On fears of renewed conflict, Araghchi said: "It is clear that we are prepared for every scenario. The possibility of war from a belligerent regime — one that has initiated multiple conflicts in our region — cannot be ruled out. But we are fully ready for any situation."

He stressed that Iran has learned from the 12-day war, improving operational capabilities, intelligence, and morale: "We are even more ready than before the 12-day war. Israel achieved none of its objectives then, and if it repeats that failed experience, it will face the same outcome, only this time we are stron-

On June 13, Israel launched a blatant and unprovoked act of aggression against Iran, triggering a 12-day war that killed at least 1,064 people in the country, including military commanders, nuclear scientists, and ordinary civilians. The United States also entered the war by bombing three Iranian nuclear sites in blatant violation of international law.

In response, the IRGC launched a meticulously calculated series of missile and drone strikes over twelve days. These targeted assaults, now known to have reached 22 distinct operational waves, dismantled key Israeli military, intelligence, and technological infrastructure—leading to a pressured halt in

Araghchi highlighted weaknesses in Israel's military: "Israel's air defense system is completely penetrable. Despite external support and multiple defensive layers, our missiles breached it. We now have far more experience, tested in real combat, and can strike with greater precision and power."

He noted that while Israel claimed to control Iranian airspace during the 12-day war, Iranian missiles reached Israeli territory as well, exposing flaws in their defenses.

Araghchi stressed that preparedness is itself a deterrent: "Our readiness for war is the best way to prevent war. We have no interest in conflict or its escalation, but we face a belligerent, expansionist regime.'

He added that Iran's regional ties have strengthened since the last war, creating a clearer understanding of the real threat: "Netanyahu, despite his crimes, has shown the region that Israel — not Iran — is the true enemy. This awareness is now shared across the Middle East."

Araghchi addressed reports that Netanyahu is not seeking a new war, noting Iran maintains high alert. On the U.S. and the disputed snapback mechanism, he said Washington and its European allies acted illegally: "Over 120 Non-Aligned Movement countries support Iran's position. There is no global consensus on sanctions against Iran — only a legal and political dispute."

Pezeshkian inaugurates 4 key water, power projects across Iran

TEHRAN – President Masoud Pezeshkian on Monday inaugurated four major water and power projects nationwide via video conference, marking a new step in expanding Iran's renewable energy capacity and improving water infrastructure.

According to the Energy Ministry, the inaugurated projects include renewable power plants and electricity optimization programs with a total capacity of 917 megawatts and a combined investment of about \$330 million.



The ceremony also featured the launch of the Sahand combined-cycle power plant in East Azarbaijan Province, the Robat Karim wastewater treatment facility in Tehran Province, and the Taleqan water transfer system to supply drinking water to Tehran and Alborz.

Officials said the new projects would enhance energy efficiency, secure water resources, and boost service reliability across several regions.

Iran, China stress creation of joint cooperative committee to boost economic ties

TEHRAN – Iran and China have agreed to form a joint cooperative committee to enhance collaboration in key economic sectors, including agriculture, mining, petrochemicals, and joint investment, officials from both sides said during a meeting in Tehran.

The meeting was held between Bahman Abdollahi, head of the Iran Chamber of Cooperatives, and Cong Peiwu, China's ambassador to Iran.

Both sides underscored the long-standing strategic partnership between Tehran and Beijing and explored new avenues for cooperation between cooperative enterprises in the two countries.

Abdollahi noted that Iran's cooperative sector, with more than 104,000 active cooperatives, has remained unaffected by foreign sanctions and can serve as a reliable channel for economic engagement with friendly nations such as China. He proposed forming a joint committee to coordinate joint projects, trade missions, and specialized exhibitions in Tehran and Beijing.

He also highlighted the potential for collaboration in modern irrigation, seed and vaccine production, and animal feed technologies, as well as mineral processing and petrochemical industries.

Abdollahi added that the current trade volume between Iran and China stands at about \$14 billion, but with the existing capacities, that figure could rise substantially through strengthened cooperative and industrial partnerships.

In early October, Majid-Reza Hariri, the chairman of the Iran-China Joint Chamber of Commerce, commented on the extent to which the UN Security Council sanctions would affect Iran-China relations, and stated: "Given that none of the UN sanctions are trade-related and instead pertain to the nuclear industry and some sectors of the country's missile industries, consequently, they should not impact our normal trade with China"

He added: "Although the U.S. sanctions have completely prohibited oil sales, we see that the Chinese are currently buying nearly over 90 percent of the country's oil. Therefore, UN sanctions are not related to the commercial sphere and logically should not affect these types of relations either."

Hariri further added: "The UN sanctions will have psychological and secondary effects which must be examined."

As previously announced by Abolfazl Akbarpour, the deputy head of the Islamic Republic of Iran Customs Administration (IRICA) for planning and international affairs, the value of non-oil trade between Iran and China stood at \$34.1 billion in the past Iranian calendar year, which ended on March 20, 2025.

He said that importing non-oil goods worth \$14.8 billion from Iran, China was the first destination of Iranian products in the pact year

He also announced that by exporting nonoil products valued at \$19.3 billion to Iran, China was the second source of import for Iran in that year.

On May 4, Iran-China Business Development Forum convened at the Tehran Cham-

ber of Commerce, Industries, Mines and Agriculture (TCCIMA), with the participation of China's ambassador to Iran, the head of Iran's Trade Promotion Organization (TPO), the chair of the Iran-China Parliamentary Friendship Group, and senior officials from the Tehran Chamber.

A large number of business leaders from both countries attended the event, where state, legislative, and private-sector strategies for deepening bilateral trade ties were outlined, the TCCIMA portal reported.

Opening the event, TCCIMA Head Mahmoud Najafi Arab welcomed Chinese delegates who traveled to Iran for the Iran Expo. He expressed gratitude for the Chinese ambassador's continued efforts to expand economic ties between the two nations.

Najafi Arab said Iran and China share thousands of years of cultural and commercial relations, which have entered a new phase in recent decades, marked by growing partnerships across multiple sectors. He said the two countries could serve as a model for sustainable cooperation based on mutual respect in today's increasingly interdependent

He also highlighted recent visits of Iranian private sector delegations to various Chinese provinces and exhibitions, emphasizing the need to identify investment opportunities and facilitate financial exchanges. The Chamber, with over 140 years of history, is prepared to host expert meetings, present economic opportunities, support joint ventures, and activate professional networks between Iranian and Chinese businesses, he said.

China's Ambassador to Iran Cong Peiwu, thanked Iranian participants and the Tehran Chamber for organizing the event. He expressed hope that the forum would help strengthen bilateral trade and economic cooperation.

Referencing the recent meeting between the two presidents at the BRICS summit in Russia, Cong said China is fully committed to enhancing cooperation across all sectors in ways that benefit both peoples.

Also speaking at the forum, Ruhollah Nejabat, chair of the Iran-China Parliamentary Friendship Group, said Iran's non-oil exports to China surpassed \$14.8 billion last year, making China the largest destination for Iranian goods and accounting for about one-quarter of Iran's total non-oil exports. Imports from China reached approximately \$19.3 billion, or 27 percent of Iran's total imports, making China Iran's second-largest import partner after the United Arab Emirates

These figures, he said, demonstrate the resilience and strategic importance of Iran-China trade, even amid global economic slowdown, with both countries supplying a significant portion of each other's needs.

Nejabat noted that Iran's Seventh National Development Plan emphasizes industrial modernization and attracting foreign capital and technology. He said Iran aims to upgrade its industries—from automotive and textiles to pharmaceuticals and medical equipment—and that this will be achieved more quickly with partners like China, now a global industrial superpower.

He added that technology transfer and joint investment are two strategic priorities for Iran. Chinese firms, he said, could take advantage of Iran's market size and skilled labor to establish production lines and access broader regional markets.

Conversely, Iran could supply intermediary goods and industrial components needed by Chinese industries. Nejabat said Iran will offer special incentives for foreign industrial investment and provide a secure legal environment for Chinese companies. Infrastructure development—including rail networks, highways, and ports—is also a priority, and many of these projects will require Chinese expertise and participation.

He also pointed to Iran's largely untapped mining sector, including vast reserves of iron, copper, aluminum, and rare earth elements, as an area ripe for development and export

Speaking at the forum, Mohammad Ali Dehghan Dehnavi, head of Iran's Trade Promotion Organization (TPO), outlined four key strategies for expanding trade with China. The first is technology transfer. He said Chinese companies have made major investments in research and development, much of which has not yet been fully commercialized. Iran, as a long-time partner, seeks deeper collaboration in these cutting-edge sectors.

The second strategy, he said, is increasing trade in high value-added goods. Currently, much of the bilateral trade consists of raw or semi-processed materials. The average value of Iran's exports stands at less than \$400 per ton. "We want to change that," he said, calling on Chinese importers to prioritize Iranian products with higher added value. He welcomed the Chinese ambassador's praise for the competitiveness of Iranian nanotechnology and biotechnology products.

The third strategy is joint production through co-investment. Dehnavi said Iran offers a secure investment climate, with legal guarantees allowing foreign investors to repatriate both capital and profits. "There are many documented cases of investors successfully exiting after profitable ventures," he said

Iran offers highly competitive costs, a wide range of investment opportunities, and strong security for foreign capital, he added, expressing hope for increased joint ventures with Chinese firms.

The fourth strategy is mutual market access. Dehnavi said Iran produces many goods that are well-suited for the Chinese market and that joint production could also help both countries expand into third-country markets. "This kind of cooperation can make our trade ties deeper and more sustainable," he said.

Fereydoun Vardinejad, secretary general of the Tehran Chamber of Commerce, said China had stood by Iran during both stable and turbulent times, and that the two peoples share a strong emotional bond.

However, he warned that a lack of information exchange and mutual understanding of economic capacities had led to a wide gap between political relations and economic realities. "Our ties are excellent in potential but need significant work in practice," he said.

Iran, Russia agree to form joint transport task force, digital single window

TEHRAN – Iran and Russia have agreed to establish a joint transport task force and launch a digital single window system between Tehran and Moscow to address logistical challenges and boost bilateral trade, a senior Iranian transport official said.

According to Mehdi Asadi, head of logistics and multimodal transport at Iran's Ports and Maritime Organization (PMO), the two initia-

tives aim to streamline customs procedures, enhance transparency, and facilitate trade operations between the two countries.

Asadi said the agreement followed recent talks between Iranian and Russian transport officials, during which the two sides discussed shipping challenges in the Caspian Sea, obstacles along the eastern branch of the International North-South Transit Corri-

dor (INSTC), and trade imbalances.

He added that the creation of a permanent joint working group would allow regular meetings to monitor progress and coordinate solutions.

Both sides, Asadi noted, demonstrated strong commitment to overcoming current barriers and expanding transport capacity between Iran and Russia.

The U.S. continues close strategic partnerships with both the UAE and Israel, despite their entanglement in RSF's rise. Sudan's normalization with Israel remains a U.S. foreign policy goal. From page 1 ▶ Alongside this, more false stories have been circulated: that Iran's IRGC Quds Force commander Esmail Qaani is meeting Iragi resistance leaders; that Kataib Hezbollah controls long-range drones; that the occupying regime is striking "logistics hubs" near the Iran-Iraq border; and that the "96th Gilad Division is training intensively in the Jordan Valley."

These fabrications have no verified sources. They are part of a broader disinformation campaign to paint Iraq as an Iranian pawn and to justify future attacks by the Zionist regime and its American backers.

Breaking down false claims

1. Iraqi forces are national, not foreign-controlled Iraq's armed forces, including the Popular Mobilization Forces, operate under the authority of Iraq's commander-in-chief and the Ministry of Defense. They are funded by Baghdad, not Tehran. Calling them Iranian-controlled is a clear attempt by the occupying regime and Washington to weaken Iraq's sovereignty and independence.

2. Iraq wants peace, not another war

After two decades of war and terrorism, Iraq's government has made it clear that it strongly opposes any new conflicts. Prime Minister Mohammed Shia al-Sudani and his national security advisor Qasim al-Araji have repeatedly made this clear.

With elections approaching, Iraq's focus is on stability, security, and rebuilding, not confrontation with the Zionist regime or anyone else.

3. No proof of an Iraqi attack plan

There is no credible evidence that the Iraqi resistance movement is preparing to fire missiles or send drones toward the Israeli regime. The idea of a coordinated Iraqi strike is unrealistic and makes no military sense. It is designed to give the United States and the occupying regime an excuse to attack Iraq and increase pressure on Iran.

4. Misrepresentation of Iranian contacts

Claims that Iran's Quds Force chief General Qaani is directing Iraqi resistance groups are false. If General Qaani visits Iraq, he would meet government officials, not resistance leaders. The Zionist regime and its American allies are twisting normal diplomatic or security protocols into tales of "ter-



ror coordination" to support their narrative.

The claim that Kataib Hezbollah, a unit of the Popular Mobilization Forces, controls long-range drones aimed at the Israeli regime is also false. The group has no interest in igniting new tensions, especially after assurances by the government in Baghdad that U.S. occupation forces are leaving Iraq. These exaggerated allegations serve only to make Iraq appear like a threat and justify new acts of aggression by the United States and the occupying regime.

Terror as doctrine: How Zionist ideology weaponized violence to invent its past

AMMAN - This ongoing spectacle of Zionist terror and criminality — now in policies of extermination in Gaza and extending across the length and breadth of Palestine is driven by a deliberate ideology, strategy, and malevolent set of objectives.

Their proclivity for terror and crime has been elevated to a kind of philosophy, most clearly embodied by Jabotinsky's foremost disciple and devoted heir, Menachem Begin.

Begin insisted on the centrality of violence to historical formation:

"The force of progress in world history is not peace but the sword."

He framed struggle as constitutive of existence: "I fight, therefore I am." He even issued an incitement to killing: "Be my brother, or I will

In his book The Revolt, he declared: "From blood and fire and tears and ashes will emerge a new type of man, a model utterly unknown to the world for the past eighteen hundred years — the fighting Jew. First and foremost, we must take the offensive; we attack the killers."

To whom is Menachem Begin alluding when he speaks of "killers?" It is plain that he is referring to the Palestinian Arabs defending their homeland and their very existence.

David Ben-Gurion, the first prime minister of the Zionist entity, likewise expressed his conviction that "force and violence are a civilizational rebirth" for the people of Israel — the modern continuation of ancient "Judea." He proclaimed: "Judea fell by blood and fire, and by blood and fire it will rise again."

He compared Jewish settlers in Palestine to the Spanish conquerors who, by arms and fire, destroyed millions of the indigenous peoples of Central and South America, and to American colonists who waged war against "wild nature" and against the "savage Red

This is only a sliver of the vast corpus of Zionist thought, culture, and literature taught in their educational institutions — especially in religious Jewish schools — texts and curricula that, in effect, call for "the extermination of the Amalekite Arabs" — here referring to the Palestinians.

Gaza's shadow over NYC: How a mayoral race turned into a moral referendum

Calling genocide by its name, Zohran Mamdani forced a reckoning and unleashed a fierce counterattack

TEHRAN - Zohran Kwame Mamdani, the Ugandan-Indian son of a postcolonial scholar who was born in Uganda, has done something the pundit class assumed impossible: his campaign dragged the once-distant politics of Gaza into the center of a New York mayoral election and forced voters to decide whether American power remains accountable.

Mamdani's blunt language — "We are on the brink of a genocide of Palestinians in Gaza" didn't occur in ivory-tower debate; it landed in subway stations, viral clips, and the homework of

That moral naming is the reason his rise matters and the reason the backlash was immediate.

When he doubled down with lines like "If I'm the Mayor, the NYPD will arrest Netanyahu" and "It is important that NYC is in compliance with international criminal law," Mamdani signaled that his politics weren't just rhetorical—they were about wielding power in ways that unsettled the estab-

What followed reads less like policy disagreement than a coordinated playbook to otherize. Al-generated attack ads, some quickly deleted but widely seen, portrayed Mamdani's supporters in criminalized, racialized terms; civil-rights groups called it racist and dangerous.

This is old-fashioned Islamophobia in new clothes: codewords, manufactured fear, and now AI to amplify the lie.

At the same time, Trump publicly labeled him a "communist" and threatened to curtail federal support for New York if Mamdani won—a move that turns municipal elections into a constitutional

Polls show Mamdani leading into election day, fueled by under-45 turnout and a coalition of Muslims, Arabs, young progressives, and disillusioned working voters who care about rent, transit, and childcare as much as foreign policy.

But popularity is not the same as power. Mayors can use procurement, divestment, and moral pressure — not unilaterally halt arms shipments or rewrite foreign policy — and pretending otherwise shrinks political courage by rewarding tactical

A sober left must hold two truths at once. First: Mamdani injected moral clarity when much of the party offered platitudes. If naming genocide shocks a nation into debate, that's a strategic gain.

Second: the left's history includes a parade of rhetorically brave figures - Sanders, AOC, and other Squad members — whose supposed courage dissolved when tested, leaving only theatrical posturing and habitual compromise.

Criticism of Israel, conditional aid, and BDS are righteous stances; translating them into lasting policy requires sustained organizing and the willingness to use power, not only language. Words are wind; policy is the millstone that grinds them into

There are also tactical errors that opponents seized. Mamdani's earlier refusal to disown certain provocation-ready slogans gave adversaries a tidy opening: conflate critique of Israel with support for

Later walk-backs — discouraging inflammatory phrasing and promising Jewish New Yorkers protection - may have appeared as politically necessary, but they also revealed how easily moral clarity becomes political liability. The left should neither demand martyrdom nor accept dilution as inevitability. It must sharpen strategy, not surrender principle.

The broader story is structural. Gaza has loosened old partisan loyalties: younger Jews and Jewish progressive organizations canvassed for Mamdani even as institutional bodies tied to the Israel lobby mobilized in opposition.

If the Democratic Party cannot move from rhetoric to real leverage - conditioning aid, building congressional pressure — it risks losing the very base that wants ethical coherence.

This brings us to the crux of the matter. Mamdani is neither saint nor savior: he is a test case. If he wins and governs by principle and practical coalition-building, his administration could model municipal solidarity that constrains complicity.

"Mamdani has turned NYC's mayoral race into a test of moral courage: can the city use municipal power—contracts, divestment, sanctuary—against complicity, or will entrenched political and financial forces bend principle into performance?"

If he retreats into the comfortable compromises that blunted other progressives, Gaza's will be another missed turning point for the American left.

Worse, the political and financial establishment may actively try to make a Mamdani-led NYC failstarving it of resources, weaponizing regulation and markets, or otherwise setting it up as a cautionary tale—just as the U.S. empire has historically undermined left-leaning experiments abroad.

The choice New Yorkers face is larger than one man: will a city known for its immigrant muscle keep its moral nerve, or will fear and money snuff out a rare alignment of conscience and politics? Strike while the iron is hot — and return to the forge when the fire wanes.

Israeli fire kills three north of Rafah despite ceasefire

Three Palestinians were killed by Israeli fire north of Rafah, Nasser Medical Complex staff told Al Jazeera, in what many observers consider a breach of the fragile ceasefire.

The Israeli military said it struck after alleging people crossed the so-called "yellow line," but it was unclear whether that attack caused the deaths.

Since the October 10 truce, repeated Israeli strikes have killed over 100 Gazans, according to health officials. The incidents have intensified a humanitarian crisis of acute malnutrition and growing neurological illness.

Speaking on the sidelines of a visit to the historical house of Dr. Shariati in the village of Kahak, Qorbani emphasized the need to preserve the site as a cultural and identity landmark of the city, ISNA reported on Monday.

Dr. Ali Shariati, one of the most prominent contemporary thinkers of Iran, has had a profound impact on the social and cultural thoughts of the people throughout his life, he

He noted that Dr. Shariati's house, which is known as a symbol of thoughts and life of this great thinker, is not only considered a historical monument but also provides a space for those interested in Shariati's works and thoughts to gather.

Qorbani considered the protection of this house to be very important, adding that preservation and restoration of Dr. Shariati's house is considered a national and cultural duty.

"This report will be sent to the relevant provincial and national administrations to provide the funding and start the restoration operations as soon as possible. This action will be an effective step in the protection and restoration of this historical monument and a good opportunity to attract the attention and support of various institutions."

Davarzan continued that attracting tourists to this place can help the economic and social development of the region and at the same time increase public awareness of Dr. Shariati's thoughts and their importance.

He emphasized that paying attention to Dr. Shariati's house not only helps preserve a historical monument, but also strengthens the cultural and social identity of Davarzan county.

"Given the various threats that have put the cultural heritage at risk, it is essential that we all pay special attention to this issue and strive to protect these historical and cultural monu-

Qorbani noted: "Dr. Shariati's house, as a symbol of Iranian thought, should be a priority in the cultural and social programs of Davarzan county so that we can properly protect it and pass it on to future generations."

The historical monument of Dr. Ali Shariati's house and birthplace in Kahak village, Davarzan county, was registered under number 9591 on the National Heritage List of Iran in 2003.

Although Dr. Shariati's origins go back to the village of Mazinan, located 80 kilometers west of Sabzevar, he was born in the village of Kahak. His birthplace house is currently a historical and cultural monument, requiring attention and protection.

Golestan Palace: centuries-old canal to be restored to revive Persian garden layout

TEHRAN - Restoration work on a historical water canal at Tehran's UNESCO-listed Golestan Palace is set to begin after 13 years, as part of efforts to revive the traditional geometry of the Persian garden.

The north-south stream, also known as the Naseri canal, named after the Qajar monarch Naser al-Din Shah, was last restored in 2012 through nonstandard methods and later abandoned, IRNA reported on Monday.

The new restoration aims to conceptually recreate the flow of water and restore the original spatial design of the palace gardens, officials said.

Ali Omidali, expert for the Golestan Palace World Heritage Site, said the restoration plan was drafted in 2024 and approved by the site's steering and technical councils.

"Because the original qanat that supplied the canal has dried up, the restoration will be symbolic, using circulating water to recreate the sense of flow and preserve the garden's central geometry," Omidali told IRNA.

He said the canal will contain about 50,000 liters of water flowing at a shallow depth of around 10 centimeters. To conserve resources, fountains within the palace complex have also been repaired, including the Almas Mansion fountain, which was restored earlier this year using modern sealing technology.

"The Naserieh Canal forms the core of the Persian garden layout," Omidali said. "Restoring geometric order, planting climate-adapted species, and rehabilitating garden axes are key elements of the project."



Golestan Palace Director Afarin Emami said the complex still uses a historic well to irrigate its green spaces. After the canal's restoration, part of the well water will be redirected into the canal for aesthetic purposes, she

Emami added that during summer, when the well's water level drops, the Tehran municipality provides additional water by tanker. She said the site has ended the use of chlorine for water clarification to allow natural recycling of water within the garden and that a smart irrigation study is underway in cooperation with the Cultural Heritage Minis-

According to Emami, the project will allow Golestan Palace to recover part of its historic structure and symbolically revive the concept of the Persian garden in the center of Tehran.

Located in the heart of Tehran's historic core, the palace complex is one of the oldest in the city, originally built during the Safavid dynasty within the historic walled city. Over time, it underwent several expansions, receiving its most defining features in the 19th century, when it was designated as the royal residence and seat of power by the Qajar ruling family. Today, the Golestan Palace complex comprises eight main palace structures, primarily used as museums, along with the eponymous gardens, a central green space surrounded by an outer wall with gates.

The complex exemplifies the architectural and artistic achievements of the Qajar era, including the integration of European motifs and styles into Persian art. It served not only as the governing base of the Qajar kings but also as a residential and recreational compound and a center of artistic production during the 19th century. Through these activities, it became a primary source and hub of Qajar art and architecture.

Golestan Palace offers a unique and rich testimony to the architectural language and decorative arts of the Qajar period, particularly reflecting the legacy of Naser al-Din Shah. The palace showcases European-inspired artistic motifs alongside Persian traditions, representing some of the earliest examples of a synthesized European-Persian style. This blend became a defining characteristic of Iranian art and architecture in the late 19th and 20th centuries, with parts of the palace complex regarded as foundational to the modern Iranian artistic movement.

UNESCO recognizes Eid al-Fitr, Eid al-Adha

TEHRAN--The United Nations Educational, Scientific and Cultural Organization (UN-ESCO) has recognized the two major Islamic holidays of Eid al-Fitr and Eid al-Adha at the 43rd session of UNESCO General Conference in Samarkand.

According to IRIB, this decision was ratified following a proposal from the Republic of Indonesia and based on Resolution 219 of Executive Council at the General Conference.

TEHRAN - Ardabil province, with its more than 1,800 historical monuments, unique natural attractions, and excellent geopolitical position, is on track to become Iran's leading hub for health, winter, and nature-based

Announcing this, Ardabil Governor-General Masoud Emami-Yeganeh emphasized the strategic position of this northwestern province in the development of the country's tourism, Miras Aria (CHTN) reported.

Speaking at the 24th meeting of the Strategic Council of the Ministry of Cultural Heritage, Tourism and Handicrafts, which was held in the presence of Minister of Cultural Heritage Seyyed Reza Salehi-Amiri on Monday, he said that Ardabil is one of the most important tourism destinations in the country, hosting more than five million domestic tourists annually.

Referring to the province's privileged geopolitical location, Emami-Yeganeh said: "Ardabil is the gateway to the Caucasus and the geopolitical connection point of the Islamic Republic of slopes of Sabalan, has paved the way for the formation of health, nature, and winter tourism axes."

He added that with 110 hot and mineral springs, Ardabil is one of the main origins of medical tourism in the country. The creation of a special health tourism zone centered on Sarein county is on the agenda, and negotiations with investment holdings in this area have reached the final stage, he pointed out.

Emami-Yeganeh announced the development of winter tourism in the slopes of Sabalan and said: "Two active ski resorts in the Alvares region and the Sabalan tourism complex have been equipped with an investment of 230 billion rials (\$230,000)."

This infrastructure has provided the basis for holding the national and international winter sports competitions, and Sarein Winter Festival is being held in cooperation with the Ministry of Sports and Youth.

Referring to the prominent billion rials (\$350 million) and

Iran secures first place among Islamic nations in Leiden ranking

TEHRAN – The 2025 Leiden University ranking system has included 48 Iranian universities among the top 1,594 universities worldwide, up from 46 in 2024, ranking the country first among Islamic nations in terms of the number of universities for the second consecutive year.

A total of 184 universities from Islamic countries are included in this year's ranking. Turkey, with 45 universities, Saudi Arabia, with 20, Pakistan, with 16, and Egypt, with 15, are placed second and fifth, respectively, IRNA reported.

The University of Tehran (ranked 166 globally), Tehran University of Medical Sciences (ranked 235), and Iran University of Science and Technology (ranked 361) rank first to third in the country.

Tarbiat Modares University (372), Shahid Beheshti University of Medical Sciences (383), Amirkabir University of Technology (408), University of Tabriz (508), Sharif University of Technology (510), Ferdowsi University of Mashhad (512), and Tabriz University of Medical Sciences (525) are placed fourth to tenth, respectively.

The Leiden Ranking provides indicators of scientific impact, collaboration, open access publishing, and gender diversity. Size matters when comparing universities: performance can be viewed from an absolute or a relative perspective (e.g., the number versus the percentage of highly cited publications). That is why size-dependent and size-independent indicators are consistently presented together in the Leiden Ranking. This highlights that both types of indicators need to be taken into account. The ranking uses publications over a four-year period (2020-2023 for the 2025 release).

Compared with other university rankings, the Leiden Ranking offers more advanced bibliometric indicators. The underlying methodology is richly documented. The Leiden Ranking provides information exclusively about the research done at universities. Research is represented in publications, and carefully collected data about



these publications form the basis for the Leiden Ranking. This basis also ensures the independence of the Leiden Ranking, since there is no reliance on data submitted by the universities themselves. Finally, because universities are complex institutions that have a variety of forms, contexts, and missions, their performance cannot be represented by a single number

Recent rankings

The Times Higher Education World University Rankings 2026 has placed 101 Iranian universities among the top institutions, up from 85 universities in 2025.

The 2026 rankings include 2,191 ranked universities from 115 countries and territories. There are 99 new entries compared with last year.

The THE World University Rankings are the only global performance tables that judge research-intensive universities across all their core missions: teaching, research, knowledge transfer, and international outlook

Amirkabir University of Technology, Kermanshah University of Medical Sciences, and Sharif University of Technology are among the top Iranian universities, with a global ranking of 351-400.

Iran University of Science and Technology and University of Tehran were jointly placed second, ranking 401-500 globally. Shiraz University of Technology and Tehran University of Medical Sciences ranked third collectively, with a

global ranking of 501-600. Twelve other universities are ranked 601-800 worldwide, including Alborz University of Medical Sciences, Babol Noshirvani University of Technology, Babol University of Medical Sciences, Golesran University, Iran University of Medical Sciences, Isfahan University of Medical Sciences, Isfahan University of Technology, Lorestan University of Medical Sciences, Qazvin University of Medical Sciences, Shahid Beheshti University of Medical Sciences, Shiraz University of Medical Sciences, Tabriz University of Medical Sciences, Tarbiat Modares University, University of Tabriz, and Urmia University of Medical Sciences.

The 2024 World University Rankings (WUR) report by the Islamic World Science Citation Center (ISC) has included 72 Iranian universities, up from 69 in 2023. A total of 426 universities from 31 Islamic countries are listed in the ranking, where Turkey, with 102 universities and Iran, with 72 universities, and Pakistan, with 39 universities, are placed first to third, IRNA reported.

Among the top universities of Islamic countries, Saudi Arabia ranks 172. Iran, Pakistan, Malaysia, and Egypt jointly rank 401–450, Qatar ranks 451–500, and Turkey, the UAE, and Lebanon rank 501–600.

Tehran University's ranking has changed from 501-600 in 2023 to 401-500 in 2024. The University is placed first in the country. Tehran University of Medical Sciences ranks second. The university's global ranking is 501-600, up from 601-700 in 2023.

Shahid Beheshti University of Medical Sciences' ranking has also improved from 801-900 in 2023 to 601-700 in 2024, ranking third in the country. Sharif University of Technology and Tarbiat Modares University are placed fourth and Fifth, respectively.

Shanghai University ranking 2025 has placed six Iranian universities among the top 1,000 institutions worldwide, down from 9 in 2024. Tehran University of Medical Sciences and University of Tehran are among the top 500 universities in the world, ranking 401–500 globally. Tarbiat Modares University ranks 701–800.

Shahid Beheshti University of Medical Sciences and Sharif University of Technology rank 801-900. Iran University of Medical Sciences ranks 901-1000. The July edition of the Webometrics world ranking has included 64 medical universities from Iran, unchanged from January's edition, 11 of which have advanced in the ranking compared to the January edition.

Tehran University of Medical Sciences (485) is the only university ranked among the top 500 institutions in the world, Mehr news agency reported. Pasteur Institute of Iran holds intl. pandemic preparedness course in Pakistan

TEHRAN – The Pasteur Institute of Iran has organized a week-long international training course in Pakistan to enhance the pandemic preparedness capacity in addressing future health threats.

Hosted by Karachi from October 21 to November 1, the event was held in cooperation with the Standing Committee for Scientific and Technological Cooperation (COMSTECH) and Pakistan's International Center for Chemical and Biological Sciences (ICCBS).

Over 30 health experts from 11 countries, including Benin, Uganda, Somalia, Senegal, Singapore, Sudan, Egypt, Ethiopia, Afghanistan, Cameroon, and Pakistan, participated in the course titled 'Investigating Infectious Disease Outbreaks with a Focus on Crimean-Congo Hemorrhagic Fever', as a part of a comprehensive course on 'Virology and Future Pandemic Preparedness'.

Arboviruses and Crimean-Congo Hemorrhagic Fever, Biosafety and Risk Assessment, Outbreak Planning and Early Warning Systems, Descriptive and Analytical Studies in Epidemiology, and International Health Regulations (IHR).

The program blended theoretical sessions with practical workshops and exercises, fostering active engagement and yielding highly positive feedback from participants.



The training marks the second joint program under a five-year Memorandum of Understanding (MOU) signed between the Pasteur Institute of Iran and COMSTECH in October 2023, indicating a sustained commitment to collaborative health security across Islamic nations.

According to the Pasteur Institute of Iran, the five-year MOU commits both parties to collaborate on developing and implementing joint training programs and strengthening health systems, particularly in Islamic countries. The inaugural joint training course, titled "Assessment and Management of Infectious Disease Outbreaks," was held in December 2023 in Karachi and Islamabad, Pakistan, featuring specialists from the Pasteur Institute of Iran.

Tehran to host Iran Smart City Exhibition and Conference

TEHRAN – The sixth Iran Smart City Exhibition and Conference will kick off tomorrow in Tehran and will wrap up on Friday.

With the theme of Iran's smart cities and artificial intelligence, the event will be held on the occasion of the World Cities Day, aiming to promote innovation, develop smart city infrastructures, and share experiences between scientific, industrial, and management sectors, IRNA reported.

The exhibition section features a series of companies, organizations, municipalities, and technology institutions showcasing their latest products, designs, and achievements in fields related to smart cities and artificial intelligence.

It will focus on smart urban management systems and public services, data infrastructure, Internet of Things and big data analytics, smart transportation and clean energy, as well as new technologies in education, health, and urban environment.

The conference is organized by the Iranian Research Institute for Information Science and Technology, known as Irandoc.

The conference involves a series of expert panels, scientific meetings, and policy discussions that study the latest achievements and challenges in smart cities, urban data, artificial intelligence, and digital governance fields. Professors, managers, and experts in technology will share their views.

The main themes of the conference include smart governance and the role of data in urban decision-making, ethics and justice in using artificial intelligence (AI) in urban management, the role of AI in the sustainability of cities, and national capacity development for future smart cities.

It will bring together domestic and foreign scholars, practitioners, urban managers, industrialists, scholars, and experts, as well as knowledge-based companies, to share experiences and knowledge and accelerate the change to smart cities.

The conference will also provide an opportunity to display the latest achievements, scientific findings, technologies, techniques, and tools for implementing smart cities projects.

A highlight of this year's conference is 'Iran smart city national award', which aims to identify, evaluate, and honor the best designs and projects in urban smartness. It will be launched immediately after the end of the exhibition.

World Cities Day

The World Cities Day was marked in Tehran with the theme of Smart Cities, Sustainable Innovation, Green Buildings, Bright Future.

The event was held both in-person and on-

line, bringing together relevant government organizations, academic institutions, professional bodies, the private sector, young innovators, city managers, students, and stakeholders.

Sharing expertise, showcasing innovative urban projects, and discussing the challenges and opportunities of sustainable urban development in the country and all over the world were among the main parts of the event, the UN Iran Habitat website reported.

The event was centered around smart cities, technological innovation, sustainable construction, urban resilience, and alignment with the United Nations Sustainable Development Goals (SDGs).

World Cities Day is observed annually on 31 October, marking the conclusion of Urban October. First celebrated in 2014, the day features a global observance hosted by a different city each year and focuses on a specific theme.

The UN General Assembly (UNGA) declared the Day to promote interest in global urbanization and encourage cooperation among countries in addressing the challenges of urbanization and contributing to sustainable urban development around the world.

The Global Observance of World Cities Day 2025 took place in Bogotá, Colombia, under the topic of people-centred smart cities.

It showcases how data-driven decision-making, technology, and AI can be used to improve urban life and recover from current shocks and crises. It also focuses on promoting smart city initiatives centered on people.

This year's theme reflects the growing recognition that the transformative power of digital technologies is reshaping urban life globally, offering profound opportunities to enhance how cities and human settlements are designed, planned, managed, and governed.

The theme aims to promote people-centred smart cities and demonstrate how crucial it is for smart cities to prioritize human needs, inclusivity, and accessibility.

Second, the observance will provide a platform for cities to exchange best practices, experiences, and strategies in implementing people-centred smart city initiatives globally, especially in addressing key challenges such as the global housing crisis.

Lastly, by increasing global awareness about the role of technology and innovation in advancing improved access to adequate housing and achieving urban development, the goal is to foster and encourage international cooperation and collaboration among all societal sectors on People-Centred Smart Cities.

128 earthquakes hit Iran in a week

TEHRAN – A total of 128 earthquakes were recorded across the country in a week from October 25 to 31, according to the seismological networks of the Institute of Geophysics of the University of Tehran.

Statistically, 111 earthquakes with magnitudes smaller than 3; 16 earthquakes with magnitudes between 3 and 4; one earthquake with a magnitude between 4 and 5, and no earthquake with a magnitude over 5 have occurred in the country, ISNA reported.

Among the provinces of the country, South Khorasan and Hamedan, each with 15, experienced the highest number of earthquakes, followed by Yazd and Khorasan Razavi, with

12 and 11 earthquakes.

Of the total quakes, one had a magnitude of 4.9 on the Richter scale, which occurred on October 26 in Nahavand, Hamedan province.

During the same period, two earthquakes. No earthquakes were recorded in East Azarbaijan, West Azarbaijan, Ardabil, Alborz, Zanjan, Sistan-Baluchestan, and Qazvin provinces.

A total of 6,272 earthquakes were recorded across the country over the past calendar year (March 2024 – March 2025), according to the Seismological networks of the Institute of Geophysics of the University of Tehran.

Out of registered earthquakes, 150 were more than 4 on the Richter scale; at least five earthquakes with a magnitude of more than 4.5 occurred monthly in the country.

The Iranian plateau is located in a very seismically active region of the world and is known not only for its major catastrophic earthquakes but also for the disasters relating to natural hazards, especially earthquakes

About 2 percent of the earthquakes in the world occur in Iran, but more than 6 percent of the victims of the world's earthquakes during the 20th century are reported from Iranian earthquakes.

Smugglers of fuel, livestock fined \$570m

Smugglers of fuel and livestock have been fined 24 trillion rials (about \$570 million at the official rate of 42,000 rials) since the beginning of the current [Iranian calendar] year (March 21).

The figure represents a 47 percent increase compared to the same period last [Iranian calendar] year.

Out of a total of about 42,000 smuggling cases, about 28,000 are related to export smuggling, of which 20,000 are related to the smuggling of fuel and petroleum products, mostly to Pakistan and Afghanistan, and to a lesser extent to Turkey and Iraq.

A number of these cases are related to livestock trafficking. Most of the cattle are smuggled to Iraq, and then to the Persian Gulf countries.

Shakespeare's "Macbeth" on stage at Tehran theater

TEHRAN- Iranian director Javad Molania is staging an adaptation of William Shakespeare's masterpiece "Macbeth" at Tehran Pardis Theater Complex.

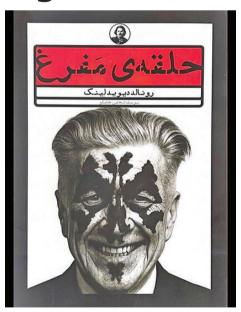
Ronald David Laing's "Knots" available in Persian

TEHRAN - The Persian translation of the book "Knots" written by Ronald David Laing has been released in the bookstores across

Originally published in 1970, "Knots" consists of a series of dialogue-scenarios that can be read as poems or brief plays, each complete in itself. Each chapter describes a different kind of the "knots" of the bonds of love, dependency, uncertainty, and jealousy.

The dialogues could be those between lovers, between parents and children, between analysts and patients or all of these merged together. Each brilliantly demonstrates Laing's insights into the intricacies of human relationships.



Ronald David Laing (1927-1989), usually cited as R. D. Laing, was a Scottish psychiatrist who wrote extensively on mental illness-in particular, psychosis and schizo-

Laing's views on the causes and treatment of psychopathological phenomena were influenced by his study of existential philosophy and ran counter to the chemical and electroshock methods that had become psychiatric orthodoxy.

Laing took the expressed feelings of the individual patient or client as valid descriptions of personal experience rather than simply as symptoms of mental illness. Though associated in the public mind with the anti-psychiatry movement, he rejected the label. Laing regarded schizophrenia as the normal psychological adjustment to a dysfunctional social context.

Commemoration of infamous Balfour Declaration in Argentina and Mali through cultural events

The embassies of the State of Palestine in Argentina and Mali commemorated the 108th anniversary of the infamous Balfour Declaration by organizing a series of events.

In the Argentine capital, Buenos Aires, a cultural event was organized as part of the International Days of Palestinian Cinema, featuring the screening of the film "When I Saw You" by Palestinian director Annemarie Jacir, emphasizing the role of art in conveying the suffering of the Palestinian people and their struggle for freedom, in facing the occupation, settlement, and ongoing injustice

for more than a century. The film presented a human and poetic

image through the eyes of a refugee child, reflecting the resilience of the Palestinians and their steadfastness in hope and collective determination for freedom, life, and the return to their homeland, with wide participation from cultural institutions around the world, including the Cinema for Palestine group - Argentina, LATINARAB.

The Acting Ambassador of the State of Palestine, First Counselor Riyad Halabi, emphasized the importance of Palestinian art as a front of resistance against attempts to obliterate national identity.

He explained that Palestinian cinema, with its human stories and live testimonies, rep-

resents one form of cultural and political struggle, embodying an ethical stance that expresses human dignity and the right to existence and freedom.
