#### The mirage of peace: Gaza under fire

TEHRAN – It has been more than 50 days since a ceasefire between Israel and Hamas took effect, intended to end the Gaza war. For Palestinians, however, that promise has meant nothing. The Israeli bombardment has continued unabated, and the humanitarian crisis has only

The toll is staggering. Since the war began in October 2023, more than 70,100 people have been killed and over 170,000 wounded. Since the October 10 truce, 360 Palestinians have also been killed.

Israel's actions have stripped the word ceasefire of any meaning. Rather than halting attacks, the military campaign has pressed on—destroying homes, overwhelming hospitals, and leaving families in constant grief. For Palestinians, there has been no pause, no safety, only more loss. The continuation of strikes reflects a deliberate disregard for international agreements and humanitarian law.

TEHRAN – The United Nations overwhelmingly condemns the ongoing Israeli occupation of Arab lands amid opposition by the U.S. and a few of its allies.

The UN General Assembly delivered a resounding diplomatic setback to the Israeli occupation regime, adopting two major resolutions that underscored the international community's near-unanimous rejection of its continued violations of international law in Palestine and the occupied Syrian Golan.

In the first resolution, "Peaceful settlement of the question of Palestine," an overwhelming 151 Member States voted in favor, while only 11, led by the United States, opposed the measure. Eleven abstained.

The scale of support reflected global impatience with the regime's ongoing defiance of international norms and its entrenched occupation policies.

The resolution renewed demands for urgent, coordinated diplomatic efforts to revive credible negotiations on all final status issues.

#### Enhancing deterrence and military cooperation via joint exercises

Jam-e-Jam, examined the anti-terror military exercises -- codenamed "Sahand 2025" -- that Iran is holding jointly with five countries from the Shanghai Cooperation Organization (SCO) in Shabestar, East Azarbaijan Province, arguing the drills will enhance Tehran's military deterrence and help foster military cooperation between the SCO states. It said the drill represents a golden opportunity for Iran to enhance its military capabilities within the SCO framework. By focusing on joint counterterrorism operations, the drill allows Iran to share its experience in confronting cross-border threats with other member states. Cooperation with military powers such as China and Russia—core members of the SCO—facilitates the exchange of advanced technologies. Iran can benefit from Russian air defense systems or Chinese information technologies, strengthening its deterrence against external threats. Such collaboration not only guarantees Iran's security but also contributes to regional stability across Eurasia and reinforces initiatives in the fight against

#### Kayhan: A distorted narrative of the 12-day

Kayhan, in a commentary, criticized the distortion of the truth about the 12-day war by the West, Israel, and their supporters inside Iran. The paper wrote that the 12-day war was the moment when the United States and Israel imagined they could inflict a military blow on Iran by destabilizing the country. Yet the reality on the battlefield shattered that dream with a heavy defeat. This truth is repeated in Hebrew and Western outlets. However, when the ceasefire was declared, the machinery of distortion was activated. What is striking, Kayhan commented, is that at this very historical juncture, pro-Western currents inside Iran attempt to downplay the enemy's defeat. The truth of the 12-day war is now clear and recorded, and what remains is the necessity of confronting distortion. If the military arena marked the defeat of the U.S. and Israel, the media must not become a space where the defeated can conceal their loss with inverted headlines. The postwar period, Kayhan concluded, is a time to consolidate achievements; achievements that will be preserved not through compromise, but through clear narration and steadfast defense of national authority.

#### Iran: Tehran-Beirut ties still based on interests, strategic principles

The Iran newspaper, in an interview with regional affairs expert Seyyed Reza Sadr al-Hosseini, analyzed the latest developments in Tehran-Beirut relations. The analyst noted that after the October 7 operation, the Lebanese

government did not show a positive reaction; an approach that raised expectations that Lebanese officials, unlike in the past, would tread more cautiously in strengthening ties with the Islamic Republic. Beyond the political differences between Tehran and Beirut, there is a deliberate effort by regional and international media linked to the U.S. and Israel to portray natural disagreements between the two governments as deep rifts and political crises. Importantly, the level of diplomatic relations between the two countries has remained unchanged compared to the pre-October 7 operation. This reality contradicts the narrative of media outlets that exaggerate differences to suggest structural coldness in Iran-Lebanon relations. Given the deep historical and social roots of the bond between the two nations, and their shared needs—such as the importance of independence, resistance against occupation, and opposition to land seizure-Tehran-Beirut relations continue to be pursued and strengthened based on national interests and strategic principles.

#### Arman-e-Emrooz: A region on brink of

Arman-e-Emrooz, in an article on the region's critical situation and potential war between Iran and Israel, wrote that according to most observers, a second war between Iran and Israel is inevitable. They argue it is only a matter of time. In recent days, due to the ongoing deadlock in Iran's relations with the International Atomic Energy Agency, the lack of political breakthroughs in Iran-U.S. relations, and certain media-driven narratives, the likelihood of war has once again increased. The ignition of the current frozen conditions may require smaller triggers, such as the resumption of uranium enrichment in Iran or developments regarding the uncertain status of enriched uranium stockpiles. The most likely development that could draw Iran back into conflict is an imminent war on Lebanon. The deadline set by the U.S. and Israel for the Lebanese government to disarm Hezbollah is nearing its end, and Israeli movements indicate readiness to return to war. The intensity and consequences of such an attack could provoke an Iranian response and expand the fronts of conflict. Tel Aviv, by adopting a new doctrine, is determined at all costs to prevent a return to the pre-October 7 era—the so-called "age of equations." This doctrine is designed to block the revival of the Axis of Resistance under the leadership of Iran. Clearly, under this strategy, both the weakening of Iran's military capabilities and the continuation of economic isolation remain central objectives. This is precisely the deadlock in which even a small spark could ignite a raging fire.

### Iran taking new steps to boost security along borders

Meanwhile, the National Security and Foreign Policy Committee of the Iranian Parliament held a meeting attended by representatives of the Police Force, the Border Guard Force, the General Staff of the Armed Forces and Iran's Islamic Revolution Guards Corps (IRGC), among others. "The Islamic Republic of Iran, the People's Republic of China and the Russia Federation remain fully committed to continuing their constructive diplomatic partnership with all members of the council, and announce their readiness to support collective efforts to safeguard the peaceful nature of Iran's nuclear program," wrote the top three

For nearly two decades, Iran's peaceful nuclear program has been met with relentless opposition from the West. Pressure came in many forms, endless negotiations that went nowhere, punishing sanctions and even military aggression.

When the United States struck Iranian nuclear sites during the illegal U.S.-Israeli military aggression in June, the European trio, France, Germany and Britain, stepped in with their own strategy, activating the socalled snapback mechanism.

Before its expiry, JCPOA was rendered defunct by the West's shunning and by subsequent US-Israeli attacks on Iranian nuclear sites

"Snapback" was a mechanism under UN Security Council Resolution 2231, designed to automatically reinstate UN sanctions against Iran if it violated the terms of the JCPOA, a nuclear agreement signed by Iran, the U.S., UK, France, Germany, Russia, and China in 2015. Under its terms, Iran committed to limiting its nuclear program in return for sanctions relief. However, the U.S. unilaterally withdrew from the deal and re-imposed sanctions in 2018. European signatories said

Iran must continue adhering to the JCPOA. despite their inability to compel Washington's return or mitigate the debilitating impact of

The E3 triggered the countdown for the automatic return of UN sanctions on Iran in August. While welcomed by Washington and Tel Aviv, the move failed to materialize in practice when Russia and China declared they would not recognize the snapback of UN sanctions. This stance was echoed by over 120 other countries, which voiced support for Iran during a Non-Aligned Movement (NAM) conference held in Uganda. The legal basis for re-imposing pre-JCPOA UN sanctions was further undermined after Resolution 2231 officially expired in October. Iran, Russia, and China noted the expiry in a separate letter to the UN Security Council and the UN Secretary-General.

In their recent joint letter, the ambassadors of the three countries also urged all relevant parties to remain committed to working out a "political solution that would allay the concerns of all parties through engagement and political dialog based on the principles of mutual respect and to avoid resorting to force or any other action that might escalate

From page 1 > "Today, there is a shared awareness across the government that solving national problems requires drawing on every available resource - especially public participation. We are trying to view problems as a gold mine," he said.

Highlighting the neighborhood-based mobilization initiative, Pezeshkian drew historical parallels with the Iran-Iraq war, recalling how widespread international support for Saddam Hussein failed because "the people stood by the revolution." He added that Israel and the United States made a similar miscalculation earlier this year when they believed that "a few days of bombing" could trigger unrest inside Iran. "Once again, the people stood with their nation and foiled their plots," he

His remarks came in the aftermath of the June 13, 2025 conflict, when Israel launched an unprovoked attack on Iranian territory, triggering a 12-day war that killed well over 1,000 Iranians, including military commanders, nuclear scientists, and civilians. The United States escalated the confrontation by bombing three Iranian nuclear facilities, justifying the strikes with unsubstantiated claims that Iran was seeking

nuclear weapons.

Iran retaliated with more than 22 waves of missile and drone strikes targeting Israeli military sites and infrastructure under Operation True Promise III. A halt in the fighting was announced on July 3 at the request of Israel and the United States. Iran declared the outcome a strategic victory, arguing it had successfully prevented the enemy from achieving its objectives.

The conflict also derailed diplomatic efforts aimed at crafting a new nuclear agreement to replace the 2015 JCPOA, which the U.S. President Donald Trump abandoned during his first term. In the months leading

up to the war, Iranian officials had signaled willingness to reassure Washington that Tehran was not pursuing nuclear weapons if U.S. sanctions were lifted, though they insisted that uranium enrichment would continue. Reports indicated Iran might have been prepared to offer greater concessions than those included in the original JCPOA allowing Trump to claim a "better deal."

Despite these challenges, Pezeshkian emphasized that the government remains committed to working closely with the public. "Anyone who believes problems can be solved without the support and presence of the people is mistaken," he said. "If we rely on the people — regardless of gender, language, or ethnicity — no problem is unsolvable. We must not divide society into insiders and outsiders."

He added that the administration is working with public support to address longstanding structural imbalances, particularly those resulting from decades of uneven development. He noted that improving conditions for persons with disabilities remains a priority, while acknowledging that "the government alone cannot solve everything, but with the people's participation, we can overcome any obstacle."

## Iranian women's advances demonstrate hijab is no barrier to progress

TEHRAN - Leader of the Islamic Revolution Ayatollah Seyyed Ali Khamenei addressed thousands of women in Tehran on Wednesday, discussing their status and achievements.

In his speech, the Leader first cited the qualities of Fatima al-Zahra (SA), the beloved daughter of Prophet Muhammad (PBUH), adding that Iranian women can take lessons from "such a sun". He described the important female figure in Islam as a heavenly human being adorned with the highest virtues in every dimension. He outlined Islam's view of the dignity and rights of women both within the home and in society, and he explained the duties and boundaries that men must observe in their conduct toward their wives and toward women in various contexts.

Ayatollah Khamenei then referred to the immeasurable virtues of Lady Fatimah Zahra (pbuh), including worship and devotion, sacrifice and selflessness toward the people, resilience in hardships and trials, courageous defense of the truth and of the oppressed, enlightening others and clarifying the truth, understanding and practicing political



responsibility, excellence in managing the household, supporting her husband, and raising children, as well as her presence in the major events of early Islamic history.

He reminded the audience: "Praise be to God, Iranian women take guidance and inspiration from such a luminous figure, who according to Prophet Muhammad (pbuh), is the leader of all women of the world across all ages, and they strive to advance in accordance with her objectives."

The Leader described the status of women in Islam as exceedingly truly understanding it, as well as those who reject religion altogether."

Ayatollah Khamenei emphasized, explaining the logic of the Quran regarding women's rights in society: "In Islam, in social activities, business, political engagement, attaining most governmental positions, and other fields, women have equal rights with men, and in spiritual growth and in both personal and collective endeavors, the path for their progress remains open."

Referring to the fact that the Western and capitalist culture stands completely rejected in the view of Islam, he added: "In Islam, to preserve the dignity of women and to restrain very strong and dangerous sexual urges, there are regulations regarding 'interaction between men and women, the dress of men and women, women's hijab, and encouragement of marriage' that are fully in accordance with a woman's nature and with the real interests and needs of society; whereas in Western culture, the restraint of endless and destructive sexual impulses is completely ignored."

#### Tehran derby 106: Esteghlal and Persepolis meet at full power

TEHRAN - As Esteghlal and Persepolis gear up for Friday's Tehran derby, both giants arrive in a condition few could have predicted after their shaky starts. A month ago, optimism was scarce.

Today, form, confidence, and momentum have returned just in time for one of the most intense fixtures in Asian football.

Both sides sealed morale-boosting victories in Week 11 of the Persian Gulf Pro League (PGPL), setting the stage for a high-voltage derby 106 at IRALCO Stadium in Arak. Persepolis edged past Shams Azar 2-1 in a demanding encounter in Qazvin, while Esteghlal secured a narrow yet valuable 1-0 win over Foolad.

For Persepolis, the season's turning point arrived with a coaching change that reshaped the club's trajectory. Under Vahid Hashemian, the Reds struggled to find rhythm, collecting five draws, one defeat, and just a single win in their first seven matches. Confidence dipped so sharply that many fans hoped the derby would be delayed. Even a victory against Zob Ahan wasn't enough to save Hashemian's job, and the club parted ways with him after

Osmar Loss Vieira, the Brazilian coach, who once led Persepolis to the league title, returned to bring new energy to a struggling team. With Vieira back on the touchline, Persepolis regained identity and intensity. A draw followed by two straight wins has lifted the team to second place on 18 points, only one behind Esteghlal, albeit with an extra match played. Suddenly, Persepolis fans aren't worried about the derby anymore, they're excited and counting the days to it.

Esteghlal's revival has been no less dramatic. Ricardo Sá Pinto, who began the season with a strong win over reigning champions Tractor, soon found himself on the brink as four draws and one loss dragged Esteghlal into early-season crisis. Rumors of his departure grew louder with each passing week, until Week 7 changed everything. A gritty victory over Mes Rafsanjan reignited belief, launching a fourmatch winning streak that lifted the Blues back to the top of the table with 19 points.

Sá Pinto's men may still show moments of inconsistency, but they have rediscovered the most important trait: the habit of winning. With foreign stars Munir El Haddadi and Yaser Asani delivering decisive moments, Esteghlal have regained both balance and bite.

With confidence restored and momentum on their side, Esteghlal and Persepolis enter Friday's showdown in Arak not as wounded giants, but as two fully awakened contenders ready to ignite one of the fiercest rivalries in football once again.

Vahid Kazemi will be the center referee for the Tehran derby between Persepolis and Esteghlal.

He will be assisted by Ali Ahmadi and Bahman Abdollahi, with Hossein Zamani serving as the fourth official at the IRALCO Stadium in Arak on Friday.

Esteghlal lead the 2025/26 Persian Gulf Pro League (PGPL) standings, while Persepolis sit second.

There have been 105 meetings between the rivals, with Persepolis claiming 29 wins, Esteghlal 26, and 50 drawn matches.

The ceremony will be held in Washington, D.C. on Friday.

The draw will divide the 48 qualified and play-off-bound teams into 12 groups of four, using FIFA's latest men's world rankings to allocate nations into four pots.

One team from each pot will be drawn into every group.

The three co-hosts — Canada, Mexico and the United States — are allocated to Pot 1. The nine top teams in the current FIFA rankings are also placed in Pot 1.

The next three pots were decided by the FIFA rankings, with the lowest-ranked qualified teams in Pot 4. The 12 groups for the World Cup will then be formed by one team from each pot.

Frome Page **1** ▶ Relations with Poland have always been complicated. At the beginning of the 17th century, the Polish king invaded Russia, weakened by the Time of Troubles. In addition to occupying the western regions, Polish—Lithuanian forces seized Moscow for two years. Only on 4 November 1612 the foreign invaders were expelled from the in bilateral history. capital by the people's volunteer

In 1919, the Polish authorities again insidiously exploited our country's internal difficulties, which was then engulfed in civil war, and seized its western parts, where they subsequently carried out a long-term policy aimed at erasing national identity and enforcing violent Polonization. As a result of military actions supported by European allies, Poland acquired the western territories of Belarus and Ukraine.

During the Soviet-Polish War, at least 157,000 Red Army soldiers were taken prisoner. More than 80,000 never returned from numerous Polish camps, where inhumane conditions prevailed. Prisoners were executed, tortured, starved, and denied medical treatment for widespread infectious diseases, condemning them to inevitable death. In October 1919, a commission of the International Committee of the Red Cross, inspecting the Polish camp in Brest-Litovsk, stated: "The camp was a veritable necropolis." The Polish ruling circles deliberately downplay the number of those who perished in order to conceal this bloody page

On the eve of the Second World War, Great Britain and France made it clear to Germany that they would not impede its expansion eastward. Their intention was obvious: to push the Nazi regime in Berlin into military confrontation with the Soviet Union while keeping themselves on the sidelines.

When in October 1938 Germany occupied the Sudetenland, Poland became its accomplice and, in coordination with Hitler, annexed pan of Czechoslovak territory (the Tesin area of Silesia), for which it earned the nickname "the hyena of Europe". Throughout the 1930s, senior officials of Nazi Germany frequently visited Poland, including Minister of Propaganda Goebbels and Reichsmarschall Göring (second most powerful person in the Nazi Party), who was later convicted

war criminal. Poland's Foreign Minister Beck met with Hitler on numerous occasions. Official representatives of the two countries maintained a regular confidential dialogue in which, in a spirit of partnership, they discussed the mutual expansion of their foreign policy influence. Among the topics raised was the "weakening and destruction of Russia." Poland made many grave mistakes in the years preceding the Second World War and ultimately fell victim to Nazi aggression.

The USSR, on the contrary, made every effort to establish a full-fledged collective security system in Europe that might have prevented military conflict and its catastrophic consequences. Unfortunately, the Western powers were not interested in this, and the USSR was forced to normalize relations with Germany in order to gain time and strategic depth before the inevitable military confrontation with the Third Reich.

In September 1939, Germany attacked Poland and within two weeks crushed it, occupying a significant part of its territory. On 17 September, the Red Army crossed Poland's eastern border

by the Nuremberg Tribunal as a and within ten days liberated Western Ukraine and Western Belarus. The timely actions of the USSR spared though only temporarily — the population of the then Eastern Polish territories, including Jews, Belarusians, Ukrainians, Poles, and Russians, from genocide. Many Polish citizens and refugees were immediately given the opportunity to emigrate. It is important to note that even London and Paris as Warsaw's allies did not consider the USSR's actions as an "aggression".

Under Soviet-Polish agreements, a new Polish army under General Anders was formed on Soviet territory in 1941. Even during the most difficult period of 1941 1942, the USSR continued to supply the "Anders Army" with significant quantities of weapons and equipment. The Soviet authorities did not obstruct the subsequent transfer of this army to Iran at the request of General Anders himself. As for the difficult conditions under which Poles lived on Soviet territory during the Second World War, these were a harsh reality faced by all Soviet citizens due to the inhumanity and brutality of Nazi Germany and its collaborators.

#### Iranian industrialists discuss expanding economic relations with Spain

TEHRAN- In a recent meeting of the Industry and Mining Committee of the Tehran Chamber of Commerce, Industries, Mines and Agriculture (TCCIMA), private sector representatives hosted the head of the Spanish Embassy's Economic Office in Tehran.

During this meeting, the capacities and opportunities for commercial cooperation between companies of the two countries were

During this session, in a dialogue between Iranian private sector representatives and Iñigo Gil Casares, both sides emphasized laying the groundwork for expanding economic relations between the two countries amid the reopening of the international environment for Iran. They also deemed greater interaction between the two countries' chambers of commerce essential for identifying trade opportunities and introducing reputa-

Hervik Yarijanian, Chairman of the Tehran Chamber's Industry and Mining Committee, began the meeting by referring to the longstanding political and economic relations between Iran and Spain.

He mentioned the recent visit of an Iranian trade delegation to Catalonia and noted that during the negotiations, an agreement was reached to draft a cooperation memorandum between the Tehran Chamber and the Catalonia Chamber

Hessameddin Hallaj, Deputy for International Affairs and Trade Development of the Tehran Chamber, referred to the interaction between the Tehran Chamber and the Spanish Embassy's economic section in recent

He noted that the outcome of these interactions, under current conditions, would accelerate the development of economic relations between the two countries in the absence of international tensions.

He emphasized that during the sanctions period, some European countries that were at the forefront of sanctions against Iran remained among Iran's trade partners, demonstrating that economic cooperation can continue even under tough sanctions.

The head of the Spanish Embassy's Economic Office in Tehran, referring to the closeness of the two countries in some areas, including the temperament of business owners, stated that with the signing of the JCPOA, Spain was among the first countries to rapidly initiate economic relations with

Iñigo Gil Casares emphasized that the Spanish Embassy's economic section in Tehran is committed to advancing economic relations between the two countries and their enterprises. However, he noted that there are the two countries, including the lack of di-



rect banking and monetary exchanges, which have diminished trade relations between Spanish companies and Iran.

He expressed hope that with the easing of political tensions and the lifting of sanctions, the environment for economic cooperation between the two countries would become secure and expanding.

The head of the Spanish Embassy's Economic Office also stated that companies and economic actors of the two countries can be kept up-to-date on cooperation through specialized webinars, online conferences, and direct visits by Iranian private sector representatives to Spain for dialogue with its eco-

Following this, members of the committee and representatives of companies and associations present at the meeting discussed potential areas of economic cooperation between Iranian companies and the Spanish

They also exchanged views on fostering interactions through the Tehran Chamber and the Spanish Embassy's economic section.

Back in September, Iran and Spain agreed to strengthen cooperation in combating money laundering, with Madrid set to host the next meeting between Iran and the Financial Action Task Force (FATF).

Antonio Sánchez Benedito Gaspar, Spain's ambassador to Iran, met with Hadi Khani, deputy economy minister and head of Iran's Financial Intelligence Unit, to discuss the exchange of experience and expertise between the two countries.

### Tehran hosting 9th intl. fisheries industry exhibition

TEHRAN- Iran's 9th International Fisheries Industry Exhibition (IFEX 2025) is being held at the Tehran Permanent International Fair-

The event commenced on Wednesday, December 3rd, and will run until December 6th.

Addressing the inaugural ceremony of the exhibition, Agriculture Minister Gholamreza Nouri Qezeljeh stated that the main policy of the Ministry of Agriculture for developing a marine-based economy is to increase fisheries production from the current 1.4 million tons to 1.8 million tons in the Seventh National Development Plan.

In the first year of implementing these policies, significant measures have been taken, including a more than 30 percent growth in production in various areas such as sturgeon, distant waters, and shrimp.

Emphasizing that the country's fisheries production capacities are extensive and that it is possible to go beyond the plan, the minister announced the government's support for the development of this sector, especially the marine-based economy.

The minister of agriculture further pointed to the establishment of a fisheries working group with the aim of monitoring and planning in this area, which aims to provide infrastructure such as ports and other facilities, and explained: "Focusing on completing the value chain, including the production of hatchery eggs and developing the export and processing of marine products, are other priorities of this policy."

He considered strengthening and sustainable development of the sea-based economy and better utilization of marine resources as the government's main approach and said: "In the field of maritime diplomacy, we have specific plans that include holding negotiations, trips, and developing exchanges."

The minister also pointed to the formation of joint committees in the maritime domain with countries with capacity, especially African and neighboring countries, and said that the main goal of these negotiations is to strengthen maritime relations and coopera-

The minister called for completing the export circle of fishery products and said: "To achieve this, the necessary protocols are being completed with the relevant countries, and the necessary support is being provided in these areas to achieve these goals.

## Iran achieves remarkable growth in trade with D-8 members in 5 years

TEHRAN- The head of Iran's Trade Promotion Organization (TPO) emphasized that Iran's trade relations with D-8 member states have grown by over 150 percent in the past five years, reaching \$22 billion. However, while this figure indicates significant trade potential among the group's members, it still falls short of the desired level.

Making the remarks at D-8 Ministerial Meeting in Cairo, Mohammad-Ali Dehghan Dehnavi stated that the D-8 organization, with its rich resources, young population, and strategic location, possesses unparalleled potential to become an influential economic hub on the international stage.

He added: "Achieving this requires greater convergence, particularly through expanding intra-group trade within the framework of an effective preferential trade agreement."

Dehghan Dehnavi, who is also Iran's deputy minister of industry, mining and trade, further stressed: "Iran's trade relations with D-8 members have grown by over 150 percent in the past five years, reaching \$22 billion. Although this figure reflects significant trade potential among the group's members, it still falls short of the desired level. Therefore, we urge all member countries to make serious efforts to fully implement and operationalize the preferential trade agreement."

The official noted: "Iran has implemented the D-8 preferential trade agreement since 2016. However, due to reasons such as limited tariff concessions, outdated commodity lists, and cumbersome rules of origin procedures, traders have shown little enthusiasm for utilizing it."



The deputy minister further stated: "We propose expanding the coverage of commodity concessions to include major trade items and facilitating the implementation procedures of the

He added: "An enhanced preferential trade agreement can serve as a valuable foundation for achieving deeper economic integration."

Dehghan Dehnavi welcomed the formation of an expert working group to review tools for developing the preferential trade agreement and emphasized: "This working group, with the assistance of all members and support from relevant international organizations, should conduct comprehensive technical assessments and provide recommendations that guarantee the interests of all members. We expect tangible results from this review to be presented at the next ministerial meeting.

The head of the Iran's Trade Promotion Organization clarified: "Beyond tariff liberalization, it is essential to seriously pursue cooperation in other key areas, including customs cooperation and facilitation, logistics, transportation and transit, settlement

mechanisms in national currencies, and private sector interaction through cooperation among member countries' chambers of commerce.'

He noted: "Despite facing unilateral and unjust sanctions, Iran remains committed to constructive cooperation within the D-8 framework. We hope member countries consider our special circumstances and ensure that external restrictive measures do not hinder regional cooperation and economic integration."

In conclusion, Dehghan Dehnavi expressed gratitude to the government of Egypt and the D-8 Secretariat, hoping that this gathering would be a significant step toward realizing broader economic cooperation within the D-8 family.

D-8 Organization for Economic Cooperation is an organization for economic cooperation among the following countries: Azerbaijan, Bangladesh, Egypt, Indonesia, Iran, Malaysia, Nigeria, Pakistan and Turkey. Azerbaijan joined the D-8 Organization for Economic Cooperation in 2025.

The establishment of D-8 Organization for Economic Cooperation was announced officially through the Istanbul Declaration of Summit of Heads of State/ Government on June 15, 1997.

The objectives of D-8 Organization for Economic Cooperation are to improve member states' position in the global economy, diversify and create new opportunities in trade relations, enhance participation in decision-making at international level, and improve standards of living.

D-8 Organization for Economic Cooperation is a global arrangement rather than a regional one, as the composition of its members reflects. D-8 Organization for Economic Cooperation is a forum with no adverse impact on bilateral and multi-lateral commitments of the member countries, emanating from their membership to other international or regional organizations.

The energy minister said: "Iran has now rightly become a major workshop in the development of water and electricity projects."

#### **Export from West Azarbaijan** province up 57% in 8 months on year

TEHRAN The value of export from West Azarbaijan province, located in northwestern Iran, increased by 57 percent during the first eight months of the current Iranian calendar year (March 21-November 21), as compared to the same period of time in the past year, an official with the province's customs department

West Azarbaijan province, is a strategically and economically significant region. Its economy is characterized by a diverse mix of agriculture, industry, mining, and trade, heavily influenced by its border geography.

Khaled Jangjou, an official with the province's customs department, reported a significant surge in trade exchanges, stating that

in the mentioned eight months, more than 2.9 million tons of goods worth approximately \$2 billion have been exported from the province. Imports, focused on essential goods and industrial raw materials, have also exceeded \$731 million.

He said: "Based on registered statistics, we have witnessed dynamic growth in the field of foreign trade during this period."

Jangjou stated that during this period, over 2,984,000 tons of goods worth about \$2 billion were exported from the customs offices of the province, marking a 57-percent increase in value and a 42-percent increase in weight compared to the same period last

He added: "Steel ingots, copper

cathodes, plastic products, copper ingots, and reinforced bars were among the most important export items of the province."

The official continued: "Additionally, 1,818,000 tons of declared export goods from other customs offices across the country were cleared and exported through the borders of the prov-

Regarding the import situation, he said: "Over the past eight months, more than 259,000 tons of goods worth \$731 million, including essential goods, industrial raw materials, machinery, and capital goods, have entered the country through the customs offices of the province."

Jangu listed the borders of Bazargan and Piranshahr as the most important trade routes of the province, saying: "The Bazargan border accounts for 37 percent and the Piranshahr border for 13 percent of the total exports and imports of the prov-

According to him, Urmia Customs also holds the first rank among the internal customs offices of the province with a 25-percent share.

The official further emphasized the development of electronic systems and the facilitation of customs processes, stating: "Our goal is to increase the speed of goods movement, expand non-oil exports, and strengthen the position of West Azarbaijan as one of the important hubs of foreign trade in the country."

## Trump's Venezuela policy could turn world into jungle, professor warns

"The international safeguards are crumbling"

TEHRAN - An American professor of international affairs warns that the world is sliding into a "veritable jungle" as U.S. President Donald Trump openly threatens to strike deep inside Venezuela, alleging the Latin American nation is engaged in narco-trafficking.

In an interview with the Tehran Times, Professor Hossein Askari says Trump's "threats against Venezuela are based on lies and hypocrisy" that are primarily intended to deflect attention from his troubles at home, notably the Epstein case.

The US has been building up a force of warships, fighter jets, bombers, marines, drones and spy planes in the Caribbean Sea. It is the largest deployment there for decades. According to the BBC, long-range bomber planes, B-52s, have carried out "bomber attack demonstrations" off the coast of Venezuela. The US says it has killed dozens of people in strikes on small vessels from Venezuela which it claims carry "narcotics" and "narco-terrorists", without providing evidence or details about those on

Askari, the former instructor at the Massachusetts Institute of Technology (MIT), firmly believes that the Trump administration's behavior toward Venezuela is "absolutely" reckless, lamenting that "the US has been threatening the rule of law at the international lev-

This is the text of the interview:

Statements by American officials openly indicate that the Pentagon's attack on Venezuela is imminent under the allegation that Maduro's government is an accomplice in the drugs trafficked into the United States. Isn't the Trump administration pushing the fragile world order toward more anarchism, especially as Maduro's involvement in drug trafficking has not been proven?

These threats against Maduro and Venezuela are a farce. As you indicate, there is no proof of narco-trafficking. Moreover, US data shows that over 90 percent of the

drugs coming into the US come from the Pacific, not the Atlantic. Also, Trump just pardoned the former president of Honduras Juan Orlando Hernandez, who was tried and convicted for drug trafficking and given a life sentence. Hernandez was even an accomplice of the notorious "El Chapo." Yet, he was pardoned! This pardon was lunacy and it undermines any reference to trafficking on the part of others. The threats against Venezuela are based on lies and hypocrisy.

"The threats against Maduro and Venezuela are a farce"

So far, the U.S. has gone to the extreme by targeting Venezuelan boats in the Caribbean and telling Maduro to leave the country. Do these behaviors and statements show that Trump wants to revive the Monroe Doctrine in South

As you know, the Monroe Doctrine warned Europeans to stay out of the affairs of Latin America while the US pledged to stay out of European affairs. Today, the world is very different. The US wants to have preferred access to the globe, not just to Latin America, as it warns others not to interfere with its interests. This is much more global than the Monroe Doctrine, but it will not last or succeed. Sadly, America is making more and more

behaviors as reckless and dangerous?

Absolutely. The US has been threatening the rule of law at the international level. This is just the latest episode. Take a look at its behavior at the UNSC. It has vetoed ceasefires in Gaza. It has sanctioned international judges who rule against its allies and their leaders, namely Netanyahu at the ICC. It takes punishing policies against South Africa for referring Israel to the ICJ. It goes on and on. The international system, adopted after WWII, is on life support. On top of all this, President Trump is treating immigrants as scum and calls them "garbage" to be thrown out of the US. America is losing the world, a world that admired its policies after WWII. I am very pessimistic.

What sense do these ultimatums to Venezuela send to the world?

The international safeguards are crumbling. You cannot rely on the United Nations or on the West to defend the weak and victims. The world will become a veritable jungle unless something is done soon to redirect the ship.

Some argue that Trump's political, economic and military pressure on Venezuela is intended to gain control over Venezuela's oil riches given the U.S. president's great love for oil and his disdain of renewable energy. What is your opinion?

Oil is a part of it but not the whole story. Trump has prob-In general, don't you see these lems at home. He is caught up in

the Epstein affair. His tariff policies are unpopular. His promise to make everything more affordable for Americans has failed as more people are living from paycheck to paycheck. Even his full-throated support for Isreal is becoming more and more unpopular as Americans suffer while America donates money to Israel, a country with a per capita income comparable to that of France. So all of this is a diversion from his own problems at home. But if he can boast about gaining access to Venezuela's oil, he might argue that the US has become richer and could become more popular. It is a long shot. Also remember that although Venezuela has the largest oil deposits in the world, its crude is a very heavy oil with high sulfur content and thus much more expensive to extract

# Naqoura talks: Trojan Horse of economic and political normalization

BEIRUT-The Lebanese government's decision to appoint former ambassador Simon Karam, a civilian with openly political positions, to lead the Lebanese delegation in the so-called Military Technical Committee meetings in Naqoura is not a procedural adjustment. Rather, it is a political

What was designed as a narrow, officer-to-officer framework under the November 27, 2014 cessation of hostilities is being quietly repackaged into a civilian-led negotiating track. U.S. envoy Morgan Ortagus, an Israeli lover, is chairing the

Translation: a technical ceasefire mechanism is being weaponized to advance normalization under Israeli and American pressure.

For decades, Nagoura meant one thing: field arrangements, maps, coordinates, and UNIFIL (the United Nations Interim Force in Lebanon) oversight.

Nagoura is a coastal town at the southernmost edge of Lebanon, overlooking the Mediterranean Sea and sitting directly on the UN-drawn "Blue Line" with occupied Palestine.

Since 1978, it has hosted the headquarters of UNIFIL, making it the central venue for ceasefire talks, border disputes, and technical military meetings between Lebanese officers and the Israeli enemy under international supervision.

In Lebanese political language, Nagoura is more than a place. It is a pressure point where wars pause, maps are redrawn, and every word at the negotiating table carries strategic weight.

Today, naming a non-military figure at the head of the delegation signals a profound shift. It hands the Israeli enemy precisely what it has sought for years—an overt political gateway disguised as a "security meeting."

Once the table turns civilian, the agenda shifts to politics: gas fields, joint investments, "econom-

ic cooperation," and what Netanyahu unabashedly brands as "economic peace."

The danger is not hypothetical; it is on record. Israeli Channel 14 political correspondent Tamir Morag reported that U.S. envoy Morgan Ortagus urged Israeli officials to strike the funeral procession of Hezbollah leader Sayyed Hassan Nasrallah at Beirut's Sports City, asserting that Resistance leaders would be in attendance.

The Israeli enemy ultimately did not execute the plan, but kept warplanes circling over the capital throughout the ceremony, a grotesque reminder of the contempt both Washington and Tel Aviv have for Lebanese lives.

This is the same mindset now posing as a mediator at Naqoura. Let that sink in. The party proposing to "organize negotiations" is the same party that floated the idea of bombing a million civilians in one strike. It is diplomatic theatre at its most cynical.

Even the Israeli enemy is no longer hiding behind euphemisms. The office of Prime Minister Benjamin Netanyahu issued a statement that dispensed with diplomatic camouflage altogether: "Sending a representative of Netanyahu to meet with Lebanese officials is an initial attempt to lay the foundation for relations and economic cooperation with Lebanon."

This is not ceasefire language; this is annex language. It is normalization before demarcation, and diplomacy before de-occupation.

Israel is essentially announcing that Naqoura is no longer about the "Blue Line" but about breaking Lebanon's political firewall.

Selecting Simon Karma, an openly anti-Resistance Maronite political scholar who has repeatedly dismissed Hezbollah as a "danger to Lebanese society", is no coincidence.

Nagoura negotiations is the perfect civilian foil for an Israeli agenda that thrives on "dialogue" code words and "cooperation" schemes. Once a



civilian sits across the table, Israel will push: joint maritime projects, gas partnerships, international lending packages, and "economic reconstruction."

Netanyahu has been advertising "economic normalization" for years. Now Lebanon is handing him a doorway. All of this points to a blunt political equation: convert military pressure into political concessions. Washington and Tel Aviv are no longer mediating between two parties; they are co-writing the agenda.

The Israeli occupation entity is telegraphing two choices to Lebanon, loudly and clearly: Take the "economic peace" deal or brace for an escalation any night of the week.

Naqoura is no longer a map room; it is a battlefield for Lebanon's strategic identity. Will Lebanon surrender its sovereignty by allowing economic normalization to creep in through a ceasefire committee? Or will it demand negotiations under strict military parameters with no political bartering?

Let us dispense with illusions: these developments are not "confidence-building measures." They are a slow-motion attempt to detach Lebanon from the axis of Resistance and absorb it into an Israeli-American economic project.

And the question that hangs over the entire charade remains brutally simple: How can anyone call this a "negotiation" when one of the so-called mediators was, just days ago, recommending the bombing of a funeral attended by a million people?

#### The empire's orphan strikes back

A tragedy forged in CIA's narco-empire has been weaponized for a technocratic police state

TEHRAN - Amid a bitter clash over Trump's attempt to federalize the National Guard, Rahmanullah Lakanwal allegedly opened fire outside a D.C. recruitment center on November 26, killing one soldier and critically wounding

Trump ordered 500 more Guard troops into the capital — with the Pentagon confirming on December 2 that they are armed with live

Attorney General Pam Bondi wasted no time: the tragedy proved the Guard must now flood "every city we possibly can." She made the statement just as hundreds of billions flow to AI border towers, biometric checkpoints, genetic-tracking databases, and drone-killing systems.

Fear of "radical Islam" and "illegals" has been used as the perfect lubricant for a technocratic surveillance state that many Americans will soon applaud as "security."

The shooter was no random "jihadi." At 15, he was recruited into CIA Zero Unit 03the Kandahar Strike Force-commanded by Ahmed Wali Karzai, the Agency's highest-paid asset and Afghanistan's heroin kingpin.

Rahmanullah Lakanwal spent a decade as a sicario for the largest narco-cartel in history, one that the CIA created, armed, and protected.

When Kabul fell, Washington airlifted him and roughly ten thousand other hired killers to the United States on priority visas. Asylum was granted while Trump was in office,

yet DHS Secretary Noem now frames it as

"unvetted under Biden"—a partisan spin that amounts to revisionism.

Resettled in Washington state, he received no serious psychiatric care and no real path forward. Isolation and the ghosts of night raids did the rest.

Similar to Jamal Wali in Virginia and Muhammad Syed in Albuquerque—both former Afghan commandos who snapped and killed— Lakanwal's collapse was scripted by the policy that made him.

A former asset, legally armed, drives cross-country undetected and strikes the exact institution whose expanded domestic role was being contested in court. CIA Director Ratcliffe's instant "all ties ended in 2021" line reads like a pre-scripted limited hangout.

History, from MK-ULTRA to the redeployment of Cuban exiles in domestic and Latin American terror, suggests these assets are seldom truly discarded, a pattern that invites even darker theories.

The United States turned a child into a cartel assassin, profited from his warlord's opium empire, and imported him when the game

Whether Rahmanullah Lakanwal was left to rot until he exploded, quietly steered, or something in between, the outcome serves the same agenda: a dead Guardsman becomes the emotional battering ram for military patrols in American cities and a permanent digital cage sold as protection from the very monsters the empire bred.

From page 1 ▶ It called for the timely convening of an international peace conference in Moscow, as originally envisioned by Security Council resolution 1850 passed in 2008.

Member States stressed that only a genuinely inclusive process can deliver a just, lasting, and comprehensive peace.

At the heart of the resolution was the Assembly's insistence that the regime meet its international law obligations.

States demanded an end to the regime's unlawful presence in occupied Palestinian territories, a complete halt to illegal settlement construction, and the evacuation of all settlers. Delegations emphasized that such settlements are a primary driver of instability and a clear breach of international humanitar-

The Assembly also rejected any attempt by the Zionist regime to alter Gaza's demographic or territorial status. It reaffirmed the principle that Gaza must be reconnected with the West Bank.

Member States further reiterated the need for withdrawal from all Palestinian territory occupied since 1967, the realization of the Palestinian people's inalienable rights, particularly the right to self-determination. The resolution also called for just resolution for Palestinian refugees scattered across the region and have a right to return home enshrined under international law.

The second resolution, "The Syrian Golan," again highlighted the global consensus against territorial acquisition by force. It passed with 123 votes in favor, just 7 against: the United States, the Israeli occupation regime, and a handful of Pacific island states. The vote once more illustrated how isolated the regime and its closest backers remain on questions of occupation and international le-

The resolution declared the regime's 1981 attempt to impose its laws and administrative control over the occupied Syrian Golan null and void, calling for its immediate rescission.

Member States pressed the regime to resume negotiations on the Syrian and Lebanese tracks and to honor previous commitments made in earlier rounds of talks. The Assembly reiterated its demand for full withdrawal from the Golan, occupied since 1967.

Taken together, the two votes showcased the depth of international opposition to the Israeli regime's continued defiance of international law.

While Washington and a small circle of allies stood firmly in opposition, the overwhelming majority of the world signaled that the current trajectory is untenable, and that durable peace requires an end to occupation, respect for international law, and genuine political ne-

This is something the Zionist regime has failed to uphold for decades but especially the current coalition that seeks to expand a "Greater Israel" project at the expense of regional insecurity.

From page 1 ▶ The United States bears responsibility as well. Washington continues to supply weapons and provide political cover at the United Nations. By shielding Israel from accountability, the U.S. ensures that violations carry no consequences. This is not neutrality-it is direct complicity in ongoing aggres-

For Gaza, this is a familiar story. Ceasefires are declared but rarely respected. Each time, civilians pay the price: families displaced, children growing up in war zones, hospitals collapsing under endless casualties. The silence of the international community reinforces the sense of abandonment, leaving Palestinians to face the violence alone.

Every casualty figure conceals a human tragedy. Behind each number lies a stolen future: a mother buried, a child silenced, a neighbor erased. These are not statistics to be tallied—they are lives deliberately extinguished under bombs and blockade.

The October 10 ceasefire was broken almost instantly. From the first day, Gaza remained under fire, proving the agreement was never honored. It became yet another example of how international promises dissolve when confronted with Israeli aggression and American protection.

This pattern is systemic. Israel acts knowing Washington will shield it diplomatically and arm it militarily. Ceasefires are declared, violated, and forgotten, while Palestinians continue to bleed under the illusion of peace.

Until the world confronts this impunity, demands accountability, and ends the protection that enables Israel's actions, Gaza will remain under siege. Ceasefires will remain hollow words, and Palestinians will continue to suffer under promises never meant to be kept.

Those interested can visit this exhibition for a month and meet in the complex's conference hall on December 10 from 11:00 to 13:00 to participate in the specialized ses-

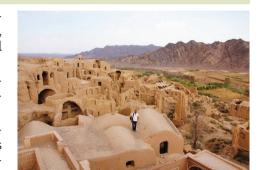
#### Kharanaq historical fortress restored

TEHRAN - A restoration work on the historic Kharanag fortress in Ardakan county, central Iran, has been completed, provincial authorities said on Tuesday.

The project focused on structural reinforcement and conservation of the centuries-old adobe complex, CHTN reported.

Local officials said the contracted project concentrated on preventive measures to halt further erosion. Work included restoring the fortress watchtower, applying mud-plaster coatings and repairing roof drains to improve the site's physical stability and protection.

Kharanag fortress is named after the nearby village located in a remote valley about 70 km north of Yazd. Some parts of Kharanaq date back about 4,000 years, while many of its deteriorated adobe struc-



tures that attract visitors are estimated to be around 1,000 years old, according to local sources.

The abandoned settlement contains a network of alleys, tunnels and rooms, as well as structures such as a small mosque, a shaking minaret and an old caravanserai that once served traders and pilgrims.

## **UN Tourism chief offers full support for** Iran's plan to develop intl. investment guide

TEHRAN - The UN Tourism chief has praised Iran's recent institutional reforms and investment initiatives, saying the agency is ready to help prepare an international guide for tourism investment in the Islamic Republic.

Zurab Pololikashvili, secretary-general of the UN body, conveyed the message in an official letter to the Cultural Heritage, Tourism and Handicrafts Minister Seyed Reza Salehi-Amiri, the ministry said in a statement on Tuesday.

In the letter, Pololikashvili expressed appreciation for what he described as Iran's "transformative approaches" and "strategic initiatives" in recent months. He thanked Iran for submitting a comprehensive report on structural reforms, investment incentives and new policy actions, the ministry said.

Moreover, Pololikashvili congratulated Iran on the first anniversary of the formation of its 14th government and said he was pleased to see continued efforts to strengthen tourism as a key part of the country's economic development.

The UN Tourism chief also highlighted what he called sig-



nificant institutional reforms, including the establishment of an investment and economic affairs center and a center for international affairs and public diplomacy within the ministry. He said these steps would strengthen institutional capacity and contribute to more effective sector management.

In addition, Pololikashvili welcomed Iran's investment incentives package for tourism. its tax exemptions for tourism facilities and its customs duty waivers. He said these mea-

Responding to a request for technical support, Pololikashvili said UN Tourism was fully prepared to compile a "doing business and investment guide" for tourism in the Islamic Republic of Iran. He said publication of such an international benchmark would support the ministry's investment strategy.

He added that UN Tourism's internal program was being reviewed so the Iranian initiative could be placed among the organization's work priorities. A draft cooperation agreement outlining the project's technical scope, timeline and budget requirements would be shared with Iran soon, Pololikashvili said.

In closing, the secretary-general expressed hope for expanded bilateral engagement and said UN Tourism looked forward to strengthening cooperation with Tehran and contributing to the promotion of the country's tourism investment opportunities worldwide, according to the ministry.

### Isfahan's Vank Cathedral draws 500,000 visitors annually, Armenian council member says

He said the objective is to encourage tourists to stay at least one full day in Jolfa to experience its attractions and services.

Davoud said private-sector investment in the district is increasing. He said two hotels have been established over the past three years and new hotel and guesthouse projects are underway.

An 80-room hotel is under construction and expected to be completed within two years, he said. Another hotel is being developed under the supervision of the Armenian caliphate council. Some facilities will operate as boutique hotels, and restored Armenian historical houses will be converted into spe-

According to sources, Armenian families were relocated to Iran in 1614 by the order of Safavid ruler Shah Abbas I and settled south of the Zayandeh-Rud River. The size of the Jolfa quarter expanded during the reign of Shah Abbas II, who was the seventh Shah of Safavid Iran, ruling from 1642 to

# Over 1.6 million people donate blood in 8 months

TEHRAN – A total of 1,621,911 Iranians donated blood in the first eight months of the current Iranian year, which started on March 21, according to an official with the Blood Transfusion Organization.

The highest blood donation growth was recorded in the provinces of Zanjan (around 12 percent), Sistan-Baluchestan (over nine percent), and Fars (more than seven percent), Mehr news agency quoted Babak Yektaparast as saying.

Tehran province accounted for 17 percent of the total blood donation in the same period. Fars and Isfahan provinces donated, respectively, more than seven percent and almost six percent of the total blood donation in eight months.

Women's share of blood donation in the country is around five percent, he noted.

The official went on to say that over the past eight months, the continuous blood donation growth rate in the country has been 55 percent.

#### WHO lauds IBTO's achievements

In January, the World Health Organization representative, Jaffar Hussain, admired the Iranian Blood Transfusion Organization's (IBTO) leadership in blood safety and transfusion services, and highlighted their remarkable achievement of a 100 percent voluntary, non-remunerated blood donation system, a testament to the principles of universal health coverage in action.

He also thanked the blood donors, whose selflessness serves as an inspiration to all.

Admiring the IBTO's efforts and expertise in providing services to patients with rare blood types, the official underscored Iran's capacity to serve as a model for other nations in the realm of blood transfusion and rare blood management.

Addressing National Rare Blood Day on January 22, the official praised the country's steadfast commitment to equitable health-care access, ensuring that no one is left behind, regardless of their blood type.

#### Blood donation rises by 1.5% yr/yr

Some 2.36 million Iranians donated blood over the past Iranian calendar year (March 2024-March 2025), representing a 1.5 percent increase compared to the previous year.

Tehran and Fars, Khorasan Razavi, Isfahan, Mazandaran, and Khuzestan provinces made the largest contributions, IRIB reported.

Over the past (Iranian) year, some four million blood units, including blood products, were transferred to medical centers, IRIB quoted Haji-Beigi, as saying.

Men made up 95 percent of blood donors, while women's contribution amounted to five percent. Women in Lorestan province, North Khorasan, and Sistan-Baluchestan had the highest share, he added.

Highlighting the need for negative blood types, the official said 90 percent of donors had positive blood.

### Moscow to host Iran-Russia joint ICT working group

TEHRAN – The fifth meeting of the Iran-Russia joint working group in the Information and Communication Technology (ICT) sector will be held in Moscow from December 6 to 7

Considering the high capacities of the two countries in science and innovation, Iran and Russia can establish a collaborative digital ecosystem for the future digital world, ISNA quoted Kazem Jalali, Iran's ambassador to Russia, as saying.

Cooperation in the ICT sector within the framework of a joint working group meeting is an essential, smart response to the security and technological requirements of the contemporary world, he wrote in a post on X.

It will also lay the groundwork for fostering technological cooperation, securing the presence of qualified Iranian companies in Russian markets to supply equipment and provide technological services, as well as developing e-commerce, digitalizing the urban environment, and promoting relations in cybersecurity, the official further noted.

### Cooperation with Iran in emerging technologies

In May, Russian Presidential Aide Andrei Fursenko emphasized the significance of promoting partnerships and collaborations with Iran in emerging technologies.

It is a fact that focusing on already established technologies will not be beneficial for the two countries. So, it is essential to put on the agenda the technologies that have not (fully) developed yet, which is a much more difficult task, IRNA quoted Fursenko as saying.

The official made the remarks in a meeting with the head of the Organization for the Development of International Cooperation in Science and Technology, Hossein Roozbeh, and the head of Pardis Technology Park, Mehdi Safarinia, while attending Iran-Russia diplomacy meeting on Friday on the sidelines of the International Innovation and Technology Exhibition (INOTEX 2025), which was held from April 29 to May 2, in Tehran.

"Although working on new technologies is risky, we should not fail to prioritize them, because there is no other way to be the first in the world," the Russian official added.

For his part, Safarinia said Iran is committed to promoting international scientific cooperation, highlighting that Russia is among the top countries with which Iran is willing to expand ties.

The official went on to say that Russian companies can have offices in Pardis Technology Park. The establishment of Russian universities' branches in the country was the second point mentioned by Safrinia. "We have already reached agreements with St. Petersburg University and Moscow State University. We are following up on the issue in cooperation with the University of Science and Technology.

This will be the first foreign university to have a branch in Iran. Both Iranian and regional students will be able to study at this university, spending part of their studies in Iran and the rest in Russia," Safarinia further noted.

The official also announced readiness to further enhance collaborations in research

and education, as well as market opportunities, as members of the Shanghai Cooperation Organization (SCO) and BRICS.

During the Iran-Russia diplomacy meeting, the two countries also signed a memorandum of understanding (MOU) to establish two joint tech zones.

The three-day event provides a valuable platform for knowledge-based companies to showcase their latest products and achievements in the healthcare sector. They also seek to establish a permanent presence in Afghanistan's market, ISNA reported.

Medicine and medical equipment are two important areas related to people's health, he said, adding: "We are trying to reach self-sufficiency for the supply of medicine and medical equipment," IRNA reported.

On January 13, the head of Iran's Union of Medical Equipment Manufacturers and Exporters said that medical equipment worth around \$20 million is exported to more than 60 countries annually.

More than 70 percent of medical equipment and 100 percent of normal hospital beds are domestically made, IRNA quoted Abdolreza Yaqoubzadeh as saying.

Also, over 95 percent of specific ICU and CCU beds and more than 85 percent of operating room medical equipment, such as anesthesia machines and other equipment, are manufactured with cutting-edge technology in the country, he added.

Yaqoubzadeh went on to say that the country's need for medical equipment production is three to four billion dollars per year, some one billion dollars of which is imported.

Some 600 medical equipment companies are active in the country, producing around 99 percent of the medicine supplied to the domestic market.

Medical equipment manufacturers in the country produce and supply over 10,000 types of medical equipment to domestic and foreign markets. Now, various pieces of laboratory equipment are manufactured at prices much lower than the same foreign products.

#### Kafka's "Letter to His Father" appears in Iranian bookstores

TEHRAN- A Persian translation of Czech writer Franz Kafka's book "Letter to His Father" has recently been published by Kharazmi Publications in Tehran.

Faramarz Behzad the translators of the book first released in 1919.

Franz Kafka penned a poignant and confrontational letter to his father, Hermann, which has since become known as "Letter to His Father" (German: "Brief an den Vater"). This seminal work offers a profound insight into the complex and often tumultuous relationship between the two men.

As documented by Kafka's biographer, Max Brod, the letter was given to Kafka's mother with the instruction that she deliver it to his father. However, this assignment was never fulfilled, and the original manuscript, comprising 45 typewritten pages with extensive handwritten corrections, remained unpub-

The letter was first translated into English by Ernst Kaiser and Eithne Wilkins and published by Schocken Books in 1954 as part of the collection "Dearest Father: Stories and Other Writings". A bilingual edition followed in 1966. More recently, a new translation by Hannah and Richard Sieburth has been published, offering readers a fresh and nuanced understanding of this pivotal work.

Franz Kafka (1883 -1924) was a prominent Czech-born writer who authored in the German language. Born into a middle-class Jewish family in Prague, then part of the Austro-Hungarian Empire, Kafka is regarded as a major figure in 20th-century literature.

His works blend elements of realism and the fantastical, often depicting isolated protagonists confronting bizarre, surreal situations and oppressive bureaucratic systems. The term "Kafkaesque" has entered common usage to describe such disorienting and oppressive scenarios.

His most famous works include the novella "The Metamorphosis" (1915) and the novels "The Trial" (1924) and "The Castle" (1926). Kafka's influence extends across various disciplines, impacting artists, philosophers, filmmakers, and cultural theorists.

Despite his literary success, Kafka trained as a lawyer and worked in legal and insurance jobs, which created internal conflict given his true passion for writing.

During his lifetime, only a few works were published, including "Contemplation" (1912) and "A Country Doctor" (1919). He maintained a strained relationship with his father, to whom he wrote numerous letters.

Kafka died at age 40 from tuberculosis, relatively unknown at the time. Besides his novels and stories, he is also celebrated for his aphorisms and fables, often combining dark themes with moments of humor, and his writings are sometimes seen as prophetic of future totalitarian regimes.
